On March 18, 1950, the formal reactivation of Champ Clark Chapter at Washington University, St. Louis, Missouri, became a reality when Supreme Justice Douglas L. Edmonds presented to the newly initiated group the charter. The original Champ Clark Charter was issued on May, 1922 and remained an active chapter until before the war, when, due to the lack of students at the school, became inactive. The charter was presented at the banquet held in the Crystal Room of the Hotel Jefferson in downtown St.

The reactivation of Champ Clark Chapter is a result of the hard work of William Bret and his fellow brothers at John L. Sullivan Chapter at St. Louis University, the St. Louis Alumni Chapter and National Field Representative Rae. Informal rush parties had previously been held. 28TH BIENNIAL CONVENTION

The 28th Biennial Convention will be held August 31 through September 2, 1950, at French Lick Springs Hotel, French Lick Springs, Indiana.

This site was selected by the Supreme Executive Board for the holding of the 1950 Convention. Attending this Convention will be delegates from 70 active chapters throughout the United States and 30 alumni chapters. In addition to the official delegates, it is estimated that more than a hundred visitors will be in attendance. Convention rates will apply to delegates attending the Convention even though they arrive prior to the opening of the Convention or remain thereafter. These rates are \$10.00 per day, per person, in a double room or \$12.00 per day in a single room. Members desiring to attend this Convention should fill out the form provided in this issue of "The Reporter" and send the same directly to the hotel. Reservations are being handled directly by the hotel but all members are requetsed to verify their reservations by sending a confirmation form to the Executive Office.

All active and alumni chapters have been sent forms from the Executive Office notifying them of their status with the Executive Office and whether they are in good standing or not. Only delegates from chapters in good standing will be seated at the Convention.

The National pays the reasonable and necessary expenses of but one delegate from each chapter. These expenses are first class railroad fare, upper berth rates, subsistence of \$3.50 per day while traveling to and from the Convention, and a hotel allowance of \$40.00. The National Chapter does not pay the expenses of delegates from alumni chapters.

Each chapter is entitled to have seated 2 delegates and 2 alternate delegates. Each Alumni Chapter is entitled to one delegate and one alternate delegate. Delegates from active chapters must have at least 6 months additional law school work following the convention.

French Lick Springs Hotel is located in Southern Indiana, approximately 50 miles from Louisville, Kentucky. The facilities available at this hotel are ideal for a convention. It has over 600 rooms, numerous meeting rooms and convention halls. In addition to facilities for meeting purposes, it has many recreational facilities including but not limited to horseback riding, 2 golf courses, 2 swimimng pools, bowling alleys, skeet shooting range, mineral baths and an attractive cocktail lounge for indoor exer-

Young Lawyers **Should They**

Join Large or Small Firm?

One of the burning questions that confronts the young lawyer -whether to begin practice with a large law firm or small one, was the subject of a panel discussion before the Loyola Law School of Los Angeles at a recent meeting.

Participants in the panel were Attorneys Irving Walker and Graham Sterling.

Monetary compensation, the speakers agreed, should be no criterion for making the choice. Large law firms, it was noted, often afford more security, but less opportunity for financial re-

Sterling, a partner in the leading Los Angeles law firm of O'Melveny and Myers, said that stability and security are the advantages of the large law firm, and that the young lawyer is afforded a greater opportunity to enter into an executive business capacity. He minimized considerations of nepotism and inter-office politics as a dis-advantage. The necessity for a large law firm to maintain its vitality negates such considerations, he declared. On the other hand, Sterling said lack of seniority and lack of close client relationship are disadvantages of the large firm.

Alumni Relationship

Discusisng alumni relation erally their failure to establish an efficient program of alumni relations. This was due to several factors among which were the lack of a substantial number of alumni in some localities and the lack of time of the alumni in general. Supreme Vice-Justice Tom Henderson gave to the group at this point several reasons as to why alumni relations are not up to par. He mentioned the fact that the average young lawyer upon graduation is con-cerned with the task of getting his practice established, paying for his library, obtaining and advising clients, and in general making a living for himself. Consequently, his time and finances are very limited. Mr. Henderson said that on the average, it would be from 5 to 10 years after graduation before the alumni would be able to do anything of a substantial nature for the local chapters.

Supreme Justice Edmonds made the suggestion that the local chapters invite 2 or 3 of the parties, functions, etc., and acactive chapters in order to stimulate the interest of the alumni. He also told the group of the various practices employed in some of the larger cities whereby the gathering places and in some instances have set aside certain tables in dining establishments for the actives and alumni to each other and further promote fraternal relations. The majority of the chapters represented outgenerally their respe mote and foster alumni relations.

Chapter Finances

Speaking of chapter finances, most of the delegates designated they had employed the assessment principle to take care of expenses. One suggestion was made to let the alumni chapter either pay dues to the local or to contribute a certain amount towards financing the local. Another chapter told of the system they employed whereby a tentative social calendar was submitted at the beginning of the semester or quarter and assessments to cover that were levied accordingly.

We can therefore confine our discussion to the matter of a frater nity house alone, but this limitation is in no way mandatory and a discussion of the entire topic is desired.

During the last few weeks, I have discussed this topic with some of my brothers in Sullivan Chapter and for the most part have received negative arguments. The principal negative arguments have been:

1. A legal fraternity such as ours has no need for a fraternity

2. Such a project would be too expensive to finance.

But, by looking only to these negative arguments, no progress can ever result; we shall always be content with the status quo, because generally all first steps are clothed with risks and doubts of success. Then, before a definite conclusion is reached as to whether a fraternity house should or should not be established, the affirmative arguments should be heard—to weigh with the negative arguments proposed by my brothers.

Benefit by Establishment



Judge Savarese Addresses Wilson Banquet

Initiation ceremonies for 48 pledges on April 21 climaxed the most eventful year in the recent history of Woodrow Wilson Chapter at Cornell. Following the formal ceremonies, the chapter held its first post-war initiation ban-quet, with 85 of the 100 active members and pledges in attendance.

Highlight of the banquet was an address by the Hon. Anthony P. Savarese, Surrogate of Queens County, N.Y., and Supreme Treasurer of Phi Alpha Delta. After discussing briefly the aims and principles of P.A.D., Judge Savarese devoted most of his talk to probate practice in New York.

He noted the post-war resurgence of Woodrow Wilson Chapter and praised its members for their return to preeminence in Eastern law fraternity circles. Judge Savarese made special mention of the chapter's emphasis on academic and extracurricular activities, balanced with a monthly program of lectures, study clinics and social events. "Your outstanding success during the recent rushing period, when 62 first-year were pledged, is proof that your activities have something to offer the students of Cornell Law School," he told the banquet guests.

Faculty Attend

Judge Savarese's address was preceded by a humorous talk by Brother Prof. Lyman P. Wilson, faculty advisor to Woodrow Wilson Chapter. Another brother on the Cornell Law School faculty, Prof. Rudolf B. Schlesinger, served as toastmaster.

Prof. Schlesinger announced that Felix Liebmann, secondyear member of Woodrow Wilson Chapter, had just been elected editor-in-chief of the Cornell Law Quarterly. Liebmann is the first P.A.D. member since World War II to achieve this honor, although five members of the chapter's graduating class are currently on the Quarterly's board of editors.

Another highlight of the banquet was the presentation by Norman L. Hess, newly-installed justice of the Cornell chapter, of a past justice's key to Emlyn riffith, retiring justice. He paid tribute to Griffith's leadership in the last 12 months and pointed to Woodrow Wilson Chapter's "impressive growth, quantita-tively and qualitatively," during the administration of the outgoing officers.



John L. Sullivan Chapter of Phi Alpha Delta and Bakewell Senate of Delta Theta Phi Law Fraternity have arranged the first of a projected annual moot: court series. "THE LAWYER-

Public Citizen No. 1"

(An address delivered by District Justice ROBERT E. FREER, District 12, at a Smoker held by Watson Chapter and Pittsburgh alumni at the University Club, in Pittsburgh, on February 21, 1950. Brother Freer, formerly was Chairman of the Federal Trade Commission.)

The lawyer for decades has played a stellar role in the play of dynamic forces, giving shape to America's way of life. The University, too, has had top billing on this stage. Such was the identity of direction that it was written in the stars that one day the students of the Law School of the University of Pittsburgh and the active and alumni members of Phi Alpha Delta Law Fraternity would join in honoring the lawyer as a citizen.

The prime goal of each is to promote better citizenship and better social institutions. High on this agenda is an interest in the progress of the legal profession. Being a member of that profession I will stick to my last.

I pass quickly over the many things concerning the lawyer that our friends and neighbors take for granted. For instance, the legally trained almost invariably are active and articulate participants in the economic and social life of town and country. Likely having served with distinction in one or both of the global conflicts, Mr. Average Lawyer, a civilian again, gives his time to charitable enterprises and religious affairs; and he exercises conscientiously his right to the ballot. He is part and parcel of a mature, vigilant and enlightened electorate. His debates, altercations and contentions, whether expressed in the courtroom, on the stump around the hustings or in the town meeting, help mold public opinion. Any school child knows that from one Esquire's clashes in the courtroom with his brother Esquire on the opposite side of a case, many of our basic truths have evolved, as translated by another brother-lawyer—His Honor on the bench.

The Cultural Side of Lawyers

We have our cultural side, too. Noah Webster, one of those who later "agitated for the calling together of the Constitutional Convention," compiled his first speller, forerunner of the dictionary, as a means for supplementing his income as a lawyer. Boswell, of Samuel Johnson fame, began the practice of law in Edinburgh as heir to a 10-mile manorial estate, predicting a brilliant future for himself. William Howard Taft, to name a more recent lawyer whose accomplishments, besides teaching me Federal Procedure in University of Cincinnati law school, are too numerous to mention, wrote a very fine book entitled "The Chief Executive."

Still reflecting on the obvious, the economic facts of life may make legal services peculiarly available to the so-called "entrenched interests." Yet traditionally there have always been those ready to afford advocacy to the so-called "underdog," testimony to our eternal vigilance in preserving our country's institutions. Of the fifty-five signers of the Declaration of Independence, drafted largely by 33-year-old lawyer Thomas Jefferson, twenty-six were lawyers, and among the 550 members of the French National Convention convening after the fall of the Bastille, 350 were lawyers. These undoubtedly represent the greatest efforts of all time to correlate abstract justice and the law. Their technique has been used since, but never before had men the faith or the ingenuity to direct pleas to so vast a jury. Those appeals were to the conscience

The legally trained are indispensable to a society where the welfare of the individual is paramount. Law is the only reasoned adjustment to human relations. It is the expression of the best aspirations of humanity. How different is the march of the political philosophy which seeks to challenge our own. Its grotesque and brutish pattern is now familiar. First there is the campaign of false propaganda, then terrorism followed by rigged elections, jailing of the opposition, and, finally, after execution of one or more of the leaders, there emerges the old familiar government by men rather than by law based upon principles and ideals of justice.

Law Fraternities and Bar Associations

Every lawyer can contribute to maintain the high standards which the public has come to expect. All of us need an outlet broader than our day's work. Partiipation in the activities of Law Fraternities and of Local, State and National bar associations affords friendly association and a medium for the exchange of ideas. Especially, the fraternity and the local bar association affords a channel in which to blow off steam. Such exchanges of ideas can go far toward divesting us of that characteristic which Mr. Justice Holmes attributed to judges and which Mr. Justice Douglas said lawyers incline to as well, by being "more likely to hate at sight any analysis to which they are not accustomed, and which disturbs repose of mind, than to fall in love with novelties.'

Rugged Individualists

Traditionally, lawyers are rugged individualists. They are schooled to back their own decisions and to foster and depend on their own initiative. This may account for the fact that the perentage of participation in association activities is much lower in the law than for the other professions, medicine, for instance. Many of those not participating in organized activities, nevertheless, have acquiesced in, and contributed to, these t dvances.

The lawyer's role as officer of the court is important in the administration of justice. The degree of freed m individuals must renounce in our complex society is decided by democratic processes. The lawyer, however, expressly undertakes to forego more than other segments of our citizenry. Essentially the trust thereby imposed is that he will do his part toward conducting actions in an orderly manner and free from political, racial and religious animosities, to the end that causes be tried and decided on their true

A Product of Democracy

Peter, the Great, as a 17th Century visitor to London, was amazed at the number of lawyers at Westminster Hall. Reports have it that he said there were but two lawyers in all his dominions, and that he had made up his mind to have one hanged when he got home. A past president of the Colorado Bar Association, no doubt, was relying on other and more recent evidence when he said, "The lawyer is the product of democracy. When dictators seize power, they liquidate the lawyers. They want to lawyers to be in

the way by asserting the rights of citizens." Rightly called the North Carolina Chapt. the maintenance of democratic institutions has been enormous. This influence has been important abroad as well. Past president Plan Spring Banquet Lashley of the American Bar Association three years ago made a Lashley of the American Bar Association three years ago made a trip to France, Italy and Germany to tender the understanding and aid of American lawyers to their brothers overseas, upon whom Europe must depend for preservation of these ideals.

The Older Warriors

There persists among lawyers of my age the same fond and fatherly interest which the elders of my law school days displayed toward me and my contemporaries, as just prior to World War No. 1, we were completing the academic phase of this indoctrination course we call the study of law. The more mature braves delight in reminding newcomers that, unlike the ceremony of great dignity by which young American Indians of proved worth were Rutledge Chapter; Dick Bailey, accorded the status of the Brave and forever after shared in the Mc Watkins, Timberlake Chapresponsibility of tribal councils, no magic transformation occurs through survival of the trial by ordeal inherent in bar examinations. Possibly, older warriors already may have reminded some of you that the young lawyer's prime function is to grow older, and that, like the law, he is but a process, and not the completed product. Additional testimony is that of an English barrister, rich in maturity, achievement, and clientele, who observed that, when young, he lost cases he should have won, and, when older, he won cases he should have lost; and summed it up by indicating that, thus, on the average, justice had been done.

Bar Admission Standards

The legally trained are keenly aware of the ethical responsibility which the public trust imposes. Hence, the continuous sharpening and refinement in the selection process among candidates for a career in law has more than kept pace with the raising of standards in the other professions. Though advocates were a standing order in England prior to 1255, and barristers as early as 1291, they were the creation of custom, not statute. Early in the the banquet in Raleigh on 15th Century, Parliament provided that none but "good and virtuous" men, "learned, and of good fame," should be examined, sworn and registered as attorneys, and that any such found in default thereafter "shall forswear the court." The substance of this British statute had its origin in French and Roman law but it came to the New World as part and parcel of the Common Law which served as the foundation of our American Law.

The number of lawyers in the States at the close of the Revolution has been variously estimated at from 300 to 700. by the middle 1880's the profession numbered 70,000 strong. Efforts of the profession itself, through the bar associations and the law schools, in gradually revising upward our standards have met with general public approval. In a very real sense the graduates of today's law schools have the requisite technical training to admit them to this finest profession in the land. Significant, too, has been the contribution of the law fraternities in the undergraduate training of our legal rookies.

Public Confidence and Respect

As to the shape of things to come, I believe that increased public confidence and respect will inure to our legal institutions, provided we lawyers steer our course on the beacon of our duty as officers of the court, avoiding the shoals of crass commercialism, a commercialism so aptly illustrated by a humorous commment made several years ago at the American Bar Association meeting in Cleveland by my British barrister friend, Member of Parliament, and former Counselor of the British Embassy in Washington, Brigadier John Foster. He had for his topic the subject, "The Barrister in Parliament" and he stated that there were not many of them in Parliament, perhaps because, too often, too many people passing the Inns of Court, on a warm day, might have overheard one barrister, in conference with another, say, "What, settle the case and see the estate frittered away among the beneficiaries"?

One contemporary problem is as old as jurisprudence itself. Justice delayed is Justice denied; but summary judgment is no panacea. The 20th Century practitioner and his clients are the beneficiaries of substantial progress that has been made in the direction of speedy trial or hearing, on the one hand, and the full protection of the rights of litigants, on the other. Especially is this being achieved through increased emphasis on opportunity for pretrial conferences and settlements. The availability of the former is encouraged also by the Administrative Procedure Act of 1946. The Act, I believe, is a landmark in the evolution of federal administrative law. As you know, it deals comprehensively with all phases of the administrative processes, including separation of prosecuting and deciding functions, evidence, rule making, appeal, and public information.

The Administrative Procedure Act

In the field of administrative law, certain sections of the Administrative Procedure Act tend toward bridging the gap between the general practitioner and the specialist in practice before many federal agencies. Its influence likely will spread to state reception in the Mural Room of agencies. International law is still a frontier, but the future of all the Stephen F. Further on the subject of things to come, I believe that lawyers will continue to enjoy the abundant life, the greatest blessings of which are as abstract as the ideals of their jealous mistress, the all alumni of the Tom C. Clark law. Rich in fellowship, too, are lawyers, as Shakespeare observed centuries ago:

"And do as adversaries do in law Strive mightly, but eat and drink as friends."

Far from being a thing separate and apart, the bar, as a matter of fact, is a splendid index to public virtue. Corruption of its standards inevitably would effect the whole body politic. I shall conclude with a reference to our trust, so well spelled out by former Chief Justice Hughes, with whom I once had the honor to cross legal swords, when he described, as follows, democracy's stake in

> "With a sound, courageous, and independent bar, a foe of demagogy but a friend to rational improvement, vindicating its expert leadership by intelligent conception of the interests of the community, and by its zeal for the better administration of justice which is its especial cares, democracy will not essay its tasks in vain."

It was also agreed by the chapters to continue our efforts toward forming a North Carolina alumni chapter by contacting our alumni individually and soliciting their support of the local chapters on professional projects.

Freer Visits Timberlanke

After the meeting Brother Freer visited the chapter house at Wake Forest and met many of the brothers there. We all look with pride at this chapter house since it enables the brothers there to work more closely on all matters of fraternal business.

A member of each of the three chapters will meet with Wally McCown, Rutledge Alumni, on Friday, March 17, 1950 to consolidate final plans for the spring banquet.

Clark Honors Clark

The Tom C. Clark Chapter, at the University of Texas, honored Associate Justice Tom C. Clark of the United States Supreme Court on April 13, 1950, with a Polk Hildebrand, late Dean of the School of Law.

Phi Alpha Delta Man Acquitted!

A jury composed largely of sociology majors from the University of North Dakota took but a few minutes to establish the innocence of Brother Wes Sando to a charge of first degree murder. Sando was brought to trial for the slaying of Professor Robert Ford before a class of shocked and unsuspecting freshmen. Defense counsel Wes Christopherson proved to the satisfaction of the jury that the defendant was so mentally irresponsible at the time of the shooting as to be incapable of knowing the nature of his act.

With the exception of a few unrehearsed but humorous dem onstrations, the trial was conducted in a professional manner and was an effective, practical means of familiarization with North Dakota criminal procedure. Corliss Chapter plans to make a similar undertaking an annual event.. It must be fairly conceded, even by the prosecuting attorney, Brother Paul Bueh ler, that the verdict was just inasmuch as the prosecutor retained as his advisor the alleged decedent.

Movies To Be Used

The mock trial also pointed out the need for practical experience in interrogation of witnesses. To correct this apparent deficiency in legal training, Corliss Chapter plans to stage simple tort scenes of which movie will be made. The movies will then be exhibited to groups e witnesses who will be examined by chapter members under simulated trial conditions.

A committee is now working on the movie production and expects to present films for the Chapter's use in the very near future. Corliss Chapter wishe to acknowledge its thanks to Campbell Chapter at the University of Michigan School of Law for its original idea and for its advice in their attempt to profit by a similar program.



Federal Union

Under the Constitution of 1917, Mexico is a federal union of 28 states with three territories in the federal district. The Congress is Bicameral with a Senate of 58 members and a Chamber of Deputies of 147. The President is elected for a 6 year term and may not be re-elected. He is aided by a Cabinet of 15 minis-

Mexico has experienced a general rise in its cost of living. This was accelerated by scarcity of basic commodities including wheat, beans and corn. Mexico's economy is based upon agriculture and mining. Corn is the principal crop staple food. Other important domestic crops are beans, wheat, sugar and cotton, rice and fruits.

Mineral constitute a large part of Mexico's exports ,and equipment for mines account for a good part of its imports and capital goods. Mexico's major mineral product, by value, is silver. It leads all other countries as exporter of this metal, and produces 40 per cent of the world's output.

Consumer's Goods

Mexico's industrial growth has been phenomenal in the past few years. Prior to that time, manufacturing in Mexico was chiefly confined to consumer goods with ittle development in the heavy industries. The cotton textile industry has increased the great-
