

HENRY CHAPTER HITS RADIO QUIZ JACKPOT

Richard Ryder hit a radio quiz jackpot on Richmond, Va., station WRVA January 17 which brought loot valued at approximately \$660 into Patrick Henry Chapter coffers and an additional \$260 worth of prizes for Dick personally, including flying lessons dancing lessons and beauty treatments—guaranteed, it is reported, to make Dick the Flying Adonis of the T. The ingenious scheme for bolstering Chapter finances by participation in the WRVA program 'Win If You Can" was devised by Henry Chapter Clerk Gordon E. Heath. Brother Heath arranged for Henry Chapter to be the guest in the law school courtroom of the 50,000 watt clear channel station's quiz show, with questions for the program prepared by Dean William T. Muse and Supreme Marshal J. Westwood Smithers. Legal questions were chosen which would be of general informative interest to the public. In advance of the broadcast, the Chapter agreed that if the jackpot question should be answered correctly, the prizes would be sold for as much as could be obtained, one-fourth of the proceeds to go to the contes-tant answering and the other three-fourths to be placed in the Chapter treasury.

Hay Chapter Is Booming

Hay Chapter, at Western Reserve University, which was just reactivated on May 12, 1950, reports that eight members and four pledges are on the Law Review Staff at Western Reserve. Three of them have had articles published recently and two more had articles appearing in the January issue.

Of the four Law Review officers two are Hay Chapter members.

The chapter holds luncheon and dinner meetings regularly which are attended by the active chapter and pledges together with the alumni in and around Cleveland, Ohio.

Richard Berry, of Hay Chapter, is the top scholastic man in the second-year class and John Butta, Jr., is the second highest student in the third-year class. Brother Berry's grade averages one of the highest in the history of Western Reserve Law School Another second-year man and also a PAD, Earl Sheehan, placed first in the Comprehensive Examination given in September, 1950. Only 11 men out of approximately 130 were able to pass this examination which was a test of retention of previous subjects

District 12 Plans

The second annual District Conclave of District 12 will be held in Raleigh, North Carolina, on March 17, according to an announcement by McNeill Watkins (Timberlake), District Steering Committee Chairman.

More than 100 delegates are expected to attend the Conclave, being sponsored by North Carolina host chapters Timberlake, Wake Forest College; Ruffin, University of North Carolina; and Rutledge, Duke University. Conclave headquarters will be the Sir Walter Hotel in Raleigh.

One of the highlights of the Conclave program, which is under the direction of Robert E. Freer (Chase), District 12 Justice and Washington, D. C., attorney, will be the active initiation of Carroll W. Weathers, new dean of the Wake Forest College School Weathers, new Dean of the Law of Law and prominent North Carolina attorney.

Representatives of Districts 2 and 3, combining in the second annual joint Conclave of the two Districts in Fresno, Calif., on February 9 and 10, followed the lead set last Fall by District 7 in establishing their own District self-government for greater District operating efficiency and closer contact between Chapters.

Student officers elected by the bined District organization for the ensuing year were George S. Youngling (Temple), Vice - Justice of District 2; Dale H. Heinly (Ross) Vice-Justic of District 3; Harold C. Hohbach (Field), Clerk; and Vincent Pagliarulo (Ford), Treasurer.

Students from six of the seven Active Chapters in the two Districts gathered in Fresno as the guests of the Fresno Alumni Chapter for the second consecutive year. Represented at the Conclave were Field Chapter, University of California; Holmes Chapter, Stanford University; M. Sullivan Chapter, University of San Francisco; Temple Chapter, Hastings College of Law; Ford Chapter, Loyola University; and Ross Chapter, University of Southern California. Delegates from Knox Chapter, University of Arizona, were unable to attend because of a conflicting examination schedule.

Admission on Motion

Principal item of business at the morning session was a discussion of a proposed resolution to the State Legislature of California regarding admission to the bar on motion of those students whose studies are interrupted by call to active military service before they have been able to take the bar examination. At the close of the discussion, the Conclave adopted the following resolution:

"WHEREAS, the Legislature of the State of California has heretofore enacted Section 6060.5 of the Business and Professions Code providing for the admission to the bar on motion of certain law school students, and "WHEREAS, the provisions of said Section were applicable only to those student whose legal

Message from the Supreme Justice

We are starting the new year with definite plans for carrying out the resolution of the convention concerning the furtherance of legal aid. In two or three localities the local legal aid organization has agreed to take law students for part time work. These arrangements have been made with the approval of the deans of the law schools involved. We hope that in other localities law school students will be put to work in the legal aid organization.

Although not all lawyers are supporting legal aid, the differences of opinion concerning it principally arise in regard to matters of detail. No lawyer worthy of the name turns away a deserving person in need of legal service because of inability to pay a fee. Many members of our profession devote considerable time to assisting those in need. But the establishment and maintenance of legal aid in an organized way presents problems which the profession has not yet solved with general unanimity.

The National Legal Aid Association presently is attempting to establish a system of area organization roughly comparable to our district organization. How-directory and its annual suppleever, necessarily such an organization must be confined to the state. The National Legal Aid Association is especially interested in finding leaders of the bar particularly in the south, south-west and west who are willing to undertake activities in behalf of legal aid. Such persons would either promote the establishment of legal aid in his state or if such work is already established, help to correlate the activities of the various organizations and generally promote the interest of the bar in legal aid

I am sure that there are many members of Phi Alpha Delta who are willing to give some time to legal aid work in one way or another. I ask that those who are willing to do so, write to me stating to what extent, if at all, he is now participating in the work of legal aid and what he thinks should be done in his state. Yale Mourns Passing of John A. Hoober

John A. Hoober (Calhoun) died at his home in York, Pa., on September 25, 1950, at the age

The following editorial memorial to Brother Hoober, reprinted here in its entirety, appeared in the December 1950 issue of the Yale Law School Alumni News-

"Eighty-three years is a long life, but not always a full one. In the case of John A. Hoober, however, there is no doubt that it was both.

"Mr. Hoober died on the twenty-fifth of September last. There had been nothing wasted about his eighty-three years of life. After graduation from the Yale Law School in 1891, he remained there on the faculty for a while and later taught at the Dickinson Law School in Carlisle, Pa. But Mr. Hoober's main role was played outside the academic life.

"He became a prominent fig-ure in legal circles in York County, Pennsylvania. His broad talents spread out into the business and industrial world where he served as officer and director of several York banks and industrial concerns.

"Yet, immersed as he was in the workaday world, he always found time to aid in the furtherance of special beneficent projects. For more than a decade Mr. Hoober was President of the Yale Law School Association, At his death he was chairman of the association's executive committee and a Law School member of the Yale University Council.

"During his lifetime Mr. Hoober gave over \$1,000,000 for religious and legal education at Yale University. He established the Trumbull Lectures and endowed several scholarships, including the John A. Hoober Scholarship for the Law School. In the Yale Divinity School he endowed a professorship of historical theology.

"These things are merely symbolic of John Hoober's greatest characteristic—his deeplying Christian temperament. Perhaps this temperament is best pictured in the words spoken by Yale President Griswold upon Mr. Hoober's death: "His contributions to Yale were not to strengthen the material or mechanical aspects of our civilization, but to inquire further into ly and earnestly about legal aid the spiritual values of life and the legal forces operating in our

National Legal Aid Ass'n. Seeks Field Assistance

The National Legal Aid Association is seeking parttime field representatives throughout the nation to assist in state-wide development of legal aid activities, according to Emery A. Brownell, Secretary and Executive Director of the Association.

Phi Alpha Delta has been requested by the Associa-

tion to assist it in finding attorneys willing to undertake such sociation needed financial supfield work for it in their own port and gives professional memstates. Volunteers for this work preferably should have had some pate, at nominal cost, in a procontact with legal aid work in law school or in their own communities, an experience which would be of invaluable assistance to them in these assign-

Of the first five part-time field representatives already appointed to serve with the NLAA in its development work, one is a PAD. He is John W. Cummiskey (Campbell), practicing attorney in Grand Rapids, Michigan. The other new field staff representatives are George S. Bradley, Toledo, Ohio; Harold Budd, Philadelphia, Pa.; Mitchell Leiken, Chicago, Ill.; and Arthur E. Schoepfer, Boston, Mass.

These representatives already have begun active work in their respective territories to assist state and local bar associations in the establishment of needed legal aid offices in larger cities which lack adequate facilities. Each representative chosen will cover the state in which he resides. The general plan is to develop co-ordinated programs through the American Bar Association, the Conference of State Bar Presidents, and the various state bar associations. Local community chests and councils of social agencies, as ABA Standing Committee on Lewell as other welfare groups, will be invited to participate.

Phi Alpha Delta alumni interested in further particulars concerning this program are requested to contact either the PAD Executive Office, 403 W. 8th St., Los Angeles 14, Calif., or Mr. Emery A. Brownell, Secretary and Executive Director, National Legal Aid Association, 328 Main St. East, Rochester 4, N. Y. Mr. Brownell has indicated that field representatives are especially needed in the South and Southwest. PAD has been given to understand that the work involved will not be excessively time-consuming, and that necessary travel expenses involved will be met by the NLAA.

However, at this time, when goodwill means so much to both the NLAA and the profession, it was determined that a new relationship between the two would be of great benefit to both groups.

The logical answer to this mutual need has been supplied with the creation of a class of individual memberships in the NLAA limited to the legal profession. Attorneys may join the NLAA as professional members by the payment of \$10 annual dues. This type of membership gives the asbers an opportunity to particigram vital to their future. "Journal" Article **Lauds Fraternities**

The important place of legal fraternities in the extracurricular life of a Law School was stressed by Kenneth Robert Redden, Associate Professor of Law at the University of Virginia, in an article written jointly with Edgar Allan Jones, Jr., founder and first editor of the "Virginia Law Weekly," entitled "Extracurricular Activities—The Ugly Duckling" which appeared in the Winter, 1949, issue of the "Journal of Legal Education," 2 J. Legal Ed. 195 (1949).

Presenting a searching analysis of the problem of extra-curricular activities in our modern law schools, and upsetting with facts and figures the outmoded dogma that extracurricular activities have little or no place in legal education, Prof. Redden deplores the present lack of emphasis upon extracurricular projects which can broaden legal education. Listing the extracurricular activities which he considers of greatest value to a Law School, Prof. Redden places legal fraternities second only to the school Law Review, and points out that they can be the basis for development of virtually all of the projects suggested in his article.

He states, "Although the value of a law review is well recognized, only sixty-two per cent of the schools examined sponsor a legal periodical. This lack of emphasis upon the provision of extracurricular opportunities for our law students is even more strikingly demonstrated in the other potential channels of student activity less connected with the curricular process than the traditional law review. In descending scale the percentages existence of legal fraternities; government bodies for the management of law student activities; thirteen per cent possess student bar associations; five per cent have established student newspapers; four per cent have student groups which consult and advise the faculty on curriculum matters; four per cent publish student year books; and two per cent have student bodies which sponsor speakers on topics

Part of his army work in World War II was as presiding District 8 Conclave judge in spy trials, and he is credited with supervising the reorganization of Italian Civil Courts. Judge Waugh is a Past State Commander of the American Legion and is a member of Amvets and Veterans of Foreign Wars. A. J. PETIT DIES IN CHICAGO

Adelor John Petit (Webster) died at the age of 82 on February 12, 1951, in Chicago, Ill., following a heart attack. Funeral services were held February 15 at 5501 N. Ashland, Chicago, followed by interment at Rosehill Cemetery, Chicago, Ill.

PAD was represented at Brother Petit's funeral services by a large delegation headed by John P. Burita (Blackstone), Justice of the Chicago Alumni Chapter, and the following Past Justices of the Chicago Alumni Chapter, John A. Brown (Story); George E. Brother Petit was born in Chicago on July 12, 1868. Educated in the Chicago public schools, West Division High School and Powers Business College, he received his LL.B. in 1893 from the Chicago College of Law, then the law department of Lake Forest University, now the Chicago-Kent College of Law. He was Master in Chancery of the Circuit Court of Cook County, Ill. from 1902 to 1904, a Judge of the Chicago Municipal Court from 1906 to 1908, and a Judge of the Circuit Court of Cook County from 1909 to 1915.

Initiated into Webster Chapter of Phi Alpha Delta in 1910, Brother Petit was a consistent and loyal member. He seldom missed any affair of the Alumni Chapter. His genial disposition and his willingness to reminisce on his experiences as a lawyer and judge endeared him to the old and young alike. Taney Chapter Honors Dean Robert G. Storey

Taney Chapter conferred hon-orary membership in Phi Alpha Delta upon Dean Robert Gerald Storey of the Southern Methodist University Law School on January 5 at ceremonies held in the Lawyers' Inn Game Room in Dallas, Texas.

Dean Storey is one of the best known and most highly respected men in the field of legal education, with a background in active practice, business and governmental office which places him among the foremost law school deans of our time. Primarily as the result of his vision and endeavor, Southern Methodist University has become the center of legal education in the great Southwest with the establishment of the Southwestern Legal Center on its campus, the new quadrangle for which will be dedicated during "Lawyers Week" in Dallas from April 16

Taney Chapter officers presiding at the honorary initiation of Dean Storey were Irvin Wall, Justice; Robert Caldwell, Vice-Justice; Gilbert McGloin, Clerk; Bill Ellis, Treasurer; and Wesley Alexander, Marshal. Faculty PAD's participating were Professors Aaron J. Thomas, Jr. (Taney), and Jack W. Riehm (Hammond).

Dean Storey received his academic and legal education at the University of Texas and Southern Methodist University and was awarded an LL.D. degree by Texas Christian University. Prior to becoming Dean of the Southern Methodist University Law School he was senior member of the law partnership of Storey, Sanders, Sherill and Armstrong in Dallas. He has served as a director of the Southwestern Bell Telephone Company and as Chairman of the Board of Directors of the Lakewood State Bank.

Brother Dean Storey has a distinguished military service record in both World Wars. In World War I he rose from Private to 2nd Lieutenant with the Heavy Artillery. In World War II he served as a Colonel in the Army Air Corps, his service including posts as Director of Intelligence at the School of Applied Tactics, Orlando, Florida, and as Deputy Director of Intelligence, Mediterranean Allied Air Forces from 1944 to 1945. Following the close of hostilities in World War II. Brother Storey was a member of the special mission to investigate, identify and apprehend war criminals in Bulgaria from September 1944 to February 1945. He was then appointed executive trial counsel to Mr. Justice Robert H. Jackson (Jay) in the prosecution of the Nuremberg war crimes trials during 1945 and 1946.

For his military services, Brother Storey has been awarded the Bronze Star for his work on war crimes in Bulgaria, the Legion of Merit for his conduct of Intelligence activities in the Mediterranean Theatre of Operations, the Army Commendation Ribbon for his general services to the Army Air Corps, and both the Medal of Freedom and the French Legion of Honor for his services at the Nuremberg trials.

Brother Storey has also been prominent in public life, having

served as Assistant Attorney General of Texas in charge of all criminal appeals from 1921 to 1923. During 1921-22 he was a member of the National Executive Committee of the American Legion. From 1924-30 he served as a Regent of the University of Texas, and in 1931 he was elected Governor of the Kiwanis Clubs of the Texas-Oklahoma District. He was President of the Park Board of the City of Dallas, Texas, from 1938 to 1941.

In the field of professional service, besides his activities with the Nuremberg war crimes trials, Brother Dean Storey has served as President of the State Bar of Texas from 1948 to 1949, and he is presently President of The Southwestern Legal Foundation, having assumed this office in 1947. He was President of the Dallas Bar Association in 1934. From 1938 to 1940 he served as Chairman of the Section on Legal Education of the American Bar Association, and since 1947 he has been a member of the Council of the Inter-American Bar Association. In addition, he is a member of the Board of Governors and House of Delegates of the American Bar Association.

At the invitation of Brother Dean Storey, the first Conclave of District 8 will be held in Dallas, Texas, on April 21 in conjunction with the Lawyers Week activities dedicating the new Southwestern Legal Center. These activities will include American Bar Association and local bar association groups from throughout the Southwest in a program which will provide the greatest assembly of lawyers ever held in the Southwest.

"WHEREAS, enabling legislaion is necessary to provide comparable legislation for those comparable registation for those students or graduates who are called back into the service be-cause of the present hostilities between the United States and North Korea or any oher nation,

"WHEREAS, there has been introduced in the Senate of the State of California a Bill designated as Senate Bill 527 providing for such enabling legislation, and

"WHEREAS, the undersigned chapters are composed of students now attending accredited law schools in the State of California, and

"WHEREAS, students from said chapters have been or will be called into the military service before they have had the opportunity to take the State Bar Examination,

"NOW, THEREFORE, BE IT RESOLVED that the undersigned chapters respectfully petition the Legislature of the State of California to enact legislation to admit on motion those students who are called into the military service and who have satisfactorily completed two years of study at a law school then accredited by the Examining Board and who, within five years from separation from such service under conditions other than dishonorable, graduate from a law school accredited by the Examining Board, and those students who, after such graduation from an accredited law school but before taking a State Bar Examination, are called into the Armed Services:

"BE IT FURTHER RESOLV-

"BE IT FURTHER RESOLV "BE IT FURTHER RESOLV-ED that the chapters attending this Conclave respectfully peti-tion the Legislature of the State of California to enact Senate Bill 527 now pending for consid-eration before that honorable body."

Placement

The next topic of discussion to come before the Conclave was a report by John R. Griffin (Temple), San Francisco attorney, regarding the development of the District 2 Placement Service of which he is the chairman. Sandy Rae, National Field Representative then presented a brief report on the activities of the national organization and the implications of the war manpower requirement upon Chapter activities for next year, presenting to the Conclave the attitude of the Association of American Law Schools on the probable 1951-52 enrollment decline as estimated at the Association Convention at which he represented PAD during the Christmas vacation. Brother Rae suggested that Active Chapters do everything within their power to increase Chapter memberships with high caliber students this year as protection against an anticipated 50% decline in law school enrollments next year.

The Conclave luncheon was held in the Patio Room of the Californian Hotel with Fenton B. Hackett (Temple), Fresno attorney, serving as toastmaster. Gordon G. Dunn, Mayor of Fresno, welcomed the assembled dele-

clave would return to the city in 1952. Supreme Justice Douglas L. Edmonds responded to Mayor Dunn's welcoming address, praising the Mayor for the record which he had earned in giving Fresno a wholesome city government. Guests at the luncheon included David E. District Organization

Henry C. Rohr (Ross), District 3 Justice, presided at the afternoon business session which was occupied primarily with a discussion of the new District organization proposed by the District Organization Committee. The Conclave ratified for the coming year the \$1 per member assessment which was first instituted at the 1950 Conclave as a means of underwriting annual Conclave expenses. It then proceeded to adopt a system of self-government based upon the organization of District 7 which had been crystallized at St. Louis last November. Districts 2 and 3, under the new plan, will be integrated as one single organization for all practical purposes, the objective being to provide a greater exchange of ideas and information between Chapters than is practicable in either District separately, each District being composed of Chapters located primarily in one city.

Heading the two Districts will be the separate District Justices provided by the National Constitution. Serving as District officers under them will be students elected by each annual Conclave to fill newly-created District offices. For the purposes of utmost inter-District co-operation, there will be a District Vice-Justice in each District, charged with the duty of co-operating with his District Justice in the planning of inter-District activities. Below the level of Vice-Justice, the two Districts merge their joint government, with one Clerk and one Treasurer. Future Conclave planning will be under the direction of the District officers, functioning as an Executive Committee, rather than under the previous system of a loosely-knit Steering Committee.

District By-Laws

The Conclave delegates agreed that this District self-government scheme should remain experimental during the coming year, and that the two District Vice-Justices should draw up a set of gates to the city of Fresno and permanent District By-Laws expressed the hope that the Con- based upon this system for refer-

ral to the individual Chapters and final ratification at the 1952 District Conclave. If these By-Laws are ratified by the individual Chapters and the Conclave in 1952, a permanent District government, semi-autonomous in nature, will have been created.

A special feature of the Conclave this year was the scheduling of a Conclave Forum following the close of the afternoon business session. This Forum consisted of a panel of National and District Officers who undertook to answer any and all questions concerning either National or local aspects of the fraternity which were presented to them either in writing in advance of the Forum or from the floor. Officers sitting on the panel included Supreme Justice Douglas L. Edmonds, Supreme Secretary A. A. McDowell, National Field Representative Sandy Rae, District 2 Justice J. Albert Hutchinson, and District 3 Justice Henry C. Rohr. Frank E. Gray, Executive Secretary, presided over the Forum dis-

Lones, Jr. (Ross), Chairman of Elect Officers the Fresno Alumni Conclave Committee, presided. Supreme Justice Edmonds presented the principal address of the evening, discussing the growth of the fraternity and the present scope of its national activities and stressing the importance of the new program of assistance to Legal Aid. One feature of the evening was the introduction of the wives or girl friends attending the banquet, with each being requested to discuss her conception of the wife's place in a lawyer's life.
