Counsel, National Headquarters, Selective Service System, before Interfraternity Conference Representatives at Pentagon. PAD was represented by Supreme Marshal J. Westwood Smithers."

At the outset, let me say that my personal view is that the program which the President and the Congressmen have prescribed for handling college students under the Selective Service Law is far the best, the fairest and most equitable plan that we have ever had. It is designed to help colleges and students by giving them an oppor-

tunity to make a reasonable forecast of their activities in the fields which are essential to our foreseeable future. It is designed to help Selective Service by providing a means for a fair approach to the so-called "Student Problem." As you know, college students remain in such status at the present time, through two main avenues — Deferment and Postponement of Induction. The Congress provided in the basic law for the Postponement of Induction of certain college students, and also in the basic law authorized the President to make provisions for the deferment of certain college students.

The logical approach therefore, is first to consider Postponement of Induction. Any registrant who is ordered to report for induction while he is satisfactorily pursuing a full time course of instruction in a college, university, or similar institution of learning, is entitled to have his induction postponed until the end of the academic year, or until he ceases satisfactorily to pursue such course of instruction, whichever is the earlier.

Notice Mailed Is Date

It is our conclusion, that a registrant is ordered to report on the day the notice is mailed by his Local Board, rather than the day when he receives it, so that he must be satisfactorily pursuing a full time course of instruc-tion at college on the day his order to report for induction is mailed by his Local Board, in order to qualify for postponement.

Also, the academic year is the academic year of the school rather than that of the student. The postponement of induction is merely a change of the date for reporting for Military Service. In the absence of some administrative action, the classification of the student is firm. He is IA. His appeal rights have expired, and he has a duty to report at the termination of his postponement, without regard to his desires for further consideration for deferment from, or postponement of his military service.

The deferment of college students is another matter. The Congress has authorized the President to provide for such deferment, and the President has taken action under this authority. When a student is deferred. he is in the same general category as a scientist and other highly skilled registrants who are deferred from military service because their work in the civilian occupation is deemed to be of greater benefit to the National health, safety, and interest than their service in a military establishment would be. Before a deferred registrant can be inducted, he must be reclassified, and at that time, he has the right of appeal if he is dissatisfied with the action of the local board.

national leadership. Student deferments are also necessary to provide for training in highly specialized fields in which the military establishment n eds trained men. No one doubts that some college students must be deferred from military service. At the same time, no one contends that all college students should be deferred. Trouble comes when we attempt to devise a plan for the selection of those students who should be deferred.

At this point, I believe it is well to consider the principal objection to the student deferment Program. History will prove that a nation cannot long survive when its wars are no longer fought by its citizenry as a whole. Supreme Executive **Board Meets**

If the member has since died, or his address has become unknown, this will be shown in the supplement. If a member has moved from Chicago to some other city in Illinois, a reference will be made "see Bloomington, Illinois." Under Bloomington, Illinois will be the correct mailing address of the member.

MESSAGE FROM THE SUPREME JUSTICE

The scholastic year 1951-52 has opened under conditions much more favorable than were be-lieved possible last May. Although international tensions continue, the drastic cut in student enrollments which had been anticipated has not occurred. True, many of our members have been recalled to military service and many college graduates have been prevented from beginning their legal education. However, the overall decline in student enrollment appears to have been negligible.

All of our student Chapters have resumed their activities. Unless the international situation takes a drastic change for the worse, it appears that these Chapters will be able to continue with normal programs and near normal memberships. The difficulties in maintaining Chapter memberships, however, inevitably will be increased by the uncertainty of the times. More than ever, fraternities will be called upon by prospective members to prove their value. With the probability of military service facing a large majority of entering students in law schools this Fall, there will be a strong inclination to avoid associations which do not manifestly offer professional opportunities.

Phi Alpha Delta should have no difficulties in convincing students of the inherent worth of legal fraternities in general and PAD in particular. We are today the undisputed leader in the field of legal fraternities. Our professional activities, designed to be of service to our profession, to legal education, to our communities, and to our individual members, have surpassed any program ever before attempted by any professional fraternity.

I cannot state our accomplishments in the short space of this column. The record is available to every Chapter in the regular publications, reports and correspondence which it receives. However, again I call to the attention of all of our members a recent article which presents in graphic detail some of the purposes and services of Phi Alpha Delta.

Every active Chapter and Alumni Chapter recently has received from the Executive Office a reprint of the article "Ex-

Legal Fraternities" by our former National Field Representative, Sandy Rae. This article originally appeared in 3 Journal of Legal Education 564 (Summer edition, 1951). The Air Force Needs Lawyer Reservists

Current Air Force needs for well-trained legal officers were stressed by Major General Reginald C. Harmon, The Judge Advocate General, in a recent statement concerning the present officer procurement program of the United States Air Force Reserve, Judge Advocate General's Department. It was indicated that applications under the program are now being accepted.

The principal objective of the effort is to secure additions to the new Service's Reserve roster in the grades of first lieutenant and captain, although more mature lawyers with previous legal experience can qualify for commissions in higher grades. Minimum demands have been set at graduation from a law school approved by the American Bar Association plus admission to practice before the highest court of a state or a Federal Court. No practical legal experience is, therefore ,necessarily required for appointment or assignment as first lieutenant, although the Department distinctly prefers a few years contact with clients and courts. Applicants for this military grade should be less than 34 years of age. Applicants for captaincies should ordinarily be between the ages of 34 and 40 years and should offer four or more years of legal experience beyond law school.

Lawyers holding reserve connections, commissioned or enlisted, with other branches of the The Supreme Executive Board | service are not ineligible for consideration, provided they are conditionally released by the service concerned and are not on duty with that branch. It follows that members of the United States Air Force Reserve who have not been assigned to the Judge Advocate General's Department, and are able to meet its requirements, are also eligible. Thus far the Air Force's legal staff needs have been met through voluntary service, and there is no current plan to depart from this system.

Active duty assignments which may be expected by members of the Judge Advocate General's Department lie in the fields of Military Justice (court-martial work) Military Affairs (general military legal office practice), Claims, Contracts, International Law, Patents and Legal Assistance (legal advisory service available to military personnel concerning personal affairs). It was asserted that in the fullest sense members of the Department engage in the practice of law in a number of important professional areas. For the purpose of furnishing training in military legal specialties, there has recently been established the Judge Advocate General's School, The Air University, Maxwell Air Force Base, Alabama. The school's second class began instruction on May 17, and a third is scheduled for September 1951 opening.

Committees on District Organization and Resolution were announced and approved, and both the District Organiza. tion Committee and the Resolution Committee went into session after the opening business session in an effort to be able to report to the delegates at the afternoon business session.

Conclave Luncheon was held with Professor Sam H. Behrends of Wake Forrest School of Law acting as toastmaster. The principal address was delivered by the Honorable Thad Eure, Secretary of State of North Carolina.

At the afternoon business session, the Committee on District Organization made its report, which was unanimously accepted by the delegates in Conclave assembled. This report provided that a District Student Justice be elected, and that he be a second year law student from one of the chapters within the District, and he was to hold office io che vear, and to be elected at each Annual Conclave. Each chapter was to have two votes in the election of the Student Justice.

The duties of the Student Justice as spelled out in the committee's report, would be to plan the Annual Conclave each year with the Host Chapter, and to keep a record of all conclaves. He also was to facilitate the transmission and exchange of information of mutual interest to the chapters within the District. Each chapter was to be assessed \$5.00 to cover the expenses of the Justice.

Thomason Elected Student Justice

After the report had been accepted, Supreme Marshal Smithers called for nominations for Student Justice. Tommy Thomason, of Jefferson Chapter, at the elected as Student Justice. The Third Annual Conclave of District No. 12 was to be held in Washington, D. C., with Taft and Jay Chapters as co-hosts, and Student District Justice Thomason immediately started to make arrangements with the delegates from these chapters for the next Annual Conclave.

The Committee on Resolutions submitted its report which was accepted by the delegates. This report provided that Pinckney Chapter, at the University of South Carolina, be made a part of District No. 12, and to accomplish this, an amendment to the Constitution be supported. The committee also proposed a resolution in appreciation to Timberlake, Ruffin, and Rutledge Chapters for the successful Conclave in Raleigh, North Carolina.

Expression of regret, and commendation of the work of Matthew S. (Sandy) Rae, Rutledge Chapter alumnus, who recently resigned as National Field Rep resentative of Phi Alpha Delta, was adopted.

The delegates adopted resolutions requesting that the Supreme Chapter allocate funds to defray the expenses of annual conclaves, and also that where the District Justice was unable to visit the Student Chapters, that the Student Justice be provided National funds to make such visitation.

Formal Initiation

Following the business session, a formal initiation was held at 6:00 o'clock p.m., at which time, Judge John J. Burney, of the Supreme Court of North Carolina; John D. Larkin, State Senator from Jones County, North Carolina; Dean Carroll Weathers. Dean of Wake Forest Law School; and John Taylor, Speaker of the House of Representatives, of North Carolina, were initiated.

Supreme Historian, C. Cloud Morgan, of Macon, Georgia, presided at the Banquet closing the Conclave. Dean Carroll Weathers introduced the principal speaker of the evening who was the Honorable Johnson J. Hayes, Judge of the U.S. District Court for the Middle District of North Caro-

The award was made on behalf of the University and is designated the University Alumni Meritorius Service Award "to honor one who through good deeds has served alma mater." Members of the fraternity who have recently graduated from Law School, and as such have become new members of the Alumni, will receive their Directory upon payment of their current dues of \$2.50. The support of the Alumni is necessary to carry on the extensive program of the National Chapter in the support of the National Legal Aid Program, the publication of "The Reporter," and the publica. tion of the Directory and Supplement.

Chosen By Supreme Court

Justice Joseph E. Dailey (Calhoun) was chosen Chief Justice, at the adjourned session of the Supreme Court of the State of Illnois.



Justice Edmonds Says DEAN McCLAIN NAMED 'Don't Be Brash!'

Supreme Justice Douglas L. Edmonds, and a member of the California Supreme Court, reminded members of Holmes Chapter, Stanford PAD, that candor and terminal facilities were the appelate lawyer's most welcome attributes. Addressing a luncheon meeting on the subject of oral advocacy, the Justice explained that modesty and sincerity in presenting a point are the only means to insure a sympathetic hearing. He cautioned the lawyer to admit frankly any weakness in his case. "When a brash young lawyer snaps at the court, 'There is only one tenable theory; you can decide but one way,' the judge, only human, stiffens and inaudibly mutters. 'wait and see."

Justice Edmonds emphasized the bench's dependence on counsel for what Holmes phrased the implements of decision The lawyer has lived with the case perhaps three years before the appeal and has an acquaintance with the facts that the judge, swamped under scores of 3000-word records, simply cannot acquire in the piddling time he has available.

Justice Edmonds reported to the chapter on the ABA meeting from which he had just returned at S.M.U.'s enviable new law center. He also presented Bill Keogh, retiring Holmes Chapter Justice, with a Past Justice's Key.

At the meeting the establishment of a legal aid center in the city of San Jose was discussed and approved. An honored guest at the luncheon was Judge Fred B. Wood, for 25 years legislative counsel, and now on the district court bench.

It was announced at the meeting that of seven Stanford graduates selected for the Order of the Coif, four were Holmes Chapter PADs.

DEFENSE CONSULTANT

Joseph A. McClain, Jr. (Fish), Dean of the Duke University School of Law, has been named legal consultant to the United States Department of Defense.

In conjunction with the holding of the Alabama State Bar convention in Montgomery, Alabama, the Alabama Alumni Chapter held a luncheon on July 13, 1951. Special recognition was given to the Committee on Arrangements for the PAD luncheon which committee was composed of William Inge Hill, William B. Moore, Otis J. Goodwyn, and

Charles R. Adair, Jr. of Dadeville, Alabama, chairman of the State Committee on organizing local alumni chapters, then re ported for that committee. Legal Aid

John W. Gillen, of Birmingham, reported for the Committee on Legal Aid for Birmingham and Jefferson Counties. He reported in substance that the matter deserved further study and definite consideration, but that the role of PAD should be to encourage Bar associations in taking the leadership in the matter. Brother William B. Moore, of Montgomery, reported that the matter was being given consideration in the City of Montgomery, and he felt that under the sponsorship of PAD a definite move would be made in that city to establish legal aid facilities.

James C. Howard, Jr. of Atlanta, Georgia, District Justice for District No. 10, was introduced as the principal speaker. Brother Howard in his message to the Fraternity have been extremely beneficial. Brother Howard reported on the history of the Fraternity in its over 50 years of existence. He stated that Phi Alpha Delta was founded by a group of law students faced with a problem of arbitrary rules for admission to practice; that this Association in the common effort to relieve the oppression had resulted in the establishment of the fraternal organization.

"That just as a problem confronted the law school more than 50 years ago," Brother Howard reported. "A problem is now confronting us, and it is up to us to again work together. That problem before us now is that of legal aid and it is up to us as practicing attorneys to see that those who are unable to pay for legal services should have their rights protected."

Poor Man's Justice Brother Howard further stated that the law for the poor and

same as for those who are able same as for those who are able to pay, and that when the poor Addressed by Howard man's justice is reduced to a lower plane than that ch can be afforded to the wealthy, we can expect such things to develop in our profession as Magna Carta, the Fall of Bastille, the American Revolution, and the rising tide of Communism.

Brother Howard stated "that so many of the people of this country have been unable to procure adequate medical attention, that the medical profession is already experiencing difficulties with cries for socialized medicine. The legal prosession can expect the same problems, unless the need for adequate justice for the poor and indigent is met within our profession, and the answer to this is legal aid," he said. Brother Howard also went on to say that the profession also owes a duty to young law students to assist them with the practical problems of the profession, and that legal aid presents real life problems with which the students can assist under the leadership of the director, and can approach problems from a practical, rather than a theoretical point of view.

Brother Howard summed up this talk by saying that the Alabama Alumni Chapter had a real opportunity to assist Legal Aid, which in turn, could afford equal justice and protection of the law to all. He stated that our country was founded upon the principles of justice, equality and freedom for all, and that it was up to the practicing attorneys to organize groups, such as alumni chapters of law fraternities, to see that the principles of justice and equality always remain the same for all people.

Petition for Charter

Following District Justice Howard's talk, the presiding officer reported that the Alabama Alumni Chapter was an informal group, and that consideration should be given to obtaining a charter for it, so that it would be part of the national organization. Accordingly, a committee was appointed to petition for a charter for an Alabama Alumni Chapter.

Election of officers was then had, and the following were elected for the Alabama Alumni Chapter as officers for the next year: Justice Charles M. Nice, Jr. of Birmingham, Alabama; Vice Justice Charles R. Adair, Dadeville, Alabama; and Clerk, William D. Moore, Montgomery, Ala-

Stainback Holds Hawaiian Judicial **Post**

Ingram M. Stainback (Marshall Chapter), former Governor of Hawaii, is now a Justice of the Supreme Court of the Territory of Hawaii.

In an address by Brother Stainback to the Los Angeles Bar, in June of this year, he stated:

"From the standpoint of National security, it is just as important to curb Communism in the East as in the West." In his address, he also told the members of the Los Angeles Bar of his experiences after Pearl Harbor, and the efforts that were made to curb lawlessness in the Islands.

The Supreme Court of the Islands, to which Stainback has been elevated, has three members. Brother Stainback was on the Federal District Bench in Hawaii before being appointed Governor in 1942. He also served as United States Attorney and as Attorney General of Hawaii.

SELECTIVE SERVICE

(Continued from Page 1) relieved of liability from military service for any reason other than the good of the nation, or in other words, for a reason which stems from the benefit to the individual or to some special group rather than to the country. In a democracy, the rich and the poor must fight side by side. The same is true of the educated, and the uneducated. During the War Between the States, men were permitted to hire substitutes to fight for them. The result was that the very word "draft" became a hated thing in both the North and the South, and in both sections, we heard much of a "rich man's war and a poor man's fight." Let us be doubly cautious that this time, we never approach a situation in which we have an "educated man's war and an uneducated man's fight." Let us also remember that when a student is deferred from military service, it means merely that some other man has to go in his place, and that because of his being deferred, the boy next-door is fighting in Korea, since his number came up only because a man was deferred who would otherwise have been called earlier.

Aptitudes and Tests

The present plan for the de-ferment of college students is based on the theory that the best minds should be deferred to finish the college course. The selection is made by identifying those who have greatest aptitudes, as shown by the results of a nationa college for the next year; or have entered upon, and are satisfactorily pursuing the next year's course.

The most startling aspect of this plan, is its provisions for consideration for deferment 'across the board." in other words, the course which a student is pursuing is relatively immaterial. The student of music has the same right to consideration as the student of engineering. There are those who urge that since college student deferment must be limited, it should be restricted to students who are pursuing courses in the sciences, since the fundamental purpose of the deferment is to maintain the Chapter, and the alumni in the leadership of this country in the scientific fields. Unified Military Code

The Unified Military Code has now become effective, and Phi Alpha Delta played no small part in its enactment.

Ryan Chapter, at the Kansas City Convention in 1946, offered a strong resolution advocating drastic changes in court-martial procedure. The resolution was discussed at considerable length; amended in several particulars; and the Supreme Officers were instructed to forward it to the proper parties and to support the enactment of a uniform code.

Past Supreme Justice Frank M. Ludwig presented the resolution to the Armed Services Committee of the House of Representatives and the Senate. Coming as it did from an organization of lawyers, a great number of whom had recently been in the Armed Services, and in a position to realize the need for changes, the resolution attracted an unusual amount of interest. In both public hearings, Phi Alpha Delta was represented by Past Supreme Justice Frank M. Ludwig, and he was interrogated at considerable length by Committee members. He was recalled several times for private conferences.

The Unified Military Code provides that all services will be subject to the same Articles of War and will conduct courtmartials in the same manner.

Also, for the first time, convictions under Military Law may now be appealed though a system of court similar to procedures under civil law. Although trial courts will remain entirely military, with enlisted men serving as court members if the accused desires, the final appellate court will be composed of civilian judges. One of the three civilian judges is Paul Brosman (Magruder Chapter) and former Dean of Tulane University.

Greater Justice Expected Other innovations which their proponets believe will result in greater justice are:

1. In general courts-martial, both trial and defense counsel must be lawyers. Defense counsel need not be a lawyer in special courts, unless the trial counsel (corresponding to the prosecutor) is a lawyer.

2. The accused can refuse trial by some recourse, in which case, he must be tried by a higher tribunal, where procedures are more formal, and where he can demand that, at least, one-third of the members of the court be

3. General courts must include a "law officer" who takes no part in voting on questions of guilt, or degree of punishment. He supersedes the former "law member" who advised on points of law, but also voted with the

4. No sentence involving the death penalty, or applying to a general, or flag officer, can be put into effect without approval by the President. Sentences involving discharge, dismissal, or year automatically go before an Appellate Court.

5. Judge Advocates General will control appointment of Staff Judge Advocates, who will be authorized to communicate directly in legal channels, without going through the military chain of command.

The bill was signed by President Truman on May 6, 1950.



PAD in the News

In the February, 1951 issue of "The Legal Aid Brief Case" published by the National Legal Aid Association, the following recognition of the services of Phi Alpha Delta in the development of legal aid appears:

"The Phi Alpha Delta Law Fraternity, which has 97 chapters throughout the United States, unanimously passed a resolution at its biennial convention, that it would assist the National Legal Aid Association and the American Bar Association, and local aid associations in cities and towns where the Fraternity has active chapters.

Supreme Court Justice, Tom Clark, spoke on the need for in-creased legal aid service. He urged that each chapter take out a professional membership in the National Legal Aid Association.

Judge Douglas L. Edmonds, Supreme Justice of the Fraternity paid tribute to the incorporation of the National Legal Aid Association as a notable step toward unification of legal aid work. He based his recommendation of the Fraternity's support of legal aid on four grounds:

1. That it is a duty of lawyers not now being adequately discharged.

2. That if the remedy for the existing need does not come from the profession, then the government will be under heavy press ure to provide the remedy.

3. That it offers opportunity to obtain practical knowledge of the problems of law practice before admission to the Bar.

4. That it opens channels for placement of members of the pro-

Clyde Bruce Aitchison

In a recent issue of the "Washington Evening Star" tribute was paid to Interstate Commerce Commissioner Clyde Bruce Aitchison (Jay Chapter). The article stated that Brother Aitchison probably knows as much, if not group, since he has made substantial personal contributions to this history in the 34 years he has served on the ICC, evaluating rail and other property, and arriving at rates for rail and other carriers.

Charter Member Dies

James R. Garrett, a charter member of Lambda Epsilon and Fuller Chapter, died in New York | District No. 2 City August 22, 1951, after many months of illness, at the age of 72. He was one of the signers of the South Haven Articles and was the first Justice of Fuller Chapter. This is confirmed by Sidney B. Meyer, likewise a charter member of Fuller Chapter and was Clerk of the Chapter during brother Garrett's administration.

At the time of his death he was president of James R. Garrett, Inc., 45 John Street, New York City, which is the eastern Accident and Health Department of the National Casualty Company. He lived at 120 Scarsdale Road, Crestwood, New York.

Born in Macomb, Ill., Mr. Garrett was graduated from Northwestern University in 1901. His College course was interrupted by service in the Spanish-American War as a corporal in the 1st Regular Illinois Volunteers.

In 1902 he became associated with the Ocean Accident & Guarantee Corp. in New York City. In 1906 he became assistant manager of the Eastern department of the National Casualty Co. In 1909 he formed the agency of Ballard & Garrett, Inc., representing the National Casualty and other companies in New York and New Jersey. Five years later he formed his own firm. At the time of his death he was also vice-president of the East-Detroit concern,

Brother Garrett had been a leader in the casualty field for many years and was known as the dean of the Health & Accident Insurance executives.

Col. Gray Describes Army JAG

"The World's Largest Law Office" was the description which Colonel MacDonald Gray, Staff Judge Advocate of the Sixth Army, applied to the Army Judge Advocate General's Corps in an address to a Holmes Chapter luncheon held at Ramor Oaks in Atherton, California, on April District Conclave Manual for the

Colonel Gray, speaking to the Stanford University School of Law Phi Alpha Delta members, illustrated graphically the operation of the Army JAG covering every conceivable field of law from the criminal law aspect, commonly associated with the corps, to the highly specialized fields of patent law, taxation, corporation law, maritime law rate hearings, and a host of other legal problems which confront an Army in its operations.

In response to questions from the members of Holmes Chapter present, Colonel Gray stated that the Army JAG takes most of its personnel from civilian life, the majority of its new officers being recent law school graduates. The qualifications for a JAG commission include the usual physical requirements; graduation from an accredited law school; admittance to a federal court, or the highest appellate court of the state; and proof of military fitness for a commission.

Alumni guests at the Holmes Chapter luncheon include I. M. Peckham (Holmes), who presented the Chapter with an inscribed gavel for the use of its Justicethe third which he has presented during the Chapter's history. LEIB NAMED ACTING DIRECTOR OF IOWA LABOR, MANAGEMENT BUREAU

Professor Karl Leib (Holmes) of the State University of Iowa College of Commerce, Iowa City, Iowa, has been appointed acting director of the University's newly-created Bureau of Labor and Management, according to an announcement by University President Virgil W. Hancher (Hammond).

AN INTERVIEW WITH **JUDGE SAVARESE**

(The following is a reprint from one of the issues of "The Demurrer," a publication of the Pre-Bar Association of the New York University School of Law, the school's student bar association. The Surrogate Court is a pro-duct of legislation. There is, throughout the State one Surrogate for each county - except Manhattan which has two.

Each court has its own staffand complete control of its own records, some dating back over 100 years. Its jurisdiction is competent to all courts from Municipal to Supreme Court. The funds and estates of all deceased citizens of the county must initially be handled by the Surrogate Court.

In addition to this the court may try any other type of action, with the permission of the Supreme Court, if there is a death involved, since the funds eventually will have to come through Surrogate's Court.

It is divided into several departments, each with its own staff:

Probate Dept. — which handles

Administration Dept. - descent and distribution where there is no will.

Accounting Dept. - appointment of executors, and administrators.

Guardianship Dept. — handles funds for persons under 21 who

have inherited estates, Law Dept.—doing all the legal

Transfer Tax Division-which is a part of Surrogates Court but is paid for by the State. Its function is obvious.

The Draft And The Study of Law

Under the new draft law now in effect the theory is "Go to college and make good grades or face an early draft into service." Under the new plan which is being adopted, the law school administrators have revised their estimates upwards of the number of law students who will be in schools throughout the coun-

To be eligible for deferment as a student he must be accepted for admission or enrollment in a recognized college. To keep his draft deferment status he must (1) be rated by his professors as in the upper half of his class as a Freshman, the upper twothirds if a Sophomore, the upper three-fourths if a Junior or (2) get 70 on a test that will be graded by the mechanical brain.

This test is no snap. More than half of the nation's high school seniors would flunk it, officials believe. Among the general public 84% would score under 70, the passing mark for draft purposes. So the mechanical brain in some ways is to be more exacting taskmaster than the professors. On the other hand it fessors. school any youth is guaranteed deferment until he completes the school year as long as the school doesn't kiek him out. This automatic one year deferment is in the present draft law. Officials expect the same rule to be in the new draft law that Congress is getting ready to pass. College seniors can be deferred for graduate work if they make 75 on the test or if they rank in the upper half of their class.

Students now in graduate work can be deferred if their professors certify that they are doing satisfactory work. If a graduate student takes the test and makes 70 or more he won't have to take the test again or another one like it next year. Once that score of 70 is on the books it is permanent unless the college authorities should dismiss him.

Complete reports on how the draft classification is going to work in graduate work for graduate students is not now available but the pattern seems to be the student who is doing satisfactory work and is applying himself will not be called into the armed services unless of degree of mobility of population ization.

Christopher Teaches Tasty Law Course

The legal aspects of southern fried chicken may not be part of the course, but students of Thomas W. Christopher (Morgan) at Emory University believe they can work it in on a field trip.

Brother Christopher, assistant professor of law at Emory, is teaching the nation's only undergraduate class in "food law" at the Emory University School of Law, having inaugurated the course during the fall quarter this year. The food seminar, open to juniors and seniors; is one of two such courses available in this country's law schools, the other being a graduate course given at New York University.

The course features a study of the federal food, drug and cosmetic act, and includes the work of the Federal Trade Commission. "Food law is a specialty like tax law," declares Brother Christopher. "Food plants, bottling companies, drug companies, cosmetic manufacturers, and packers all have their own lawyers. With the coming of more processed foods - by dehydrating, freezing, and ready-cooked methods—the field of food law grows," he states.

In the course students discuss current problems, such as bills now before Congress to prevent indefinite refilling of some prescriptions. They prepare papers on the legal aspects of labeling and advertising. They make field trips to local food plants and the offices of the Food and Drug Administration.
