

Rep. Elliott Addresses Miami Members

Over 200 members of Phi Alpha Delta, both alumni and actives of Rasco Chapter at the University of Miami, attended a banquet held at the Cadillac Hotel in Miami Beach on December 1, 1951. The banquet was held in honor of the new members of the chapter who had been initiated that day.

Chairman Jim Nowell intro-duced George B. Pomeroy, Justice of Rasco Chapter, who in turn introduced Dean Rasco and the PAD faculty members, the honored members of the bench and bar and the balance of the officers of the chapter.

Brother Pomeroy then intro-duced U. S. Congressman Carl Elliott, member of Morgan Chapter. In his introduction of Representative Elliott, Justice Pomeroy read Article II of the Phi Alpha Delta Constitution and explained it was with these concepts in mind that Brother Elliott was extended an invitation to the Chapter and Alumni, i.e.-to promote social and intellectual intercourse among its members
—to aid the development of fraternal and brotherly sentiments
—the attainment of a higher and broader culture than that af-forded by the regular college

Congressman Elliott urged the members not to lose the faith that created the United States. He also made mention of the fact that the founding fathers of this country were mainly composed of lawyers and that it is that type of leadership which we must look to in these troubled days. Representative Elliott's speech resulted in an editorial appearing in the December 4 Miami Herald.

Following his speech, which was well received by the members in attendance, John Doyle Carmody, Past Supreme Justice and present Chief Tribunal, presented a \$100 check to the chapter for the renewed drive for the trust fund of \$10,000 the chapter had undertaken.

After an excellent meal, all enjoyed an evening of entertain-ment consisting of three acts followed by dancing until 1 a.m.

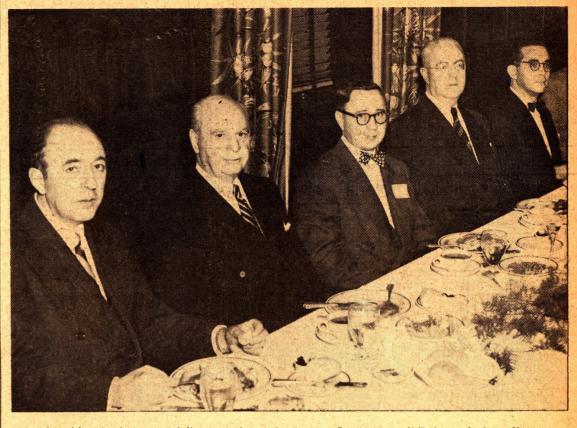

Justice Emmett | PAD Collects H. Wilson Dies



JUSTICE WILSON

Brilliant and Worthwhile Career Ends

Justice Emmett H. Wilson, (Ford Chapter) of the District Court of Appeals of the State of California, one of the most highly respected and conscientious members of the California Bench, died on December 15, 1951, after a brief illness. He was seventyfive years old.

Justice Wilson had recently undergone major surgery, and had returned home three weeks be-fore his death. His sudden passing came as a surprise to his many associates, as he was reported on the road to recovery.

"On Bench Since 1927"

Justice Wilson became an hon-orary member of Ford Chapter of Loyola University at Los Angeles, in 1941. He was selected by that Chapter to have honorary status bestowed due to his leadership in the Los Angeles Courts. He was appointed to the Superior Bench in 1927 and was promoted to the District Court of Appeals

While he was sitting on the Superior Court, he heard all cases involving labor, fair trade and the N. R. A. Many of his decisions in the Thirties, when Labor was organizing, were considered landmarks in that field. He also initiated the policy that minors seeking approval of motion picture contracts must set aside a specific sum for the future. That policy was later incorporated into the State law.

U. N. Charter

One of Justice Wilson's most controversial and pioneering de cisions dealt with the United Nations Charter. He ruled that any State Law which violated the Charter was void.

Justice Wilson was a loyal member of Phi Alpha Delta and never failed to attend the meetings of the Los Angeles Alumni Chapter. He steadfastly refused to sit at the head table with other judges, stating that he desired to sit among his brothers and practicing attorneys.

Edward A. Hogan, Jr. (M. Sullivan), Vice-Dean of the Hastings College of Law, is the author of a leading article appearing in the Fall, 1951, issue of the Hastings Law Journal.

Odd Wills

Fred J . Hoffmeister (Campbell), retired Missouri circuit judge, possesses one of the world's largest collections of odd wills.

One of Brother Hoffmeister's favorite wills in the collection, which has taken him 35 years to amass, is that of Herman Oberweiss of Texas. The testator wrote: "First thing I want done, I don't want my brother Oscar to get a dam thing I got. He is a mumser and he done me out of \$400 14 years since."

Brother Hoffmeister also enjoys the forty page will of Benjamin Franklin, which includes the following comment on inherited wealth. "It is my opinion, that the person who receives an estate from his ancestors is under some kind of obligation to transmit the same to their posterity; this obligation does not lie on me, who never inherited a shilling from any ancestor or relative."

Hen-pecked husbands sometimes find their revenge after death, Hoffmeister notes. In Australia, a man whose wife would never let him get the last word finally got it in his will. Francis Reginald Lord left his widow "one shilling for tram fare to some place to drown herself." Another wound up with: "And to my wife I bequeath the balance of my estate, both real and personal, including my pants, which she has wanted to wear for the past 15 years."

Young Estate Involved

Other domestic problems also come to light amongst Hoffmeister's testaments. In New Jersey, a Chinese named John Ling left his son one dollar with the wish that he use it "to purchase a rope long and strong enough to sup-port his Irish wife." When Brigham Young died, he left an estate of \$2,500,000 in trust for his families. They were divided into classes to provide for his 18 living wives, 48 children, and an adopted child. The estate was apoprtioned into nineten different parts.

One of the most unusual wills in the Hoffmeister collection is that of Mrs. Etta Mellier of New Haven, Conn, A "broadminded" woman, she left \$1800 per year income from her estate to Mrs. Jeanette Paterson Wallace of Philadelphia, Pa. Mrs. Wallace was Mrs. Mellier's husband's "other wife." Mellier had been married to both women for 20 years and only on his death did the women learn of each other's existence and became the best of

Charles Vance Miller of Canada left his wish that \$500,000 be paid from his estate to the Toronto woman who bore the most children in the ten years following his death. The Ontario Supreme Court gave the prize to

Richard H. Seward, an investment counselor who served as foreman of the discharged grand jury, disclosed to a meeting of Blackstone Post on October 2 that Senator Richard H. Nixon (Rutledge) is investigating the controversial discharge of the jury by Judge Edward P. Mur-phy of the United States District Court.

Retired Naval Captain William H. Wilterdink (Temple) is Commander of Blackstone Post of the American Legion. The Post is composed entirely of members of the legal profession. Following Seward's talk explaining the discharge over the jury's protests that its job was incomplete, Dean David E. Snodgrass (Temple) moved that the Post invite Judge Murphy to present his side of the controversy at its October 16 meeting. The motion, seconded by Arthur Sammis (Temple), was carried unanimously.

Blackstone Post, in which PAD's have been active since its founding, is believed to be unique among American Legion posts in restricting its member-ship to members of the legal profession. Its record for service to the community and the legal profession has been earned by its consistent willingness to investigate controversial issues in the public interest. Seward's address to the Post is a typical example. Although the jury was discharged in July, it is believed that the Post's invitation to him to speak was the first opportunity which the jury foreman had been given to air his complaints publicly.

Chapter Housing

On the question of housing, Hammond Chapter delegate, Leo Baker, outlined the arrangement of Iowa. They have rented three rooms located a block and a half from the Law School for \$75.00 a month. Frank Northrop Dies

Frank E. Northrop (Marshall Chapter), a practicing attorney in Council Bluffs, Iowa, since 1913, died on November 20, 1951, at Columbus, Georgia, of a heart attack. Brother Northrop, with his wife, recently toured the eastern part of the United States and had gone to Columbus to visit their daughter and son-in-law.

He suffered a heart attack while in Georgia, and was confined to the hospital for three weeks. After his release from the hospital he was believed to be improving rapidly. He suffered another heart attack shortly before his death and was returned to the hospital.

Brother Northrop secured his law degree from the University of Chicago in 1912. He was admitted to the Bar of Iowa in 1913. He served as Assistant County Attorney and County Attorney in Iowa until 1931. He had also served as a Referee in Bank-

ruptcy.

The body was returned to Council Bluffs for burial.

Court was the principal speaker. Justice Dailey, a member of Calhoun Chapter, spoke to the delegates on Bar Examinations and admission to practice. He stated "I have always considered admission to the bar as being a matter of increasing concern to the State. As its economic life and social life become more intricate, legal rules governing social conduct and their administration through courts of justice become more complicated; so that adequately trained lawso that adequately trained law-yers are increasingly necessary PROF. YNTEMA EDITS to the competent exercise of their function as officers of the courts administering justice." He stated further "You cannot be overprepared for the future practice of law, and you will find it will be a continuous study during your after life."

Big Cities versus Small Communities

Justice Dailey discussed the opportunities for practice as between the big city and the small town. He stated that he determined when he was admitted that it would be better for him to go back to the county seat of his home county where he knew a few people and where he was more adapted to the quieter life of that size community. He stated that each attorney would have the same choice to make. "In my prejudiced view point, the big city, while it has the bigger income possibilities, also necessarily has the larger office and family expenses to be subtracted from the income. The fees in the smaller places are in turn smaller, but outlays are likewise less than the big city. For one who enjoys the personal acquaintances of his fellow men and the closer social life resulting therefrom and has this question to decide," I would recom-mend to him that he settle in the reasonably small community.

Justice Daily also recommended that the young attorney make foreign countries. an early entry into what he would call political life. He did recommendation that they seek should take an interest in local be given to all. He stated, "There never was a time when the public conscience was so quickened as today. There never was a time when the American people were looking so intently for young men of character, not alone in the public office but in the molding of healthy public sentiment for law enforcement, for high ideals of government.

Justice Dailey, in quoting from the writings of his former law partner, stated "Never fear to do what is right, but strive contin-ually to build a character that has the courage and strength to do it. Knowledge of right, without the courage and strength to perform is of little practical value."

Justice Dailey's inspirational speech brought the conclave to a

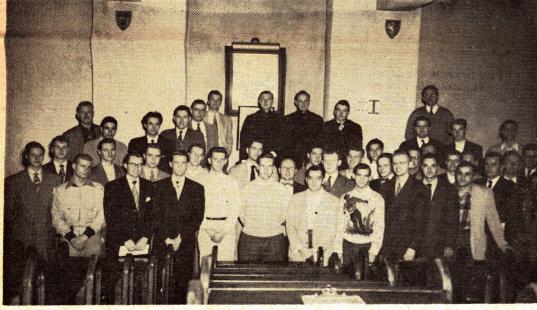

Army Commmissions Offered Attorneys

The Department of the Army has inaugurated a program to commission 200 officers in the Judge Advocate General Corps Reserve.

Successful applicants will be commissioned as First Lieutenants and called to active duty for three years. This active duty may be extended beyond the three year period at the individual officer's request. Attorneys who are presently Reserve of ficers may apply for active duty with the JAGC if they will voluneer for three years' duty

The starting rank of First Lieutenant gives the new military attorney a position equivalent to three years' credit on the promotion list. Base pay for a First Lieutenant without previous military service is \$249.38 per month. In addition, he is entitled to a monthly subsistence allowance of \$42. Where quarters are not furnished by the Army there is an additional allowance of \$67.50 for an officer without dependents and \$82.50 for an of ficer with dependents.

GEORGE KENNEY BOWDEN MOURNED

George Kenney Bowden, a member of Marshall Chapter (1920) and of the Chicago Bar Association (January, 1923), died suddenly in Chicago, Illinois, on July 13, 1951.

He attended the University of Minnesota, from which he received the degree of A.B. cum laude in 1917, and also the Hoidale Certificate for excellency in scholarship. He studied law at the University of Chicago Law School and was graduated from that institution in 1921 with the degree of J.D. cum laude. At this university he was elected to the order of the Coif and was the winner of the Wig and Robe Prize given to the student receiving the highest grade in his class. He received the honorary degree of Doctor of Civil Laws from Lawrence College, Appleton, Wisconsin, November 4, 1943.

Bro. Bowden was admitted to the Illinois bar in 1921 and practiced law, with offices in Chicago, Illinois, and Washington, D.C. from 1921 to his death, except while engaged in government service.

In addition to membership in the Chicago Bar Association, Bowden was a member of the Washington, D.C., Illinois and American Bar Associations. He was active on committees of the various associations, and this service included membership on five different committees of the Chicago Bar Association. He was also a member of The Law Club of Chicago, the University Clubs of Washington, D.C., New York and Chicago, The Attic and The Chicago Club.

In August, 1917 Bowden was commissioned a Second Lieutenant of the Infantry in the Regular Army of the United States. He served as an infantry officer during World War I, resigning his commission in September, 1919. From 1923 to 1924 he served as Special Attorney in the Office of the Solicitor of Internal Revenue. He tried for the Solicitor some of the more important cases in which the Solicitor represented the government. In 1925 and 1926 he served as Chief Counsel for the Senate Committee on Public Lands and Surveys, investigating the administration of land laws. From 1942 to 1944 he served as Assistant to the Coordinator of Information and the Director of the Office of Strategic Services. He organized and administered several of the branches of the Office of Strategic Services. In 1944 he was appointed consultant to the Director of Foreign Economic Ad ministration and served as adviser to the United States Delegate to the Council of UNRAA at Montreal. In 1944 he was appointed a member of the Advisory Committee to the Secretary of the Treasury and authorized to report on the revision of estate and gift taxes and assisted in the preparation of a comprehensive report on the income, gift and estate taxes.

In September, 1941 he was appointed a member of the National Panel of Arbitrators of the American Arbitration Association. He served as arbiter in the first wage arbitration conducted under the auspices of the American Arbitration Association and has served as arbiter in numerous other labor controversies.

Miss North Carolina "Murdered"

Judge Savarese Attends N. C. Meeting

Ruffin Chapter at the University of North Carolina, staged a mock court trial on December 8, 1951 in the Superior Court Room in Durham, North Carolina. The mock trial is conducted every year by Ruffin Chapter.

The details of the "murder incident" were as follows: On the evening of Wednesday, November 28, 1951, a mock murder was staged at the Saddle Club, a local night club in Durham. The par-ticipants in the incident were Miss Lou Long Ogburn, "Miss North Carolina of 1951," Tommy Medlin and Skeet Hesmer, both football players for the University of North Carolina, George Grune and Carl James, football players from Duke University. Miss North Carolina was sitting at a table with the football players from the University of North Carolina. A photographer had taken her picture and was about to take another when George Grune of Duke walked over to their table and put his arm around Miss North Carolina, saying: "Why don't you take pictures with players from the big team?"

Tommy Medlin of the University of North Carolina, who was Miss North Carolina's escort.
jumped up and said to Grune, "I told you in the game last Satur-day that I would kill you if you ever crossed my path again."

As Medlin said this he pulled a knife out of his pocket and seemed to go for Grune. Grune also pulled a knife out of his pocket and lunged at Medlin, missing him and mortally wounding Miss North Carolina. Local police officers rushed to the night club and placed Grune under arrest.

Miss North Carolina was taken away in an ambulance and later died in the hospital. Grune was booked for murder. Subsequently, the grand jury returned a true

Patrons Faint

These were the incidents leading up to the trial and the incident as staged in the night club was so realistic that several of the patrons who happened to be at the night club and were unaware of what was going on, became quite concerned. In fact several of the young ladies in the night club also fainted and real need for the ambulance and attendants occurred.

On the day of the trial Timberlake Chapter at Wake Forest College joined with Ruffin Chapter in staging the affair. Ruffin Chapter members acted as counsel in the trial and Timberlake Chapter arranged for the luncheon that was held during the noon recess. Invitations were sent to the first year class of Duke University by the Ruffin and Timberlake Chapters to attend the trial and luncheon to be held on December 8, 1951.

The jury was selected from a panel consisting of the entire first year law class of the Duke Law School. Following actual court room procedure, a jury was impanelled and thereupon Court was adjourned for lunch by presiding judge, Marshall T. Spears, a former Superior Court Judge, and now prominent Durham At-

Wage and Hour **Book Written**

Legal Education of the American Law Institute recently published a study of "The Federal Wage and Hour Law" by Charles H.

This book deals with what has been described as the most litigated statute enacted in recent years-the Fair Labor Standards Act. The problems which it discusses are likely to be encountered by any attorney engaged in general practice, and it is for him that the book primarily is designed. However, as the first book of its kind-a one-volume treatment, compact but comprehensive, of both basic principles and the more important technical rules in this area of law-it should be useful as a working manual for the labor specialist as well.

Here are readily accessible, easily understandable answers to the questions which most fre-

quently arise under the Federal law relating to wages, hours and child labor. In this respect, the book adopts the approach of providing concise, practical discussions of currently significant fields of practice which has produced enthusiastic acceptance of The Committee on Continuing other volumes in the series being published by the A.L.I. in collaboration with the American Bar Association.

> purpose of providing a handy tool for the practitioner, the book is not cluttered by any attempt at encyclopedic documentation, but cites a carefully screened selection of the more important decisions, regulations and administrative interpretations. Further research is facilitated by extensive cross-references to the legislative history of the Act, useful articles in the professional journals ,and collections of cases in the standard labor law services and other reference sources.

While the entire book devotes special attention to questions of practice and procedure, the final chapter gives further consideration to some recurrent questions on this aspect of the law. Its notes on such matters as pleading and proof, motion practice and the allowance of attorneys' fees will indicate how a number of costly mistakes can be avoided.
