Wilson W. Wyatt of Louisville, Kentucky, was made an honorary member of Fred M. Vinson Chapter of Phi Alpha Delta on Wednesday afternoon, March 18, 1953. The ceremony took place in the Landsome oak-panelled Allen Court Room of the University of Louisville School of Law. Mr. Wyatt stated that a major change in the law profession is the new emphasis in law. This change is naturally reflected in the courses offered in the law school such as tax courses, economics, legal accounting, etc.

Today many men take law to prepare themselves for executive positions in business, and it is frequently the general counsel for the corporation rather than the man raised in the business that becomes the president of the organization. This, in itself is a tribute to the profession and to the training which law gives them. This growing importance of the lawyer in business is noted by the trend to "preventive

out, the practice is an "intriging exciting adventure," and he will find that many factors are unchanged and unchanging. Among those are his INTEGRITY, DILI-GENCE AND THOROUGHNESS. The young lawyer must be careful of the dangerous pitfall of making an assumption as to what the degree ought to be. Diligence and thoroughness on the part of the other lawyer may make his assumption false. In his search the lawyer should never forget his primary source material: The United States Constitution, his State Constitution, and the Statutes. Along ths same line, he stated that it is well for the young lawyer to practice every type of case to gain a broad knowledge of the law and broad experience. He (the young lawyer) will find that "Knowledge is an unchanged factor" for which there is the property of the property of the property of the young lawyer). which there is no substitute.

The group of seventeen men who constitute the new chapter chose to name their chapter Abraham Lincoln Chapter because "the high ideals which made Lincoln stand far above the rest are the same ideals by which this group has dedicated itself. MESSAGE FROM THE SUPREME JUSTICE

During the last few months the active chapters of Phi Alpha Delta have convened in their various district conclaves for the avowed purpose of exchanging ideas and programs and thus improving and strengthening each individual chapter and the fraternity as a whole. Conclaves have been held in ten of our twelve districts and the remaining two districts have scheduled meetings for the fall. HENRY CARTER FOSS Supreme Historian

Henry Carter Foss, our Supreme Historian, was born in Chicago, Illinois, some 37 years ago. Migrating to New Orleans, he attended undergraduate and law school at Tulane University.

Upon graduation he became associated with the firm of Montgomery, Fenner and Brown but in 1944 was called to active duty with the Army Air Corps. Upon discharge from active service he served as attorney for the California Company, a Standard Oil Co. of California subsidiary. Subsequently he reentered Duke University Law School for graduate work and earned his LL.M. While a student at Duke he was initiated into Rutledge

Since that time he has held various positions the most note-worthy of which was that of legal and financial counsel to the Petroleum Administration for Defense. Brother Foss just recently resigned this position and entered the private practice of law in Washington, D. C.

At the 1950 National Convention, Mr. Foss was elected a trustee of PAD, and at the 1952 Convention he was elected to the position of Supreme Histor-He is currently very active in Washington Alumni and District XII affairs.

"The Seven Lamps of Advocacy." Each of the seven lamps represented a different trait which the successful advocate should possess, such as honesty, wit, industry and fellowship. Judge Murrah elaborated on each lamp and illustrated how the acquisition of each would improve the effectiveness of the advocate. For example, he said, 'It is better to wear out at the bar of law than to rust out." The Judge, a popular speaker at PAD functions, held his audience spellbound throughout his very effective presentation.

Brother Murrah also serves PAD as District Justice of District VIII. He is a past chairman of the Judicial Section of the American Bar Association.


Phi Delta Phi Trophy Won By PADS By LEONARD E. ZAK Chapter Correspondent

Two of the best ways to enter the law field are to work in a

district attorney's office or for a congressional committee.

This was the advice given by William R. Foley, counsel of the U. S. House of Representatives Judiciary Committee, at a banquet following the joint spring initiation of Taft (Georgetown University) and Jay (George Washington University) Chapters of Phi Alpha Delta Law Fraternity held April 11 in Washington, D. C.

"Before you ask what you want to do, ask yourself what you can do," Mr. Foley told 23 initiates and 30 active and alumni members. He suggested that a district attorney's office is "the greatest school there is." "You deal with raw facts and human nature and you prepare cases for trial and write legal briefs and memorandums," he added.

The U.S. Congress with its many legislative and investigating committees provides another source of learning and advance-ment for lawyers. Since the 80th Congress committee staffs have been chosen largely on a non-partisan basis. There is little turn over on the staffs of the Ways and Means, Appropriaions, Foreign Affairs and Judiciary Committees, Mr. Foley explained.
"It's hard to break into a pro-

fessional staff position, but once you do the opportunities for learning are unlimited," he said.

Prior to the banquet the initia-tion was held in the United States Court of Military Appeals. This is the first time a PAD initiation in Washington has been held in a court room.



William F. Waugh: The Chicago Alumni Chapter lost one of its most beloved members Friday, March 6, 1953 when Judge Wiliam F. Waugh died of a heart attack. The jurist had just finished introducing Governor Stratton of Illinois to an audience at the Executives Club luncheon in the Hotel Sherman when he suffered the attack.

He was scheduled for appointment to the U.S. District Court in Chicago the following week. He compiled one of the finest records ever recorded in his position as Probate Judge. When the Chicago Bar Association was called upon to rate the judges seeking re-election Judge Waugh was rated 99%, the highest in the history of the poll.

Judge Waugh was born in 1892, attended the New York Military Academy, Utah Agricultural College and received his law degree in 1916 from Loyola University. He was a member of Webster Chapter.

In World War II he did valuable work in presiding over spy trials in Italy and supervising organization of Italian courts. Before his election to the Probate Court in 1946 he was one of the outstanding trial lawyers in Cook County.

Brother Waugh was a past state commander of the American Legion and a member of the Foreign Wars and Amvets as well as a member of the American, Illinois and Chicago Bar Associations, and the Law Club of Chicago. He was a 32nd degree Mason and a Shriper degree Mason and a Shriner.
