100th Charter Granted To Seton Hall University

On May 7th, 1964, the 100th charter of our fraternity was granted to the William Paterson Chapter of Seton Hall Law School. Seton Hall Law School has now joined ninety-nine other law schools in offering its students the opportunities to form a strong bond among the members of its different classes, to form a strong link between the school and its former students, to establish a widespread exchange for interchange of business information and matters of common interest to the members of our fraternity, and to foster, under the influence of intimate, friends, those principles that tend to form a higher type

of manhood. It is appropriate that the 100th charter granted by our fraternity should go to a chapter containing the largest number of charter initiates of any chapter in our history. On May 7th, 59 individuals became our brothers by joining and becoming the charter members of William Paterson Chapter. We are very proud to note that the Dean of Seton Hall Law School, John T. Loftus, chose to become one of the charter members of William Paterson Chapter.

Supreme Vice Justice Robert E. Redding presented the new chapter its official charter at a banquet in Newark's Robert Treat Hotel, following initiation ceremonies conducted in the courtroom of the Newark Superior Court earlier in the day.

To illustrate his point, Mr. Zinn described the intricate details of the inception, consideration and adoption of bills as they pass through the Congressional mill. Mr. DeFino then presented a plaque on behalf of all the charter members to Howard F. Cerny, of New York, for his "exceptional efforts" in organizing the chapter.

While highlighting the evening's festivities, Mr. Redding emphasized to his audience the historic nature of the action by reminding them that the William Paterson Chapter of Seton Hall Law School was the 100th law school organization to receive a charter from Phi Alpha Delta Law Fraternity. MITCHELL CHAPTER

The wind blew 100 miles an hour - trees were uprooted streets were flooded - window panes were broken, but fourteen candidates braved the storm to be initiated on the reactivation of William Mitchell Chapter at the University of Minnesota recently. The ceremonies were conducted in the court room of Judge Larson, Judge of the United States District Court, in Minneapolis.

First William Mitchell Chapter was formally reactivated. This was followed by the formal pledging of the candidates. Then came the formal initiation ceremony which was followed by the first official meeting of the reactivated Wil-Mitchell Chapter. At that meeting the officers were elected. The ceremonies were concluded with the installation of the newly elected officers.

Supreme Justice Murrah presided at the installation, which approximately three took hours. The other members of the initiation team were John E. Tomas, Terry Smith, Sherman Kemmer and Paul Rosenthal.

The reactivation of Mitchell Chapter was due primarily, of course, to the hard work and cooperation of the fourteen newly initiated members who have formed a strong nucleus from which a well established chapter will grow. However, among the individuals who were especially significant in the reactivation was Terry Smith, a transfer student from the University of Kansas, where he was a member of Green Chapter. At the first official meeting of Mitchell chapter, Brother Smith was appropriately elected Justice. Bruce Carlson, a student at the University of Minnesota, worked hard with Brother Smith in cultivating interest among the students in the prospect of reactivating Mitchell Chapter. Brother Carlson was elected Clerk of our reactiatved chapter.

Of course, the strength of any of our chapters depends to a great extent upon the support of alumni members of our fraternity. John E. Tomas, a successful attorney in Minneapolis and an alumnus of Taft Chapter, contributed a great deal of time, effort and advice to the students in their effort to reactivate Mitchell Chapter. Without such support, the reactivation would not be a reality. The Assistant Dean of the University of Minnesota's School of Law, John G. O'Brien, an alumnus of Hammond Chapter, at the University of Iowa, lent great assistance to the reactivation of Mitchell Chapter. In fact, Brother O'Brien made his home available for meetings to organize the reactivation. Of course, Ray Judice, our National Field Representative, expended much of his time and energy to reactivate Mitchell Chapter, as he has so generously contributed in the past, with other reactivations.

The brothers from Butler Chapter at William Mitchell School of Law, and in particular, Rex David, Sherman Kemmer, Paul Rosenthal, Samuel Fried, and James Knutson, should not be overlooked because of the time they expended in assisting at the ceremonies and providing helpful suggestions to the new members of Mitchell Chapter.

Because of impending final examinations and because of the lengthy ceremonies, the social aspects of the reactivation ceremonies were held to a minimum. However, most of the newly initiated members of Mitchell Chapter are attending summer school and plan activities and meetings during the summer, during which they will plan an active rushing program for the

All of the members of Phi Alpha Delta join together in giving warm congratulations to the new members for the reactivation of Mitchell Chapter, and thanks to the many individuals who joined together to make this reactivation possible.

Message From The Supreme Justice

Indeed, as each day passes, our Fraternity grows in prominence as the most outstanding fraternity in the legal profession. In March of 1963 I stated that "Our Fraternity is, indeed, in its finest hour and brightest day. We have more active and alumni chapters than ever before in history, 88 and 54 respectively. Our Fraternity is rendering more service to its members than ever before as evidenced by the wonderful success which is being enjoyed by our various insurance programs, the PAD Professional Directory, the activities sponsored by alumni chapters, and the professional and social programs carried on by our active chapters." Yet each hour brings a finer hour and each day a brighter day for our Fraternity.

Within the short period from September of 1962 until May of 1963, charters were granted to Duquesne University, Louisiana State University and the University of Houston, creating Egan Chapter, White Chapter and Hickman, respectively. Also during this time, Lurton Chapter, Rutledge Chapter and Green Chapter were reactivated. Recently Fordham University received a charter, thus creating Wormser Chapter, and McKinley and Mitchell Chapters were reactivated.

Our Fraternity marked another milestone with the granting of its 100th charter to Seton Hall University.

Our alumni chapters have also increased in number. The Valley of the Sun Alumni Chapter in Phoenix, Arizona, received its official chapter charter on December 13, 1962 and the Akron Alumni Chapter, was chartered on November 21, 1963.

As a result of my travels for Phi Alpha Delta, I have had the opportunity to associate not only with federal and state judges across the country, but also I

have had the privilege of associating with the neophytes in the law, the students in our fine law schools across the country. This association I treasure because it has helped me maintain the young, fresh, bright and enthusiastic outlook toward our profession. This is a treasure which every member of our Fraternity can receive as a result of active participation in the activities of our active chapters, and by close association with the other brothers of Phi Alpha

Since this will be my last report to you as your Supreme Justice, I wish to take this opportunity to thank the members of the Supreme Executive Board, Supreme Tribunal, and District Justices, as well as all of the active and alumni members of our Fraternity, for their cooperation and encouragement, without whom our Fraternity would not enjoy the position it now

In the future I urge all members to actively participate in the activities of the Fraternity since only through such activity can we hope to fulfil our obligation of "service to the student, the law school and the profession."

DISTRICT IV CONCLAVE AT DENVER

Hughes Chapter of Phi Alpha Delta, at Denver University, Denver, Colorado hosted a very successful District IV Conclave on Friday and Saturday, April 24 and 25, 1964. In attendance were brothers from Gunter Chapter at the University of Colorado at Boulder and from Sutherland Chapter at the University of Utah at Salt Lake City. Participating and enjoying the activities were Supreme Justice Alfred P. Murrah, former Supreme Justice John L. Griffith, District IV Justice C. Nelson Day, Denver Alumni Justice Jack H. Dwyer, and a large number of federal, state and local judges.

Winston Jensen, brother from 3 Sutherland Chapter, was elected Student Justice of District IV. and Brother Douglas Fitz Douglas from Hughes Chapter, was elected Student Clerk of District IV. Ably directing the Conclave for the host chapter was Jere Corlett, Justice of Hughes Chapter, assisted by Robert N. Mil-ler, Justice of Gunter Chapter, and Robert J. Stansfield, Justice of Sutherland Chapter.

The District IV Conclave commenced Friday evening, April 24th, 1964, with a reception at the Coronet Room of the worldfamed Brown Palace Hotel in Denver, honoring the United States District and Circuit Judges, and the State Supreme, Circuit District, County and City Court Judges attending the Conclave.

The following morning, Saturday, April 25th, coffee and doughnuts were served in the student lounge at Denver University's new Law Center, followed by the first General Session of the Conclave which commenced at 10 a.m., in one of the spacious English style seminar rooms at the Law Center. At this morning general session, discussion was led by Jack H. Dwyer, Denver Alumni Justice, ist, Hon. Mitchel B. Johns, and Winston Jensen, Student Judge of the Denver District

Chapter of PAD at University of Colorado and C. Nelson Day, Justice of District IV, who is a District Court Judge in Utah.

From the references to Colorado and Utah law as well as to the M'Naghten, Durham, Currens and other cases it developed that the states of Colorado and Utah have the same tests for insanity as a defense to a criminal charge, which include: 1. Did the accused know the nature of his act, 2. Did he know the difference between right and wrong, and 3. Was he acting under an irresistable impulse.

If the accused by reason of mental incapacity did not know the nature of the act, or did not know that it was wrong, or he was acting under an irresistable impulse, the defense of insanity should apply - but such is a jury question.

The Conclave concluded Saturday evening with a banquet in the Onyx Room of the Brown Palace Hotel, honoring Supreme Justice Alfred P. Murrah. Brother Hon. Hatfield Chilson, United States District Court Judge at Denver, chaired the affair, with former Supreme Justice John L. Griffith acting as toastmaster.

Highlights of the gala affair were the conducting of the pledging ceremony by Supreme Justice Murrah for five new brothers into Hughes Chapter, following which our brother Honorable Hatfield Chilson presented Supreme Justice Murrah with a certificate of appreciation from the chapters and brothers in District IV. Supreme Justice Murrah's humorous and appropriate response and commentary brought the delightful evening and the Conclave to a fitting

Edward Bennett Williams Addresses District XII Conclave

of Law.

The Conclave Committee of the Fifteenth Annual District XII Conclave of Phi Alpha Delta Law Fraternity gave their annual award for "that individual who has contributed the most to the legal profession in the past year" to Edward Bennett Williams. Mr. Williams accepted the award at the Conclave banquet and addressed the gathering on the lawyer's "Bill of Obligations."

The noted attorney spoke of the vanishing breed-the courtroom lawyer — and concluded that if we are to maintain the dignity attached to and the respect of our profession, we must channel some of our most talented members into this area of the law. Mr. Williams condemned the drive for monetary reward and security which dominates the legal profession today. In illustration of this bias he pointed to the academic curricula of the major law schools. His suggestions were to include extensive courses in courtroom procedure and the study of criminal jurisprudence and to expand opportunities for actual court room experience for graduate students. The purpose of these programs would be to encourage and to train members of the pro fession to enter trial work in criminal cases.

Mr. Williams added regretfully that one reason that attorneys hesitate to go into criminal law is that the public tends to associate a lawyer with his client - defense of a person subject to public condemnation holds the same condemnation for the lawyer. He commented that a doctor, were he to save the life of such a person would not be condemned, nor would be a clergyman were he to advise such a person on atonement for his sins. The only reason for at-


that his work is done in a public forum. The speaker deplored this condition because every man, no matter how hated or scorned or evil, is entitled to the protections guaranteed in the Bill of Rights. The responsibility to protect these rights is charged to the lawyer. For the lawyer, the Bill of Rights is a "Bill of Obligations.'

Mr. Williams concluded by citing recent surveys and polls which reveal a shocking lack of interest on the part of law students to carry out these obligations and a frightening lack of knowledge as to the meanings





Knauss Receives Norlin Award

Brother Francis J. Knauss, alumnus of Chicago University and Story Chapter, recently received the Norlin Award given by the Associated Alumni of the University of Chicago for outstanding achievement by an alumnus in his chosen field of endeavor.

Brother Knauss received his LL.B degree in 1905 and served in the Colorado Senate from 1914 until 1930. In 1927 Brother Knauss was a candidate for Congress.

Brother Knauss served as Denver County Republican Chairman from 1942 until 1946 when he was appointed to the District Court Bench in Denver. He was elected to that same office in November of 1946 and re-elected in 1948. He was appointed to the Colorado Supreme Court in August of 1951 to fulfil a vacancy in the Court and in 1952 was elected to complete the ten year term of his predecessor.

Brother Knauss has performed many civic duties and has held high positions in organization, including Grand Master of Colorado Masons in 1940. He was widely recognized during his tenure on the Colorado Supreme Court for his scholarship on the bench and his dedication to the improvement of judicial administration throughout the state. Brother Knauss retired from the Court in 1961.



Mexican ranchers meet with the Board of Ranchers, the United States Land Owners, other accretive border problems, thereby exercising the international tribunal rather than the usual court system of Law enforcement.

Summarily, Mexico and the United States cooperate in every possible manner in order

The use of the accrual method more clearly reflects net worth and income for a particular purpose but can, and usually does, penalize the conscientious taxpayer. The accrual method of accounting sets a value on each animal when it is counted, usually once a year at roundup.

The cash method of accounting does not recognize any value on the animal until it is

Using the accrual method you might be taxed on the value of animal before you have realized any cash with which to pay the taxes. But on the cash basis you would not be taxed on the sale of the animal until you had realized the cash with which to pay the taxes.

GOOD YEAR FOR KNOX CHAPTER

A speech contest, a forum, a practice examination, and publication of a directory have been the special projects of Knox Chapter this year.
