WASHINGTON ALUMNI CHAPTER HOLDS JUDICIAL-CONGRESSIONAL RECEPTION

The annual Judicial-Congressional Reception on Saturday evening, February 27, was one of the highlights of the 1964-65 program of the Washington Alumni Chapter. The function was held, appropriately, in the Committee Room of the Committee on the Judiciary of the House of Representatives in the Cannon House Office Building. Nearly 300 alumni, active members, pledges and guests attended.

KNOW YOUR SUPREME TRIBUNAL

The National Government of our Fraternity is divided into 3 parts: the Supreme Executive Board, the Supreme Tribunal and the Supreme Advisory Board. This article is intended to give an insight into the men who constitute the Supreme Tribunal.

It is the duty of the Supreme Tribunal to interpret our Constitution, render advisory opinions and administer recall procedures involving Supreme Officers.

CHIEF TRIBUNE CHARLES DI GANGI

It is the duty of the Chief Tribune to preside at all meetings of the Supreme Tribunal and to be custodian of its files, documents and opinions. He is to participate with the two associate tribunes in all decisions on review and in the rendering of advisory opinions. Further, he is to administer recall procedures involving all Supreme Officers except himself.

Brother Charles Digangi has served as our Chief Tribune since 1960. He has attended every National Convention since 1938 with the exception of the 1946 Kansas City Convention. He is a Past Justice of the New York Alumni Chapter and a Past District XI Justice.

Brother Digangi received his LLB degree from New York University where he became a member of Rapallo Chapter.

He is the permanent President of the Class of 1939 of the New York University School of Law and is presently the Treasurer of the Board of Directors of New York University Law Alumni Association. He is also a Past President of the Columbian Lawyers Association in New York City and Recording Secretary of the New York Univerity Alumni Federation.

McCoy Retires From ICC

Brother Harold D. McCoy recently retired as Secretary of the Interstate Commerce Commission after 43 years of Government service.

Brother McCoy became a member of Ryan Chapter in 1926, while he was attending the University of Wisconsin School of Law.

He joined the Interstate Commerce Commission in 1921, and then returned to the Univerity of Wisconsin to obtain his LL.B degree.

Prior to working for the ICC he held the position of Assistant Clerk to the House Interstate and Foreign Commerce Committee. After completing his legal education, Brother McCoy came the Assistant Chief Examiner of the Agency. His experience with the ICC included being a member on the personal staff of former Commissioner John J. Esh and in the Bureau of Informal Cases, the Bureau of Formal Cases and in different sections of the Bureau of Motor Carriers.

He assumed the position of Secretary of the Interstate Commerce Commission on March 1, 1955, and continued in that poition until his retirement.

The Chairman of the Interstate Commerce Commission, Abe Mc-Gregor Goff, stated, "With great regret I announce the imminent retirement of Harold D. McCoy.' He further stated, "The distinguished secretary of the Inter-state Commerce Commission is an able and devoted career public official on whom I have particularly relied during my term as chairman. His encyclopedic memory of Commission precedents, conference actions, both formal and informal, legislation, personalities and traditions is phenomenal. With his background and knowledge of transportation, plus his tact and sound judgment, he has been extremely helpful to the public and to the Commission."

PAD New Secretary of the Treasury

Henry H. Fowler, an alumnus member of Calhoun Chapter, took the oath of office as Secretary of the Treasury at a ceremony held at the White House on April 1,

Brother Fowler, who has spent half of his career in Government service, previously served as Under Secretary of the Treasury from February 3, 1961, until April 10, 1964, when he returned to private law practice as senior member of the Washington firm of Fowler, Leva, Hawes and Symington. As Under Secretary, Mr. Fowler served as a general deputy to Secretary Dillon, playing a crucial role in the shaping and in the enactment of the Revenue Acts of 1962 and 1964, the liberalization of depreciation procedures, and the coordination of related programs designed to promote economic expansion of '65 to date.

On October 3, 1963, Mr. Fowler was appointed head of a Presidential Task Force to seek ways of meeting our balance of payments problem by encouraging greater foreign investment in American securities as well as greater foreign financing for American corporations operating abroad. On April 27, 1964. the Fowler Task Force reported its recommendations to President Johnson. The President has submitted to Congress legislative proposals issuing from that Report, and a large measure of the current voluntary program to meet the balance of payments problem is based on its recommendations.

A graduate of Yale Law School and a lawyer by profession, Mr. Fowler first entered Government in 1944, when he joined the legal staff of the Tennessee Valley Authority, where he assisted in the preparation and successful conduct of the four year litigation establishing the constitutionality of that program. By 1939, he had risen to Assistant General Counsel of the TVA and subsequently served as Chief Counsel of a Subcommittee of the Senate Committee on Education and Labor. Prior to and during World War II mobilization, from 1941 to 1944, he was Assistant General Counsel of the Office of Production Management and afterward of the War Production Board, thereafter performing missions in Great Britain and Germany in 1944 and 1945. After spending the next five years in private law practice, he returned to Government service from 1951 to 1953 — to work in the mobilization buildup following the outbreak of hostilities in Korea.

He held successive posts as Administrator of National Production Authority, Administrator of the Defense Production Administration, Director of the Office of Defense Mobilization and member of the National Security Council. Mr. Fowler then resumed private practice until his appointment as Under Secretary of the Treasury in

Mr. Fowler served as a member of the Commission on Money and Credit from 1958 to 1961, and of the National Committee on Govrnment Finance \mathbf{of} Brockings Institution from 1960 to 1961. He is a Trustee of Roanoke College and of the Funds of the Protestant Episcopal Church in the Diocese of Vir-

Mr. Fowler has received distinguished alumni awards from Tau Kappa Alpha and from Roanoke College, as well as the highest Treasury Department honor — the Alexander Hamilton Award.

Mr. Fowler was born in Roanoke, Virginia, September 5, 1908, the son of Mack Johnson and Bertha Browning Fowler. He graduated from Jefferson High School, Roanoke, Virginia in 1925 and from Roanoke College in 1929. He received his bachelor of Laws degree from Yale University Law School in 1932, and became a member of Calhoun Chapter in 1930.

Mr. Fowler is married to the former Trudye Pamela Hathcote of Knoxville, Tennessee. They have two daughters, Mrs. Roy Campbell Smith IV of Cambridge, Massachusetts, and Susan Maria who is attending Sarah Lawrence College, and one granddaughter Kelly Mc-Gregor Smith.

Lurton Has Successful Rush

On March 3, 1965, Lurton Chapter continued its membership expansion program in initiating thirty new members.

Established at Vanderbilt University in 1919, Lurton Chapter compiled an outstanding record in District V. Until 1957, the chapter was quite active but time and law school changes saw membership decline to the final status of inactive in 1958. But through a motivating visit of Brother Ray Judice, Assistant to the Supreme Justice, a new spirit was rekindled in Lurton Chapter. Beginning with only thirteen third-year members in the spring of 1963, the following fall saw a pledge class of twenty-five strengthen the membership. Due to the impetus and organization of Brother Howard Nations the pledge class of twenty-five devised a re-building program from which the chapter was to grow.

Brother Nations became the succeeding Justice after all thirteen members had graduated in 1964. It was the desire of Brother Nations to bring into the chapter thirty members in 1965 and thirty members in 1966. Thus in the spring of his senior year, he envisioned a membership of approximately ninety.

The initial part of Brother Nations' plan has become reality. On March 3, 1965, thirty new members were initiated. Present at the initiation ceremony and dinner-dance which followed were Brothers Ray Judice and Tom Powell, District V Justice. Because Brother Judice inspired the re-activation program, it was a fine tribute to him to see the fruits of his labor result in the re-establishment of an old and outstanding chapter. Likewise Brother Powell was encouraged by the addition of another chapter to District V.

The second stage in Brother Nations' plan is still in embryonic form. However, through the leadership of Past Justice Bob Rust and present Justice Henry Bushkin, the chapter is assured of a strong rush program in the fall of 1965.

Presently Lurton Chapter is guided by the ideal "service to the school and its members." Active participation in the Vanderbilt Bar Association and in the Legal Aid Society are two examples of dedication to this ideal. With a continuation of such enthusiasm, Lurton Chapter will. once agan fulfill its responsibities to the legal profession and society.



Rohr, Supreme Secretary, Honorable C. Nelson Day, District IV Justice, and Don E. Hammill, Salt Lake Alumni Justice, were in attendance.

After being settled in Salt Lake City's Desert Inn, the delegates were guests of Sutherland Chapter and the Salt Lake Alumni at a cocktail party on Friday evening. Feeble conversation was replaced by warm greetings from members of the Utah Bench and Bar, and the hosting chapter.

The following morning the general business sessions were called to order in the newly completed University of Utah Law Center. The morning business session involved discussion of fund raising and rushing problems specifically, and common chapter problems in general. The morning session was interrupted by a much welcomed break in the student "Commons" lounge at the new Law Center. Ellet, Judge 3rd District Court; District IV Justice, Honorable C. Nelson Day, Judge 5th District Court; Professor John J. Flynn, University of Utah School of Law; and Mr. John H. Snow, Esq., a Salt Lake City practitioner. It is noteworthy that Judge Ellett is an avid supporter of pre-trial and has participated as instructor in the Judges started last year by the American Bar Association of the Law Fraternity.

University of Colorado at Boulder. Comments from practitioner Snow and Professor Flynn presented a fair view of all the practical and theoretical pros and cons of the pre-trial conference. The comments, in summary, laid the burden of making pre-trial work upon the trial judges. Judge Ellett asserted that the pre-trial won't help relieve hurden of backlog courts unless the judges help carry the proceedings. If counsel is well prepared for pre-trial and the trial judges sees to it that he is, the pre-trial conference will serve its intended function. It was also noted that disregard of the function of pre-trial, and to go through it as a mere formality, would work a serious detriment to our system of advocacy.

Brother Directs Ford Grant

They also will draft legislation needed by the police and appear at legislative hearings on bills affecting police powers and functions.

The period of training under the program is two years. The first year will be spent in full time residence at the law school. During the second year the student actually will serve as legal advisor to a metropolitan police department. While in the field during the second year the trainee will return to law school to participate in one or more five-day seminars which the school will conduct periodically for police legal advisors from various parts of the country. At the end of the second year participants in the program will be eligible for the Master of Laws
