



Two Past Supreme Justices Die

Tribute On the Passing of a Very Real Person

People are of two kinds, and he Was the kind I'd like to be. Some preach their virtues, and a few Express their lives by what they do; That sort was he. No flowery phrase or glibly spoken word of praise Won friends for him. He wasn't cheap Or shallow, but his course ran deep, And it was pure. You know the kind. ANTHONY P. SAVARESE

Phi Alpha Delta is saddened by the recent passing of our beloved Brother Anthony P. Savarese who served as our Supreme Justice from 1952 to 1954.

Brother Savarese commenced his administration with five main goals, which were: To strengthen district organizations; to develop an effective placement program at the national level for use in the districts; to foster, encourage and assist greater participation in national, state and local bar associations among PAD members; to seek greater alumni interest and activity in the local chapters; and to work out a financial program which would adequately support and maintain these services. EDGAR A. JONAS

Phi Alpha Delta has lost a dear friend with the passing of Brother Edgar A. Jonas, past Supreme Justice, on November 14, 1965 at the age of 79.

Brother Jonas entered the national scene in our fraternity in 1913 when he was elected as First Supreme Vice Justice.

In 1914, Brother Jonas, an alumnus of Webster Chapter, was chosen to lead our fraternity as its Supreme Justice. The policies of Brother Jonas' administration were as follows:

1. To devise a scheme to increase the finances;

2. To encourage the building of fraternity houses by chapters; 3. To create a trust fund for trophies for awards for fraternity

system of initiations; and 6. To stimulate greater interest in the quarterly.

During his administration, Reese Chapter at the University of Nebraska and Brewer Chapter at Stetson University were char-

tered. In addition, an official Phi Alpha Delta convention train was organized to carry brothers from all points between Chicago and San Francisco, the 1915 convention site. It is to be noted that the one-way upper berth cost was \$10.40 from Chicago to San Francisco.

In his private life, Brother Jonas served as an assistant corporation counsel in Chicago from 1919 until 1921. He then served as the First Assistant State's Attorney of Cook County until 1923, when he was appointed a judge of the Chicago Municipal Court. He served three terms in the Municipal Court and later served on the Superior Court bench.

He served as the United States Representative from the 12th Congressional District from 1949 until 1954.

Brother Jonas also found time to serve as Board President of the Illinois Masonic Hospital Association for 37 years. Earlier this year, a new pavilion was named for him.

The new officers of the ALSA were elected at the American Law Student Association's 17th Annual Meeting in Miami Beach, Florida. They will serve the nation's 134 student bar associations during the following year.

JOHN H. NIEBLER

Brother Niebler, a member of Ryan Chapter at the University cf Wisconsin School of Law, was elected Treasurer of the ALSA.

Brother Niebler holds a Wevmouth Kirkland scholarship for the study of law and has attained the Dean's honor list for all four of the past semesters of study. He graduated summa cum laude from Marquette University in 1963 where he earned his degree in history and philosophy.

Message From The Supreme Justice

My first official visitation this Fall was to the Wilson Chapter at Cornell Law School on Thursday. October 14. The Chapter is in excellent condition, starting the year with a membership of 42 prior to the rushing period. A reception and dinner had been arranged, and I was honored by the presence of Chief Judge Desmond of the Court

of Appeals; Professor Gray Thoron; Associate Dean Lewis R. Morse, a former District Justice and long time faculty advisor; and Professor Walter Oberer, a recent addition to the faculty and a former member of the faculty at the University of Texas Law School.

Dean Ray Forrester spoke highly of Wilson Chapter, and I was greatly honored by his presence at the reception and dinner. Mrs. Magaw and I were his guests for breakfast. We both appreciate his hospitality and that of Mrs. Morse who extended the hospitality of her lovely home to Mrs. Magaw while I was with the Chapter-

The next day we drove to Syracuse for a visit with Carmody Chapter which began the Fall term with a membership of 37 plus 8 pledges with rush to take place in the Spring.

A delightful lunch had been planned at the University Club by the Chapter, and Professor Landry who has been a most efficient Chapter Advisor. Dean Kharas honored us by his attendance at the luncheon and spoke very well of our Chapter and its contribution to the Law School. Professor Alexander and Professor Anderson, both active and loyal members of Phi Alpha Delta, were also at the luncheon.

My next visitation was in New York City which began with a most delightful two hour visit with Judge and Mrs. Anthony Sevarese in Forrest Hills. Our Fraternity owes a great debt of gratitude to Judge Sevarese who served as Supreme Treasurer from 1946 to 1952 and as Supreme Justice from 1952 to 1954. Those were trying times after the War and the splendid contribution by him made possible the growth and strength of our organization as developed under each of his successors to a total of 97 active chapters which we expect soon will be increased to 100. His death, only two weeks after my visit, brought sadness to all who knew him.

The following day I had a short meeting with the members of Rapallo Chapter, New York University, and Professor Million. Chapter Advisor, who had just returned from a year's leave of absence to be a Visiting Professor at the University of Michigan Law School. From there I went to St. John's Law School where I was warmly received by Dean Harold McNiece who gave me an excellent report with regard to de Bracton Chapter and its profession program.

de Bracton Chapter of 75 members under the able leadership of Justice Alan F. Ruf and its splendid chapter advisor, Professor Edward Fagan, is one of the very best in the country.

On October 23, 1965, the Moot Court Room of Fordham University Law School in Lincoln Center was the situs of a very important event for Wormser Chapter, a very fine group under the excellent leadership of Justice Sanford Joel Schlesinger and Chapter advisor, Professor Robert Hessler

It was a most pleasant priviledge to confer honorary membership upon Judge John Cannella, of the United States District Court, and faculty membership upon Professor Martin Fogelman. Thereafter the Chapter conducted an initiation ceremony for new pledges. Following this we then proceeded to the Hotel Astor for a very nice banquet. Honoring us with their presence were Mrs I. Maurice Wormser, who made a very interesting address, the widow of the famous lawyer and professor after whom the Chapter is named, and Mr. and Mrs. Liss, the son-in-law and daughter of Mrs. Wormser.

On Monday evening, October 25, 1965 I had the opportunity to attend one of the very fine functions conducted by the New York

Alumni Chapter at the Yale Club. The occasion was a banquet in honor of honorary member Judge Paul P. Rao, recently made Chief Judge of the United States Court of Customs. It is interesting to note that among those present were thirty-five members of the splendid de Bracton Chapter from St. John's Law School.

Wednesday morning, November 10, 1965, I flew to Pittsburg for a visit to Duguesne University Law School and Egan Chapter and also to pay my respects to Dean Quinn who became an honorary member last year. The Chapter is an excellent one under the able leadership of Justice John L. Doherty.

From the Law School I went to the Penn Sheraton Hotel where it was my priviledge to have lunch with Judge John Brosky, one of our most loyal and devoted alumni members. An hour later I left for Chicago for the banquet given by the very active Chicago Alumni Chapter at the Ambassador East. Over one hundred were present for a most pleasant evening. It was my good fortune to present on behalf of the Alumni Chapter a Distinguished Service Plaque to Judge F. Ryan Duffy of the United States Court of Appeals for the Seventh Circuit who became a member of Phi Alpha Delta through Ryan Chapter at the University of Wisconsin in 1912.

Thereafter Judge Duffy conferred honorary membership upon Judge Luther Swygert for Halleck Chapter at Valpariso University Law School and upon Judge Roger Kiley for Webster Chapter at Loyola University Law School Both are on the Court of Appeals for the Seventh Circuit. One of those present and having a particular interest in the initiation ceremony was the son of Judge Swygert and a member of the excellent Halleck Chapter.

On Thursday morning I left Northern University Law School and Willis Chapter. Brother Al Dobnicker, Assistant State Attorney General and charter member of Willis Chapter, met me at the Lima Airport and took me to Ada. We are grateful for the continued support that he is giving to the Chapter.

BROTHER WHITTAKER ACCEPTS NEW POSITION

Brother Charles E. Whittaker, former Associate Justice of the United States Supreme Court, has accepted appointment as Dealer Relations Umpire under the General Motors Dealer Relations Umpire Plan. Justice Whittaker succeeds Judge William C. Coleman, former Chief Judge of the United States District Court for the District of Maryland, who is now retiring as Umpire under the plan after having served since 1956.

Brother Justice Whittaker received his law degree from the University of Missouri and after admission to the Missouri Bar practiced law in Kansas City until appointment as a federal district judge for the western district of Missouri in 1954. Thereafter he was elevated to the United States Court of Appeals for the Eighth Circuit and in 1957 he was appointed by President Eisenhower as an Associate Justice of the Supreme Court of the United States.







Whitten Addresses **National Agricultural** Chemicals Assn.

Congressman Jamie L. Whitten, an alumnus member of Lamar Chapter, recently spoke at the 32nd annual meeting of the National Agricultural Chemicals Association.

He described American agriculture as Labor and Industry's biggest customer, the people's best and most economical supplier, greatest dollar-earner in world trade, key to prosperity and, when neglected, the cause of depressions.

Brother Whitten is a veteran member of the Appropriations Subcommittee for National Defense and Publice Works and Chairman of the Appropriations Subcommittee for Agriculture.

He said, "Many people understand the danger of a break in farm prices, but few seem to realize that the real danger to our overall economy is a drop in farm purchasing power, which could come from a reduction in volume as well as from a drop

"We need all of our people to know that the real basis of price supports for farm products is to assure the producers a fair return, as compared with that of Industry and Labor, in order to enable agricultural producers to provide a ready market for Industry and Labor while supplying consumer needs for food, clothing and shelter."

Urging that farm price supports be considered in the light of legislation which provides for minimum wages and the right of Labor to organize and to strike in order to increase Labor's share of the consumer dollar, Brother Whitten said that recently he had requested the Library of Congress to supply him with information on the gross increase in cost of living due to minimum wage laws and the right of Labor to organize and to strike."

"I received a nine-page reply," he said. "The substance of the information supplied in the nine pages, however, was contained in the second sentence which read as follows:

'Unfortunately, we find it impossible to reduce these phenomena to measurable

"Farm purchasing power is probably more essential to the national economy than is that of Labor and Industry, since it is the supplier of raw materials. A breakdown in income from agricultural production and the resulting decline in farm purchasing power could set off another depression, just as it has other depressions in the past.

"If we want to help ourselves and the peoples of the world, we should keep producing our bountiful supply of food and fiber and keep them offered for dollars on the counters of the markets of the world, for what The effect of these two activi- they will bring."

Referring to the recent farm

"With the fire which could upset the world already burning in Vietnam, we should never promote a program of scarcity. It is unsound to pay American farmers not to produce food and fiber; to limit American commodities offered in world markets; to reduce our reserves on hand and cut U.S. acreage while promoting increased foreign production at a time when we need dollars so badly.

"Cash instead of labor, cost and risk may look good to the farmer," he said, "but neither he nor the rest of us can forego the production, supply, distribution and the business activity resulting from American farm production.'

"Money paid him not to farm may take care of the farmer's immediate problem, but it is not going to put groceries on the tables of American consumers nor buy machinery and equipment from Industry and Labor to cultivate land which his government pays him to leave idle."


Cleveland Alumni Chapter has been very active within its own organization as well as exercising full cooperation with the local active chapters.

He quickly took the reins of our fraternity and within seven months had established effective machinery for the placement program in several districts, and had stimulated wider and more effective participation in legal aid work throughout the country.

Judge Savarese then turned his interest toward maintaining the high standards of our membership. He began by encouraging active participation in District Conclaves and directed his officers to attend the conclaves in their areas.

Brother Savarese was never reluctant to state his mind and as a result of his firm beliefs, Phi Alpha Delta maintained its high standards of membership. When he saw weakness, he was the first to face it. As he said in April 1954, "In my travels around the country for PAD I have discovered one weakness among some of the present PAD students in the law schools and in some of our active chapters. The present day student is no longer the boy who moved into a law college from high school or even the undergraduate college. Most of them have seen active service in the armed forces or have undergone the rigors of two to four years of rugged and rigid training. They have acquired an emotional urge to champion the un-

derdog. They talk like men of experience.

"This laudable urge is commendable in the hands of loyal, honest men. At the same time where reason and caution are cast to the winds, a soft, venerable spot develops in a man's armor which is readily susceptible to being pierced by men of weird and high-sounding ideologies. It is in such softness where these unscrupulous agents plant their insidious seeds of dissension, unrest and discord for the purpose overthrowing established sound order for a complete changeover and ultimate integration."

Brother Savarese concluded by saying, "Therefore, I warn not to drop high standards of quality. We are liberal minded and tolerant, but we still should exercise great care and caution in the quality of the men we select and choose to call 'brothers.'"

As a result of his unending energy, our Fraternity saw the establishment of six new student chapters and one new alumni chapter; and as a result of his strong leadership and firm beliefs, our Fraternity maintained its high standard of quality.

In addition to his outstanding work for our Fraternity, Brother Savarese served twenty years as Queens County, New York Surrogate. He had also been prominent in Queens charitable affairs and also had been one of the most active alumni of the New York University School of Law.

A native of Manhattan, he received his law degree from NYU and served as an Assistant United States Attorney until he was appointed by Mayor La-Guardia to be a magistrate in Queens in 1935.

It was the sitdown strike era and one of his early cases involved thirty-five WPA workers who had staged sitdowns in the Queens Borough Hall until the Borough President ordered their arrest on disorderly conduct charges.

Brother Savarese gave the men suspended sentences because they looked like "respectable and respected citizens," but he issued a lecture on the subject of sit-

"There has been much discussion about sitdowns in industrial buildings," he said. "In this instance, a public or government building, government property and government employees are involved. Remaining in the place constitutes seizure of government property. This cannot and must not be tolerated or permitted. Any other action than the one taken, any lackadaisical attitude toward this by officials, might eventually lead to chaos, rebellion, anarchy or overthrow of the government."

Brother Savarese ran for Surrogate in 1942 as a candidate of the Republican party and was successful.

As President of the NYU Law School Alumni, Past Supreme Justice Savarese led a drive to raise two million dollars for the school's law center. As a result, a room in the center was dedicated to him and he was given an honorary degree by the school.

Surviving Brother Savarese is his lovely life, Helen, a daughter, Mrs. Franklin Mascia, and his son, Anthony Peter, also a member of our fraternity.

Phi Alpha Delta and Queens County will greatly miss this man of many talents.
