Missouri on September 3, 1966.

The close fraternal bond which each member of Phi Alpha experiences is well exemplified by the fact that these men are willing to assume the duty of leading the fraternity in addition to the arduous duties for which they are responsible as jurists and successful attorneys the country. The devotion of these men to Phi Alpha elta makes its members proud of their affiliation.

#### SUPREME JUSTICE Robert E. Redding

Brother Redding is Vice-President and General Counsel of the Transportation Association of America. The Transportation Association of America is an industry-wide, policy-making, research and educational association of transportation users, investors and carriers of all types. It was founded in 1955 to assure that all shippers, passengers, consumers, investors and carriers may enjoy efficient low cost but profitable transportation under private ownership and manage-

Brother Redding's legal career began in 1946 upon his graduation from Georgetown University Law School where he was a member of Taft Chapter.

Since that time Brother Redding's career has been varied in five years in Government Service with the Civil Aeronautics Board and Tax Court of the United States. Mr. Redding was in private practice in Washington, D. C. for nine years, representing United States, International, Foreign, local service and helicopter air-carriers as well as State authorities, cities, counties and chambers of commerce. Brother Redding also served three years as judge of the Appeal Tax Court of Montgomery County, Maryland.

His affiliations include the American Bar Association, Federal Bar Association, District of Columbia Bar Association, Maryland State Bar Association, American Judicature Society, Inter-State Commerce Commission Practioner's Association, Scottish Rite and various other clubs and fraternal orders.

He has long served Phi Alpha Law Fraternity and has held positions such as District XII Justice, Washington, D. C. Alumni Chapter Justice, and Second Supreme Vice-Justice. He also was an associate Tribune, Director of Professional Activities for six years and Supreme Treasurer.

Brother Redding is a native of Indiana and resides in Kensington, Maryland with his wife, Blanche and three children.

#### SUPREME VICE-JUSTICE Honorable Tom C. Clark

One of the most distinguished jurists in the nation, the Honorable Tom C. Clark, Associate Justice of the United States Supreme Court, was unanimously elected to serve a second term in the position of Supreme Vice-Justice of Phi Alpha Delta.

Justice Clark has devoted his life to public service since he obtained his L.L.B. Degree from the University of Texas in 1922. His service began in 1927 when he became Civil District Attorney for Dallas County.

In 1945 Brother Harry S. Truman, a member of Phi Alpha Attorney General of the United States. Prior to this appointment he served in such posts as Speccial United States Attorney in the Bureau of War Risk Litigation, Special Assistant to the Attorney General in the Anti-Trust Division, Chief of the West Coast Offices of the Anti-Trust Division, Co-ordinator of Alien Enemy Control of the Western Defense Command and Chief of the Civilian Staff for Japanese War Relocation.

Justice Clark was nominated Associate Justice of the United States Supreme Court by Brother Truman on August 2, 1949 and took his seat as successor to Mr. Justice Murphy on October 3, 1949, thereby joining Brother Justices William O. Douglas, Harold H. Burton and Robert D. Jackson.

Brother Justice Clark has also been of service to Phi Alpha Delta by accepting a graduate member of our fraternity each year to act as one of his law clerks. In addition, he attends a great many fraternal affairs and

The Supreme Executive Board first received information concerning the fine financial situation in which the fraternity finds itself; namely the strongest financial position that the fra-ternity has ever been in. The Board felt that at a time such as this when the fraternity is prospering that funds should be set aside to protect against the risk of a financial reversal. For this reason the Board resolved that it shall be the policy to seek to maintain cash reserves in the general and contingency funds at all times in an amount equal to at least the expenditures of the last preceding fiscal year in addition to reserves for the convention, directory and directory supplement.

> The Supreme Executive Board next reviewed the Endowment Fund and considered the problems with a number of delinquent loans.

The Executive Secretary then presented a report on the various

insurance programs and proposals for improving them. At the conclusion of this report, the Supreme Executive Board resolved since its chartering in 1950. umbrella malpractice insurance coverage. The Supreme Executive Board also approved the offering of a hospital money plan, subject to verification of reasonable competitive rate structures.

While on the topic of insurance, the Supreme Executive Board resolved to obtain a group travel life insurance policy covering various officers of the fraternity.

The subject of bonding all acive chapters treasurers with a fidelity bond was referred to committee for study and to report at the next meeting of the Supreme Executive Board after the 1966 Convention.

### Past Supreme Justice Gilbert Dies

Allan Thurston Gilbert, past Supreme Justice of Phi Alpha Delta, and an alumnus member of Blackstone Chapter passed away on March 4, 1965 at the age of 70.

Brother Gilbert was born on December 2, 1894 in Chicago, Illinois, the son of Allan Arthur and Grace Thurston Gilbert.

He graduated from Lewis Institute and obtained his LL.B. Degree from Kent College of Law.

Upon graduation from Kent College of the Law, Brother Gilbert comenced practice in Chicago, Illinois. He served as special assistant corporation counsel for the City of Chicago and attorney for Citizens Traction Settlement Committee from 1928 to 1932. Thereas he practiced with the fir of Schuyler & Hennessy.

Brother Gilbert was a member of the America Bar Association, Illinois State Association and Chicago Bar Association. He was also affiliated with the Law Club, the Legal Club, the American Legion, the Art Institute of Chicago, the Chicago Historical Society, the Sons of the American Revolution, the Sons of the Confederate Veterans and the Masons.

Brother Gilbert was very active in Phi Alpha Delta. From 1923 to 1930 he served as Supreme Historian of the fraternity.

From 1930 to 1934 he served as Supreme Justice of Phi Alpha Delta having the distinction of serving for four years, a distinction which only three other men have had. Also a term of office exceeded only by Supreme Justice J. Harry LaBrum who served in that position during the Second World War.

After having served as Supreme Justice for four years, Brother Gilbert continued his active participation with the Fraof the Board of Tribunes from 1934 to 1936. Thereafter Brother Gilbert actively participated as chairman of the Board of Trustees from 1936 to 1946.

In total, Brother Gilbert gave 23 years of leadership on the Supreme Executive Board, the Board of Tribunes and the Board of Trustees of Phi Alpha Delta Law Fraternity.

Brother Gilbert worked hard during the depression years to keep PAD strong. As he said to the active chapters on the eve of rushing in the year 1931, "If in some cases the enrollment in the freshman classes is not as large as usual discretion should be used in the selection of members for our great organization. We want strong men. We want men of personality, men who will be the leaders of the future and who will add to our already streaming pages of success.'

Phi Alpha Delta is indebted to Brother Gilbert for his devoted service to the Fraternity.

### Message From The Supreme Justice

In setting the tone for my use of the traditional Reporter message from your Supreme Justice I have always been impressed by the following assertion in the October 1961 American Bar Association Journal: "No move-ment in history for the improvement of man's condition and for the establishment of justice has ever succeeded without the presence, the influence, and the leadership of great and coura-geous lawyers." It is my conviction that our Fraternity should and does perform an important role in developing such lawyers.

I have mixed emotions of humility and profound gratitude from being elected as Supreme Justice. No greater honor can be conferred on any man in Phi Alpha Delta. With God's help, I hereby pledge to translate my appreciation into meritorious deeds and conduct serving the best interests of our Brotherhood.

I shall use my message capsule to speak to all Brothers, all wives and sweethearts, and the world at large of our aspirations; our continuing efforts to serve the law student, law school, and legal profession; and our progress toward such objectives.

Our Fraternity has reached a high point in its three score and four years of existence, as made clear to all delegates attending our recent convention in Kansas City, Missouri. Yet, as we continue to expand our membership and the opportunities for professional service, there is much to be done together. All of your Supreme Officers and District Justices have resolved to advance our rate of progress in the next two years.

At the convention I stated my intention to direct our energies primarily toward a dozen principal objectives. By so doing, I am confident we can also achieve other objectives as well. I would like, therefore, to summarize these modern and attainable dimensions in the remaining space available to me.

First and foremost, we must extend greater alumni service, working toward the objective of an alumni chapter in every area in which an active chapter is located.

Second, we must enhance the effectiveness of our faculty and alumni advisors, the one remaining echelon in our administrative structure needing special attention and strengthening.

Third, the expansion of high caliber professional programs by active chapters is a vital key to PAD excellence. We must meet the challenge of our time.

Fourth, we must promote optimum law school relations and expanding faculty memberships. Fifth, I am particularly interested in the role of PAD for in-stilling leadership qualities and

forging leaders of men. How better can we contribute to the postulate quoted above?

Sixth. we must enhance our Fraternity relationships with the bar, the bench, and the general public. We must do our part to improve the low public esteem for the legal profession.

Seventh, we should also make PAD a substantive force in the law, including, for example, the public defender program, continuing legal education, Law Day activities, and expanded legal aid services.

Eighth, we must maintain financial stability as well as the continued growth and effective usage of our Endowment Fund.

Ninth, we should continue to confer honorary memberships on the leaders in the legal profession, working toward the goal of at least one new honorary member each year for every active chapter.

Tenth, with our new Ritual volume now available, we should place special dignified and phasis on the ressive exemplification of our Ritual. It is important to impress the meaning and purpose of PAD into the of each new heart and mir Brother.

Eleventh, we must strengthen our pledge orientation activities, one of our weakest links today.

Finally, we must consolidate the strength and vitality of our active and alumni chapters now in existence. While we will undoubtedly continue to add new chapters, I favor a primary emphasis on enhancing the stability of our current chapter complement.

I hope each of you will extend your personal support and help in this Fraternity program. The highest reward for a man's toil is not what he gets for it but rather what he becomes by it.

Lawyers may expect a tightened market and higher rates for their professional liability insurance. These facts have been underscored lately by several articles appearing in "The Wall Street Journal."

The National Bureau of Casualty Underwriters and the Insurance Information Institute both have recently expressed similar views. The bureau reported that the placement of lawyers liability was "critical" as very few companies will even write it anymore.

The higher costs and withdrawal of companies from handling the business at any premium is the result of the rising number of malpractice suits and the generally larger damage awards. The bureau said that the average loss per insured lawver increased over 30% in one recent year.

### 1966 Outstanding Chapter Awards Announced

Selected as the top chapter in the country was Benson Chapter at Washburn University School of Law. Second place went to Timberlake Chapter at Wake Forest College of Law while DeBracton at St. John's University School of Law took third place. Hay Chapter at Western Reserve University School of Law received the Supreme Justice Award for Excellence.

#### BENSON CHAPTER

Benson Chapter, at Washburn University School of Law, boasted 73 active members and 62 pledges for the 1965-1966 school year, in a school having a total enrollment of 260 students.

Benson Chapter members are well known for their enthusiastic leadership, guidance and support of all Washburn University Law School activities. Members of Phi Alpha Delta serve as members of the Moot Court Team, Student Bar Association Officers, Committee Chairmen, Committee members, Law Review writers, student newspaper editors and contributors as well as many other offices and positions.

There are eight major committees which are under the control and supervision of the Washburn Student Bar Association. Each of these committees are either headed or supervised by the brothers of Benson Chapter.

Following his retirement as Dean of the University of Illinois, he served for one year as Acting Dean of the Law School at the University of California at Los Angeles and the following year he began teaching law at Hastings College in San Fran-

Dean Harno served as Court Administrator from 1961 until 1964. He then returned to Hastings College of Law where he taught until his resignation from the college in 1966 because of poor health.

Brother Harno was President of the Association of American Law Schools in 1932; Chairman of the Board of Directors of the American Judicature Society from 1945 to 1951; President of the American Judicature Society from 1953 to 1956; Chairman of the Section of Legal Education of the American Bar Association from 1942 to 1945; President of the National Conference of Commissioners on Uniform State
Laws from 1947 to 1949; memben the Borrow of Governors of

### Robert M. La Follette Chapter Installed

Dean Boden considered the recommendation and also heard pros and cans offered by members of the faculty. Although not exactly pleased with the tumult created by this struggle for acceptance, the Dean said that he would not prevent PAD from seeking possible members during scheduled rushing periods. The Milwaukee Alumni Chapter, led by Alumni Justice Richard Nelson, Carl Dietze, James Murphy, and David Baldwin, responded with all-out assistance and arranged and paid for an

**THE ENDOWMENT FUND COMMITTEE** recommended an increase in student loans from \$500 to \$1,000 and an increase in alumni dues from \$5.00 to \$6.00 per year. Both resolutions were passed by the convention.



THE CONCLAVE COMMITTEE concluded that it would be inadvisable to lay down an inflexible uniform conclave format; however, the committee concluded that the most successful conclave is one held all day Saturday divided equally between a profressional program and a chapter workshop.



THE PUBLICATIONS COMMITTEE reviewed sixteen of the fraternity's publications for format and content.



THE CREDENTIALS COMMITTEE determined that almost all of our 104 active chapters and 55 alumni chapters were represented at the convention.



THE PROFESSIONAL PROGRAMS COMMITTEE recommended strengthening alumni relations, initiating a big brothers program, advance planning of professional programs, honorary initiations and paticiption in Indigent CiminI Cases and the Manhattan Bail Programs.

### **SUMMARY OF 1966 CONVENTION ACTION**

Phi Alpha Delta Law Fraternity was strengthened and improved through the active participation of the delegates and alumni members present during the 36th Biennial National Convention. Much of the work was accomplished in committee where strong debate and complete discussion was given to the various issues. The following is a summary of the convention action on committee reports:

#### AUDIT AND FINANCE:

1. Approved the certified financial statement and related schedules of the General Fund of the Fraternity for the twoyear period ending July 31, 1966.

2. Approved the certified financial statement and related schedules of the Endowment Fund for the two-year period ending July 31, 1966.

3. Directed that a condensed financial report of the Fraternity be prepared for publication in The Reporter and that the Supreme Secretary, or someone at his direction, prepare a statement to be published in conjunction with the financial report setting forth the growth of the Fraternity from the standpoint of membership and active and alumni chapters.

4. Declined to adopt an amendment to the National By-Laws which would provide for the payment of all or part of the expenses of a second representative from each chapter to each National Convention.

#### AWARDS AND SCHOLARSHIPS:

1. Declined to adopt the majority report of the Convention Committee on Awards and Scholarships and referred the matter of the adoption of a National Scholarship Program to the Supreme Executive Board.

#### CONCLAVES:

1. Directed the Supreme Executive Board to budget an additional amount to the conclave Discretionary Fund for the purpose of providing appropriate travel allowances in District Conclave budgets.

#### CONSTITUTION AND NATION-AL BY-LAWS:

1. Declined to adopt a proposed Constitutional amendment which would allow the Supreme Executive Board to initiate the conferring of Honorary memberships.

2. Declined to adopt a proposed amendment to the Constitution which would provide for the office of Supreme Justice elect.

3. Adopted an amendment to the Constitution which provides that no person shall serve more than eight (8) consecutive years as a member of the Supreme Executive Board, unless he be elected to the office of Supreme Vice-Justice, in which event he may serve four (4) additional years.

5. Adopted proposed amendments to the Constitution which provide for removel procedures applicable not only to Supreme Officers but also to elected student district officers and Chapter Officers.

6. Defeated a proposed amendment to the Constitution which would have made mandatory the election of student district offi-

7. Adopted various amendments to the National By-Laws which had to do only with matters of form or procedure.

8. Adopted a proposed amendment to the National By-Laws which provides that each District may elect certain student district officers.

9. Adopted an amendment to the National By-Laws which provides that alumni chapter delegates to the National Convention will have their expenses paid on the same basis as active chapter delegates.

10. Defeated a proposed amendment to the National By-Laws which would have increased the amount of per diem allowance paid to delegates to the National Convention to the amount of \$10.00 per day.

### ENDOWMENT:

1. Increased the amount of individual student loans from \$500.00 to \$1,000.00.

2. Adopted a policy that no interest is to be charged on the principal amount of any loan (C

except that interest at the rate of five per cent (5%) per annum is to be charged on the amount of any past-due installment.

3. Adopted a policy that a borrower is required to keep the minimum amount of P.A.D life insurance in force during the term of the loan.

4. Amended the National By-Laws to provide that alumni dues shall be increased from \$5.00 per year to \$6.00 per year.

5. Adopted a policy that the additional dollar increase in alumni dues is to be added to the Endowment Fund in the following proportions:

A. Eighty per cent (80%) to the working capital of the fund.

fund.
B. Twenty per cent (20%) to the corpus of the Fund.

C. Any portion of the 80% which remains unused at the end of the year is to be added to the principal of the fund.

#### PROFESSIONAL PROGRAMS:

1. Directed the Supreme Executive Board to study ways and means of strengthening relations between active chapters and local alumni chapters.

2. Suggested that at the 1968 Convention there be a workshop concerning the relationship of active chapters and alumni chapters.

3. Recommended that "Big Brother" programs be instituted between the alumni and the active chapter.

4. Recommended that alumni chapters cooperate with active chapters in puring oyment of members before and after graduation.

5. Recommended that local alumni chapter be correctly advised of active chapter activities and urged to participate.

6. Recommended that local alumni present to the outstanding pledge an award.

7. Recommended that active chapters plan professional and social programs at least one semester or quarter in advance.

8. Recommended that active chapters be encouraged to continue Speaker Programs.

9. Recommended that active chapters invite faculty members to professional and social activities.

10. Recommended that active chapters be encouraged to initiate outstanding members of the bench, bar and faculty as Honorary Members.

11. Recommended that active chapters consider participating in Indigent Criminal Cases and Manhattan Bail Programs.

12. Recommended that faculty advisors be used for counseling of student and liason with the administration of law school.

13. Recommended that local chapters incorporate and expand professional programs for law wives

#### PUBLICATIONS:

1. Recommended changes in content of P.A.D. Facts.

2. Recommended that the Pledge Manual be continued in its present form.

3. Recommended minor changes in The Reporter.

4. Recommended that the Rushing Booklet be continued substantially in its present form.

5. Adopted the publication of a Chapter Officers Manual.
6. Abolished the Rushing

6. Abolished the Rushing Guide and the Meetings and Social Activities Guide.

7. Recommended that the paper entitled "Comparison of Law Fraternities" be reserved for use of active chapter members only.

8. Concurred in the action of the Supreme Executive Board in appointing a committee to investigate the publication of a complete history of the Frater-

### National Legal Aid and Defender Conference

Although the American Bar Association (ABA) has had a Standing Committee on Legal Aid Work since 1970, with Charles Evans Hughes being the first chairman, it was not until 1949, just 20 years ago, "that it can fairly be said that the ABA awakened to the major resopnsibility of the organized bar to spawn legal aid and defender offices around country." Marden addressed delegates to the 1966 National Legal Aid and Defender Conference. He spoke at the Annual I r recently, the closing session of the conference.

"Some evidence of our extraordinary growth over the past twenty years can be gleaned from a glance at the 1945 statistics," Marden said.

"In the entire country there were only 64 legal aid offices and 24 defender organizations." (Today theer are 332 legal offices and 249 defender services.) The total number of cases handled were 256,651. (Last year nearly 700,000 indigents received legal advice and representation.)

Many people have made outstanding contribtuions to legal aid and defender services over the years, Marden said. Among them, and to illustrate their varied backgrounds, Marden singled out and praised the following: Hon. Earl Warren, Chief Justice of the United States; Fay Van Wagoner of the New York Legal Aid Society; Emmett R. Field, retiring General Counsel of the Louisville Legal Aid Society; Theodore Voorhees, retiring President of National Legal Aid and Defender Association (NLADA); Major General Charles L. Decker, Director of the NLADA National Defender

NLADA, with headquarters at the American Bar Center in Chicago, is the national coordinating body of local legal aid and defender offices which provides legal services to the poor. Last year, the cost of representation was nearly \$12 million, or an average of \$17 per case. The annual conference provides legal aid and defender lawyers an opportunity to exchange information with the view to improving their services to the public. Three hundred delegates are attending this year's conference.



### **MORIARTY DIES**

Brother Charles P. Moriarty, alumnus member of Dunbar Chapter, recently passed away at the age of 71.

Judge Moriarty, as he was still known to his friends, had an outstanding career at the bar and was one of the youngest men ever appointed to the King County Superior Court.

He was appointed in 1925 and won election the following year. He served as judge of the King County Superior Court until his resignation in 1929.

Born in Leavenworth, Washington, Brother Moriarty graduated from Gonzaga University with a B.A. Degree, and a M.A. Degree. He obtained his Bachelor of Law Degree from the University of Washington in 1919 and an honorary Doctorate of Law Degree from Gonzaga in

Bro ted to the Washington Bar in 1919 and became general counsel of the Washington Veteran's Commission in 1922 and assisted the United States Attorney at Tacoma, Washingon, in 1923.

He was appointed United States Attorney for Western Washington by President Eisenhower in 1953 and was renamed for a four year term in 1957. In 1963 he served as King County Judge Protem.

He resumed his law practice in the firm of Moriarty, Olson and Campbell in 1961.

In 1950 Brother Moriarty was named to the Seattle University's first Board of Regents and was still a member at the time of his death.

He was a Grand Knight of Seattle Council Knights of Columbus in 1923 and commander of Seattle Post No. 1 of the American Legion that same Football Team in 1917 and year. He was State Judge Advoserved as the frosh coach for the cate of the American Legion in University of Washington 1932 and state commander of the 1919. Military Order of World War in 1933; and state president of the daughter and two sons.

### Bowles, Gillmor and MacLean-Clark Finalists

Each year Brother Tom C. Clark, Associate Justice of the United States Supreme Court, selects a law clerk from among the student members of Phi Alpha Delta. The qualifications of all applicants are first reviewed by the Supreme Tribunal of Phi Alpha Delta which selects three finalists. These finalists are submitted to Justice Clark for his final selection.

This year a number of outstanding student members of Phi Alpha Delta applied for this honor. Because of the extremely large number of applications and the outstandcaliber of each of the applicants, the Supreme Tribunal spent many hours in reviewing the applications.

Three applicants were finally selected as finalists from which Justice Clark will personally select his clerk. They are James E. Bowles, George W. Gillmor and Harry MacLean.

Each of the applicants is outstanding in his own right both in his academic record and extra-curricular activities.

#### TAMES E. BOWLES

Brother Bowles is a 22 year old law student at the University of Missouri School of Law at Columbia, Missouri, where he is a member of Lawson Chapter. He has served as clerk and justice of Lawson Chapter.

Brother Bowles obtained his A.B. Degree from the University of Missouri with a major in History and will obtain his J.D. Degree in January of 1967.

He has accumulated an outstanding grade point average of 3.79 and stands third in his class of 84 students.

In 1965, Brother Bowles received the award for the best brief submitted in the first year Moot Court Competition.

Brother Bowles has served as a member of the Missouri Law Review and has published a comment entitled "Recovery Against a Decedent's Estate for Services Rendered Him During His Lifetime - the Missouri View." He will serve as co-editor-in-chief of the Missouri Law Review for the 1966-67 school year.

In addition to his studies Brother Bowles has been employed by Professor John S. Divilbiss, the Reporter for the Missouri Supreme Court Committee on Jury Instructions. His employment has included background research for jury instructions that will be a part of the forthcoming supplement to the Missouri Approved Instructions. It is a compilation of jury instructions that have been approved by the Missouri Supreme Court and are mandatory when applicable in Missouri Trial Courts.

#### GEORGE W. GILLMOR

Brother Gillmor is a student of Boston University Law School having obtained his undergraduate degree from Boston University's College of Business Administration, summa cum laude.

During Brother Gillmor's first year at Boston University School of Law he was first in his class as well as participating in the appellate court program. He received awards for obtaining the highest grade in contracts, agency, civil procedure and prop-

During Brother Gillmor's second year, he participated in the

United Veterans League in 1928. He was national president of the University of Washington Alumni Association from 1927 to 1929 and president of the Family Society of Seattle from 1930 to 1933.

He was co-chairman of the National Conference of Christians and Jews from 1960 to 1962. While at the University of

Washington he was president of Newman Club. During his college career

Brother Moriarty was editor of Gonzaga, president of the Gonzaga student body and a member of the Intercollegiate debating team.

Law Review and published a note entitled "Duty to Integrate Public Schools? - Some Judicial Responses and a Statute." In addition to his work on the law review, he again placed first in his class.

During the first two years of his law school career he has earned an accumulative average which is the highest the law school has experienced in the last decade.

Brother Gillmor has been elected Editor-in-Chief of the Boston University Law Review for the forthcoming year.

During the summer between his first and second year he served as a law clerk in his father's office in Camden, Maine. This prior summer Brother Gillmor served as law clerk in the firm of Foley, Sammond & Lardner of Milwaukee, Wisconsin.

#### HARRY MacLEAN

Brother MacLean is 24 years old and a senior at Denver University Law School where he is working for his LL B. in June of 1967.

His law school efforts have earned for him the distinction of being number one in his class of 110 students and an accumulative grade point average of 2.61. He has received nine awards from the West Publishing Company in American Jurisprudence for Excellence in everal subjects and was red ly awarded Jaffa Memorial Prize given by the faculty to the student hav-ing the highest average during his first two year In the fall of 1965 law school.

Brother Mac-Lean was elected to the staff of the Denver Law Journal and is presently serving as Note Editor.

His research experience includes work as a research assistant to Professor William Stoebuck during the spring of 1965. Brother MacLean is presently

student assistant to the Dean of the University of Denver School of Law, a position involving the handling of minor administrative matters and legal research in the area of civil procedure.

He is also the student director of the Jury Verdict Report. This report is a subdivision of the program in judicial administration which is financed mainly by the Russell Sage Foundation. The Jury Verdict Report, a quarterly publication, contains all the relevant data on every personal injury case tried or settled in the City of Denver.

During the summer of 1965 Brother MacLean worked for William Erickson, a senior partner and trial attorney in the Hindry, Erickson & Meyer. In this position Brother MacLean did research for Mr. Erickson's forthcoming book on the trial and settlement of a personal action and also aided Mr. Erickson in trial preparation.

Brother MacLean is presently a clerk for Holland & Hart, a Denver firm with a large and varied practice.

In addition to his professional and scholastic activities, Brother MacLean is a member of the Advocates Club and as a member has participated as counsel in several mock trials. He was also selected by the faculty to sit as one of the judges in the freshmen moot court program.

In the fall of 1965 Brother Mac-Lean was elected to the position of senator to the Student Senate of the Student Bar Association. ### PAST SUPREME **JUSTICE CULBERTSON DIES**

Phi Alpha Delta is saddened with the loss of a dear friend in the passing of Brother William S. Culbertson, Supreme Justice of the fraternity from 1934 to 1936.

Brother Culbertson, a former United States Ambassador to Rumania and Chile, died of pnuemonia on August 13, 1966 at the age of 82.

A retired Army Colonel who served on the General Staff from 1942 to 1945, he was at different times an educator, public servant, soldier and lawyer.

A senior partner in the Washington law firm of Culbertson, Pendleton & Pendleton since 1934, he received his A.B. and Ph. Degree from Yale University and his L.L.B. Degree from Georgetown University and the University of Chile.

He became a member of Calhoun Chapter in 1912.

Beginning in 1912, Brother Clubertson was a professor at Yale University School of Foreign Service. He nued struction for 1912.

In 1910 he was named to the Federal Trade ommissi later served a airma United States Tarriff Commission.

From 1925 to 1928, Brother Culbertson served as Ambassador to Rumania and later was Ambassador to Chile.

In 1944 Culbertson was sent on special mission to French North Africa, the Middle East, Italy and France, with the rank of Ambassador.

After the war he returned to his law practice and became a specialist in the field of international law.

A native of Greensburg, Pennylvania, Brother Culbertson was an elder and for many years served as chairman of the board of trustees of the National Presbyterian Church.

The stature and the maturity of this man is best exemplified by his statement upon being elected as Supreme Justice of the Fraternity. He said, "If this honor had been mine twenty years ago it would have gone to my head-today it goes to my heart."

Upon taking office, Brother Culbertson immediately stated his objective to devote his energy toward extending the activities of Phi Alpha Delta Law Fraternity in fields of substantive importance to the profession and to the public life. He encouraged Brothers of Phi Alpha Delta Law Fraternity to take an active part in their local bar associations and in the American Bar Association; to encourage the teaching of the federal and state constitutions especially in secondary schools; to throw their influence in favor of the improvement and enforcement of criminal law; and to direct their service whether they happen to hold public office or whether they are engaged in private practice of law.

Brother Culbertson was, to paraphrase Holland's inspiring prayer, a man of strong mind, great heart, true faith and ready hands; a man to whom lust of office does not kill; a man to whom the spoils of office could not buy-a man of honor.

### Dedication of U.S. Customs Courthouse

Justice Tom C. Clark, Associate Justice of the United States Supreme Court and Supreme Vice-Justice of Phi Alpha Delta, recently laid the cornerstone of the new United States Customs Courthouse in Foley Square, New

Many dignitaries were present for the ceremonies including Chief Judge Paul P. Rao of the United States Customs Court; United States Senators Jacob K. Javits and Robert F. Kennedy, Mayor John V. Lindsay and for-mer Mayor Robert F. Wagner, Congressman Emanuel Celler, Chairman of the House Judiciary Committee; Assistant Secretary of the Treasury, William True Davis; and Assistant Attorney General of the United States, John W. Douglas.

The United States Customs Court is the only Federal Court of National Jurisdiction which has its headquarters outside Washington, D. C., its location being dictated by the great volume of business eminating from the Port of New York, the largest Port of Entry in the United States.

The Court is composed of nine Judges, who are appointed for life by the President of the United States with approval of the Senate.

The Chief Judge of the United States Customs Court is designated by the President of the United States, a distinction held in common with the Supreme Court of the United States, the United States Court of Customs and Patent Appeals and the United States Court of Claims. Brother Paul R. Rao, an alumnus member of deBracton Chapter is the present Chief Judge of the U.S. Customs Court.

The U.S. Customs Court has jurisdiction throughout the Unity States Puerto Rico, encon, asses all ports at which merchandise is imported from any foreign country. The Court sions Il major cities is juristion on scheduled dates during the course of each year. Approximately 50,000 suits involving the value of imported merchandise and the classification thereof, within the tarriff laws of the United States, are filed for adjudication by the Court every year.

The national character of the U.S. Customs Court is reflected by the several associates who have been residents of other states. As now constituted, the Court's membership consists of the following: Chief Judge, Paul P. Rao of New York; Judge Webster J. Oliver of New York; Judge Morgan Ford of North Dakota; Judge Mary H. Donlon of New York; Judge Scovel Richardson of Missouri; Judge Philip Nichols, Jr., of Massachusetts; Judge Frederick Landis of Indiana; and Judge James L. Watson of New York. Judges Charles D. Lawrence of Maine and David J. Wilson of Utah are Senior Judges.

### **Executive Secretary Speaks** to Professional Interfraternity

Brother Fredrick J. Weitkamp, Executive Secretary of the Fraternity, was a delegate at the recent Professional Interfraternity Conference Biennial Meeting held at the Gateway Hotel in St. Louis, Missouri, and spoke to those present on the "Present and Future of the Professional Fraternity.

Professional fraternities in the areas of agriculture, chemistry, commerce and business administration, dentistry, education, engineering, medicine, music, pharmacy, veterinary medicine, and law are members of the Professional Interfraternity Conference that were present. The law fraternities which are members of the Professional Interfraternity Conference include Delta Theta Phi, Phi Delta Phi, Phi Beta Gamma, Sigma Delta Kappa, Gamma Eta Gamma, and Phi Alpha Delta.

Following is the text of Brother Weitkamp's remarks:

"Last June the United States Commissioner of Education announced that federal grants would be cut off to universities and colleges that tolerated the presence of fraternities and sororities which practiced racial discrimination. Thus did the federal government indirectly attack the fraternity system. It is to be noted that there was no attempt to legislate away fraternities or to in anyway rule that they could not exist on university and college campuses. However, the indirect and very effective pressure of government money was brought into play.

"Fortunately, most professional fraternities have eliminated racial discrimination clauses and so unlike social fraternities we in the PIC have not had to concern ourselves with this attack on the fraternity world.

"However, pressure is being brought against us in other ways and will continue to be brought against us in other ways in the

"I recently ran into a situation at one law school where we had a colony existing where the faculty adopted a resolution stating that the faculty itself looked with disfavor on any organization where membership was not open to all who wanted oin. Here, the faculty was at tacking the provision contained in our Constitution which pertains to the percentage of members who must approve a new member. Note that we do not have a strict blackball system but that this has been watered down to a percentage situation.

"In another instance, a law school did not want us because we did not take in women. They felt that this was a form of discrimination. This, despite the fact that there are presently existing women's legal sororities.

"More and more we can expect indirect pressures such as these to be brought against professional fraternities. If we are to survive, it therefore becomes encumbent upon us to justify our very existence.

"Let us ask ourselves the question, "What is our purpose of existence?" Generally is it not to serve our respective professions. Specifically, is it not even more correct to say that cur purpose is threefold: One—to serve our student members; Two—to

and Three-to serve our profession?

"Far too often, I believe, we have forgotten our purpose for existence and have become, for all intents and purposes, a graduate social ternity.

"To be sure, a proper balance requires that there be a social side to the professional fraternity but this should only be a sublimated asper of our program.

"The justification of our existence is contained in just one word-professional.

"We must continually emphasize the professionl nature of our fraternities. Only in this manner can we justify our existence in the eyes and minds of the faculties and the administrations of the schools with which we have to continually

"How can we stress the professional aspect of our organiza-

"First, our programs should be geared to aid and assist the school. Chapters should be urged to adopt programs such as freshman orientation to the school, use of the library, techniques of exam writing and others calculated to make the transigraduate school an easier one. distributed to other chapters. "Second, when regional or national officers make visitations to chapters, one of the first things should be to meet with the Dean and faculty members of the school. Ask them if the local chapter is making a real contribution to the school. Stress that the fraternity, that is, the national organization, is deeply interested in the professional aspect of its chapters' activities, and that if a chapter is not conducting professional activities it is not making a worthwhile contribution to the school, and that then we ourselves recognize that there is no reason for the existence of a chapter. Find out from them in what way the professional program of the chapter can be strengthened. "Third, meet with the alumni

and faculty advisors to the chapter. Here again, emphasize the same professionalism so serve the professional school; that after you are gone these sional".



In reference to chapter supplies, the Supreme Executive Board directed the Executive Secretary to make available to all active chapters multilith leterhead stationery at cost in that this represents a substantial savings to the chapters in comparison to engraved or embossed letterhead stationery. It was also resolved to make available to all active chapters head table place cards upon request at no cost. In addition, all active chapters will now be furnished gold and purple ribbons for use in presentation of honorary membership keys to all active chapters upon request from the Executive Secretary's office at no cost. The members of the Supreme

Executive Board next considered the need of a fraternity history in that the fraternity is now 54 years old. It was resolved that a committee be appointed to report on matters of cost and procedure for the compilation of such a history.

A number of recognition awards were established by the Supreme Executive Board at the pre-convention meeting. It was resolved that a special award shall be made by the Supreme Executive Board to the District Justice who has contributed outstanding service to Phi Alpha Delta activities for each biennium. In addition, a special award to be known the "Distinguished Service Chapter" was adopted and is intended to be given to an alumnus or active member for exceptional and unusual service to the fraternity.

#### Supreme Officer's Seminar





Welcome By Tom C. Clark Following the outstanding keynote address of Justice Whittaker, the delegates received a welcome from the Honorable Tom C. Clark, Associate Justice of the United States Supreme Court and Supreme Vice-Justice, via loudspeaker telephone. Brother Justice Clark stated his regret for being unable to attend the convention because of the tremendous load of work at the Court but explained that he was most interested in the fraternity and would continue participating in fraternity activities as much as time would permit.

Justice Clark then spoke to those present about his interest in the student participation in the Indigent Defense Program. He pointed out the urgent need which students have for practige in the legal procal experi aid that it was his fession. I feeling that this practical ex-perience can be achieved by working with the Indigent Dem and allowing stufense Prog dents act participation in the

Following Justice Clark's comments, a number of the students had an opportunity to ask Justice Clark questions concerning the procedure followed by the Supreme Court.

### Chapter Workshops

Workshops in the areas of rushing, pledging, and indoctrichapter organization, nation. chapter financing, national-local relations and professional activities, were conducted during the afternoon session of the first day. The delegates to the convention were divided into five groups of approximately 40 students in each group. Each group then received a one-half hour instruction and discussion on each of the five topics. In addition, there was an alumni chapter workshop at which all of the delegates from the alumni chapters received instruction and discussed alumni chapter activities.

### **Model Initiation**

On Thursday morning, September 1, 1966, the delegates gathered to witness a model initiation during which pledges from Green, Benton and Benson Chapters were initiated as Brothers of Phil Alpha Delta. Following the honorary initiation, the ritual for deceased Brothers was performed as few brothers have had an oppertunity to perform this ritual.

#### **Convention Committees**

Much of the work at the convention is accomplished in committee. The committees at the 36th Biennial National Convention were: Audit and Finance, Awards and Scholarships, Constitution and By-Laws, Credentials, Endowment Fund, Professional Programs, Publications, Resolutions, and Conclave.

Friday morning, September 2 1966 found the delegates in convention assembled to recieve committee reports and vote on the pressing issues concerning the fraternity. Some of the major decisions reached during the convention are as follows:

1. The office of Second Supreme Vice-Justice was deleted. In its place was created the office Supreme Advocate.

2. A limit was placed on the period which a brother may serve on the Supreme Executive Board to no more than eight consecutive years unless he be elected to he office of Supreme Vice-Justice in which event he may serve four additional years.

3. A procedure was adopted for removal of all elective officers of the fraternity including student district officers and chapter offi-

4. Payment of expenses for alumni chapter delegates to the national convention on the same basis as active chapter delegates.

5. The maximum amount of individual student loans from the Endowment Fund was increased from \$500.00 per student to \$1,000.00

6. Alumni dues were increased from \$5.00 per year to \$6.00 per year and 80% of the additional dollar is to be added to the working capital of the Endowment Fund and 20% of the additional dollar is to be added to the corpus of the Endowment Fund.

7. Active chapters were urged to consider participating in Indigent Criminal Cases and "Manhattan" Bail Programs.

8. November 8 of each year was set aside as National Founder's Day of Phi Alpha Delta Law Fraternity.

9. The uniform adoption of the Degree of Juris Doctor as the first degree given law graduates who previously received an undergraduate baccalaureate degree was recommended.

Also on the last day of the convention the delegates received a very informative speech by Charles Scott on "Questioned Documents." Mr. Scott described documents which are most often ch as checks, notes. questioned wills, dee letters, and con-tracts. In addition to documents, wills, dee Mr. Scott discussed handwriting, ballistics and other means of ad identification of comparison evidence.

Post Convention Board Meeting

On Sunday, September 4, 1966, the new Supreme Executive Board met to dispense the business remaining and begin the new biennium.

Among the more important decisions and resolutions reached by the Board meeting were:


1. The Transfer of the State of Wisconsin from District V to District VIII, effective immediately.

2. Approval of a petition of Howard University in Washington, D.C. for a Chapter of Phi Alpha Delta to be known as John Mercer Langston.

3. The fraternity is to underwrite a public relations room at the American Association of Law Schools Meeting in Washington, D.C. in 1966 and at the American Bar Association in Honolulu, Hawaii in 1967 and the Supreme Justice or his appointee is authorized to attend the American Bar Association Meeting in Hawaii.

4. Adopted the budget for this fiscal year 1966-1967.

### PROF. COOK DIES

Brother Walter I of Hay an alumnus memb Chapter and professor emeritus of Loyola Law School, recently passed away at the age of 83.

Brother Cook was born in Hillsdale, Michigan and obtained his LL.B. Degree at Western Reserve University where he became a member of Hay Chap-

Brother Cook came to California in 1922 and joined the Loyola Law Faculty approximately ten years later. From the beginning, Brother Cook was regarded as a genius in the teaching profession. His success was marked by an analytical mind, keen wit, meticulous regard for details, command of the English language, intelligence, sympathy and patience beyond the call of duty.

Brother Cook's vision was impaired by glaucoma; however, his eventual total blindness.

Thirty years ago the President of the Association of American Law Schools visited Loyola with reference to the law school's application for membership in the association. The President spent the entire period of contracts in Professor Cook's classroom and was so impressed by his performance that he commented 'as good as Corbin."

He was so loved and admired by his brothers in Phi Alpha Delta that Ford Chapter sponsored a dinner for him after his blindness and presented him with a gift of a wrist watch specially designed for the blind.

In the main corridor of Loyola Law School, leading off the foyer of the new law building on the right, hangs a portrait of Professor Cook, the gift of the class of 1957. It is a splendid likeness and portrays him as he was known to legions of Loyolans, the all seasoned, incomparable "Mister Chips," ready and vibrant to spread enlightenment in the dark recesses of the law even though eternal sleep presses down his eyelids still.


### PAD Named Head of AALS

He has held visiting professorships at a number of major law schools including Northwestern University, University of Texas, University of Southern California, Rutgers University Law School, Stanford University, University of Chicago, Hastings College of the Law, the University of North Carolina and the University of Michigan.

Brother Malone's book on Louisiana Workman's Compenbook on sation Law and Practices is considered a model and authoritative work in this field. He has also written a number of articles published in legal periodicals and is especially noted for his research and teaching in all aspects of personal injury law.

Last year the American Trial Lawyers Association Award of Merit was presented to Dr. Malone for his scholarly contributions to the field of personal injury and workman's compensation law.

The Professor organized the Southern Law Review Conference and was its first chairman.

He has also served as chairman of the Torts Roundtable Division of the Association of American Law Schools and he is a member of the Association's Executive Committee.

Dr. Malone this year will complete a third term as national president of the Order of the Coif, National Legal honor society.



### APPLICATIONS FOR POSITION OF ASSISTANT TO THE SUPREME JUSTICE



# "Circling the Square"

Address by

### The Honorable Charles E. Whittaker

Associate Justice, United States Supreme Court (Retired)

before the

Thirty-Sixth Biennial Convention of Phi Alpha Delta Law Fraternity held on August 31 at the Muehlebach Hotel, Kansas City, Missouri.

"Mr. Toastmaster, Distinguished Guests, my Brothers in Phi Alpha Delta, I am happy this morning to be able to so greet you rather than to greet you as my Fellow Revolutionaries. Let me say at the outset that I think you are a most fortunate group of young men; you are headed toward a life that can bring glorious and wonderful achievements in public service. You will note I have said "can bring" this for in this life we have learned that we get from the best of activities no more than we put in. And if you will, as I am sure you will, give the right kind of effort, fidelity, and honor to your work, you will find the rewards I have spoken

"Now, I think you are especially fortunate, not only because you stand as young men before the par of e bar, but principall because of the nature of the empirical education which is practical, sensible, gives attendetails that you get in s of the land. If v sch you will reflect only briefly to your college days-you are undergraduates—you will find your own answer for you know that you did not there get the kind of education you are getting now; not just a difference in quality, indeed, it is a difference in kind. Those of you who are now sophomores or farther along in law school, in your third year or in your second year, have begun to realize that you now because of your legal training are developing a legal mind and it is very different than the lay mind, and if ever in our history there was a time when we needed the kind of education that lawyers get, it is now. The tangible, the practical, something you can take hold of and that makes good solid sense, and the type of reasoning you are required to go through in arriving at your conclusion, giving attention to all details that may make wide differences in result, can only smoke out the fallacies and make your conclusion sound and makes a real mental genius of you. And while I have said that, let me continue to say that today the law practice has very greatly changed and you are to find yourselves in practice, I suspect, very largely as business thinking instruments, not just on legal questions but your success at the bar will be measured as well by how soundly you advise

your clients on practical matters that have not much relationship to law. And if you do that, well, then your clients out of appreciation will be wedded to you throughout your lives and then accumulating in a practice, though slow, is certain.

"Now, my friends, I have prepared a few remarks, formal remarks to make to you here. I will now turn to them. They are attuned to what I have said, particularly to what I have said about the superior quality - nature, rather, so far as practicalities are concerned, of the character of your education in law schools. Can anyone reasonably believe that the fundamentals stated in the Ten Commandments are outmoded? Can any society that takes or tolerates that view survive? In all recorded history, none ever has, and I am sure that the great majority of us believe that none ever will because those fundamental rules are laws of God which men dare not defy without suffering ruin.

"I hope you will agree that the few thoughts which I shall express here today rest upon more of a foundation than nostalgia for the good old days, and that you will find them instead to rest upon those divine fundamentals, just as do the Constitution and laws of the United States which, as you know, only expound and implement those fundamental principles. Through propaganda and other consciously distorted uses of good generic terms in our language, our thinking process and our ability even to communicate with certainty have been and are being seriously impaired. Even education in our schools and more particularly in many of our colleges and universities, but not to law schools, thank the Lord, is increasingly lacking in the genuine, the practical, and the patri-

"Back in the days of my own youth and, indeed, until the last decade or two, the word "square" was one of the most honored in our language. Honest men were "on the square" and they gave their neighbors a "square" deal. Their dealings were "fair and square" and when a hungry man came to their door they proudly gave him a "square" meal. They stood "four square" against those who wilfully violated our laws, and when they got out of debt they were "square" with the world. They could and did

look their fellow men "square" in the eye.

"But more recently a lot of strange characters have gotten hold of this honest and wholesome word and have simply bent it all out of shape. Now, everyone knows what a "square" is. In his excellent recent article titled "Let's Dare to be Square" Mr. Charles H. Bower of New York pungently told us that a "square" is a man who has never learned to get away with it, a Joe who volunteers when he doesn't have to, a poor guy who gets his kicks from trying to do something better than others do it, a poor boob who still gets all choked up when the band plays "America, the Beautiful"; such a one is now "square" and some would relegate him to the heap of forgotten things. That, at the very best, his tribe has ot thrived too well in the curt climate—says Mr. Bower ne doesn't fit into the current group of anvil players, corner cutters, sharp shooters, of-offs because he is burdened own, he says, with the old-fashioned ideas of the Ten Commandments - honesty, loyalty, patriotism, courage, and thrift and he concludes he may already, indeed, be on his way out. It can hardly be denied that he and the rest of us are now living in quite a different country than the one we were taught as youngsters to respect and love,

"Now, these changes have come largely because we have been gullible patrons of the idea that our efficient disciplines should be abandoned at the start for the poor feeble souls we are thought to be. Our colleges are loaded with youngsters, and you know this from recent experiences of your own, who are hardly prepared for high school, who cannot do simple arithmetic or spell the simple words, and this, in turn, has been largely because of the new idea that the 'dull disciplines of the three r's has been thought to be disturbing to little Johnnie's ego. In only a few of our schools, and in even fewer of our colleges and universities, is any real instruction given upon the proper use of even punctuation. It is almost a dead and lost art, and it is a crime, for some of us believe it to be the best catalytic aid to the distillation of clarity and precision in thinking and writing; it smokes out the bugs. And

just one or two decades ago.

these failures have at least made their contribution to the fact that only a very few of our college students are able to compose even a three-minute original essay of passable quality and free from significant grammatical errors. These are facts. But not in the law schools! There you have got to do some original thinking and real work and get down to empirical things that count — how much an aid it would help, had you been a little better prepared below.

"Even worse, to my way of thinking, simple patriotism seems to be a forgotten subject in our schools and colleges. Very little of our history that produced the reasons for many of the provisions of the United State Constitution is being taught to our youngsters outside of the law schools. Indeed, few of them have been taught or know the fundamental principles of the Constitution, to say nothing of its specific provisions. As a result, many do not even know that our national government was designed by our founding fathers to have only the limited powers expressly given by the Constitution, which it states to the national government are prohibited to the states thereby, and that all other powers were specifically by the Tenth Amendment reserved to the states of the people, and that therefore our nation is really one of separate and independent sovereign states in whom is vested all powers of government, save only the few that were delegated to the national won through the Constitution by the states and the people. Instead, they ap r to be-lieve that the powers of our national government are all embracive and that it lawfully may do whatever is wishe in office for the the being, simply because such powers are modernly assumed and sadly, I must say, are sometimes exercised, and our youth simply have not been taught the facts except in law school, and that does not come to all of us nor as early as it should.

"Little, if any, disciplined instruction upon patriotism is given in our schools and colleges. You know that. And it is less and less as time goes by. We ought to know by now that there will be little learning without disciplined instruction. I pause to deviate from my text. Recently at a well-regarded state university where, after having spoken upon a like or similar theme, a very nice looking, apparently intelligent young lady stepped up to me and said. "I must disagree; we are a nation," she said, "a soverign nation. And I said, "Yes, we are, but we are a sovereign nation of sovereign independent states." "Oh, no," she said, "you better get yourself better informed."

#### (Laughter)

"Now, there is a fair example. She was not a beatnik. She was a young lady really interested in education, but she had had the wrong kind of education, and I paused only then to say, "Young lady, I wish you well, but I fear you cannot educate me on constitution law," (laugh-

ter) and it had by this time also been evident to me that in her state of mind I could not educate her so there was no profit in the continuation of that di-

alogue.

"Today almost anything goes and is accepted. Even the preachments of the far outs and of the sick pseudosophisticates, as stated by Mr. Brower in his excellent article earlier mentioned; today non-books are being thrown together by nonwriters who never bothered to learn how to write. And you, as lawyers, must learn how to write and write well. Say what you mean with single meaningness, "Our museums," he said, "are exhibiting paintings by people who never learned to paint, and as to some paintings one cannot tell which is the top and which is the bottom." Now, indeed, I have noted that it was recently reported that a museum did hang a bit of modern art upside down in New York and it was days before the error was discovered and we were not told and indeed I cannot tell you how they found it out. (Laugh-

"Now, these comments, my Brothers, I suppose will mark me, too, as a "square" but if they do it is not going to worry me. It will be all right. I accept it with glory, for that puts me in pretty good company. Our freedom was gained by "squares" and our government, parenthetically earlier said, ever to be conceived by the minds of men — and I add my two bits, I think it still is, or could be was fought for, thought out, and established by "squares"; "square like Washington, Jefferson, Madison, Hamilton, Marshall, Jay, and now I come to some real patriots, Nathan Hale, Patrick Paul Revere, John Paul Josephs, and more recently, I cannot omit Abraham Lincoln.

"Now, it would be easy to demonstrate that each of these national heroes was a "square" if, instead of what he did do and say there could be atributed to him, as today's squares would do, the following: Nathan Hale: "Me spy on those British? Are you trying to be funny? (Laughter) "Do you know what they do with the spies they catch? (Laughter) "I will give you a news flash, chum; they just hang them. Not for me."

"Patrick Henry: "Sure, I am for liberty. But we have got to be a little realistic. We are a small outfit (laughter) and if we start pushing these British around somebody is liable to get hurt."

"Paul Revere: "What do you mean, me ride through every village and town in Middlesex? And in the middle of the night yet! When do you think I'm going to sleep? Why pick on me? I'm not the only man in Boston

with a horse." (Laughter)
"George Washington: "Sure, sure, it's all right to allow the Constitution of the United States to be amended by usurpation and erosion. It is not to matter that this is the means by which in past times constitutional governments have historically been destroyed. We have grown up now - and we are smarter, too.' "Thomas Jefferson: "Oh, yes, it used to be thought that the people should place no confidence in the beneficent promises of men but should bind them down from mistrust by the change of the Constitution. But these are modern times and emergencies now need to be held to create power, controlling power in the national government, even if such powers were in 1789 by some words in the Constitution reserved to the people in the states."

"Abraham Lincoln: "Oh, yes, you can now in the changed conditions of today bring about prosperity by discouraging thrift; you can strengthen the weak by weakening the strong; you can help the wage earner by pulling down the wage payer; you can help the poor by discouraging the rich. It is no longer true, so runs this philosophy, that you cannot establish a sound security by spending more than you earn. And today you can help men permanently by doing for them what they could and should be doing for themselves."

"Now, we could go on and on with this, but this is enough at least to serve the purpose of proving my point in establishing the proud base upon which I would stand with them as squares. It is significant that what those men actually did say on those subjects has been quietly removed from our school books. Why was this done? Not long ago This Week magazine compared school history books issued before 1920 with those issued since. It found that Nathan Hale's statement, "I only regret that I have but one life to g for my country," appeared in eleven of the old texts and in only one of the new ones. Patrick Henry's statement, "I know not what course others may ta but as for me, give me liberty or give me death," appeared in twelve of fourteen of the old texts, but in only three of the forty-five new ones.

"But John Paul Jones sets the record. His statement, "Surrender, surrender, I have not yet begun to fight," appeared in every one of the old history books but not in a single one of the new ones. Not one.

"Now, I wouldn't attempt, my friends, to deny that those patriotic statements were square, but aren't there good patriotic lessons to be learned in all of them? And was there any good reason for taking them out of the school books? Surely, the history of Rome, the eternal city and the greatest and most cultured empire ever conceived even to this day and built by men, even to this day contains a lesson for us. The first part of that history was a long and illustrious one, one of continuing rise to great influence, affluence, and power. But there was a second and a shorter part of it, and that is that rather suddenly it fell apart. "It fell apart," wrote the great historian that was given in 1788 and therefore just one year before the ratification of our Constitution, "for five basic reasons, namely: One, the rapid increase of divorce which undermined the dignity and

sanctity of the home and its instructions to its young; two, higher and higher taxes to fund the spending of public money for free bread and circuses for the populace; three, the mad craze for leisure and pleasure; four, the building of gigantic armaments to defend from an external enemy when the real enemy was within, namely, the decadence and immorality of the masses; and five, the decay of religion, faith fading into phenomena, its exponents departing as opponents for the political platform and thereby losing the respect of the people, and hence the power to guide their morals. Gibbon's interpretations are self-explanatory and further comments upon them would only confuse the facts.

"Arnold Toynbee, the great historian, tells us that of twentyone notable civilizations, nineteen perished not from external conquest but from internal ap-

athy and decadence.

"In 1765, and therefore slightly more than 200 years ago and also fourteen years before the adoption and ratification of the United States Constitution, a scholar writing about the decline and fall of the Athenian Republic said, "A democracy cannot survive as a permanent form of government; it can only exist until the voters discover that they can vote themselves largess out of the public treasury. From that moment on," he says, "the majority always votes for the candidate promising the most benefits from the public treasury, with the result that democracy nearly always collapses under a loose fiscal policy." I would like to help you to prove him wrong. Don't you think it is worth while? What he did not say, but is obvious to all who read, is what a very honored senator from Missouri, the Honorable James A. Reed, said many years ago and in my presence and it will always remain in my memory, "While the most important consideration to an elected federal and competent official is keeping his coattails in contact with congressional mahogany," and he concluded, "he will do almost anything if there are enough votes in it." But the failure to point out the fact is probably not significant here, or to intelligent people who read, for it can hardly be news. News to anyone who has been reading newspapers, particularly in recent months and days, that the welfare of the country and the people is secondary to personal political considerations, as witness the rethe remedial executive and constitute congressional action is critically needed in certain fields, all admit it — well, this is the statement you read - no action can be expected or will be taken until after the elections. And it seems to me that we are almost constantly confronted with some election. Hence, that the interests of the people, save those of pressure groups and voting blocs, are pretty well stymied.

"A number of historians have reminded us that the average life of the world's great governments has been 200 years. Ours is now about 178 years old. It simply isn't safe to say that what happened to other governments cannot happen here. Certainly, it could. Certainly, it could happen here. Hope of contributing something toward the prevention of that catastrophe for that is what, to me, it would be — is my only reason for appearing here and speaking to you now and to ask of you, as I would like the privilege of doing, to think deeply about these matters, to revive and quicken your patriotism; you, the upcoming generation of young life in the law who will be leading our country, and ask you to arise and join in the vigorous defense of the ageless and changeless fundamentals.

"Recently Mr. Howard W. Casev. President of Acacia Mutual Life Insurance Company of Washington, closed an excellent public speech in these dramatic words in which I think every PAD will agree: "God help the land where every day its wealth increases but its morals decay." History proves the greatness of this truth. Men simply cannot live crooked and think straight. All history shows that the struggle between good and evil is eternal. I, for one, believe that the fundamentals embraced by the Ten Commandments upon which our Constitution and laws are based and which they only implement are the good and that the contrary is evil.

"I therefore would ask you to respect, obey, and carry out and support the law and when you take oaths, as many of you will, don't take them out of the corner of your mouth but straight from the heart and mean what you say, and when you s protect, serve and defend the Constitution of the United States you do not mean secretly to cut

her throat. "We now have a whose new set of "evils": Named Glenn, Grissom, Sheppard, Carpenter, Schirra, Cooper, to mention only a few. The little towns in which they lived and grew up were far away from the big cities, and so they grew up to be "squares." For who - who but a square today would volunteer his life for the good of his country? They are not ashamed of their feelings or their humble beginnings. They, not society, built themselves up. Not handouts. They are independent men of honor and ability. And John Glenn says that he even gets a funny feeling down inside today when he sees the flag go by. Imagine that, in this day!

"I hope that some of him rubs off on you, on this generation and the next. Too many of us are still sitting it out instead of sweating it out, and I think that it is time that we who are ready - and in our hearts and minds supporting the ageless and changeless fundamentals—stand up to challenge the sick pseudosophisticates and their acceptors and publicizers who share a measure of guilt, who threaten to run away with and to destroy our beloved country, that we stand up straight, courageously, and seek — not dare — to be counted as "on the square."

"Thank you! Thank you for listening."

### CRAMER INITIATED

Brandeis Chapter as an honorary member.

Brother Cramer represents the 12th District of Florida.

He was born in Denver, Colorado in 1922 and moved to St. Petersburg in 1925. He attended public school in St. Petersburg and was president of the St. Petersburg High School Student Government. He attended St. Petersburg Junior College and was elected class president.

Brother Cramer graduated from Harvard Law School in 1948 and received an honorary Doctorate of Jurisprudence from Tampa University in 1957.

He served in the Florida State Legislature from 1950 to 1952 and was the first minority leader of that body. In 1952 he was the Republican nominee for the United States House of Representatives and was defeated by a narrow margin. From 1953 to 1954 Congressman Cramer served as County Attorney for Pinellas County.

Congressman Cramer has been active in the Republican Party. This time it wasn't snowing . . . and the Bunnies were hopping in full spirit . . . somehow it seemed a bit unfair for the Board and District Justices to be the only Playboys . . . students certainly would have been better cotton-tail admirers! . . . although the ardor of **DISTRICT II JUSTICE "PANCHO" WORTHINGTON** was difficult to restrain.

But we're ahead of our story . . . food . . . excellent, unbelievable, gourmet food . . . was the key to this Convention . . . and the password to the food was that classic bit of personal research done by District VI Justice DON HUTSON, our jovial host. Following Don's advice, the Supreme Executive Board began the week on Sunday evening across the street at Brettons . . . a place found by others later in the week. At various times hereafter for the remainder of the Convention, delegates could be found scattered about Kansas City and environs . . . clutching one or more pages of Don's 3-page masterpiece . . . ALEX HARFER (San Diego Alumi) making a mad taxi dash across town to the Black Angus just at closing time . . . SUPREME SECRETARY ROHR crest-fallen because Oyster Bay didn't have any oysters . . . FRED RICCARDI and DAVE HAFT (McCormick) checking out The Place in Westport . . The Levee full of thirsty music lovers . . . and we think we saw JIM JACKSON, (Cole) and his bride at the Golden Ox . . . that's right, his bride! It was a longer Convention than ever before . . . four days for general business . . . preceded by two days for the Board and District Justices. That gave lots of time for sightseeing and enterainment as well as work . . . and the ladies' program was outstanding. BETTY HUTSON had something for everyone . . . starting with lunch at Putsch's . . . ending with a tour of Swope Park Zoo and a picnic . . . and naturally filled with shopping in between . . . But not all the ladies got to enjoy the fun . . . PHYLLIS ANDRESEN did her usual magnificent job of keeping the Convention running, ably assisted by her daughter SHIRLEY . . . who did manage to have time to share her evening off-hours with several of the more observant delegates. Delegates' social activities were a bit too numerous to try to keep track of . . . from the Reception on the Starlight Roof on Tuesday evening . . . with District I Justice JOE ZIMMERMAN acting as unofficial photographer . . . specializing in unglamorous poses . . . through the hazy Continental Breakfast the following yawning . . . to the Banquet Saturday night. Highlight of the period in between was the Thursday evening Convention Dance . . . with the customary . . but this time oustandingly attractive . . . blind dates. Most all the delegates were pleased . . . probably because they didn't have quite the luck of KEITH HABERMAN (Ryan) . . he drew a practicing member of the local WCTU. Supreme Tribune GEORGE NICKELL . . traditional Chairman of the "Surplus Committee" . . . found little to do . . . which means that all blind dates were accounted for with no surplus for George's attention . . . as usual he was assisted by Chief Tribune CHARLES DI GANGI . . . who was still remembering that Bunny whose flashlight angle induced him to buy another round of drinks . . . and we say "round" advisedly.

In retrospect, it was a Convention of fun . . . as well as constructive accomplishment. From the intimate cocktail party hosted by Supreme Justice ELDEN MAGAW and his gracious wife Mildred . . . to the Western Barbecue . . . complete with GERALD BROWN (Edmonds) in cowboy boots and sidearms . . . it was a week of fraternal good fellowship.
