Ward Elevated To Illinois Supreme Court

Brother Daniel P. Ward, an alumnus member of Story Chapter was recently elected to the Illinois State Supreme Court.

He obtained his law degree from DePaul Law School in 1941 and served on the faculty of Southeastern University from 1941 to 1942. From 1948 to 1954 Brother Ward served as Federal Prosecutor during which he served as Chief of the Criminal Division. In this capacity he directed the administration of all criminal matters in the northern district of Illinois. Brother Ward served as Dean of DePaul University Law School from 1955 to 1960 when he was elected as States Attorney. He served in this position until his recent election to the Illinois State Supreme Court. In 1964 he was named the nations outstanding prosecutor by the national District Attorneys Association.

Brother Ward is a member of the American Bar Association where he serves on the committee on fair trial — free press, member of the Illinois, Federal and Chicago Bar Associations, former president of the Illinois States Attorney's Association and former vice-president of the National District Attorney's Association.

Supreme Officers' Seminar Held in D.C.

A combined meeting of the members of the Supreme Executive Board, District Justices and Supreme Tribunal was held on February 24, 25 and 26 in Washington, D.C. at the Mayflower Hotel, site of the 1968 National Biennial Convention.

The meeting, held at the call of Supreme Justice Robert E. Redding, provided an opportunity for the groups to meet jointly in the Supreme Officer's Seminar and separately in the annual Supreme Executive Board Meeting and the District Justice workshop.

All of the Supreme Officers, Supreme Tribunal and District Justices, with the exception of Professor Ross Tisdale, were present for the meeting. Brother Tisdale could not be present because District V was holding its Conclave on February 24 and 25.

The meeting of the fraternity officers commenced promptly at 8:00 a.m. with a joint breakfast. Following the breakfast, everyone in attendance listened to committee reports on expansion and finances. It was reported to everyone's pleasure, that \$.89 out of every \$1.00 received by national, from the initiation fee is returned in direct benefits to the active chapters. The growth of the fraternity was also dramatically shown by the information that the fraternity's revenue has doubled in the last five years and the fraternity's reserves have doubled in the last three years. In addition, initiations have doubled in the last five years.

The next item on the agenda consisted of reports from each of the District Justices. As each District Justice reported on the strength of the active and alumni chapters in his District, it became apparent that the fraternity is stronger than ever before. Boasting over 50,000 members, 105 active chapters and 56 alumni chapters.

The District Justice Reports

were so extensive that they occupied all of the morning session and most of the afternoon. During the rest of the first day's session the PAD Tool Kit, Endowment Fund Loans and a review of Chapter forms and supplies were discussed.

There was so much work to be completed at this meeting, that the Supreme Executive Board adjourned briefly for dinner and then returned for the first session of the Supreme Executive Board Meeting, which commenced at 7:00 p.m. on the evening of February 24. The meetings of the Supreme Executive Board continued into the late hours of Friday evening. The Board then reconvened for an all day Saturday session and concluded its business with a Sunday morning session.

During these extensive meetings many items of fraternity business were discussed and resolved.

PAD Inns of Court Program

Recently, Jay Chapter continued its "Inns of Court" Program with a seminar conducted by the Honorable Richmond B. Keech, a PAD and senior judge of the District Court, District of Columbia Circuit, as moderator. The other two participants were Thomas A. Flennery, Esq., noted Washington defense attorney, and Judge William Bryant, also of the U.S. District Court for the District of Columbia Circuit. The area for discussion was preparing a criminal case for trial.

Judge Keech began the seminar by congratulating Phi Alpha Delta and its "Inns of Court" Program covering etiquette, ethics, and conduct of attorneys regarding adversary proceedings. Judge Keech reminded us that there should be no conflict between representing the client in court and ethical, courteous conduct before the court. As he said it, "You attract more flies with sugar" he remarked that over zaelous conduct on the behalf of attorneys before the court in a criminal trial tended to antagonize the court and the jury against the client and would do him irreparable harm.

Law School Enrollments Grow 5%

Law schools with American Bar Association approval enrolled five per cent more students in September, 1966 than the year before, according to figures in the ABA's annual Review of Legal Education.

Enrollments reached a high mark of 62,556, compared with 59,744 in 1965.

However, there were signs of a slowdown. First year students numbered 24,077—a drop of 90 from 1965. The decrease occurred despite the opening of three new law schools last year.

"It is apparent that the schools are becoming more selective in their student admissions," said John G. Hervey, adviser to the ABA Section of Legal Education and Admissions to the

Including enrollments of 5,565 in 16 schools without ABA approval, overall 1966 law student population rose to 68,121. The comparable figure for 1965 was 65,057. Fourteen unapproved schools failed to report enrollments.

New lawyers grew in number by nine per cent in 1965, accord-National Conference of Bar Examiners. Admissions to the bar reached a new high of 13,109, compared with 12,023 in 1964.

Loans to law students under an ABA-guaranteed fund passed \$2 million for the 1966-67 schoolyear. More than 1,700 students have received loans since the fund's establishment in 1964. The First National City Bank of New York makes the loans upon approval of applications by the student's dean and by a special committee of the ABA.

Law schools opened last year at the University of California at Davis, the John F. Kennedy University at Martinez, Calif., and the Florida State University, Tallahassee.

The number of schools conferring the Juris Doctor degree instead of the LL. B. has increased to 66.

ABA Studies Transportation **Industry Strikes**

President Orison S. Marden of the American Bar Association announced the memberof a nine-member ABA special committee to conduct a major study of national strikes in the transportation industries. The study will seek means to avoid "disastrously adverse effects on the economy and welfare of this country" resulting from such strikes.

Chief Judge Charles S. Desmond of the New York State Court of Appeals, who retired from that post December 31 after a quarter century of judicial service, was appointed chairman of the study committee. Its other members are lawyers knowledgearbitration procedures, and labor-management relations.

The study, to begin at once, was authorized by the House of Delegates of the American Bar Association on the heels of last the special committee said existing federal legislation and strike settlement procedures "have proved repeatedly to be inade-quate to protect the public in-terest."

"Various proposals to provide more effective remedies and procedures, protecting the interests of the public as well as the rights of labor and management, have been made in the Congress and in this Association, and it appears that these and other proposals will require the most thorough and objective consideration," the resolution said.

The House of Delegates direct ed that the study embrace rail. roads and shipping industries as well as the airlines. The special committee's findings will be reported to the ABA Board of Governors and then in turn to the House of Delegates, the policy making body of ABA. President Marden said the study may be completed in time for House of Delegates action at ABA's 90th number of teachers fails to keep annual meeting in August of this year in Honolulu.

District V Conclave) The Seminar included extensive discussions of Fraternity activities in many fields, primarily to (1) assure greater understanding and effectiveness of the seven new District Justices, (2) bring about a rededication and fresh resolve of the other District Justices and Supreme Officers, and (3) enable the Supreme Executive Board to important Fraternity transact business. We can report that all

three objectives were readily achieved. Some of the Seminar highlights were as follows:

1. Plans were completed for the 1968 Convention to be held in Washington, D.C. Because of ing to figures released by the the very favorable reactions of the delegates to the Kansas City Convention, the same basic fourday format will be used on August 28-31, 1968.

2. The 1970 Convention will be held in New Orleans.

3. This is the first year in which all 15 districts will hold District Conclaves. We are very proud of this. Recognizing the vital role of Conclaves in our continuing growth and development, however, it was agreed that special studies of their strenghts and weaknesses should be pursued.

4. The financial condition of PAD was reported to be excellent, with deeper insight now available from the results of the financial stability survey conducted by Supreme Treasurer Rae.

5. A professional activities survey is also being completed by Director of Professional Activ-

ALSA NEWS EVENTS

The annual cost of obtaining a legal education has gone up nearly 110% from 1956 to 1966, according to a recent study of the American Law Student Associa-

During the first five-year period of the decade, tuition rates climbed 47%. And, from the 1961 average of \$175, the tuition continued it's upward pace to the present \$1,013—a 42% boost.

Illustrative of the rapid rise in law school tuitions, according to the ALSA survey, is the fact that in 1956 cnly one law school posted a tuition of \$1,000. On the other hand, 1966 saw no less than able in labor law, mediation and 69 of the 135-ABA approved law schools levy a charge of \$1,000 or more for the year. Several schools are pushing the \$2,000 a year mark.

summer's protracted airlines charts the tuition rates for the strike. The resolution creating ABA-approved law schools during 1966, 1961 and 1956. The individual percentage increases for

each school are also listed.

Medical School Comparison

To establish a point of comparison, the ALSA study also examined the medical school tuitions during the same decade. The cost of medical school is generally higher than law school, as is to be expected. However, the medical school tuitions have increased only 62% in the last ten years. Tuition rates rose only 27% from 1956 to 1961, and again by the same amount during the next five-year period to 1966.

In 1956, a medical student's education cost him 78% more than a law student's schooling, according to the ALSA. Today, however, soaring law school tuitions have closed the gap to 38%

Student - Teacher Ratio Not Keeping Pace

While law school tuitions spiral upward, the studentteacher ratio is falling off as the pace with the growing student (Continued on Page 10)

6. At the urging of Supreme Vice Justice Clark, the Supreme Executive Board agreed launch a Fraternity-wide program for the defense of the indigent and to provide trial experience for law students by a new system of "Advocate Clubs" in all active chapters. We will also encourage all active and alumni chapters to participate in Law Day activities everywhere.

7. The Supreme Executive Board also spoke out in defense of respect for constituted authority so necessary in this period of widespread civil disobedience. All active chapters will be encouraged to provide volunteer speakers for public schools, civic groups, and other public gatherings under bar association or other appropriate auspices.

8. Many constructive proposals by Supreme Advocate Rohr and District Justice Van Horn to increase the effectiveness of both faculty and alumni advisors were approved.

9. We are heartened about our continual progress in faculty relations. We are proud to report that Brother Wex A. Malone, Professor at Louisiana State University Law School, was recently elected President of the Association of American Law Schools.

10. Nine of the participants in the Supreme Officers' Seminar were admitted to the bar of the United States Supreme Court in group admission ceremony. a group admission ceremony. Later this year, on May 29, we hope to institute an annual "PAD Day at the Supreme Court" and hereby invite all PAD Brothers to a similar admission ceremony.

11. We have long awaited a 'break through' in the area of alumni service. It was delivered at the Seminar by Supreme Marshal Hutson and District Justice Giblin. Many steps are planned, including special contacts with all PAD graduates, a new system of alumni awards and manuals, Reporter "Want Ads," a study of student, professor, and judicial exchange programs with foreign countries, and an effort to expand PAD judicial clerkships.



Judge Arthur K. Marshall, an alumnus member of Ross Chapter was recently appointed District Justice for District III.

Brother Marshall is a Judge of the Los Angeles County Superior Court. He received his LL.M. Degree from the University of Southern California and has served as a member of the faculty of the Graduate Division of the University of Southern California School of Law since 1953. He is a former professor of law at U.C.L.A.

Brother Marshall is active with the University of Southern California Law Alumni Association and is serving ts member of the Board of Directors and Secretary of the Association.

The new District Justice has also been active with the American, State and local bar associations. He is a former member of the committee on probate of the American Bar Association, committee on taxation of the State Bar Association and member of the tax and pleading committees of the Los Angeles Bar Association. He is presently a member of the probate committee of the Los Angeles Bar Association.

His literary accomplishments include: author of "State and Local Taxation Forms Text"; author of "Pr of "Probate Handbook"; co-author of books on family law, California Court Procedure and annual survey of California Law; and author of numerous articles, the last being "Triple Choice Method." He is a former president of the Santa Monica Bar Association and Westwood Bar Association.

In addition to teaching, Brother Marshall was in private practice for six years; former Commissioner of the Superior Court for eight years; former inheritance tax attorney; for-mer tax counsel for the State Board of Equalization and former Judge of the Municipal Court of Los Angeles.

As Judge in the Los Angeles Superior Court, he served as presiding judge for the pre-trial department and presided in the probate department. He is now in a general trial department.



Jay Chapter Sponsors Langston Reception i

On a recent snowy Washington evening warm fellowship prevailed inside the Caucus Room of the old Senate Office Building as Jay Chapter held a reception for the new Langston Chapter of Phi Alpha Delta Law Fraternity.

Following introductory remarks by the Justices of Jay and Langston Chapters, Professor Jerome Barron of George Washington University introduced Charles T. Duncan, new Corporation Counsel for the District of Columbia who spoke to those present on the opportunities in the Corporation Counsel's Office.

He told those in attendance that the office is a hybrid product due to the particular nature of the federal city. He said that the corporation counsel acts like a state's attorney in rendering binding legal advice to the parole board, the various licensing authorities, the alcoholic beverage control board, the school board and the unemployment compensation board and in addition, he acts like a city solicitor in supervising city leases, civil actions on behalf of the city and in prosecuting minor traffic and other ordinance offenses. In addition he pointed out that the corporation counsel practices international law in relations with the great number of foreign embassies located in the city.

Mr. Duncan categorized the work of the office into five divisions including the rendering of legal opinions to the District of Columbia government agencies; settling of claims against the city for vehicle, "slip and fall" injuries conducting civil litigation on behalf of the city before the case on the constitutionality of the city government; preparing legislation for submission to Congress; and acting as 'ombsudsman" in trying to develop good public relations between the office and the city. The last function is one of Mr. Duncan's creations. He feels someone ought to be available to listen and act to the myriad complaints running from poor trash collection to a plea for licensing cats to the classic "why do I keep getting parking tickets?"

He remarked that to his surprise he found the general social life of the law school more quality of lawyers in the office enjoyable and more meaningful. to be extraordinarily high. The Such activities in conjunction office employs sixty-seven lawyers thus making it the second largest "law firm" in the

In responding to questions, Ir. Duncan said the complexion of the personnel within the District was changing gradually to younger men and women more attuned to the problems of the District and the needs of the urban populace. He said he was trying to have a night court established for the convenience of the employed. He felt that landlord tenant laws would be changed more by judicial action than by legal alterations from Capitol Hill.

Mr. Duncan generally agreed with the crime commission's report of poor quality law enforcement in the City, saying the answer lay in speedy law enforcement as well as in social problems. Criminal prosecutions take too much time, he said. "I am utterly opposed to relaxing constitutional safeguards for the sake of law en- given time period.

Dakin Supervises Research Project

Brother Melvin G. Dakin, an alumnus member of Hammond Chapter, and professor of law at Louisiana State University Law School, was recently named to supervise a two year research program on expropriation law and practice. The project is designed to make more readily available the law of expropria tion as developed in the appellate courts in recent decades.

The study is supported by funds from the United States Bureau of Public Resources and by the Louisiana Highway Department.

Brother Dakin said, "It is probably safe to say that in terms of dollars and economic impact, the highway building program is one of the prime economic factors within the state.' Highway construction particularly the federally aided interstate program has brought large amounts of federal money into Louisiana and the program has also drawn large proportions of the State's annual budget." In addition, Brother Dakin said that funds from both sources seem destined to increase each

He pointed out that an important part of the cost of any highway program is the right of way acquisition and that this is becoming increasingly true as more highways are built which serve all the public instead of serving only the abutting property cwners. In such situations, he pointed out, no right of way donations occur.

The work will entail analysis of the factual and legal situations involved in the expropriation cases previously decided. Identifying legal principles and the distinctive factual situations to which they are applied. The LSU Research is actually to create a tool by which the lawyer can better find how, where and when the legislature and the courts have said what the law

is. A major aim of the research project is not only to provide a compendium of eminent domain law for use in preparing expropriation cases for trial and appeal, but to make studies in depth of existing statutes and procedures which could result in improved administration of eminent domain law in Louisiana.

CRIME AND MENTAL ILLNESS PANEL SPONSORED BY HICKMAN CHAPTER

Hickman Chapter recently sponsored a panel discussion on "Crime and Mental Illness."

The panel explored the role of the concept of mental illness in the administration of criminal justice focusing on three identifiable stages of the process. These stages were the issue of fitness to stand trial, the issue of criminal responsibilty and the disposition of persons found unfit to stand trial or found not responsible because of in-

The panel considered the verbal formuli tests or standards presently used or proposed in resolving the issues; the nature of the actual or real underlying issues involved in the questions posed in each of the three stages of the proceeding; the role of the psychiatrist and other expert testimony; and the role of the court and the jury.

The moderator for the panel discussion was Burton C. Agata, Associate Professor of Law at the University of Houston. Professor Agata received his J.D. Degree from the University of Michigan and his LL.M. Degree from New York University. He practiced law in New York as counsel for the New York State Banking De-

His subjects include criminal law and constitutional law.

The panelists included Professor Newell H. Blakely; Attorney Clyde Woody; Dr. Sanford Goldstone; and Dr. Richard I. Evans.

Professor Newell H. Blakely is presently teaching at the University of Houston's School of Law. He received his LL.B. Degree from the University of Texas and his LL.M. Degree from the University of Michigan. He has taught at the University of Houston since 1949 and was Dean of the law school from 1957 to 1965.

Clyde Woody is a practicing attorney who has been admitted to practice to all state and federal courts. He has prevailed in cluding Aguilar vs. Texas before the United States Supreme Court.

Attorney Woody told those in attendance that "any nut a law-yer defends will say he knows right from wrong." He also said that in considering a man fit to be tried if he knows right from wrong the state is following a 200 year old unrealistic approach which ignores the advance of medical science. He said the most human approach would be to consider that a man not in control of himself is not responsible - if he is not criminal in mind he is not punishable.

Dr. Sanford Goldstone received his Ph.D from Duke University where he served in the department of psychology as a clinical psychology intern.

Dr. Goldstone was a consultant to the Veterans' Administration Hospital in Durham, North Carolina and is consultant to the Veterans' Administration Hospital in Houston, Temple and St. Louis at the present time. In addition, he is professor of phychology at Baylor University College of Medicine and is head of the division of crime and de- atrist for the defense.

How PAD Chapters May Participate in Law Day

By Al Figinski, Past Justice of Darrow Chapter

First of all it should be said that the degree in which each chapter may desire to participate in the law day observance will be determined to a large extent by the scope of the present law day observance sponsored by state and local bar associations as well as the size, financial strength and standing of the chapter in the community in the law school.

Participation Within the Law School

Law Day observances at the law schools are generally handled by the school administration and student bar association. The scope of such program as well as whether or not classes are suspended on that day will determine the scope of the PAD program. In addition to any assistance which the local chapter provides to the student bar association in getting speakers and carrying off its program, the chapter may consider sponsoring a lecture or seminar with the aid of the local alumni. Specific topics such as professional ethics, lawyer as public servant, scope of legal practice would be appropriate for such lectures or semi-

Sponsorship of a banquet or luncheon not interferring or detracting from the student bar association sponsorship of such a banquet or luncheon would provide a valuable service in bringing the PAD actives and alumni closer together and in serving as a stimulus for encouraging alumni attendance during the law school observance of Law Day.

Outside the Law School

If the local bar association is not already assisting schools, colleges, civic and fraternal organizations and presenting adequate Law Day programs, it would be appropriate for the PAD Chapters, alumni and active, to work through the local association to provide aid trials, assembly programs and nity.

A mock trial using law students as participants with lawyers examining the procedures and techniques would be espeappropriate to school cially and other large assemblies gatherings to delude any false fostered by teleimpression vision trials.

Assembly programs at the neighborhood schools and colleges could take the form of a mock trial or they could include panel discussions on such topics as individual freedoms guaranteed by the Bill of Rights, responsibilities of the States citizenship or history of the legal system of the Untied States. The assembly program could also take the form of addresses by prominent members of the fraternity on such topics as origins of individual freedom, what courts do for the individual, respect for the law, world peace through world law and ethics.

A chapter may wish to design an exhibit for display in the downtown area. Such exhibit could be developed along the lines of the suggested topics noted above.

Irrespective of the particular activity chosen by the local chapter, the partiipation in observance of Law Day in and of itself will provide the individual chapter with good training and create a good reputato these organizations. Mock tion in the school and commu-

Brother McBurney overcame the awesome handicap of near total paralysis to become a successful lawyer and to win election as Dane County District Attorney at the young age of 29 years.

His short life was a success story before and after his paralysis. One of his proudest moments was last November when he was elected District Attorney. He was the first Republican candidate in eighteen years to win any of the eight Dane County elective offices.

The youthful District Attorney ran his campaign from a wheel chair, a place from which he saw his success since 1954.

In 1954 Brother McBurney suffered almost total paralysis when he broke his neck in a driving accident in Lake Mendota. After the accident he was left with partial use of his shoulders and arms but his hands and his body from his chest down had no feeling.

He completed his high school education, went on to college and finished law school with only the ability to move his shoulders and part of his upper

Cheerful and quick witted, Brother McBurney kept himself in the top 5% of his class. He was a sociology major at college and graduated Phi Beta Kappa.

Despite his physical handicap, he contributed articles to law reviews, edited the "Advocate." a semi - official, semi - humorous publication for law school alumni, wrote a bulletin on the legislatures activities for the Wisfilms of the past, and the Spring consin Protestant Legislative Topic for the Day" television

> He also found time to work three days a week in his father's law firm.

> He won the Joseph 'Davies Award and the Faculty Book Award.

He was graduated from law school in 1963 and joined his father's law firm McBurney and McBurney.

Brother McBurney used three electric wheel chairs and a van type truck with a hydraulic lift to get around.

His sense of humor never failed him. He lived with his parents and said he once remarked that he was happy that he "chose the right parents."

His other activities included Secretary of the Dane County Bar Association, member of the State Bar of Wisconsin, the American Bar Association, the American Judicature Society and the American Arbitration Association. He served as State Chairman of Governmental Affairs for the State Junior Chamber of Commerce.

BEROTH DIES

Brother Carl O. Beroth, an alumnus member of Webster chapter recently passed away.

He had practiced law in Chicago many years before entering the oil business in 1914. In 1917 Brother Beroth founded the Acme Petroleum Company in Chicago and remained with this company for 49 years.

When he recently passed away at the age of 85 years he was Chairman of the Board.

He leaves surviving a wife Lillian and a son Charles.

Lamar Chapter Initiates Legal Research Exchange

The brothers of Lamar Chapter recently initiated a legal exchange program at the University of Mississippi.

This program makes Mississippi's fine Legal Library available to all Mississippi attorneys who pay law students to research problem cases. The students learn at the same time that they earn money and the participating attorneys obtain top flight research and the cost of the research is entirely tax deductible.

The exchange's reports to attorneys include a search of up to the week reports and advance reports on recent cases as well as cases in progress.

The program has been highly successful and well received by the attorneys in the state. Lamar Chapter has had plenty of work to keep it busy.

In order to participate in the legal research exchange an at-torney contacts the exchange office with a problem for research. The case is examined, a student researcher is selected and briefed on the case. The research is begun after a deadline is set in consultation with the attorney. After the research is completed a report is made to the attorney. Each report is checked for accuracy and to see if it is properly documented before being typed in final form and turned over to the participating attorney.

The exchange is a little over one year old and now employes a part time secretary. It has a private bank account and separate bocks are maintained.

Attorneys pay \$4.00 per hour plus an exchange handling fee of \$5.00 per case for the services of the legal research exchange. This also includes a copying system which allows the exchange to send the attorneys exact copies of pertinent case material at a cost of ten cents per page.

The proceeds from the ex-

change are turned over to the University of Mississippi's Law Alumni Library Fund. They turned over \$500.00 last year

(Continued from Page 1) Judge Bryant reflected both on the lack of attention given

to criminal law in the law schools and the unfavorable image lawyers have in the eyes of the public because they repcharged with resent those crime. Judge Bryant, who was attorney for the defendant in the landmark case of Mallory v. United States, reminded those present of the need for total preparation of the client's case regardless of whether you were going to plead guilty, or not guilty, and proceed to trial. He also stressed the point that the lawyer should deal with all witnesses, the police, and the prosecuting attorney with all possible candor to gain their respect. He reminded us that when in the courtroom, the lawyer should always remember to separate what he knows as facts from mere beliefs or opinions in order to keep his case on the side of credulity. He concluded by saying that while deviation from norms of candor and courtesy before the court might be momentarily profitable, such conduct would irreparably harm such a lawyer in the long run and sully the image of the pro-

Mr. Flannery reminded us that the legal profession is an lie to a court or to a jury have no place in either the courtroom or the profession. He reminded us that the lawyer must be very careful in dealing of the Constitution, which effect with a client indicted for crime, particularly in the District of Columbia, where 14 per cent of those arrested are ever indicted. In other words, in almost every case, it is likely that your client is morally guilty, though he may not very well be legally guilty. This means that the lawyer has to remember two things. First, such a client is likely to lie to you in an at-tempt to avoid conviction, but secondly, even though the lawyer may think or know that the client is morally guilty, the lawyer has the right and even the duty to avail himself of every possible legitimate legal maneuver on behalf of his client. He also advised that the lawyer should never let the defendant tell you how to conduct his case if he wants to perjure himself; thus the lawyer should always be careful to protect both the defendant and himself. To reduce the possibility of the client telling a lie, Mr. Flannery recommended the following steps in the initial preparation of the case for the defendant. First, let the de-fendant tell his story to you before giving any advice whatsoever; otherwise, the client is likely to adjust his facts to fit the legal advice given him. Secondly, he reminded us that the lawyer has the right to question any witness whatosever in a criminal case. There is no such thing as a "government witness." Thirdly, after these steps, advise the client appropriately.

A questioning session followed which evoked interesting answers from the participants, was spiced with some sharp wit. Judge Keech posed a question regarding dealings with the news media, particularly in light of the Sam Sheppard case to which Judge Bryant responded that for a lawyer, he who lives by the newspapers dies by them. He recommended that the lawyer never talk to the press, whether prosecutor or defendant's attorney. As he put it, "I have an alergy to printer's ink." 

In response to a question regarding the practice in Britain of preventing the publishing of the facts of a criminal case until the trial is concluded, it was felt that such a practice was unfeasible here, in light of our traditions and notions regarding freedom of the press. The panel was then asked why a plea of nolo contendere under the Fifth Amendment as a half-way house between the please of guilty and not guilty could not be provided. The answer was that by not pleading a client "guilty," one could do the client a great disservice. Mr. Flannery said that the prospects of a "morally guilty" defendant being found guilty didn't particularly bother him. Under our system, the government should have to prove its case.

Judge Keech was asked if the up-town Gold Coast lawyers who act as part-time criminal trial lawyers have any ability in criminal law. Judge Keech responded by saying that invariably they did an excellent job because their "egotism and experience" required it of them. Judge Keech concluded the seminar by stating that even in a case where the evidence against your client is so overwhelming that you can "smell him burning" it is possible to gain the client's confidence and respect by dealing with the client honestly, and by doing a thorough job in his behalf.

In 1966, the median ratio was one teacher for every 18 law students. However, only five years ago there was a law school teacher for every 14 students, the same median ratio applicable in

Full-time and part-time faculty members were counted in computing the ALSA ratios.

From 1956 to 1961, student enrollment in law schools increased by 9%, and faculty forces went up 10%. However, since 1961, the law student population has ballocned by 51%, whereas the ranks of law school teachers have been expanded by only

(Continued from Page 1) fraternity were discussed and the Mayflower Hotel in Washington, D.C. was chosen as the headquarters hotel for the convention. The dates for the convention were chosen and will be August 28, 29, 30 and 31, 1968.

It was also resolved that the registration fee established for the 1968 convention be included as part of the subsistence allowance for the principal delegate from each active chapter.

Thereafter, the financial report for the General Fund and the Endowment Fund were presented and discussed and the financial condition of the fraternity was found to be excellent

The Supreme Executive Board considered the vast array of professional activities conducted by the fraternity. It resolved that the fraternity should undertake an additional program of proceeding in all proper ways to implement a program for the defense of indigent and to provide trial experience for students in law school within the limits of bar associations, and further to establish a committee to investigate procedures to accomplish these goals.

The Supreme Executive Board also discussed the value of chapter participation in Law Day USA and concluded that all measures should be taken to encourage such participation.

It was also concluded that Brothers can gain invaluable experience by speaking to organizations and concluded to encourage all active chapters to provide volunteer speakers through bar associations or other appropriate auspices to speak to public schools, civic groups and other public gatherings on the subject of legal traditions and respect for the law.

The vacancy established in the office of the Assistant to the Supreme Justice caused by the election of Brother C. Raymond Judice to Supreme Historian, was considered by the Board. There were two applicants to the position, Brothers Jerry Kaufman and Frank J. McCown. After considering the qualifications of both brothers, the Supreme Executive Board concluded that both would be accepted in the positions of Special Assistants to the Supreme Justice in lieu of choosing one as Assistant to the Supreme Justice.

The Distinguished Service Chapter award was considered and it was concluded that the recipient of this award shall receive a certificate and a lifetime waiver of the payment of alumni dues in recognition of his outstanding service to the fraternity.

Many items were considered of sufficient importance to be referred to committees for additional study. Among those, were the possibility of the national fraternity establishing a professor exchange program with England, Canada and Mexico; the possibility of establishing a student exchange program for graduate students with England, Canada and Mexico; the possibility of the fraternity sponsoring a judicial exchange program with foreign countries; the pos- value. sibility of sponsoring a judicial seminar team to travel throughout the country discussing the topic or topics of universal interest to members of the bar; and the possibility of conducting a survey of PAD judges to determine the availability of clerkship positions which could be filled on a basis similar to the Tom C. Clark clerkship program.

The question of placement was discussed by the Supreme Executive Board and it was concluded that a section of The Reporter should be reserved for available positions and positions sought and for selling of law books, furniture and other office equipment on a one year trial
