

Clark, Supreme Vice Justice, was absent because of ill health.

Sitting with the Board were Executive Secretary Fredrick J. Weitkamp, Herbert F. Smith and Special Assistants to the Supreme Justice Frank McCown and Jerry Kaufman.

Insurance Programs

The Supreme Executive Board thoroughly reviewed the insurance programs of the fraternity. After a complete discussion and after advice from the administrators of the plan, it was concluded that the premium rate on the PAD Life Insurance Plan would be reduced in the younger age groups.

ORGANIZATION OF THE LEGAL PROFESSION IN THE 1970's

Strong trends are at work in the legal profession as we approach the next decade of the 20th century. An analysis of past directions, plus a look at today's economic picture, indicate substantial restructuring in the way law practice will be organized in the 1970's.

In 1951, there was one lawyer for each 699 Americans; in 1967 one out of every 631 Americans belonged to the legal profession. Despite this rise in proportion of lawyers, a shortage in qualified younger men is apparent.

The ceremony began with introductory remarks by William Mitchell, Justice of Darrow Chapter at the University of Maryland. Brother Mitchell took this opportunity to briefly relate Darrow Chapter's history and its current activities.

PAD INITIATES SCHOLARSHIP PROGRAM

The Supreme Executive Board, at its recent meeting in Los Angeles, California, resolved to grant fifteen \$500 scholarships to be awarded to law students working in their last year toward an LL.B. or J.D. Degree.

The scholarships are not limited geographically but are available for national distribution depending upon individual need.

Applications for these scholarships during the 1967-68 school year may be obtained immediately from the

Executive Secretary. The application includes personal data including name, date of birth, fraternity chapter, law school, year in law school, number of semester or quarter hours comexpected date of graduation, school and permanent home address; scholastic data including overall grade point average in law school and transcript of school grades; fraternity activities including date joined the fraternity, fraternity activities participated in and offices held; law school leadership activities including activities and offices held in the law school government, law review and moot court and university-wide activities, organizations and offices; financial data including marital status, number and ages of children and other dependents, employment of applicant and spouse, income of applicant, parents' income, other scholarships, a list of assets, creditors and student loans; and other data including com-

ments by the applicant. The application must be certified by the Chapter Faculty Advisor that he has nominated the applicant for a scholarship from among those submitting applications at his law school. He will take into consideration scholastic excellence, service to the fraternity, leadership in the law school and financial need of the applicant.

The Chapter Faculty Advisor will be further requested to verify the grade point average and that the appli-cant is carrying a full load under the meaning of that term in the applicant's law school.

Because of the apparent financial need throughout the nation, the Supreme Executive Board resolved to implement this program immediately. Therefore, applications may be obtained by writing to Fredrick J. Weitkamp, Executive Secretary, 10722 White Oak Avenue, Granada Hills, California 91344.

Earl F. Morris, president of the American Bar Association, today called agitation a frequent factor in producing riots. He urged enforcement of present laws and, if necessary, enactment of new ones to control "the traveling in-

Morris, speaking in his home city at a Convocation of the College of Medicine of Ohio State University, described the traveling insurrectionist as a "man with no known address, who moves from city to city, subsidized by undeclared funds, shouting for revolution, inciting people to burn and loot and kill; a death-dealing gadfly of destruction." The Columbus lawyer said Maryland was pursuing the proper course in seeking to prosecute agitators despite general feeling that it is "difficult to obtain a conviction on a charge of incitement to riot."

Morris said riots are more profound than common crimes in their consequences to the country "because they go to the heart of democratic theory and prac-

"In tolerating, and at times even seeming to encourage, certain forms of civil disobedience throughout our history and most notably in recent years, we have wittingly walked a necessarily fine line between individual liberty and anachy. We have trod this path because freedom of the individual to do and say what he feels is right ha been paramount.

"But mob viclence has succeeded peaceful demonstration, and murderous turmoil has replaced calm negotiation. Much of the progress that has been made, and the civil rights that have been affirmed - in voting, education, employment and in access to public accommodations is being negated by mindless, thoughtless criminal action that has substituted anarchy for law and insurrection for order.'

Morris, who became the 91st president of ABA in August, said reasons for "the wave of insurgence" include "many of the conditions that breed all crime: crowded cities, restless youth, parental apathy." Beneath the surface the causes include "unemployment, poverty, inadequate housing, and all the fuming, mounting frustration that these circumstances create.

With these conditions, agitators either "in a quiet, private way" or "screaming" on a street corner, can provide "the spark that turns respectable people into insurgents." He added that "many of the people who ultimately riot are not poverty stricken, are not unemployed, do not live in slums.'

Morris said riots have given a new demension to the crime problem which he called the 'No I domestic problem in the U.S." Even before the outbreak of riots, he said, many considered "crime in the traditional sense assult, burglary muraer, rape, and larceny" as the nation's toppriority problem. The ABA president called for a massive public effort to curb lawlessness, "a disease gnawing at the innards of American society.

Saying there are "no easy answers," he called for: elimination cf the underlying causes of crime, such as poverty, commercial exploitation and racial discrimination; for the improvement of law enforcement agencies, their techniques and policecommunity relations; creation of citizens' organizations dedicated to the prevention of crime in all major cities: enactment of legislation to control firearms and juvenile delinquency as well as the Safe Streets and Crime Control Act; and development of "a new respect for law and order in this country.

Morris said it wasn't only the confirmed criminal, the juvenile delinquent, and the inciter of riots" who needed to develop respect for law.

"It is all of us," Morris said.

Message From The Supreme Justice

First, I extend my fraternal and cordial greetings to all my Brothers — active and alumni — and trust that all of you had a very enjoyable and relaxing summer. As we enter the 1967-68 school year, I look forward to another year of substantial progress in Phi Alpha Delta and welcome your continued cooperation

Elsewhere in this issue, you will read about the very fine PAD reception held at the American Bar Association Convention in Honolulu during the summer. In addition to the alumni who attended, our guests included a large number of the American Law Student Association delegates who were also in convention assembled.

I would like to report to you a highly productive Supreme Executive Board meeting on September 16-18. During the three day work session, the Board took action on more than 100 matters in 39 hours of deliberation. Ultimately, the motion to adjourn was enthusiastically approved and the gavel fell on a meeting of spirited yet effective discussion and action interspersed with fraternal good feeling amid a continual atmosphere of firm resolve to advance the Fraternity's declaration of purpose. The highlights of the Board meeting included the following constructive actions:

1. Approval of a nation-wide scholarship program, effective immediately, for the award of fifteen \$500 scholarships this year on an outright grant basis. This program will be financed without invading any of the Endowment Fund's principal and will enable us to continue the availability of interest-free student loans. The Fraternity is deeply indebted to the special scholaship committee members consisting of students John Klein and Stanley Kohn, Dean Frank Maloney, Associate Tri-bune Kenneth Segal, and Supreme Treasurer Sandy Rae, Chairman.

2. An annual nationwide effective speaking contest will be launched this year as a supplement to our existing program to advance the art of advocacy by our student members.

3. The "PAD Inns of Court" program, undertaken as a pilot project in Washington, D.C., last year, was approved as a national program, to be instituted this year in the cities of Chicago, Houston, Kansas City, Los Angeles, New York, and Philadel

phia. 4. PAD will take the lead in trying to create a new professional law inter-fraternity conference, to be convened preceding the biennial meeting of the Professional Inter - Fraternity Conference next March. It is hoped that this effort, to be carried forward by all law fraternity members of the PIC, will lead to the establishment of a "Code of Honor" applicable to law students throughout the na-


tion. 5. Several constructive actions were taken to enhance our PAD insurance program, including making a 20% increase in life insurance available and establishing a hospital money plan.

6. Many constructive actions were voted to expand our alumni program, as to which substantial progress was made last year.

7. The Reporter will announce planned creation of an the "Elder Statesman Club," with Past Supreme Justice J. Harry LaBrum as Chairman. This informal alliance of our many brothers in their senior years should help stimulate their renewed interest in Phi Alpha Delta and a stronger sense of participation in our many activities.

8. Considerable progress was reported in the development of a contemplated "PAD Plan" for alumni purchase of law office needs. It was decided, however, to give this ambitious program further study, with comments to be invited from the Supreme Advisory Board and all District Justices.

9. Three hours of discussion and important action hail the more effective and efficient handling of annual conclave planing and execution, an area which claimed the attention of a

special Conclave Committee consisting of Spreme Treasurer Sandy Rae, District Justice Bob Van Horn, Executive Secretary Fred Weitkamp, and Associate Tribune Don Moore, Chairman. This Committee produced an excellent report which formed the basis for salutary action at the Supreme Executive Board meet-

10. The meeting agenda included discussion of the need for formulating both short-term and long-term goals and objectives in Fraternity management. In the weeks ahead, further developmental eforts to adopt fiveyear and ten-year basic goals will continue.

11. It was previously decided to distribute the PAD Tool Kit among the alumni and faculty advisors to the active chapters. Because of the many requests received during the past year, the Supreme Executive Board decided to carry out its plan for such distribution to the alumni advisors, but to make the other additional copy available for the joint use of the faculty advisor and the active chapter justice.

12. Many actions were voted to strengthen the organizational structure of PAD, including convention activities. In response to the recommendations of many convention delegates, the appointment of chapter delegates to all convention outstanding committees (not including the Nominations Committee) prior to convening the convention will be made next year on an experimental basis.

13. In view of the fact that alumni chapter delegates will, for the first time, attend the 1968 Convention cost-free, the requisite eligibility rules were reviewed and reaffirmed, soon to be announced.

14. Detailed plans were approved for the 1968 Convention including a new fiscal control, namely, the submission for Supreme Executive Board approval by the Supreme Treasurer and Executive Secretary of a detailed convention budget by May 1,

15. All PAD's will be pleased to know that the 1970 Convention will be held at the Roosevelt Hotel in New Orleans on September 2-5, 1970.

16. There was extensive discussion of the status of active and alumni chapters in all districts, with particular attention to be given to the strengthening of active chapters during the fall visitations by Special Assistants to the Supreme Justice Jerry Kaufman and Frank McCown. Their visitations will also include efforts to re-activate five PAD active chapters and to explore the possible expansion of PAD at 17 law schools.

Approximately 130 guests, almost everyone in attendance, at the Southeastern Conference of the Association of American Law Schools at Charleston, South Carolina, attended the Phi Alpha Delta reception on Wednesday, August 23, 1967. Those in the receiving line included. Dean Frank Maloney, Dean of the University of Florida, School of Law; Charles Taylor, Representative to the North Carolina House of Representatives; Charles Randall, PAD Faculty Advisor of Pinckney Chapter; Wex Malone, PAD President of the AALS; Ben Scott Wahley, President of the South Carolina Bar Association; and Robert E. Redding, Supreme Justice.

At least 10 law school deans attended the reception, including the deans from the law schools at the University of Missouri, Stetson, South Carolina, Miami, Georgia, Texas Tech, Florida State, Duke, and the University of Florida. Also the Associate Dean from the University of Mississippi was present.

The conference was conducted from Wednesday, August 23 through Friday, August 25, 1967. Those present at the Conference faced such problems as how can the law schools meet the population explosion, examinations and grading in law schools, and civil disobedience as a political method in the United States.



Edward C. Sweeney, an alumnus member of Fuller Chapter, at Northwestern University, and President of the Explorers Club, recently succumbed at the age



Brother Paul P. Rao, Chief Judge of the United States Customs Court, was recently appointed Chairman of the Phi Alpha Delta Placement Committee.

The Committee is designed to give general guidance in helping graduating brothers prepare themselves for the legal profession and to formulate a constructive program of assistance to new members of the legal profession.

Brother Rao, a member of de-Bracton Chapter at St. John's University, obtained his LL.B. degree from Fordham University Law School and was admitted to the New York Bar.

He served as Assistant District Attorney from New York until he was nominated by Franklin Rosevelt as Assistant Attorney General of the United States in charge of Customs, a position in which he served until his appointment to the United States Customs Court in 1948. He was designated Chief Judge of the United States Customs Court by President Johnson in 1965 and took the oath of office from Mr. Justice Tom C. Clark on July 22 of that year.

He has been very active in the American Legion having been Chairman of the Legal Committee of the New York County American Legion for 5 years, commander of the Colonel Francis Vigo Post for 6 years, and a life member, twice Commander of the New York County American Legion, and honorary member of the New York County Press Association of the American Legion.

In 1960 he was honored as being the Grand Marshall of the Loyalty Day Parade held in New York by the Veterans of Foreign Wars, after having served as Honorary Commander of the New York County Council of Veterans of Foreign Wars since 1951. He is life member of the Admiral H. B. Wilson Post 196 of the Veterans of Foreign Wars.

Among the many awards and citations that Brother Rao has received are: Knight of the Order 40 islands.

Justice Clark Receives American Legion's Distinguished Service Medal Following are the remarks by Attorney General Ramsey Clark in accepting the Distinguished Service Medal for his fether Prother Justice Tom C. Clark, at the recent

for his father, Brother Justice Tom C. Clark, at the recent American Legion National Convention in Boston, Massachussetts.

"It is pardonable, I hope, for a son to be proud of his father. If not I am guilty of the unpardonable. June 12 was the last day of the past session of the Supreme Court and the final occasion on which my father will grace that great bench. Chief Justice Warren delivered a most laudatory statement of his contributions to the Court and to justice. In a brief response, Dad noted that if his father had been present we would have chuckled, perhaps laughed at what was there said — and not without a ring of skepticism; but, if his mother had been present, she would have smiled deeply — and believed every word of it.

"My son, Tom C. Clark II and I were there. We smiled deeplyand believed every word of it.

"Having been so blessed, l would venture the thought that few things more fortunate can come to a man than to have a truly great father.

"He is with us today in spirit though in body he is in Washington recuperating from an illness he has now overcome. He is deeply honored by this conference of your Distinguished Service Medal. He is a Legion member of three decades - proud of his association with you and of your good works. He is, I should note, a life member of the Department of Justice Post. Justice Clark is grateful and extends through me his appreciation. Our whole family thanks you.

"In an address in 1964, Justice Clark said:

. . what we call justice but reflects the moral fibre of the people, their character, their courage, their perceptiveness, their faith. That is because no system of justice can endure that is not based upon supremacy of the law. And the supremacy of law in turn depends upon its commanding a wide consensus among the people. In the end only that provides security in a free society.'

"Today the consensus is not wide enough. Lacking in the hearts of too many Americans is that respect for the rights of others which is the foundation of the rule of law. Abraham Lincoln said that if ever our nation should fall it would be from within. Lawlessness from within can destroy a nation which no force from without could ever overthrow.

"The American Legion, its members, and the millions who have served their country in time of war have assured to all of our people their opportunity for ful-fillment if they, left to them-selves, have only the capacity for justice. What greater tragedy can history hold than the loss of such an opportunity? What greater weakness can society show?

"If this chance is lost, then those brave men who fought for our freedom in the wars against foreign enemies fought in vain as surely as if those wars had been lost.

"For this reason the American Legion has a major stake in the war on crime and the elimination of domestic violence. Your help is needed.

"The trend toward lawlessness rising crime and rioting will not be easily arrested. Reversal will come even harder. But that it can and must be reversed is manifest. We have no higher priority. Crime is the antithesis of all our belief and hope.

"Required is the comprehensive effort of government, business, labor, churches, schools, of individuals and of our great asscciations and voluntary organizations. Each must do its part. None can place on the others the entire responsibility. We are talking about the character of our country. We must work to-

Brother Judge Michael L. Igoe, an alumnus member of Taft Chapter since 1908, recently passed away at the age of 82, after serving 26 years as a Federal District Court Judge in Chicago, Illinois.

At the time of his retirement, Brother Igoe was the oldest Federal District Judge on the bench. Even following his retirement he heard cases on a part time basis until the Fall of 1966.

Prior to being elevated to the Federal District Court, Brother Igoe was the minority spokes-man in the Illinois State Legislature. Brother Igoe was first elected to the Illinois State Legislature when he was 26 years old. He served in the Legislature a total of 16 years during the period of 1912 to 1930.

He was a delegate to the Democratic Convention in 1924, 1928, and 1932 and in 1930 he was made Democratic National Committee Man for Illinois.

In 1934 Brother Igoe was elected to the United States House of Representatives, but resigned the post to become United States Attorney.



dience, and I sympathize to some extent with those of you who have undergone the same ritual, and I would judge the only time it's really comfortable would be when you're either insensible or probably on that last eulogy when the minister is recounting for the benefit of those assembled what you did good during your lifetime. But I do very much appreciate the kind words of Don Mocre and the feelings of the Fraternity members who collaborated in the decision that probably I would eventually work out to be more of an asset than a liability to Phi Alpha Delta.

"I have hoped that after some years of public service I may be, my efforts may be channeled into a productive area so that possibly the years to come may produce something a little better than those that have gone so far. But I am most honored to become a member of this large law fraternity, and particularly to become a member during the tenure of Bob Redding as Supreme Justice. Bob Redding has been my friend for several years, and has worked with me in governmental affairs. I don't say political affairs, because I don't think anyone could ever get Justice Redding to work in a purely political atmosphere. It seems that the law profession is oftenmaligned, and I think that our public relations has not been of the best in the past. This Fraternity's work, and its work not only with law students, but with the Bar Associations; those of us in government, will contribute vastly to public understanding of what a lawyer is supposed to do; what a teacher of law is expected to teach; and what a student is expected to take from his fcrmal education in the law school. These times are troubled and we face much civil unrest, much lawlessness masquerading under the guise of civil disobedience, which to me is just a fancy way of avoiding indicates that the law is being broken. On the other hand it's not fair or circumspect for us to simply say that law and order is to be preserved without a clcse examination and a scrutiny of what there

The problems that are arising as a result of these megapoliton areas include the need for tremendous quantities of natural resources, problems of transportation, law enforcement and poverty.

Mass media, Brother Finch pointed out, is bringing all people together. The poor now know the advantages of the rich and the rich can no longer ignore the situation of the poor.

Brother Finch said that in light of the foregoing problems it is necessary that government turn its attention to priority. He queried as to whether the expenditures being made to develop an SST airplane, which will carry passengers from coast to coast in approximately 21/2

He also queried as to whether the money being spent to put a man on the moon once is better spent there than exploring the natural resources available in the Pacific Ocean.

Brother Finch pointed to education as being the area where progress must be made in bringing curriculum up to date with modern society and to alleviate mass unemployment. As he pointed out, children by the time they reach kindergarten age have logged three to four thousand hours of television and radio. They have seen everything from a full scale war to the death of a President. This, he said, prepares children to face learning at a stage beyond Jack and Jill.

Lt. Governor Finch told those in attendance that the foregoing problems can best be handled by state and local governments as well as non-governmental organizations such as churches and the bar association.



The panel discussed the trial lawyer, operation of the law office, and alternatives to private practice.

The Conclave business session reconvened at 3:00 p.m. to consider the report of the by-laws committee. Following the business session, the brothers adjourned to the law school for an examplification of the ritual including the initiation of the Dunbar Chapter Pledge Class.

The spirits of brotherhood flowed freely at the Edgewater Inn, on the Seattle waterfront, following the business session, where the delegates and brothers enjoyed a social hour preceding the Conclave hanguet

District Attorney General Shriver told those in attendance that "the federal government has vastly superior investigative resources, but relies to a large extent on local resources." He pointed out that there are on the average 30 crimes a day in Nashville and triple that amount on weekends and stated that this vastly overloads the police enforcement.

U.S. Attorney Merritt said the determination of who would handle certain criminal cases is too often determined by custom and the personalities dealing with each other. He said that another problem is that federal authorities are often afraid to give information to the local people because of leaks to the press, which can be prejudicial to the successful prosecution of the case.

Mr. Neal said that good local law enforcement is a matter of dollars and cents and more money must be spent to get a higher quality of man into police work and to provide better training.

Low Appointed to Bench

Brother Harry Low, an alumnus of Field Chapter, at Boalt Hall, was recently elevated to the San Francisco Municipal Court from the Workmen's Compensation Appeals Board.

Following graduation from Boalt Hall, Brother Low joined the Attorney General's office and quickly gained notoriety for his outstanding work with the tax section. While there he also played an important role in coordinating the collection activities of state taxing agencies, and served for several years as Chairman of this special interdepartmental group set up for that purpose.

His other activities include: Chairman of Youth for Service in Chinatown; Secretary of the Board of Youth for Service, and Vice President of the Multi-Cultural Council; and he is active in plans for establishment of a multi-cultural project to give children additional understanding of the rich and diverse cultures of the city in which they live. He is a director of the Constitutional Rights Foundation, the Telegraph Hill Service Center, and the Council for Civic Unity.

17. From a fiscal standpoint the Fraternity enjoyed a good year in 1966-67, and a national budget was approved for the coming fiscal year to finance a growing program. Progress was also made toward the goal established at the Kansas City Convention in 1966 of having sufficient cash reserves at the beginning of a fiscal year to fund a full future-year operation. At the beginning of the fiscal year recently concluded, the non-reserve cash on hand equalled 41% of the total cash expenditures during the year, whereas the total cash then available equalled 88% of such expenditures.

The foregoing highlights indicate that PAD continues to progress in its role of service to the law student, the law school, and the legal profession. Let all PAD's everywhere share in this role during the weeks and months ahead.

Legal Profession In 1970

(Continued from Page 1)

The proportion of all lawyers engaged in private practice is a declining segment of the total profession. The most rapidly increasing segment is lawyers who are being employed for salary by corporations and government, and more recently by poverty program related community agencies.

Within the private practice segment, the day of the predominance of sole practitioners appears numbered, but there will remain a place for the solo lawyer. The past decade has seen a decline in the actual number of lawyers practicing alone. During the past three years, their numbers have held even.

The number of lawyers practicing as partners or associates of firms is rising rapidly. Almost 100,000 lawyers are now in the firm type of practice. Their number increased by over 13% in the last three years, continuing a trend which has been apparent for over a decade.

There are a number of factors contributing to the changes taking place in the organization of private practice. The same economic forces which create fewer but larger business corporations favor the larger form of legal organization with its greater resources and more specialized legal talent. At the same time, organizations of specialized attorneys will grow stronger as they get increased use through referral and reputation. The information explosion alone will overwhelm those who "try to keep up with everything". Increasing awareness among lawyers of the personal security and higher income generally available in the organized form of practice also add substantially to the trend to law partnerships.

While the many surveys of lawyers conducted by bar associations in recent years bring evidence that size is the most consistent factor correlating positively with higher income, our own consulting work in assisting firms who are enlarging or merging indicates that size merging indicates that size alone will not bring improvement in legal performance or economic return. Economic success derives from the ability to manage the volume of work and the organization and system that make for effective and profitable client service.

The call for lawyers in the 1970's will not only be stronger for legal work in private and corporate practice and in government, but there will also be more demand for lawyer-trained persons in positions of executive

This will force a continued upgrading of the lawyer's economic judgment and administrative competence, the quality of his assistants, and the judicious selection of modern record keeping and research methods.

Higher costs for supporting personnel and higher income requirements for attorneys will de-mand improved cost systems in the private law offices.

The interchange of legal personnel between private, corporate and government law departments will bring a better understanding throughout the country of the nature of opinions that each may have. Lawyers will be better understood by many lawyer-trained top executives. The need for specialists in national and international law will be even greater as the knowledge required for pinpointed advice and legal service grows ever more complex.

More use will be made of salary and income studies for lawyers. These studies will tend to aid the career patterns for persons in occupations of similar stature and assist the senior group in their desire to provide a better motivated staff in an era of shortage of qualified legal

Lawyers are becoming better educated and will require ever higher skills to face successfully ticated society.

Upon discharge, Turner moved to Okron, Ohio, where he finished his undergraduate schooling at the University of Okron


He graduated in June, 1963, with a bachelor's degree in Business Administration.







Plans for the 1968 Biennial National Convention of Phi Alpha Delta Law Fraternity in Washington, D.C. were reviewed. The convention preparation is well in hand and from what can be anticipated at this date, it appears that the convention will be one of the most outstanding in the fraternity's his-

Expansion

The Supreme Executive Board carefully examined the petition of the Little Rock Division of the University of Arkansas for a chapter of Phi Alpha Delta to be known as Joseph T. Robinson Chapter.

The petition was approved subject to receipt of a written investigation report recommending approval, which is on the way.

1970 National Convention

Preliminary plans are being made to hold the 1970 National Convention of PAD in New Orleans, Louisiana.

Alumni Delegates to 1968 Convention

alumni delegates from each of the alumni chapters to 1968 National Convention will receive their travel and hotel expenses. In order to qualify for this credit, the following requirements were set by the Supreme Executive Board:

1. The annual alumni chapter tax of \$15.00 per year must be paid for two fiscal years subsequent to the 1966 convention.

Each alumni chapter must hold at least two meetings during the period August 1, 1967 through July 31, 1968, with an attendance of at least ten persons at each meeting.

3. Each alumni chapter must have duly elected officers.

Elder Statesmen's Club

The Supreme Executive Board considered the subject of a "Past 65 Club" and after discussion approved of the principal and named J. Harry LaBrum, past Supreme Justice, as Chairman.

Alumni Service Committee

The report of the Alumni Service Committee was considered by the Supreme Executive Board.

The Board resolved to institute forthwith a most outstanding member award to be made by each alumnus chapter during each fiscal year of the fraternity.

Also a certificate of appreciation is now available to alumni chapters as well as active chap-

A professor exchange program whereby Phi Alpha Delta Law Fraternity would sponsor the exchange of law professors between countries was taken under consideration and a committee appointed to make a preliminary report on the need and feasibility of such a program.

Likewise a committee was established to consider the feasibility of undertaking a student exchange program similar to the faculty exchange program.

Conclave Committee

The Conclave Committee Report was presented to the Supreme Executive Board. The report recommended that the policy of holding annual District Conclaves continue and in addition, the formation of a chapter officers seminar on a District level.

The Supreme Executive Board affirmed the policy of holding annual District Conclaves and resolved to initiate a chapter officers seminar on a trial basis in one District during the current fiscal year.

In reference to District Conclaves, the Supreme Executive Board decreed that the preparation of the budget, program, hotel arrangements and banquet arrangements must be initiated by and approved by the District Justice and that no committment which requires the expen-

without the prior approval of the District Justice. This action was taken to avoid deficits in District budgeting which has occurred in the past.

Further in conjunction with the District Conclaves, the Supreme Executive Board resolved to propose an amendment to Section 5 of Chapter VIII of the National By-Laws to read as follows: "Sec. 5. Conclave Officers -District By-Laws shall provide for the election or the appointment of a conclave justice, conclave vice-justice, conclave clerk, conclave treasurer and conclave marshal, and such other conclave officers as may be desired. Such officers shall be chosen from the members of the active chapters in the District and shall perform such duties as may be assigned to them by the District Justice."

The foregoing proposed amend ment will be submitted by the Executive Secretary to all chapters for a mail ballot, in accordance with subsection b and c of Section 1 of Chapter VIII of the National By-Laws.

Realizing the value of the presence of the faculty and alumni advisors of each of the active chapters to District conclaves the Supreme Executive Board resolved to pay their expenses for the fiscal year 1967

The following resolutions were adopted concerning the conclave

1. A one day conclave program to be held on Saturday.

2. A reception to be held on evening preceding the Friday conclave.

3. A banquet without dance on Saturday evening of the con-

In an attempt to encourage additional attendance at District Conclaves, the Board established policy of allocating transportation expenses from the Discretionary Conclave Fund on the following basis: 10c per mile per chapter for round trip from the location of the active chapter to the site of the conclave, such, however, not to exceed the lowest round trip air fare. Finally, the Supreme Executive Board urges all Districts to adopt a registration fee in an amount equal to the actual meal cost for each registrant.

Convention Committees

Standing convention committees were determined by the Board to be: audit and finance, rules, credentials, constitution and national by-laws, resolutions, nominations and publica-

The Executive Secretary was directed to pre-appoint delegates to the standing committees with the exception of the nominating committee, then resolved that each active chapter would be represented on at least one standing committee.

Speech Contest

The principle of an oratorical contest to be held on a Districtwide basis was endorsed by the Supreme Executive Board.

Scholarship Committee

After many years, Phi Alpha Delta Law Fraternity now provides scholarships on a nationwide basis.

This became a reality at the recent Supreme Executive Board meeting when a scholarship grant program was passed providing for the award of fifteen \$500 scholarships on a nationwide basis.

The scholarship program was resolved to begin immediately. Applications are available from the Executive Office and are to be presented to the Chapter Faculty Advisors by December 1, 1967.

Pursuant to the program, the faculty advisor is to choose one applicant from his chapter to be presented to the Supreme Tribunal by December 15, 1967.

Fifteen winners will be chosen by the Supreme Tribunal by January 10, 1968 and notified by January 15, 1968.

The scholarship will be delivered to the faculty advisor for delivery to the law school dean for presentation to the recipient upon his enrollment for the diture of funds can be made next succeeding school term.

In the event the winner does not so enroll but certifies his intention to return to school the award will be returned to the Executive Office to be held for later enrollment within a reasonable period to be determined by the Supreme Tribunal and not to exceed three years.

Purchase and Discount Plan

The general purpose of the purchase and discount plan is to afford members of the fraternity an opportunity to purchase office supplies, equipment and law books at a discount.

After a thorough discussion of the proposed plan, the Supreme Executive Board resolved to obtain the opinion from the District Justices, Supreme Tribunal and members of the Supreme Advisory Board regarding its advisability.

Interfraternity Law Conference

The Supreme Executive Board resolved to take the lead in Interfraternity forming Conference to be composed of the major law fraternities.

Law Student Honor Code

Phi Alpha Delta Law Fraternity has also undertaken the lead in establishing a form of standard honor code for law students.

Reporter

The Supreme Executive Board directed that a fifth issue of The Reporter be printed each year to be known as the Alumni Issue and to be printed during the

Supreme Tribunal and **Advisory Opinions**

The Supreme Tribunal was requested to present an advisory opinion on whether an active chapter could impose a minimum grade standard higher than a law school's rating of good standing as a requirement for membership.

The opinion of the Supreme Tribunal that an active chapter could not impose such a requirement was adopted by the Supreme Executive Board.

The Supreme Advisory Board was also asked to present an opinion as to whether an active chapter could confer honorary membership upon one who is already a member of the frater-The Supreme Executive Board adopted the Supreme Tribunal's opinion that such an honorary membership could not be granted.

PAD Tool Kit

Distribution of the publication commonly as the PAD Tool Kit was discussed and it was felt that this guide should be distributed to each active chapter and to all alumni chapter advisors.

Honorary Initiations

The Supreme Tribunal approved petitions for honorary membership for George H. Carswell, Norman C. Hendry, Tillman Pearson, Sam Spector, Charles A. Carroll, Charles R. Scott, Ted Cabot, Claude R. Kirk, Jr. and Congressman Wilbur D. Mills.

Alumni Chapter Notice **Mailing Policy**

In order to be of the utmost service to alumni chapters it was resolved that only charges to be made for the preparation and mailing of special notices from alumni chapters shall be the actual cost of postage for the first six mailings made by any alumni chapter during each fiscal year. Thereafter, actual postage plus 1c per envelope mailed will be the charge.

In order to facilitate the handling of alumni chapter notices they must be in the hands of Executive Office at least five full work days prior to the time the notice is to be placed in the mail.
