A TRIBUTE TO AN OUTSTANDING MAN - A SUPREME COURT JUSTICE AND A FRATERNITY BROTHER

The retirement of a United States Supreme Court Justice invariably elicits a moment of reflection on the man's accomplishments in that position. To Phi Alpha Delta, in the case of Brother Justice Tom C. Clark's retirement, it elicits a moment of reflection upon the outstanding contribtuions made by this brother to the profession of law and to the fraternity. The contributon in time and effort which he has made to either alone would stand as an outstanding achievement.

Justice Clark's Contribution To Government Service

The best tribute to Justice Clark's devotion to government service can be seen by quoting his own comments as given before the Federal Bar Association in 1964 while honoring Associate Justice Stanley Reed. He said, "As for me, I can only describe the carreer service in terms of my own experience. I well remember when I first came into it defending war risk insurance contracts of World War I. The first thing I learned was that a private office was a sure sign of prestige. And if it had a rug on the floor this meant that you were in a higher eschelon. I had neither. Indeed often was time when I returned to Washington from the trial of a case to find that I had been moved to another room and with another roommate. At first this troubled me - not only for the loss of some of my papers and padgets on the top of my side of the desk, but the more because of my ego. Well, I soon got over that. I found that Government administrators — if you could find the one that moved you were an impersonal lot. A year later I was transferred to the Antitrust Division. I found there that Government functions not only to prevent "wrong" but to promote "right." As a result of this transfer my problems increased. There were wage-hour prosecutions, restitution for victims, milk order regulations, federal trade orders, I.C.C. cases war frauds, RFC and SEC matters and a host of others coming under the category of business laws. I found that not only railroads but bankers - business and labor — all had turned to Government for assistance and protection in depression days;

that milk producers wanted price fixing; small business wanted financing and open competition; dirt farmers wanted their lands protected from foreclosure and their grain dumped in Government bins and big business wanted more and bigger mergers. And then I was transferred to the Criminal Division. There I found that the National Training School was jammed with recalcitrant kids who had been neglected by their parents and left to Government correction officers; crime was at an all-time high with federal prosecution running in the 60,000's; husbands and wives were on the rampage and the courts were becoming loaded with domestic problems; General Groves was building out in the desert of the West what he called secretly under his breath the atomic bomb; our foreign commitments in money and men had gone skyhigh and our foreign relations occupied the minute attention of additional thousands of service officers. Communism had gone

PAD DAY AT SUPREME COURT

Monday, May 29, 1967, marked the first PAD day at the United States Supreme Court. On that day 38 members of the fraternity from 19 states and the District of Columbia were admitted to practice before the United States Supreme Court. Many of them enjoyed a long weekend in Washington, D.C., and many of them brought their families for the ceremonies.

Approximately 75 persons assembled early Monday morning to meet Brother Justice Tom C. Clark at a reception in the West Conference Room of the Supreme Court Building, Mr. Justice Clark received a special certificate on behalf of the Washington Alumni Chapter and the Washington, D.C. active chapter in appreciation for his effort in making the event a success.

At 9:15 the admittees assembled in the East Conference Room in preparation to be escorted into the Court. this time Supreme Justice Robert E. Redding presented world-wide like mad and the a brief report on alumni activities in the fraternity. (Continued on Page 5)

Some of our program highlights of the year are briefly mentioned below:

1. The adjustment from 12 to 15 districts, and 15 dedicated District Justices, was completed. All districts held district conclaves this year—the first time in history!

2. A training session was held last February for all Supreme and District Officers. The many constructive actions then taken by your Supreme Executive Board were summarized in my March 1967 Message. Indicative of the "tight ship" policy on money is the fact that the actual cost of the Seminar was one dollar short of the budgeted expenditure quoted five months previous.

3. We will enter the fall season with two excellent and well trained Special Assistants to the Supreme Justice, Jerry Kaufman and Frank McCown, who will serve as our troubleshooters on active and alumni chapter expansion, reactivation, and revitalization. They will succeed the pioneering efforts of Sandy Rae and Ray Judice in this capacity.

4. The PAD reception at the annual meeting of the Association of American Law Schools last December in Washington was a highlight in our faculty relations program. More than 100 persons attended, including a dozen law school deans. This was the only law fraternity sponsored function at the meeting. A similar reception is scheduled at the Southeastern Regional Meeting of AALS in Charleston, South Carolina on August 23, 1967.

5. Our Faculty Relations Committee, under the leadership of District Justice and Dean Frank Maloney, produced a seven-point program for Supreme Executive Board consideration last February. The year's highlights included the honorary initiations of Dean Francis Allen of the University of Michigan Law School and Dean David H. Vernon of the University of Iowa Law School.

6. The 1966 Convention approved the adoption of Juris Doctor degrees at all law schools in substitution for the LL.B degree. With the assistance of the Faculty Relations Committee, we have urged such action in letters to the deans of all such law schools at which PAD chapters are located.

7. Major emphasis has been given to the more effective use of faculty and alumni advisors for such active chapter, led by a special committee chaired by Supreme Advocate Henry C. Rohr. Such areas include the goal of complete chapter coverage by this fall, distribution of the PAD Tool Kit and duties manuals, certificates of appointment, and closer reporting liaison with the District Justices.

8. The active chapter treasurer's manual has become the model for use by other fraternities and sororities during the year.

9. Our financial status has continued to stabilize this year, with new quarterly audit reports to the Supreme Executive Board and considerable progress toward the objective of a full year's operating reserves in our General Fund to meet any kind of emerreport by Supreme Treasurer Rae alumni chapter will be enlightening.

10. We have continued the granting of student loans from the Endowment Fund, reflecting the enlarged terms approved at the 1966 convention, availed of by active chapter members in the Distrist of Columbia, Idaho, Michigan, New York, Texas, and

12. During the year our insurance program was expanded by making available the new PAD professional liability "umbrella" coverage, an additional \$1 million of protection.

13. A major breakthrough on the Fraternity's alumni relations program was achieved under the leadership of Supreme Marshal Hutson, chairman of a new Alumni Service Committee. The Supreme Executive Board last February approved a 14-point program and will continue to work on this top priority problem

14. Your Supreme Justice is particularly concerned about the importance of leadership capability in a lawyer and hopes to expand the Frateernity's interest in helping to develop our active members as a "complete lawyer."

15. A personal highlight of the year was the induction on May 4, 1967 of the Honorable Charles E. Whittaker, past Justice of the United States Supreme Court, into the Fraternity's new distinguished Service Chapter, the highest honor that can be bestowed upon a PAD.

16. High honor was also conferred in recent weeks upon Supreme Vice Justice Tom C Clark, who retired as a Justice of the United States Supreme Court. Such activities include the presentation by PAD to him of his chair utilized in the Supreme Court chambers and by the completion of plans to establish, next fall, a Tom C. Clark room at the University of Texas Law School, the site of our Tom C. Clark



20. In the field of professional programming, all chapters were encouraged to participate in the annual Law Day, U.S.A. observances, and under the leadership of Judge Marshall, programs are being developed (1) for the defense to the indigent, (2) to provide trial experience for law school PAD's within the limits of bar associates activities, and (3) to encourage active chapters to provide volunteer speakers for public school, civic groups, and other public gatherings on the subject of legal traditions and respect for the law.

21. We now have available, for the first time, PAD coat-ofarms blazer emblems for purchase by Fraternity members.

22. A new PAD Inns of Court program was developed in the Washington area during the year under the leadership of Brother Warren E. Burger, Judge, U.S. Court of Appeals for the Wash-ington, D.C. Circuit. This fourmeeting program, sponsored by the local alumni and active chapters, is designed to establish and maintain high standards of professional conduct, etiquette, and ethics for members of the bar. Plans for wide publicity in professional journals have been completed and it is hoped that this program will be expanded next fall into the metropolitan areas of Los Angeles, Kansas City, Philadelphia, Chicago, Houston and New York City.

23. Although there are indications that most PAD law school graduates do not appear to face a serious placement problem, your Supreme Justice is concerned about the matter and will soon announce a Placement Committee to work in this important service area for both active and alumni members.

24. We have placed emphasis this year on active chapter fundraising activities to finance their chapter programs. They include book exchanges and book stores, coffee and doughnut service, election day reporting, window washing, duplication machine service, sale of rings, flower sales, etc. More will be listed in the forthcoming professional ac-tivities survey report by our Director of Professional Activities, Supreme Secretary Hotchkiss.

25. Also worthy of comment is tne growing interest chapters in area-wide seminars of interest to the local profession. Several were held this year, including one on "Modern Criminal Defense" and another on "Practical Aspects of Doing Business Abroad" sponsored by five active chapters in Chicago. Others included a Paterson Chapter seminar, co-sponsored with the American Law Student Association, on landlord, tenant relationships, plus others on bail release programs, corporation attorney functions, police radar use, etc.

26. The Supreme Executive Board approved a financial contribution to LAWBOOKS U.S.A., a "Lawyer to Lawyer" program for the distribution abroad of books regarding American Jurisprudence. We encourage all interested alumni members to do so.

27. Your Supreme Executive Board members have each affiliated with the American Bar Association Section of Legal Education.

CHRISTOPHER IS NAMED DEPUTY U. S. ATTORNEY GENERAL

Brother Warren M. Christopher, a member of Holmes Chapter, was recently named Deputy Attorney General of the United States.

Brother Christopher obtained his college education at Redlands and the University of Southern California where he graduated magna cum laude and was a member of Phi Kappa Phi scholastic honorary society. He entered the United States Navy as an Apprentice Seaman in 1943 and was discharged in 1946 as a Lt. (j.g.), having served in the Pacific Theater.

University Law School and obtained his LL.B. degree in 1949, and earned the Order of the Coif. While at Stanford he was President of the Board of Editors of its Law Review.

Following graduation he became law clerk to Mr. Justice William O. Douglas in the 1949 term of the United States Supreme Court.

Since 1950 he has been associated with O'Melveny & Myers of Los Angeles. He has been a member of the firm since January 1958.

Brother Christopher's other activities include membership in the California Coordinating Council for Higher Education of which he was president from 1963 to 1965; member of the Board of Trustees of Occidental College and of the Visiting Committee of the University of Chicago Law School; Chairman, Standing Committee on Aeronautical Law of the American Association, since 1966; Member of the Board of Bar Examiners of the State of California since 1966.

In Governmental work Brother Christopher served as Chairman of the United States Delegation to the United States-Japan Cotton Textile Negotiations in 1961; Chairman of the United States Delegation to Geneva Conference on Cotton Textiles, 1961; Special Consultant on Foreign Economic Problems to the Undersecretary of State since 1961; Special Representative of the Secretary of State for wool textile meetings in London and Rome in 1964 and in Tokyo in 1965; Civilian Aide to the Secretary of the Army for the

Upon his discharge, Brother Southern California area from Christopher entered Stanford 1962 to 1966; and in 1959 he served as special counsel to California Governor Brown.

In 1957 Brother Christopher was invited by the United States Supreme Court to file a brief and present oral arguments as a friend of the Court in Lambert v. California.

His writings include: The Constitutionality of the Voting Rights Act of 1965, Stanford Law Review (Vol. 18 Special Issue); and The Outer Continental Shelf Lands Act: Key to a New Frontier, 6 Stanford Law Review 23.

Brother Christopher served as Editor-in-Chief of the Los Angeles Bar Bulletin from 1955 to

PAD ASSISTS LAW BOOKS U.S.A.

Law Books U.S.A. is a non-profit organization organized to meet the need of foreign countries for books concerning the American legal system.

The idea for this program arose from a governmental organization entitled Books U.S.A. sponsored by the United States Information Agency.

The need for such a program was apparent from reports from such organizations as United States Informa-tion Agency, the Department of State, and from Peace Corps Volunteers returning from their foreign posts. The Communists have also noticed the thirst for books among other countries as is shown by the fact that they export books in dozens of different languages to some 68 noncommunist countries. One year they distributed an estimated 40 million volumes.

It encourages the American public, the publishing industry and the United States Intelligence Agency to join in a non-profit campaign to ship large numbers of English language paperbacks overseas.

Of specific importance to attorneys is the fact that Americans abroad have reported a profound interest in the American jurisprudence, particularly among the emerging nations. Many of these nations are formed of British colonies and the local leaders have been educated in English schools and are familiar with the common law system.

The lawyers and law students in these new countries also contribute the greatest single source of political and intellectual leadership. A great proportion of the educated population have studied law and these lawyers serve as statesmen, politicians, civil servants and administrators in the developing countries. Law Books U.S.A. was thus

formed. It is headed by a team of young lawyers selected on a national basis, has the full support

The Board of Trustees chosen for this organization include Justice Tom C. Clark, United States Supreme Court (retired); Dean Florence Ferguson, Howard Law School; Dean Irwin N. Griswald, Harvard Law School; Earl W. PAD Alumni Benefits

Delta after graduating from law school fail to avail themselves of the services and benefits offered by Phi Alpha Delta. Some of the highlights of these benefits which accrue to active members in the fraternity are as follows:

1. The availability of our numerous PAD insurance programs, including group life, long - term disability income, business overhead expenses, and professional liability insurance.

2. Alumni assistance in seeking membership before the bars of various courts and in business clubs, local organizations, and political affiliations.

5. Eligibility for the emerging benefits of our Leadership Development Program intended to develop the complete lawyer.

6. Availability of the PAD Inns of Court program, designed to assist younger alumni in establishing and maintaining

The eight paperback books in the packet have been selected by lawyers, law students, and law teachers in this country. In keeping with the spirit of the program, technical legal treatises have been bypassed in favor of popular paperbacks readily understandable by fellow attorneys abroad. A typical packet will contain the following: Spirit of Liberty, by Leonard Hand; The Nature of the Judicial Process, by Benjamin Cardozo; Tax on American Land, Harold Berman; Brandeis Reader, by Irwin Pollack; Equal Justice Under the Freedom Leader, by Edwin Newman; American Constitution Reader, by Robert McKay; and American Jurisprudence Reader, by Thomas Kowan.

Final selections of recipients are made by the United States Intelligence Agency. A list of prospective recipients are furnished by the American Bar Association, the Federal Bar Association and the American Attorneys serving with the Peace Corps. An individual American donor may leave the choice entirely with the United States Intelligence Agency or may indicate a particular country within which he prefers his packet distributed.

The Supreme Executive Board of Phi Alpha Delta has found this program to be of such importance that it has made a contribution to it on behalf of PAD.

In the event any member wishes to follow the fraternity's lead he may make a donation to Law Books U.S.A., Suite 4400, 1 North La Salle Street, Chicago, Illinois 60602.

Many members of Phi Alpha high standards of professional conduct as to court-room manners, decorum, and legal etiquette, as they pertain to clients other attorneys, the judiciary, and the general public.

7. Participation in Fraternitysponsored professional programs designed to meet practical problems of law practice.

8. The utilization of alumni contacts to facilitate changes in legal positions and other placement problems faced by alumni brothers.

9. The tangible benefits soon to be offered to PAD alumni members from the "PAD Plan," which will make possible the purchase of library materials, office equipment and machinery, and office supplies at a substantially reduced cost.

10. A national fraternity affiliation leading to lifetime friendships throughout the world, a priceless jewel in our professional lifetime.

11. Finally, PAD stands as a bulwark to remind each brother of his obligations as a lawyer and as a stimulus for professional responsibility. These areas include (1) rendering legal service without expectation of compensation when justice cannot otherwise be maintained, (2) individual contributions in time and effort toward the improvement of the administration of justice, (3) constant and exacting adherence to high ethical standards, (4) attaining and maintaining a high degree of competence as a legal technician and craftsman, and (5) seeking and accepting leadership in educational, cultural, patriotic, charitable, and political life.

ABA Honors Tom C. Clark

Justice Tom C. Clark was honored on June 12, 1967 at a banquet sponsored by the Committee for the Effective Administration of Justice of the American Bar Association.

Mr. Justice Clark was introduced as the first and only chairman of the Joint Committee for the Effective Administration of Justice.

ABA President Marden said of Justice Clark, "to lose him from the Court is a grievous loss indeed - for he has been a very great Justice.

"Justice Clark has gladly given us virtually all of his part time in the past decade. He has been correctly called the traveling salesman of justice and selfishly we want more — much more of his time and of his unique talent.

"And so - though saddened by his loss from the court - we rejoice that he will now be able to give more and more improvements for the administration of justice.'

"Elder brother of the discouraged, is a title we might well confer on Mr. Justice Clark.

"History will group him with Arthur T. Vanderbilt and John J. Parker as the triumvirate who modernized the machinery of justice in our time.'

As chairman of the ABA Section of Judicial Administration, Justice Clark spearheaded the movement leading to the establishment of the National College of Trial Lawyers for training of newly elected or appointed State Court Judges.

Notice To All Alumni Chapters

The 1968 National Convention will be held in Washington, D.C., August 28, 29, 30 and 31, 1968. The National By-Laws were amended in 1966 to provide that the National Fraternity will pay the necessary traveling expenses and hotel expenses of one delegate from each alumni chapter.

This means that the actual cost of air coach fare, hotel accommodations, and at least \$4.00 per day subsistence for each day of travel to and from the convention and each day at the convention will be paid for one delegate from each alumni chapter.

The Supreme Executive Board has adopted the following requirement in order for alumni chapters to be eligible for payment of travel expenses on the one delegate:

1. The annual alumni chapter tax of \$15.00 per year must be paid for the two fiscal years subsequent to the 1966 convention.

Each alumni chapter must hold at least two meetings during the period August 1, 1967 through July 31, 1968 with an attendance of at least 10 persons at each meeting.

4. Each alumni chapter must have duly elected officers.





THE OFFICIAL PORTRAIT OF JUSTICE TOM C. CLARK OF THE UNITED STATES SUPREME COURT













PAD INNS OF COURT

It was Shakespeare who spoke of the English Inns of

Court: "Strive mightily and then eat and drink together."

The "PAD Inns of Court," a program designed to enhance the professional conduct of lawyers, has now become a working reality in Washington, D.C. Guided by the founder of the program, Judge Warren E. Burger of the United States Court of Appeals for the District of Columbia Circuit, the five active Washington, D.C. chapters and the Washington, D.C. Alumni Chapter have jointly sponsored during the 1966-67 academic year a series of four seminar programs in the area of professional decorum, etiquette, and ethics relating to courtroom conduct. Some of the outstanding trial lawyers in the country participat-

Court" program was first dis-cussed by Judge Burger at the Spring Banquet of the Washington, D.C., active chapters in May 1966, when Judge Burger became an honorary member of John Jay Chapter at George Washington University Law School. Brother Burger spoke at the banquet of the need for a Fraternity program dealing with professional conduct, etiquette and ethics. Tentative plans for the program were developed during the summer of 1966.

The program began in the fall of 1966, largely due to the efforts of Brother Warren E. Burger, Supreme Justice Robert E. Redding, District Justice Dan Halpin, and Fred Warren Bennett, past Justice of John Jay Chapter and a member of the Washington, Alumni Chapter. After much discussion it was agreed that the project name would be "PAD Inns of Court-A Program to Establish and Maintain High Standards of Professional Conduct, Etiquette and Ethics." The basic purposes of the program are as follows:

1. To facilitate a growing awareness to the needs of a lawyer to practice professional conduct of the highest order in legal proceedings - both in court and out of court;

2. To bring about a greater emphasis on the need for training in the law schools in the area of legal ethics;

3. To encourage law students and young lawyers to take interest in this program so that they can obtain knowledge and practical experience in proper courtroom conduct and ethics;

4. To contribute to a higher level of esteem for the legal profession in the mind of the general public;

5. To encourage all PAD active alumni chapters to adopt and implement such a program; and

6. To bring the legal fraternity into a closer relationship with other professional organizations within the legal profession.

The "Inns of Court" program in the Washington, D.C., area has been sponsored by the John

Williams Evaluates "Inns of Court"

"I was pleased to have been able to participate in the PAD program, 'Inns of Court.' I think it important that law students and young lawyers acquire a sense of the duties of the advocate, and a program drawing upon the experience of judges, professors and active practicioners fills that need. I was particularly impressed by the 1966-67 program's emphasis upon the duty of all lawyers to undertake the defense of persons accused of crime and upon the necessity for maintaining the highest standards of professional conduct both in and out of the courtroom."

The concept of a "PAD Inns of Jay Chapter at George Washington University, Taft Chapter at Georgetown University, Brandeis Chapter at The American University Cardozo Chapter at Catholic University, newly installed Langston Chapter at Howard University, and the Washington, D.C., Alumni Chapter. Prospective rushees at all law schools were invited, as well as their wives or dates. The programs have been speaker programs - lectures followed by questions and answers. Two outstanding speakers and a moderator has been the format for three programs and the last program featured one speaker and a moderator.

The first PAD "Inns of Court" program was held on October 28, 1966. Brother Edward Bennett Williams, noted criminal trial lawyer, and Samuel Dash, Director of the Institute of Criminal Law and Procedure at George town University Law Center, were the speakers, and Brother Judge John J. Sirica of the United States District Court for the District of Columbia was the moderator. Brother Wililams and Mr. Dash discussed the "Professional Responsibilities of the Defense Lawyer in a Criminal Case" before a large audience of

several hundred people.

The second "Inns of Court" program was held on January 6, 1967. Judge William B. Bryant of the United States District Court, former attorney in the landmark case of Mallory vs. United States; 354 U.S. 449 (1957), and Thomas Flannery, Esquire, former prosecuting attorney in Washington, D. C., were the speakers, and Brother Richmond B. Keech, Senior Judge for the United States District Court for the District of Columbia, was the moderator. Judge Bryant and Mr. Flannery spoke on "Problems of Trial Preparation in a Criminal Case - Covering Relations with Defendant, Opposing Counsel, Witnesses and Law Enforcement Agencies."

The third program was held on March 10, 1967. Myron Ehrlich, Esquire, noted criminal trial lawyer in Washington, D.C., and Francis L. Casey, Esquire, a leading trial lawyer in the torts field and a partner in the firm of Hogan and Hartson, were the speakers, and Brother James E. 
February 16, 1968, and March 15, 1968. Greater emphasis will be placed in areas other than Criminal Law - such as domestic relations, torts commercial law.







(Continued from Page 1) Government was being charged with being soft about it. Excitement! There was never a dull moment. The science of Government had changed because of the exigencies of these situations from fixed principles to little more than the exercise of a sound discretion applied to public problems as they arose. It had become the science of experiment. This wholesale demand for additional Government service could only be met by huge additions to the career service. From George Washington's time it jumped from 780 to 2,500,000. And the caliber of the service changed from policeman to big brother. The Government lawyer's job was to see that justice was done in the courts between man and Government.

As Attorney General I was proud of the accomplishments of the career service lawyers scattered throughout the Government establishment. They were men not only learned in the law but men of intention and ideas. They knew why they were in the public service. It was because there was a job to be performed and they felt that it was their duty to perform it. Neither salary nor overtime deterred them in this overall purpose. They were perfectionists as well as idealists with an insight far beyond themselves. They also had a capacity to strive for higher things and to attain them. In short, they always had a cause to which they were devoted but they were not rebels. They worked within and were part parcel of what I called the symphony of Government. The drummer in that symphony was as indispensable as was the first violinist."

What Justice Clark had to say about those under him applied equally well to himself as he served in the position of the United States Attorney General from 1945 to 1949. As Attorney General, he was active in the field of Civic Affairs, organizing the National Conference of Citizenship. He also sponsored the "Big Brothers." He also created the Attorney General's Committee on Juvenile Delinquency which performed great service during the post World War II period. He sponsored the idea of the "Freedom Train" which carried our original historic documents on exhibition across the country and co-sponsored the "I Speak for Democracy" program in High Schools of the Nation.

Justice Clark As Associate Justice of the Supreme Court

Justice Clark was nominated to the United States Supreme Court by President Harry S. Truman, on August 2, 1949. On October 3, 1949 he took his seat as successor to Mr. Justice Murphy.

As an Associate Supreme Court Justice he has been described by some as "the Traveling Salesman of Justice." Those who have so labeled him have stated that the description is apt in that with only one or two exceptions no member of the Supreme Court has ever done so much to improve the administration of Justice in this country. Brother Justice Clark has contributed much more to American sonally argued three cases in the law than just the modernization of administration. His opinions and clear. He has enjoyed the reputation of being a friend of the police and the Government. To a large extent this reputation is merited, for the Justice often voted to uphold Government action in the field of criminal law and subversion which his more liberal brothers found unconstitutional.

Justice Clark has been probably the least controversial of the justices in the present court. He has led no blocks within the court, pursued no well defined theories of law or Government action. He sometimes joined and sometimes dissented when the court made landmark rulings. He held opinions that mostly settled cases rather than arouse criticism.

Justice Clark has authored some of the present court's more drastic decisions however. For example, he wrote the much criticized 1963 opinion on the prayer prohibited by the reading as a religious ceremony in public schools.

Justice Clark offered the 1952 opinion that justified freedom of speech protection for movies challenged as obscene or otherwise offensive.


In 1956 he wrote the precedent setting ruling giving Public Employees the right to plead the Fifth Amendment.

His most recent highly publicized decision was ordering a new murder trial for Dr. Sam Shepard, because of too much publicity.

From Justice Clark's opinions many persons feel that he looked to the case, not the broad theory, in deciding his vote in that in the controversial areas of religious freedom, obscenity, and the rights of the accused, Brother Clark at other times had voted a different way.

Whatever his decision, the strength and vigor of his arguments were unexcelled.

Justice Clark's opinions not infrequently contained something rare in Supreme Court literature that being amusement, the usually mild Justice was at times also capable of indigation, for example, in the Fanny Hill decision. Brother Clark said in dissent: "the public should know of the continuous flow or pornographic material reaching this court - I have "stomached" past cases for almost ten years without much outcry. Though I am not known to be a purist — or a shrinking violet — this book is too much even for me."

Brother Justice Clark has applied the same untiring devotion to his duties as Associate United States Supreme Justice as he did as Attorney General. As he stated on one occasion "being a judge is a very high honor, but it is hard work. We studied over 2300 cases last year and wrote 111 different opinions for the court. We also have a lot of homework every night just like you do except ours runs over into Saturdays and Sundays."

Justice Clark's reputation while a member of the United States Supreme Court has been that of a friend of the police in the Government, one who voted consistently against the trend of the court's majority to protect and expand the citizen's personal rights. To a large extent, this reputation is merited for the Justice has often voted to uphold Government action in the field of criminal laws and subversion, which his more liberal brothers found unconstitutional.

Ironically, however, Clark's last opinion for the court gave constitutional protection for the first time to the privacy of communication. This opinion certainly will be unpopular with law enforcement officials. However, it may turn out to be the most important decision that the Justice ever produced. It stands on a plane with his opinion establishing that motion pictures are a form of speech protected by the first amendment, that states can not constitutionally use evidence illegally seized, and that religious observances have no place in normal public school activity.

The Justice's first task in retirement is an international goodwill trip made at the request of the President.

His Honors and Organizations

Justice Clark has been honored on many occasions for his Government service. He has received honorary degrees from Bethany College, John Marshal College, Centre College, Missouri Valley College, Texas Technological College, Dickerson School of Law Vincennes University, North-western University, University of Montana, University of Maine, St. Louis University, Boston University, Ohio Weslyan, St. Johns, University of San Diego, Sepeock University, Syracuse Univeristy, University of Colorado, and George Washington University.

He has received a number of awards including the Distinguished Alumnus Award from the X Students Association at the University of Texas; the Distinguished Alumnus Award from the University of Texas, School of Law; the St. Thomas Moore Award from the University of San Francisco and the President's "Key" from Loyola University of Chicago. He is a member of the visiting committee for the University of Chicago Law School.

The Justice as a Member of Phi Alpha Delta Law Fraternity

Justice Clark began his life with Phi Alpha Delta on November 3, 1945 when he was inducted as an honorary member of Taney Chapter.

At this time Phi Alpha Delta recognized Justice Clark for his high service and unswerving devotion to the law and presented him with the Honorary Initation in token of his championship of those things devoted to the maintenance which the fraternity is dedicated and as evidence of the high esteem in which he is held by the fraternity.

On the occasion of Justice Clark's honorary initiation, Dwight H. Green, governor of Illinois and Supreme Tribune of the Fraternity, said that the fraternity "is honored to have this great American come into its ranks and march side by side with other great men in the organization.

"He is a great man with tol-erance and understanding in his soul. By his actions he already has shown that he will go down is history as one of the greatest and strongest attorneys in the annuls of the United States."

On this occasion Justice Clark said, "I have been familiar with vour great organization for a long time but I had not anticipated this magnificent welcome. am deeply touched and will try to uphold the standards of Phi Alpha Delta as best I can."

He went on to say, "I feel deeply honored that I have achieved the rank of honorary member here, along with the late President Taft, General Pershing, and President Truman. The steady growth of this organization since its beginning in Chicago in 1902 is remarkyou have sought and acquired the right sort of men in our profession. The list of luminaries of bar and bench is impressive."

Justice Clark has truly lived up to his vow to "uphold the standards of Phi Alpha Delta as best I can." This is true in both his professional and fraternity live.

No sooner had the Justice been initiated then he went to work on the initiation of Senator Robert A. Taft and was present for his honorary installation, on April 5, 1947.

In October of 1947 Justice Clark was again honored by the fraternity. This time the honor was in the form of naming a chapter after him at the University of Texas Law School.

His son Ramsey then a student at the University of Texas Law School, was among the welcoming group when Justice Clark arrived.

Justice Clark did not hesitate when asked to speak at the 28th Biennal Convention in Frenchlich, Indiana. He told those present that "the occasion of my becoming a member of the fraternity came much later in my life than your own. I am an honorary member, in fact I was Attorney General of the United States at the time. I have always been very grateful to Taney Chapter for its invitation to be initiated into the fraternity. Since then I've followed the affairs of the fraternity with great interest, admiring its able leadership and its role in the affairs of our profession. I've enjoyed particularly the friendship of the student and alumni chapters which with I have been privileged to meet in recent years.

His enthusiasm for Phi Alpha Delta Law Fraternity is exemplified by his statement during the 28th Biennal Convention that "Our chapters have brought distinction to the Law School and to themselves by sponsoring bench and bar lectures, by orienting beginners in the study of law, by administering extra curricular programs, by recognizing superior scholarship, by supporting an honor system, and through other similar activities. Undertakings of this kind have demonstrated the usefullness of the professional groups and have contributed to the esteem in which they are held by both lawyers and law school administrators."

He said to those assembled, "I would like to see Phi Alpha Delta become a group that makes all law schools conscious of our professional needs and that stimulates state and local bar activity to expand present services to handle these problems forcefully and efficiently. I would like to see it become known as the University group which has seen the oportunity for law school men to join in the worthiest phase of the public relation program of the legal profession in the United States.

Brother Justice Clark has always been ready on request to be present for honorary initiations, district conclaves, or chapter activities. He was present in 1952 for the honorary initiation of Chief Justice Edward W. Hudgins of the Virginia Court of Appeals into Patrick Henry Chapter at the University of Richmond. He was also present at a dinner banquet given by Wythe Chapter in 1955.

That year he also visited Jefferson Chapter and spoke to the University of Virginia student body during a program hosted by Jefferson.

Two months later he was at Jay Chapter outlining the handling of a typical 5 to 4 decision of the United States Supreme Court.

May, the following month of the same year, Justice Clark was present for the installation of Robert H. Jackson Chapter at Rutker University School of Law.

Justice Clark readily accepted an invitation to speak at the District XII Conclave the following year.

Also that year, he was present at the annual PAD reception during the American Bar Association Conference in New York.

The District VIII Conclave in 1958 was honored by the presence of Supreme Court Justice Tom Clark who installed New York Assemblyman Anthony P. Savarese, Jr., as an honorary member and addressed those in attendance emphasizing the importance of the defense of the indigent and the professions responsibility attended there to and also the characteristics and benefits of the fraternity.

Legal Aid Handles A Heavy Load

Legal aid and defender offices over the country handled over 825,755 civil and criminal cases last year, according to statistics released by National Legal Aid and Defender Association (NLADA). The gross operating cost for these services was nearly \$23 million. Major support for legal aid services came from the federal Office of Economic Opportunity Legal Services Program (55%) and from United Funds and Community Chests (22%), while most defender offices were supported from local (state and county) tax funds.

Commenting on this year's statistics on legal services for the poor, NLADA Director of Membership Services Mayo H. Stiegler said: "The gain in number of persons served over last year is, in fact, modest in light of the doubling of funds invested in these programs. Because many of the more than 200 government financed legal service programs were just becoming operational in 1966, the full ima close."

NLADA, with headquarters at the American Bar Center in Chicago, is the national coordinating body of local legal aid and defender offices that provide legal services for the poor. There are 411 legal aid (handling civil cases) and 273 defender (handling criminal cases) offices in the United States today. Last year, these offices provided over 825,000 clients with legal advice and representation at a gross operating cost of nearly \$23 million.

The 1966 statistics reveal an increase over 1965 of 65,289 (15%) civil cases and of 89,164 (36.4%) criminal cases handled by local legal aid and defender offices. At the same time, money expended on services has increased 96% for civil cases and 23% for criminal cases.

The statistics, now available from NLADA on request, list the services by cities. Each is classified according to the way it is ation, and the sources of finanorganized and figures are given cial support.

Occasionally situations arise which cause me to feel that I should like to do more for my family or for some of the organizations with which I am connected, than I am able to do from my modest income. One of the things I have been thinking about lately is that Phi Alpha Delta ought to start a trust fund to which members of the Fraternity might make gifts, the money to be held by the officer of the Fraternity in such a lawful way as the donors might limit and direct .

While I think that such a fund ought to be provided by our constitution and laws, I believe that the officers of the Fraternity could create such a fund and get it started. Believing that if this is done it will result in the constitutional enactment which I have suggested, I am enclosing herewith my check to your order for a hundred dollars which is my modest contribution for the purpose of planting a seed which I hope will grow and deinto something worth velop while.

3. December 1934

Brother Richmond B. Keech (Taft), former Peoples Counsel of the District of Columbia, has been elevated to the position of Public Utilities Commissioner in recognition of the distinction with which he performed his public duties as Peoples Counsel. Brother Keech is one of the most popular PADs and this honor is rightly deserved.

4. May 1936

Among the Rhodes scholars this year was selected Guy O. Farmer (Willey '34). This is not the only reason Willey Chapter has to be proud of this remarkable young man. For the past year he has been editor-in-chief of the West Virginia Law Quarterly as a result of his high scholastic standing throughout his Law School career.
