Founders' Day Plaque Dedicated at Chicago-Kent

The auditorium of Chicago-Kent College of Law, site of William Blackstone Chapter, was the setting for the dedication of a bronze memorial plaque by Phi Alpha Delta on the afternoon of Friday, November 3, 1967.

The plaque commemorates the creation of the first chapter of Phi Alpha Delta Law Fraternity on November 8, 1902 at the Chicago College of Law. The Chicago College of Law and Kent College of Law merged soon thereafter to form the present Chicago-Kent College of Law.

The program commenced with a welcome by the President of Chicago-Kent, E. Douglas Schwantes. He recalled the active participation of Phi Alpha Delta in the life of Chicago-Kent and mentioned that he had been a pledge of Phi Alpha Delta when he was a law student but had not

(Brother Schwantes has since become an honorary member of Blackstone Chapter, just forty years after he pledged the Fraternity.)

The presentation was scheduled to be made by Robert E. Redding, Supreme Justice. However, due to mechanical failure, his flight was delayed. Past Supreme Justice Anthony capably stepped in and made the presentation on Brother Red-ding's behalf. He recalled the beginnings of Phi Alpha Delta as Lambda Epsilon Fraternity and emphasized the impressive growth of the fraternity to the present time.

Edward G. Fay, Justice of Blackstone Chapter, accepted the plaque on behalf of Blackstone Chapter at Chicago-Kent College of Law. He then presented the plaque to Chicago-Kent College of Law, stressing the simultaneous development of both the law school and Phi Alpha Delta. He pointed out the vital functions of the law fraternity in supplementing the law school curriculum.

Dean William F. Zacharias accepted the plaque on behalf of the law school. He noted two happenings in Chicago in the same week, each representing a reaffirmation of belief in a noble institution. The first was the reopening of the famed Au-

He was a member of the 58th and 62nd Congresses, representing the 6th congressional district of Arkansas from 1903 until 1913.

On January 14, 1913 he resigned from Congress in order to be inaugurated as Governor of the State of Arkansas. Then on January 28, 1913 he was elected to the United States Senate and therefore resigned as Governor and took the Senatorial seat on March 10, 1913.

This Arkansas Senator was serving in the United States Senate when he passed away on July 14, 1937.

Timberlake Chapter at Wake Forest College of Law celebrated an outstanding school year with active members and 12 pledges out of a total school enrollment of 200.

The chapter was very active in law school activities including the sponsorship of over 15 speakers on the campus, as well as chairing many of the Student Bar Associations Committees. In addition, Brothers of Timberlake Chapter hold all twelve offices in the Student Bar Association.

The members of Timberlake Chapter were also active on the school law review and school newspaper a periodical founded by a member of PAD at Wake Forest Law School.

The Professional Programs sponsored by Timberlake Chapter include the Law Enforcement Support Project, during which the brothers spend an evening or more with police officers riding in squad cars, in Departmental

Campus demonstrations endanger true academic freedom, ABA official says.

Mass student demonstrations which seek to deny valid legal rights of others are a distortion of true academic freedom, President Earl F. Morris of the American Bar Association recently said in a commencement address at Ohio State Univer-

Moreover, said Morris, campus demonstrations aimed at government officials, armed forces or industry recruiters, are self-defeating in that they endanger the very individual freedom they are intended to manifest.

"In our colleges and universities, academic freedom has always been a cherished and jealously guarded doctrine," Morris said. "The American tradition of academic freedom has its roots in the philosophy of intellectual freedom which developed in ancient Greece, flourished in renaissance Europe, and found fulfillment in our Bill of Rights."

"But we must not allow academic freedom to become academic license. Just as Mr. Justice Holmes wrote that freedom of speech does not permit a man falsely to shout 'fire' in a crowded theater, the right to teach and read and hear what one wants does not bear with it the right to ignore the rules completely; above all, academic freedom must not be used to deny rights of others to which they are equally entitled."

Mr. Morris, a Columbus lawyer, cited as examples campus incidents in which student demonstrators stormed the car of Vice President Hubert Humphrey and interrupted by heckling and jeering speeches of Secretary of State Rusk and Defense Secretary McNamara.

He said what these students seem to have forgotten is that, though the techniques of coercion might be effective for the moment, they are self-defeating because they endanger the same individual freedom they are intended to manifest."

The present generation of college and university students are genuinely concerned with human freedom and human rights" and the vast majority conduct themselves responsibly, Morris added.

"But were the students who barricaded the Navy recruiter in his car for four hours manifesting that concern?", he asked. "Are students who burn the President of the United States in effigy . . . demonstrating that concern? Or the students and I may add those faculty members joining with them, who have obstructed interviewers on our campuses because they disapprove of the company's product . . . ?'

"Not alone on the campus but elsewhere in our society there is a developing philosophy that the end justifies the means," he declared, "with the result that in many instances dissent has shifted to resistance, assembly has become trespass, and peaceful negotiation has given way to mob violence."

"We have heard considerable rationalizing and intellectualizing to justify civil disobedience. But after all the rhetoric, after all the lofty quotations, the fact is that law is and must be the supreme factor in the orderly working of society . . .

Morris called upon the grad-uates to make a "full commitment to the rule of law as a necessary way of life.'

"My hope is that each of you will be a part of a revival of respect for the rights of others, or a reawakening of individual responsibility, and of a crusade for the rebirth of civil obedience throughout this land," he said.

Message From The Supreme Justice

I would like to share three minutes of your valuable reading time to discuss the results of our 1967 professional activities survey, the fourth in a series of surveys which began a decade ago.

Over the years the Supreme Executive Board has encouraged the growth and development of a sound professional activities program which has become the real strength of PAD. Why? Because we regard our fraternal fellowship to be designed primarily to assist the law student in preparing himself for his place in the legal profession. Although social activities are also proper, we must consider ourselves a mature organization for maturing men and enhance the tangible use of professional programs for our individual members, active and alumni. Finally, a strong and diversified pattern of such activities contributes both to favorable faculty relations and to repeated rushing successes.

The 1967 survey returns thus far received from the 68 active chapters reflect a gratifying expansion of professional programs. In our first 1958 survey each chapter reported an average of four programs being conducted. Today, each chapter is, on the average, conducting six programs, a 50% increase in 10 years, with several chapters reporting 10 or more programs. In total, 48 different programs were listed in the survey returns.

Of course, there were questionnaire returns typifying the comment that "The Student Bar Assocaition at the Law School has virtually taken over all professional and educational activities once conducted by PAD," and 37 such instances were reported. We also know that this phenomena is not uncommon and is just one more demonstration of the pioneering record of our fraternity. Furthermore, it has led to expand benefits to students even though no longer sponsored by PAD.

What is important, however, is not to capitulate to such takeovers or tolerate the attitude that, as one chapter recorded, "PAD members were heavily active in shifting the burden of professional activity to its proper basis, SBA." What is heartening by contrast, is that the survey returns reported 55 instances of new programs being undertaken in 1967; one of our chapters with 11 programs in operation confidently asserted that "All of us are on the lookout for new and challenging ways to make use of the professional side of PAD."

decade ago — is partially due to our PAD library of existing professional programs mailed each year to each chapter. It is also undoubtedly a reflection of the high value assigned to professional programming in the Annual Outstanding Active Chapter competition — with 15 points on our rating scale assigned thereto, as contrasted with 5 and 10 points on other individual measures of excellence.

Furthermore, we constantly seek to expand the PAD Library with new professional activities. For example, last month we in-

vited 15 1967 District Oustanding Chapters award winners to furnish for the Library Summaries of the following programs:

(1) Field trips to criminal laboratory and welcoming letter to freshmen; (2) job seminar, test-writing seminar and Bible lending program; (3) advocates club, vending machine and constitution education in high schools; (4) new enforcement support project, placement program and Defense Research Institute; (5) defender program and judicial clerkship; (6) high school program and pre-law club.

Also, the 1967 survey identified instances of fund-raising activities to help finance chapter activities, a long list of "most successful" activities, a much shorter list of "less successful" activities, a wide variety of activities favored and participated in by faculty members, and a number of programs supported by PAD alumni. Incidentally. alumni chapter activities returns were included in the 1967 survey, with encouraging results.

Thus, I commend you all for increasing excellence in professional programming spreading of the cement upon the stone of which the citadel of PAD is composed. And for those chapters which may be momentarily frustrated in their efforts to expand existing programs, just remember the following words of the 18th Century poet, Lemierre: "It is a profound mistake to think that everything has been discovered, as well as to think the horizon the boundry of the world."

As Langston Chapter celebrated the conclusion of its first year, it boasted a membership of 55 brothers and four faculty members.

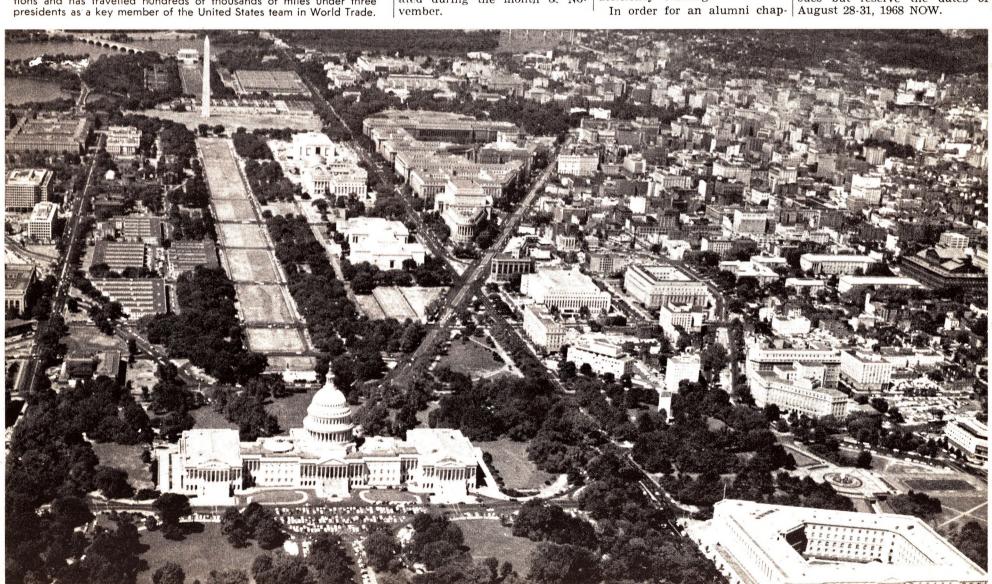

PAD Inns of Court -- 1967

On Friday night, November 3, 1967, Phi Alpha Delta's nationally renowned Inns of Court Program was initiated at the Old Senate Office Building with Judges Warren E. Burger and J. Luther Youngdahl, and well known D. C. attorney Richard W. Galiher.

The function was jointly sponsored by the five local chapters of Phi Alpha Delta Law Fraternity.

Following introductions of the panel, Judge Berger set the tone of the function by pointing out that lawyers in general are held in low esteem and the situation is getting worse each year, although new lawyers are getting better every year. Judge Burger felt that this was due to the fact that the public does not trust lawyers, lawyers who occasionally exhibit bad manners in and out of the courtroom, and on the travesty perpetrated by television and movie treatment of courtroom procedure. As he did last year, Judge Burger contrasted this with the British practice of polite, gentlemanly, courtroom combat.

Judge Youngdahl remarked that courtroom conduct needs emphasis on a national basis, and that the responsibility is with the Bar and with judges who will not command respect in the courtroom. He complained that the practice of law has become the fast buck; lawyers today file complaints at the drop of a hat and cannot even present a prima facie case. The judge should remember that his position requires courteous consideration of all before him, that an adversary proceeding can be conducted politely, and that arguments in the courtroom between lawyers can occur, but should be extremely rare. He advises the lawyer to dislike the judge if he must, but not in the courtroom; a continual problem is the lawyer who turns his back on the judge with a sneer on his face when the judge rules adversely. On the other hand, counsel are entitled to press their legal arguments, and do not have to be subjected to, or stand for, threats or contemptuous treatment.

Mr. Galiher added that it is important for the new lawyer to make a good first impression when trying his first case in court. Careful preparation of the case, appropriate attire, and simple good manners will make a lasting impression on the court for later cases. Additionally, it helps to learn one's way around the courts and, particularly in Washington, to remember that judges are always willing to bend over backwards to help young lawyers. In addition to treating the court with respect the young lawyer should remember that prospective jurors in voir dire examinations and witnesses are also entitled to be treated with respect.

In response to a question asked as to how to handle irritable judges, Judge Burger advised that the lawyer should treat him like a rich uncle who might leave you all of his money. If the lawyer is careful, the jury will tend to sympathize with the lawyer. In other words, "kill them with kindness."

The message that Judge Burger, the innovator of the Inns of Court Program, is trying to convey is a valuable one for the young lawyer just beginning to practice in a time of seemingly general distrust of lawyers, judges and the law. The message seems simple, yet lawyers continually appear before court poorly prepared, shabbily dressed and inclined to intemperate behavior, perhaps caused by over-zealous concern for the client's case. In manner and in dress many lawyers have forgotten to be gentlemen. It is hoped that Judge Burger's message may go forth beyond law students to the general legal profession. For the law student, a good example would be the best teacher.

The most successful Fall Rush Program in the history of the Charles J. Excerpts from Mr. Bress' remarks are as follows:

Change is the essence of life, in a democratic society, and the 20th century has seen more change then the whole of human history. In the last third of this century, we will fully match again the change that has occurred in the first twothirds of the century. Now, due to the jamming of people into urban centers, particularly those ill-equipped for the city, the results have been poverty, dispair, and crime. We know the efforts being made on the first two problems by the war on poverty and other programs. Mr. Bress believes that we are now moving in the right direction on the third area. Last year, there were three quarters of a million more serious crimes in the United States, an increase of 11% over 1965. The increase has been 17% for the first 6 months of 1967. Violent crimes (murder, ing trial, or plead guilty and berape, robbery, and aggravated gin his sentence, is of course assault) are up seven to thirty percent in each category. In D.C., the situation is worse. Comparing the months of Sept. 1966 and Sept. 1967, robbery is up 30%, housebreaking 21%, hom-51%, and overall crime 34%. The increase has outstripped the rest of the country.

A comparison can be made with London, a city with ten times the population of D.C. Thirty five murders occurred there last year. In D.C., there were 150, or 540 times more than there should have been; 3.5 using the London figures. The crime rate here outstrips the population increase by a factor of seven, and costs the nation twenty - seven billion dollars a year. Though the general apathy of the population does not help, virtually everyone wants safe streets. One factor that is disturbing has been the change in the criminal process in the courts, which has meant that we cannot cope with the increased number of prosecutions. The length of a trial has doubled from 1.7 days to 3.5 days. The number of indictments is up 540%. The backlog of cases awaiting has obviously accelerated.

But all of this does NOT mean But all of this does NOT mean that the rights of the accused rich and the poor defendant has should be surrendered just to speed up the criminal process. In fact, Mr. Bress feels that it is his duty and the duty of all law enforcement agencies to protect the rights of all citizens.

Yet laymen blame lawyers and the courts for the increased crime rate. In a letter to the editor published here recently, all 23 members of a federal grand jury were amazed at exaggerated concern for criminals who are allowed to roam the streets. The legislature and the courts were criticized and the group demanded to know when the scales of justice were going to be tipped back. Such a letter was beyond the duty of the duty of the grand jury, but many other citizens are asking the same question: What is being done to expedite cases so as to remove the criminal from the streets and to begin the process of rehabilitation?

In D.C., 1,100 felony cases are

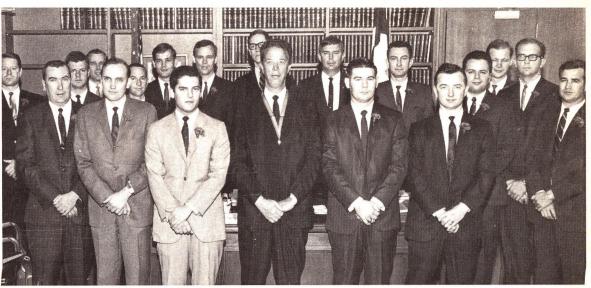
survey indicated that the time period from arrest to sentence is eleven months; 2 months to indictment, and nine months to trial. Most defendants are free from custody during this time; the Bail Reform Act giving them their release delays the process. They must go free, unless the court determines that the person is the type who will not show up for his trial, a difficult determination to make. From December 1966 to September 1967, most were either late for trial, or did not show up for trial at all. This burdens personnel and delays the court. The problem is that the Act permits release of a felon pending trial, even though he presents a danger to the community, the presumption of innocence is that strong. There are some, under the Act, that come to trial with sometimes four other cases pending against them, all for offenses occurring while he was free. The U.S. attorney's office tries to advance such a case where the accused is charged with another crime while out on bail, and this is beginning to work.

He who has a chance to be released for nine months pendmore likely to plead not guilty, even though the evidence against him is overwhelming, to gain the opportunity to delay incarceration for at least nine months. With all our quaranties for a "speedy" trial, we have now defendants filing motions to delay trial to "prepare a defense," to gain even more free

Notwithstanding liberalization of the criminal process, the day of reckoning will come and the public safety will be assured. The U.S. Attorney's office has adopted pre-trial conference techniques which either stipulate facts or invite the accused to plead to the lesser included offense. The office is willing to discuss all the evidence in the case so that the accused will be better able to make an intelligent choice. For many years, the guilty plea rate was 80% here, but recently, this has fallen to 50%, due to the fact that the defendant is more than willing to take his chances in court. He now has well paid trial counsel available (paid by the government) and he knows that if he loses there, he can appeal and have the best attorneys represent him in the Appeals Court. truly disappeared equalizing justice as never before, but the price we must pay for a slowing up of the criminal process.

The length of the trial has been delayed by the myriad of special hearings such as a Mallory determination (speed of indictment), or Miranda and Escobedo (voluntary confession) or Stovall (Propriety of a line-up) or Luck (government's right to impeach the defendant by introducing his prior record) or a Jencks Act hearing (witness) statement before trial not agreeing with testimony at trial). Society should not be heard to complain about such delays when present courts are designed to deal with a procedural system of two decades ago.

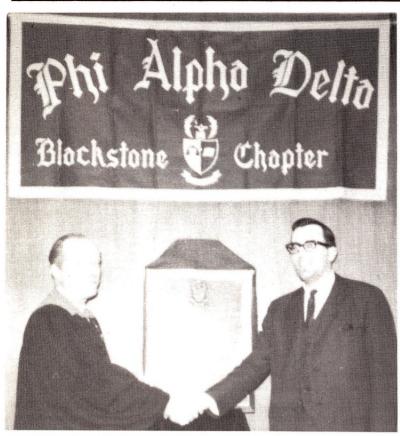

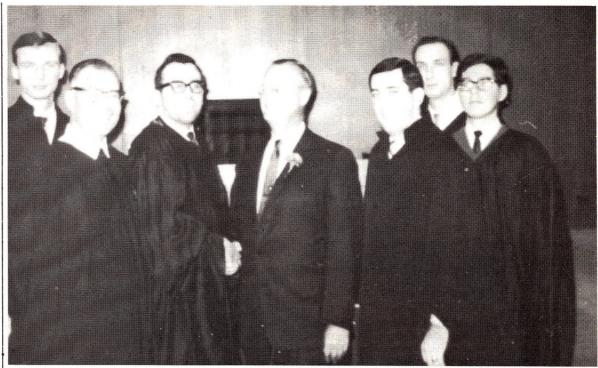

The auditorium, which had been filled with active brothers of P.A.D. and many alumni of Chicago-Kent and the Fraternity, was soon empty, leaving the plaque standing alone under a

(Continued from Page 2) the effort to establish greater respect for law and order must not become partisan political issues in 1968, President Earl F. Morris of the American Bar Associa tion said.

"I respectfully suggest that crime and 'respect for law and order' must be above partisan politics if we are substantially to reduce the former and re-establish the latter," he declared at a meeting of the Los Angeles County Bar Association.

"We must realize that law and order is more than an oft-repeated phrase. It is a vibrant, living thing, without which we - and that means lawyers and slum dwellers, politicians and statesmen - could not exist.

Morris, Columbus, O., lawyer who heads the 126,000-member ABA, said he foresees that crime will very likely be an issue in the 1968 campaign, "with each party contending it has the true answer, whether that answer be more bugging or more constitutional amendments or more money.

But he added that everyone must join in the effort to "seek a rededication of the citizens of this country to respect for law and order."

"Candidly," he continued, "I have some hesitancy in saying this - not because I do not believe that the need is one of prime importance — but because the words 'law and order' have developed almost a hollow ring. It has become somewhat like 'motherhood' which everyone is for, and 'sin' which everyone is against. It threatens also to become a political catch-phrase."

Morris said there are those who will liken the problem to the preacher's on Sunday 'that those who need to hear the message are not in the pews."

"But isn't only firmed criminal, the juvenile delinquent, and the inciter to riots who needs to hear the call. It is all of us - the businessman who thinks illegal practices in the marketplace are different than crime in the streets. the professional man who views his code of conduct as questionable restraints at which he chaffs, and the automobilist who drives well in excess of the speed limit with one eye on the rear view mirror ready to move back if a patrol car appears."

Morris stressed the importance of lawyers lending their full assistance in the crime war. He said the American Bar Association's broad program to establish minimum standards of criminal justice, and the recent creation of ABA's special Com-Control, were parts of that ef-

Another role of the lawyer in the crime war concerns the decisions of the U.S. Supreme tion meeting the late Roscoe Court in the crime field, Morris

said. He said lawyers must keep these decisions in their proper perspective and seek to have the public do likewise.

He pointed out the crime rate nationally had been increasing before the Mapp, Miranda and other controversial decisions. While it unfortunately continues to increase, certainly the curve did not shoot up sharply following any one or all of these decisions," Morris said.

"While the Supreme Court histcrically has been blamed for many of the ills that beset us ... I suggest that, whatever one may think of the recent decisions, it is impossible to support statements such as that they are responsible 'for the large number of criminals walking the streets today'.'

He said the rights of accused have been broadened by these decisions" and the issue of whether they impinge upon the public right to protection is one of deep concern, but added: "My basic philosophy is that it is still too early to tell fully what the effect will be and that we must stand ready to take corrective action if the public interest is impaired."

Crime rise gives new impetus to court reform, ABA president says.

President Earl F. Morris of the American Bar Association told the Vermont Citizens' Conference on the Administration of Justice that public concern about crime has given a fresh impetus to nationwide efforts to modernize court administration. Leaders of lay organizations participated in the statewide conference sponsored by the American Judicature Society.

In the past, court reorganization efforts have centered largely on civil law procedures, he said. But with the publication of the report of the President's Commission on Law Enforcement and Administration of Justice the focus on court needs has shifted to criminal proceedings.

"Everywhere I travel in this country, people are talking about the administration of justice and trying to devise methods of bringing our courts up to date and in line with changing times and needs," Morris told the conference.

"I am sure that many people working to improve the administration of justice have thought of their efforts as related to the civil side of the courts. This feeling was dispelled with the publication of the report of the President's Commission. It demonstrated that virtually all of the objectives which you seek and which we seek in other states are equally applicable to the criminal as to the civil side mittee on Crime Prevention and of our courts, and that achievement of these objectives will improve all justice.'

He recalled that in 1906 befcre an American Bar Associa-

(Continued from Page 8) Pound, then a young Nebraska "shocked the legal profession with a speech on the causes of popular dissatisfaction with the administration of justice.'

"The profession was mortified because never before had anyone publicly and so articulately stated the weaknesses of the judical system. What Roscoe Pound said 61 years ago was valid, and his words continue to have a ring of verity today."

The ABA president commended Vermont for recent advances including centralizing court administration, adoption of a plan for merit judicial selection and for removal of incapacitated and incompetent judges, and for replacing former municipal courts with district courts. But he said more needs to be done in Vermont and elsewhere to establish more businesslike methods and increase the capacity of the courts to cope with a vast increase in both civil and criminal cases.

Elimination of the judicial functions of justices of the peace, many of them non-lawsubstitution of judicial rule-making for rule-making by legislative agencies, and proved juvenile court procedures are among the urgent tasks remaining, he said.

He called for both bar and public support for bringing into effect the new proposals now being formulated by the ABA Special Committee on Minimum Standards of Criminal Justice under the chairmanship of U.S. Judge J. Edward Lumbard, of New York.

"By minimum standards we mean," Morris said, "rules and criteria which can be implemented by legislatures, courts and law enforcement agencies in an effort to improve the fairness, swiftness and certainty of criminal justice.'

Morris said the ABA House of Delegates is scheduled to act formally in February, 1968, on adoption of six of the Lumbard committee proposals. These are recommendations on fair trial-free press, post-conviction appellate review of remedies. sentences, trial procedures, negotiations for guilty pleas, and the providing of legal counsel for indigent defendants.

"If these standards are to be implemented," Morris said, "it must be done at the state level. This will call for leadership by citizens' groups as well as by bar associations, in urging upon legislatures and courts that appropriate steps be taken."

Two Gault lawyers call for further guarantees of juvenile rights.

CHICAGO - Two lawyers who represented the appellants in the landmark Gault case, which led the U.S. Supreme Court to extend certain constitutional rights to juveniles, today said further guarantees should be set out in guilt "beyond a reasonable

Prof. Norman Dorsen of New York University School of Law and Daniel A. Rezneck, who practices in Washington, D.C. said in an article in Family Law Quarterly, a publication of the American Bar Association's Section of Family Law, that other juvenile rights should include:

A clear definition of charges; confrontation and cross-examination of witnesses; jury trials in cases involving specific violations of criminal law; freedom from unreasonable searches and seizures; hearings to establish the need for pre-hearing detention; privilege against self-incrimination; access to all information developed by the juvenile court staff at the time of disposition; and individualized rehabilitative treatment.

In calling for juveniles to be provided a lawyer at the earli-

process, the authors of the article "In Re Gault and the Future of Juvenile Law," said "the intake point in juvenile court when juveniles are customarily interviewed by the court staffis a prolific source of juvenile admissions.

"Counsel can have a significant impact at the intake point in view of the range of alternative dispositions of the case potentially available at that time. Since one of these alternatives is the filing of a delinquency petition possibly leading to the juvenile's commitment, he may be prejudiced if he is not represented by counsel to contend against such a course of action. The intake stage is thus a critical stage of the proceedings for him, comparable to the decision whether to waive him for trial as an adult. The right of counsel seems to be the indispensable adjunct to a decision of such consequence.'

In the 546-page article, Dorsen and Rezneck said most juvenile courts apply the "preponderance of the evidence" standard in judging the guilt or innocence of juveniles. Instead, they tended, juveniles should have the benefit of the same "beyond a reasonable doubt" standard which applies in adult criminal cases in most state courts. They said the reasonable doubt test "is superior to all others in protecting against an unjust adjudication of guilt, and that is as much a concern of the juvenile court as of the criminal court.'

That is especially true, they added, when a jury is the trier of fact. They found it "difficult to see how the distinctive objecof the juvenile court (should permit) finding a juvenile to have committed a violation of the criminal law on less evidence than if he were an adult."

Dorsen is director of the Arthur Garfield Hays Civil Liberties Program at N.Y.U. as well as a professor. Rezneck now is co-ccunsel for the petitioner in the Whittington case which will be considered by the Supreme Court early in 1968. That case raises issues relating to standard of proof, fact-finding procedures, interrogation and detention of juveniles.

In a companion article in the quarterly, Judge Justine Wise Polier of New York State Family Court agreed that procedural safeguards are desirable but she said more than that is needed. She observed that in New York "judges are all too aware of how little adequate notice, the right to counsel, the privilege against self-incrimination, and the right to confront witnesses have affected what is done or left undone to meet the needs of children brought before the

court." CHICAGO - A special committee of the American Bar Association has initiated action to mobilize the nation's lawyers in the war against crime, with a personal endorsement of its effort from President Johnson.

President Johnson sent a telegram to Leon Jaworski, chairman of the Special Committee cn Crime Prevention and Control, commending the Association for giving high priority to the national effort. President Johnson stressed that success depends on bar and public supports of local law enforcement in every community.

been started. In turn, state bars will be invited to join ABA in an appeal to local bar associations in their states to set up counterpart committees to consider action programs keyed to local needs.

With the creation of such a nation-wide bar-committee network, the ABA committee plans to disseminate specific suggestions for types of programs which local bar organizations could consider undertaking to assist local law enforcement agencies in meeting local problems.

President Johnson's telegram to Jaworski, a Houston attorney who served on the President's Crime Commission, pointed out that "throughout our history law enforcement has been a local responsibility."

"It must remain so," the President said, "for the concept of a centralized police force is repugnant to our national tradition. The challenge of crime and lawlessness will be met when local authorities are supported by a concerned and understanding public, and, in appropriate ways, by the federal government when they are unable to cope with the problems themselves. As you know, I consider the war against crime to be one of the top priority concerns of my administration. The Safe Streets and Crime Control Act now being considered by the Congress would provide needed assistance to local communities to support their local enforcement efforts.

"I am encouraged to know that the American Bar Association is focusing on law enforcement as a primary area of its activity. Your eminent organization can spearhead a program of action through state and local bar associations that can assist our states and cities in improving the administration of justice. For the front lines in the war against crime are in the streets and alleys of the local communities across America. I commend and congratulate the American Bar Association on its timely action."

The committee decided to immediately assemble a manual of information describing ways in which some bar associations already have inaugurated liaison and cooperation programs with law enforcement agencies. This manual, which will include several programs which have won ABA Awards of Merit, will be designed for guidance of local committees. Such programs include lawyer assistance in police training academies, education programs in schools, local bar aid in communicating law enforcement needs to the public, and public recognition of police achievement.

Also in the manual will be recommendations of the President's Crime Commission which relate to the sphere and com-
