

Murphy Chapter Installed

American Bar Association President William T. Gossett today suggested to student protesters a different "frame of reference for confrontation — not the confrontation of four-letter words and slogans, but the confrontation that can in fact bend and shape institutions to serve the best of human pur-

Gossett, a Detroit lawyer, spoke on "The Politics of Dissent" at the Winter Commencement of the University of Michigan where he was awarded an honorary doctor of laws degree.

He called this the "most committed, most intelligent, most idealistic college generation in this nation's history" and said the spirit of protest on college campuses can have good results if it is properly channeled. But he warned that "obstructionist protest" can defeat the purpose of valid dissent and destroy positive values built over a long period of years.

The former general counsel of Ford Motor Company said he was aware that student dissent "is at root an act of patriotism and hope."

"We have seen too often those who equate dissent and disaffection with treason, thus brandishing all those who object to a policy or an act as unfaithful to America," said Gossett. "That view is worse than nonsense; indeed, it is dangerous. For it cuts out the middle grounds between the individual's absolute support of absolute rejection of America."

Gossett urged the graduates to be skeptical of the "absolute certainty" of their views.

"When a group protests the war in Vietnam, or university complicity with military research, by shutting down a campus or burning a professor's files or by other acts of brute force, it has done precisely what every totalitarian government has done," he said. "It has assumed the absolute and final truth of its perspective, and has denied any possibility of error."

He also warned young dissenters of the danger of self-defeat contained in methods of "upheaval and destruction."

"What kind of community of love is going to spring from the ashes of violence and disruption" asked Gossett. "What kind of moral imperatives will remain intact if your conruct denies the essential humanity of your fellow man - even if he did support the Vietnam War?'

The bar leader called on dissenters to recognize a distinction should 'be made between institutions and processes" and that "this generation have the courage to consider the possibility of bringing about fundamental, substantial change of institutions through orderly and peaceful processes.

"Today there are young lawyers across this country who are posing challenges to injustice far more vital than a frenzied outburst of violent emotion. They have successfully fought for farmworkers in California against the federal and state governments. They have won battles against medieval welfare laws in New York. They are reaching into the roots of social legislation — into the highway and urban renewal programs, into health care programs; they are demanding that the rights of those minorities affected by these programs be fully protected in their frequently ignored constitutional dimensions.

"They are struggling against all of the elements that have denied the poor equal protection of the law - in criminal cases, against consumer frauds, against slum landlords. They are, in effect, waging a continuing dissent against the status quo every single day in the courtrooms of America. And they

Message From The Supreme Justice





Hughes Chapter Frolics

After a very active fall, members of the Hughes Chapter relaxed at the Silver Slipper Saloon in historical Central City, Colorado during the evening of November 15, 1968. Special arrangements were made by PAD member Burton Cawthorne who is the proprietor of the Silver Slipper. Western attire added authenticity to the gathering of wives, dates, alumns, and members who enjoyed singing many old western songs with a honky tonk piano accompaniment. Hughes Chapter would like to share some of Central City's interesting history with other fraternity members throughout the country.

Central City has been considered by many to be the most colorful town in Colorado. In 1859 several gold strikes were made. Even though a supposedly worthless claim was salted with gold dust, the news of a major strike carried around the world. Central City absorbed most of the camps in the area west of Denver and soon became the largest city in Colorado producing multi-millions in precious metals.

It was said that a bootblack in a hotel in Central City became rich by washing the rags that he used to clean boots, and panning the muddy water for gold. When a shaggy dog came into the hotel, he was given a place to shake the dust off and sleep. Then the area was swept and panned for gold.

Later Central City gave birth to culture in Colorado. Miners and dance hall girls were refined into a polished group. Before one play was performed, the theatre owner, by the name of George W. Harrison, gunned down a boxer named Charlie Swits by pumping thirtyfive shots into him. Harrison's novel legal defense was based on the fact that he didn't like Charlie. Since the jury didn't like Charlie either, Harrison was acquitted.

Many notable performers came to Central City, including Lillian Gish, Louis Calhern, Faye Emerson and Helen Hayes. President Grant was perhaps its most distinguished visitor in 1873, the city fathers sent to Caribou for silver bricks and lined the entrance of the Teller House in order that Grant could walk on pure silver when he alighted from the stage.

Like many of the towns of that era, major fires ravaged the city and a diptheria epidemic killed hundreds in 1879. The city was snowbound for two weeks in 1913 but still the town did not die. Today its population is increasing and it has a summer festival of cultural that is the highlight on the summer theatrical calendar from Maine to California.

So if you wish to enjoy theater or opera or maybe visit the past at Glory Hole, the richest square mile on earth, and search for bits of gold tailings, visit Central City. Don't forget to look up Burt Cawthorne at the Silver Slipper. When you get there, walk and don't drive. You will see and enjoy much more.

PADS SCORE IN NATIONAL ELECTIONS

The recent National Elections involved PADs as candidates for virtually every type of office ranging all the way from the highest office in the land, the Presidency, to the office of city councilman.

Forging a dramatic political victory for the White House was the PAD team of President Richard M. Nixon (Rutledge Chapter) and Vice-President Spiro T. Agnew (Darrow Chapter). There were PADs among the opposition such as Senator Edmund S. Muskie (Wilson Chapter) candidate for Vice President and former Governor George C. Wallace (Morgan Chapter) candidate for the Presidency.

Named by Brother Nixon to serve as Secretary of Health, Education and Welfare was Robert H. Finch (Ross Chapter). Brother Finch was the Lt. Governor of California at the time of his selection for the Cabinet and figured prominently in the President's campaign.

Elected to the Unted States Senate was former Congressman Charles M. Mathias (Jay Chapter) of Maryland. Re-elected to the United States Senate for six year terms were Senator Frank Church (Kent Chapter) of Idaho; Senator Alan Bible (Taft Chapter) of Nevada; Senator Norris Cotton (Roberts Chapter) of New Hampshire and Senator Gaylord Nelson (Ryan Chapter) of Wisconsin.

Still incumbents are Senators Robert C. Byrd (Brandeis Chapter) of West Virginia, Frank Carlson (Green Chapter) of Kansas, Robert P. Griffin (Campbell Chapter) of Michigan, Fred R. Harris (Harlan Chapter) of Oklahoma, Roman L. Hruska (Roberts Chapter) of Nebraska, Edmund S. Muskie (Wilson Chapter) of Maine, John Sparkman (Morgan Chapter) of Alabama, William B. Spong (Jefferson Chapter) of Virginia, John Stennis (Jefferson Chapter) of Mississippi, and Strom Thurmond (Pinckney Chapter) of South Carolina.

Senator Edward M. Kennedy (Jefferson Chapter) of Massachusetts was selected as Majority Whip by his fellow Senators while Senator Hugh Scott (Roberts Chapter), of Pennsylvania was selected as Minority Whip.

Professor Tevis served as the 1966-67 chairman of the Governor's Commission on the Law of Preemption and he is a member of the Pasadena, Los Angeles, California and American Bar Associations.

Indiana Jurist Passes Away

The Honorable Homer J. Byrd (Blackstone Chapter), Judge of Wells Circuit Court for an unprecedented 20 years in Northern Indiana has passed away. Brother Byrd was one of Northern Indiana's prominent and distinguished jurists who had strong support for a State Supreme Court nomination and once was advanced for Governor of Indiana. He previously served as a councilman in Arlington Heights, Illinois, a four year terms as Magistrate in Cook County, Illinois, and as Democratic Ward Comitteeman in Cook County for 8 years and in 1930 was elected to the office of County Commissioner of Cook County. In 1934 he was selected by Governor Henry Horner to administer the professional trade laws for the State of Illinois.

Judge Byrd returned to Wells County, Illinois in 1943 to resume the practice of law until his election to the Circuit Court Bench in named by President Eisenhower to 1948. Prior to assuming the Judgeship he served as president of the Bluffton (Illinois) Chamber of Commerce and two terms as chairman of the Wells County Democratic Central Committee.

stitutions without tearing them up by the roots, without ripping to shreds the fabric of American life."

Gossett said he did not ask the dissenters "to put aside that sense of indignation at conditions that in fact seem to demand your anger." He asked they "place on this indignation a sense of perspective: a perspective that retains love of this nation as an incentive to act; that remembers the need for the restraint that can prevent dogmatism: that avoids throwing away the moral imperatives of dissent; and that recognizes the possibility of prodding our structures effectively through peaceful protest."

The team was undefeated in five debates losing only in the finals to the Nebraska Petitioners. Both the Wisconsin and Nebraska team will go to the National Finals. There they will compete against approximately 25 other teams who were winners in their regions. Mr. Welker as Vice-Justice of Ryan Chapter and Mr. Apfelberg is Clerk for the Fall, 1968 Semester. Region 12 includes all the law schools in Wisconsin, Minnesota, Nebraska, Iowa, North Dakota and South Dakota.

HARLAN ALUMNUS **RETIRES**

Q. B. Boydstun (Harlan Chapter) of Fort Gibson, Oklahoma and general counsel of the Grand River Dam Authority will retire effectively February 1, 1969.

Brother Bodystun was born in 1898 in Caddo, Indian Territory and has served as attorney and general counsel for the Grand River Dam Authority for more than 30 years. During that time Boydstun has seen the G.R.D.A. grow to a 95 million dollar public corporation. Brother Boydstun received a law degree from the University of Oklahoma School of Law in June 1919 and has been admitted to practice law in the U.S. Supreme Court, U.S. District Courts, Oklahoma Supreme Court and the U.S. Court of Claims. Brother Boydstun is a member of the American Bar Association, Oklahoma Bar Association, Muskogee County and Craig County Bar Associations.

Wash., D.C., **Jurist Resigns**

The resignation of Associate Judge Frank H. Myers (Jay Chapter) from the District of Columbia Court of Appeals was recently accepted by President Johnson.

A Washington, D.C. native, Brother Myers was in private law practice there when President Truman, himself a PAD, in 1948 appointed Judge Myers to the Bench of Municipal Court now called the D. C. Court of General Sessions.

In 1956, Brother Myers was the Domestic Relations Branch of the Court and in 1962 President Kennedy elevated him to the Court of Appeals for a ten year term.

Taylor Chosen Minority Leader

Charles H. Taylor, (Timberlake Chapter) at Wake Forest University, was chosen Minority Leader of the North Carolina House of Representatives for the coming 1969 session. Taylor, a District Justice of Phi Alpha Delta since 1967, was first elected to the State House in 1966. He was subsequently reelected in 1968.

In both the 1966 and 1968 legislatures, Representative Taylor is the youngest member of record. In his first term, he completely rewrote North Carolina's antiquated epilepsy laws, bringing them up to modern standards. North Carolina law on epilepsy is now considered some of the most enlightened in the nation.

WILLIAM D. METT





The Henry C. Morris International Law Essay Contest is being conducted by the ABA Law Student Division, with the cooperation of the ABA Section of International and Comparative Law, and with funds provided for in the will of the late Henry C. Morris of the Chicago bar. The purpose of the contest is to create a greater interest in international law among law students.

Eligibility: All law student members of the American Bar Association are eligible to compete, except for executive officers of the Law Student Division and employees of the American Bar Association and the American Bar Foundation.

Cash Awards: Members of the ABA Section of International and Comparative Law, who will serve as judges, will select the two best essays submitted. A first place cash award of \$500 will be presented to the most outstanding essay, with the runner-up receiving a cash award of \$300. The winners will be announced and the prizes awarded during the ABA's August 11-15, 1969 annual meeting in Dallas, Texas. The awards will not be made if the judges determine there are no worthy entries.

How to Enter the Contest: Law student members of the American Bar Association considering entering the contest should write immediately to the Law Student Division of the American Bar Association (1155 East 60th Street, Chicago, Illinois 60637 to request an entry form. This entry form, when returned to the contestant, will contain a contest number to be placed on his essay so that his identity will not be known to the judges. The entry form must be completed and returned to the Law Student Division with the essay being submitted for award consideration.

Contestants may submit an essay on any aspect of international law. The essay, to be submitted in quadruplicate, shall not exceed 3,000 words in length and be typed double-spaced. The contestant's name is not to appear on any copy of the submitted essay. Instead, the contestant shall use the contest number assigned to him by the Law Student Division. This number shall appear in the upper right hand corner of each page of the essay.

Essays to be considered for the cash awards must be submitted to the Law Student Division postmarked on or before June 30, 1969.
