

## Alden Chapter Installed At Buffalo Law School

December 7, 1968 was the proud occasion of the installation of the Carlos C. Alden Chapter at the State University of New York at Buffalo School of Law. The installation and initation ceremonies occured in the Supreme Court Chambers of the Erie County (N.Y.) Hall followed by a champagne reception in the Blue Room of the M and T Plaza Suite in Buffalo.

The Chapter was named after Carlos C. Alden who served as the law school's first dean from 1904 until 1936. Milliard Fillmore, the first Chancellor of the University of Buffalo and later thirteenth President of the United States, established the "Department of Law" and incorporated the Faculty and the students of the former Buffalo-Niagra Law School. Dean Alden was noted for his keen interest in the school and his energy and drive which produced outstanding accomplishments during his administration. The extension of the course of student from two to three years, the raising of pre-law requirements, the acquisition of a separate law school building and the establishment and expansion of a law library stand out among his accomplishments.

Joining the 36 students as charter members were Dean William D. Hawkland (Magruder '47), Assistant Dean George P. Smith, III (Hamill '65) and Professor John Hollands. Serving on the installation team were Supreme Justice Henry C. Rohr, Supreme Historian Donald R. Moore, Associate Tribune Kenneth C. Segal Special Assistant Frank J. McCown, Dean Hawkland and Assistant Dean


## **PAD Goes International**

## \$10,000 PAD Trust Established by John A. Kerr

Brother John Alexander Kerr, who was initiated into Ross Chapter at the University of Southern California in 1938 died suddenly February 22, 1969 at the age of 57. He was born in Portland, Oregon.

Brother Kerr left the sum of \$10,000 to the University of Southern California to be used for a scholarship to be awarded to a member of Phi Alpha Delta at the University of Southern California Law School at the end of his first year of law school. The recipient each year is to be chosen by the Dean of the law school, all PAD faculty members and the Justice of the active chapter. Consideration is to be given to the student's character, scholastic aptitude and lack of financial means and preference is to be given to students coming from the College of Commerce and Business Administration of the University.



JOHN ALEXANDER KERR

Brother Kerr graduated from Harvard Military Academy in Los Angeles and attended the University of Southern California receiving his B.A. in 1936 and his LL.B. in 1939. While in college he enjoyed sports and was a member of the varsity track team.

He was thereafter admitted to the California Bar and to the United States Courts of that State. Following extensive travel, he engaged in the practice of law specializing in the fields of corporate law and finance.

During his lifetime Brother Kerr was an active member of the San Fernando Valley and Los Angeles County Bar Associations, of James A. Garfield Masonic Lodge, of Kappa Sigma Fraternity and of the North Hollywood Presbyterian Church.

# Rutherford B. Hayes Chapter Installed at Franklin Law School

Phi Alpha Delta's 116th Chapter was installed in ceremonies at Columbus. Ohio, on February 22, 1969. Supreme Justice Henry C. Rohr was presiding officer.

The new chapter at Franklin Law School of Capital University is named after Rutherford B. Hayes, the Nineteenth President of the United States. President Hayes also served as City Solicitor of Cincinnati, United States Representative, and Governor of Ohio.

The charter was received on behalf of the Hayes Chapter by Chief Justice Kingsley A. Taft (McKinley 28) of the Ohio Supreme Court. The presentation was made at the installation ceremonies held in the United States District Court for the Southern District of Ohio, Eastern Division, in Columbus.

Supreme Justice Henry C. Rohr presided over the ritual. Also participating were Associate Tribune Kenneth C. Segal, District IX Justice Lawrence S. Turner, Special Assistant to the Supreme Justice members and honorary members, Frank J. McCown, and Brothers from the neighboring McKinley Chapter at Ohio State University.

In planning for some six months, the colony at Franklin Law School was formed following an open rush in October, 1968. Assisting in the planning and organization of the chapter were Lawrence S. Turner, District IX Justice; Frank J. Mc-Cown, Special Assistant; and Robert A. Butler, head of the Central Ohio PAD Alumni Chapter.

Following the installation a reception was held for the newly-initiated members and guests at the Neil House Hotel.

On Sunday, February 23, 1969, a breakfast was held at the Neil House Hotel, at which time Supreme Justice Henry Rohr, assisted by Brothers Turner, Segal, and Mc-Cown, installed the officers of the Rutherford B. Hayes Chapter.

The new chapter already has plans underway for a number of social and professional activities. Included among these are several professional seminars, participation with the Columbus Police Department as observers in patrol cars, plans to initiate a number of alumni rush parties and social events.

Franklin Law School became a part of Capital University in 1965, and the first classes were held on the Capital campus, in suburban Bexley, in September, 1966. Although Franklin Law School has held only evening classes since its inception, a day division has been established and will begin its first classes in September, 1969.

### Morgan Chapter **Toastmasters Program**

Our toastmaster's program, although still in the infant stage, has provided the chapter with one of the best methods to bring our members closer together and thereby making us a strong organization. Our program began this past summer, when Richard Charlton and Ross Diamond decided that we needed some function other than chapter Gerald M. Kaplan, Donald F. Williamsburg, Virginia was the site for the 1969 joint Conclave of Districts XIII and XIV the weekend of February 28-March 2.

This was the 20th annual Conclave for this middle Atlantic area.

Chapters represented were Brandeis at American University, Cardozo at Catholic University, Darrow at University of Maryland, Henry at University of Richmond, Jay at George Washington University, Jefferson at University of Virginia, Langston at Howard University, Staples at Washington & Lee University, Taft at Georgetown University, Willey at University of West Virginia, Wythe at College of William and Mary.

The opening function was a model initiation conducted Friday evening with the initiates coming from various chapters as did the participants in the initiation team. The Great Hall of the Wren building on the campus provided a most impressive background for the exemplification of the ritual. The initiation team was headed by Wythe Chapter Justice Harry Saunders.

Following the initiation the traditional reception was held with wives and dates swelling the crowd.

The Saturday morning session was preceded by a Continental breakfast. The feature of the morning program was a seminar on various chapter activities conducted by past Supreme Justice Robert E. Redding and District Justices Dan Halpin and Charles Taylor. Subjects covered included Pledge Indoctrination, Honorary Membership Program, and Exemplification of the Ritual.

The Conclave luncheon with about 40 in attendance featured a down to earth bread and butter talk by Charles Rideout, a Williamsburg attorney, who discussed in an entertaining but instructive way the highlights of his early months of practice both as an associate in a law firm and as a solo practitioner.

One of the resolutions adopted by the Conclave was to favor the admission of women into membership.



Donald M. Graham (Fuller Chapter) has been selected as chairman and chief executive of Continental Illinois National Bank and Trust Company, the nation's eighth largest bank. Brother Graham succeeds David M. Kennedy who was named Treasury Secretary by President Richard M. Nixon (Rutledge Chapter).

## PAD's Place in National Moot Court

The Justice and Vice Justice of Watson Chapter of the University of Pittsburgh School of Law, led the school's team to the posiion of second in the National Appellate Moot Court Competition ast December.

At the final rounds held at the House of the Association of the Bar recently in New York City, the Pitt team defeated four other teams before being edged out by the team from the Georgetown University School of Law in the last round before The Honorable Thurgood Marshall, Associate Justice of the Supreme Court of the United States. Allan McClain, Justice of Watson Chapter was awarded the trophy for Runner Up Best Individual Oral Argument in the competition.

The team consisted of three members, two of whom were PADs. Mr. McClain, a second year student and Edward Symons of the third year class agrued for the team. Michael A. Malakoff, Vice Justice of Watson Chapter, did much of the vital research for the brief and assisted in preparation for the oral agrument. Mr. William J. Brown, Faculty Advisor to Watson Chapter, advised the team.

The argument in this year's competition centered around the constitutionality of the war in Viet Nam. The case was before the Supreme Court of the United States on Writ of Certiorari from the circuit court where the petitioner, a private in the United States Army who had refused to go to Viet Nam with his unit, had already lost his first appeal from an adverse ruling of the district court. The case had been originally dismissed on the grounds that it presented a purely political question. The fact situation in the case was quite similar to that of Luftig v. McNamara in which certiorari was denied last spring Sub.



# Supreme Executive Board Meets in Houston, Texas

The Supreme Executive Board of the Fraternity met January 24-26, 1969 in Houston, Texas at the Shamrock Hilton Hotel pursuant to call of the Supreme Justice Henry C. Rohr.

Present were Supreme Justice Henry C. Rohr, Supreme Vice Justice Alex Hotchkiss, Supreme Advocate Matthew S. Rae, Supreme Secretary C. Raymond Judice, Supreme Treasurer Don Hutson and Supreme Historian Donald Moore. Also sitting with the Board were Past Supreme Justice and Chairman of the Supreme Advisory Board Robert E. Redding, Executive Director Fredrick J. Weitkamp and Executive Secretary Richard P. McCully.

Among items discussed and action taken by the Board during its three day meeting was the following:

- 1. Adoption of a policy that no active chapter shall be named after a known member of another law fraternity.
- 2. Approval of a petition for an active chapter charter at Capital University School of Law to be known as Rutherford B. Hayes.
- 3. Referral to the Supreme Advisory Board of the matter of determining basic goals of the Fraternity for report and recommendation.
- 4. Adoption of a policy opposed to multiple honorary initiations in any one ceremony except in en bane or substanially en bane initations of Courts.
- 5. Referred the matter of appropriate Founder's Day celebrations, both National and local, to the Professional Programs Committee.
- 6. Appointed an interim Constitution and National By-Laws Committee for continuing review of the Constitution and National By-Laws of the Fraternity.
- 7. Received a complete report on the Fraternity's sponsored insurance programs and adopted certain modifications thereto.
- 8. Revised the travel allowance formula for Conclaves to provide for an allowance of 10c per mile per chapter for roundtrip road mileage and if more than six actives or pledges attend and a second automobile is sent then such chapter shall receive an additional 10c per mile for roundtrip road mileage.
- 9. Directed the Executive Director and Executive Secretary to present to the Supreme Executive Board a concrete proposal for a historical display in the Executive Office.
- 10. Directed the Supreme Justice to appoint a committee of three persons to conduct a study of the manner of nominations and elections of national officers.
- 11. Directed that a committee be appointed to study the problem of how to achieve more effective

Supreme Executive Board-Law Student Relationships.

- 12. Adopted fixed dates for the 1970 Convention of September 2, 3, 4 and 5, 1970.
- 13. Assigned areas of planning for the 1970 Convention.
- 14. Adopted the general program for the 1970 Convention.
- 15. Selected San Francisco, California for the 1972 Convention and adopted the dates of August 30, 31, September 1, and 2, 1972.
- 16. Directed the Supreme Justice to appoint an investment committee to consider the investment of the General Funds of the Fraternity as they may exist from time to time.
- 17. Directed the appointment of a committee to study the problem of Endowment Fund Loans and all of its ramifications.
- 18. Designated Supreme Justice Henry C. Rohr and Executive Secretary Richard P. McCully to attend the 1969 American Bar Association meeting and adopted a budget for the PAD Reception at such meeting.
- 19. Adopted a policy of distributing the 1970 edition of the PAD Directory to all alumni members upon payment of their alumni dues, and the distribution of one copy to each active chapter and to each library of all law schools where an active chapter of PAD exists.
- 20. Approved the entry of a final order of expulsion of certain members of Fuller Chapter.
- 21. Established a price for the sale of the official History of the Fraternity.
- 22. Referred to the committee on Justice Under Law the matter of a student to student program.
- 23. Reaffirmed the policy of encouraging all active and alumni chapters to participate in Law Day U.S.A.
- 24. Reviewed the matter of expansion and reactivation.
- 25 Directed the appointment of a special committee to make an in depth study on the subjects of financial delinquencies and irregularities on the part of active chapters and individual members, the question of appropriate penalties or other corrective measures such as trust fund deposit of initiatition fees, etc., and the appropriateness of present procedures relating to seating of convention delegates.
- 26. Adopted an official flag of the Fraetrnity .
- 27. Referred the matter of the use of law students for indigent defense to a committee for report at the next meeting of the Supreme Executive Board.
