PAD Day at Supreme Court

On Monday, June 1, 1970, 46 PAD Brothers were admitted to practice before the Supreme Court of the United States. The admission group represented 17 states and the District of Columbia. Their admissions to the Bar of the Nation's highest Court were moved by Associate Justice Tom C. Clark (retired).

Mr. Justice Clark, a former Supreme Vice Justice of the Fraternity, hosted a reception in the Supreme Court building honoring the new admittees preceding the admission ceremonies.

A luncheon followed at the Rayburn House Office Building during which Mr. Justice Clark, retiring Director of the Federal Judicial Center, and John F. Davis, retiring Clerk of the Supreme Court, were honored for their public service and for their service to Phi Alpha Delta. The presentation of certificates of distinguished service, as well as gifts, was made by Robert E. Redding, past Supreme Justice of PAD.

Judge Alfred P. Murrah, past Supreme Justice of the Fraternity, was honored in absentia as Brother Clark's successor as Director of the Federal Judicial Center. Judge Murrah was formerly Chief Judge

of the United States Court of Appeals for the Tenth Circuit.

The luncheon program included remarks by Supreme Historian Donald R. Moore; Past Associate Tribune William B. Robertson and District Justice Dan D. Halpin, Jr. Mr. Robertson was Chairman of the Arrangements Committee, which included Frank Caccipaglia and William J. Pendleton.

Seaver New U.S. Supreme Court Clerk

Brother E. Robert Seaver has been appointed Clerk of the Supreme Court of the United States to succeed Brother John F. Davis.

Brother Seaver was a member of Benton Chapter at the University of Kansas City and served as an officer in that chapter for three years. He was voted the most outstanding member of the chapter in his senior year.

Upon graduation from law school he continued briefly in the employment of a large law firm in Kansas City and thereafter went on active duty as a reserve midshipman at the United States Naval Academy in December, 1941. He served on active duty in the Navy for four years, had duty as commanding officer of minesweepers in the South Pacific Theater and later as a lecturer in mine warfare. He was re-

leased from active duty in December, 1945 and retired from the Naval Reserve with the rank of Captain in 1964.

He re-entered private practice in Kansas City, Missouri at the end of World War II and in addition served as a Principal Assistant City Counselor until 1949 when he moved to Washington, D.C. to accept a position as an attorney for the federal government.

He served with the Department of Justice for five years and in 1957

Past Supreme Justice J. Harry "Hap" LaBrum Dies

Brother J. Harry "Hap" LaBrum, who served as Supreme Justice for a longer period than any other person, passed away April 4, 1970 in Philadelphia, Pennsylvania.

Hap LaBrum served as Supreme Justice from 1938 to 1946 during some of the most troubled years in the history of the Fraternity. It was largely due to his stewardship and vision that the Fraternity emerged from World War II in a position which enabled it to thereafter make rapid strides toward its eventual achievement of the position of being the leading law fraternity in the world.

Brother LaBrum was a senior partner in the law firm of LaBrum & Doak, and was a Fellow of the American Bar Foundation, a Fellow and Director of the International Academy of Trial Lawyers, and President of the Federation of Insurance Counsel Foundation.

He enlisted in the Army as a Private in World War I and was discharged as a Sergeant. During World War II he served in the Signal Corps as an officer where

he received the Legion of Merit Award, the Order of the Crown of Italy and the American Commendation Ribbon. He retired from active Army duty in 1945 but remained active in the reserve retiring in November of 1962 with the rank of Brigadier General.

During his career he also served as chairman of the National Conference of Lawyers, Insurance Companies and Adjustors of the American Bar Association and as a Consul General for Finland in the States of Pennsylvania and New Jersey.

His community activities were many and varied. Included among them were the presidency of the Greater Philadelphia Chamber of Commerce, the presidency of the Philadelphia School Board and directorships in various corporations and community organizations.

He was a member of the Philadelphia, Pennsylvania and American Bar Associations, the Union League, the Racquet Club, the Port of Philadelphia Maritime Society, the Catholic Philopatrian Literary Society and the Pen and Pencil Club.

The last PAD Convention which he attended was the 1968 Convention in Washington, D.C., where he was awarded membership in the Distinguished Service Chapter of the Fraternity, the highest honor which can come to a member.

To all brothers in PAD.

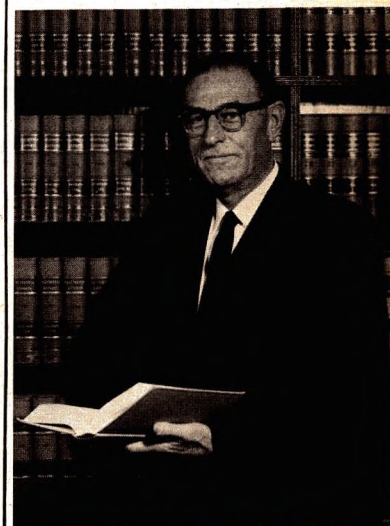
My message for this Alumni issue of the Reporter is primarily directed to our Alumni members.

Edward Bennett Williams To Head ABA War on Crime

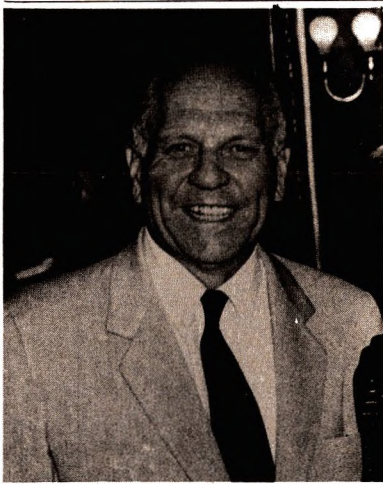
Brother Edward Bennett Williams, one of the country's leading trial lawyers and a member of Taft Chapter of the Fraternity, has been appointed chairman of the Crime Prevention and Control Committee of the American Bar Association.

Brother Williams background in criminal law is extensive having taught criminal law and evidence at Georgetown University where he earned his law degree. He has also been guest professor at the University of Frankfurt, in Germany.

He is president of the Washington Redskins Football Club and a member of the Board of Regents of the American College of Trial Lawyers. He has authored two books on law: "One Man's Freedom" and "You in Trial Law" and has also written numerous articles for national magazines.

The purpose of this ABA Committee is to study the problems of crime and secure action for its prevention and control and is currently involved in a project to stimulate and assist state and local bars in implementing the recommendations of the President's Crime Commission.

The Committee is establishing a series of pilot programs in several cities working with state and local bar groups to meet crime control and criminal justice problems. Information gained through these pilot studies is being used to develop a manual to help other state and local bars launch similar action programs.

The beautiful and modernistic United States Custom Courthouse in New York City was dedicated May 11, 1970 by Chief Justice Warren E. Burger (Jay). He praised the building in its design and called it an inspiration to the people who worked there.

The second speaker at the ceremonies was former Assistant Justice Tom C. Clark of the Supreme Court (Taney) one of the original sponsors of a bill now before Congress that would modernize the Custom Courts procedures. He too praised the court building and gave Chief Justice Paul P. Rao, also a PAD, most of the credit for the building's completion.

The Courthouse is the first for the 44 year old Customs Court, the arbiter of all tariff disputes between importers and customs agents.

Professional Interfraternity Conference Holds Meeting

The Professional Interfraternity Conference held its 1970 Biennial Meeting at the Cascades Meeting Center, Williamsburg, Virginia, on May 8 and 9. Representing Phi Alpha Delta were Supreme Justice Henry C. Rohr, Supreme Vice Justice Hon. Alex Hotchkiss, and Past Supreme Justice Robert E. Redding.

The theme "Retention and Expansion" was developed through panel discussions on student chapters, alumni participation, ladies' auxiliaries, local professional interfraternity councils and insurance programs. Contemporary campus conditions were given extensive discussion. Participating in this discussion were Messrs. Armand L. Zanecchia and Tom Martin, student members of Alpha Kappa Psi from Old Dominion University.

The role of the PIC and its contributions to member fraternities was studied, and suggestions presented for restructuring the organization's program. An interim committee will be appointed to study proposed improvements. A special Meeting of the Conference is to be called before June 1 next year with fraternities urged to include student members among their delegates.

The Hon. Benjamin B. Blackburn, Sigma Delta Kappa, Congressman from Georgia's Fourth District, addressed the delegates and their wives at the Banquet on Friday evening.

The idea exchange exhibition, a regular PIC Meeting feature, included displays from several of the member fraternities. An inspiring paper titled "Why Fraternities?" was presented by Dr. Bernard B. Brody of Rho Pi Phi, Illinois.

The opening session included special reports on recent federal tax legislation affecting professional fraternities and on the current Federal Trade Commission litigation involving fraternity insignia regulation. Results of the recent survey of professional fraternities were presented, and a new leaflet on professional fraternities was introduced.

The Professional Interfraternity Conference, established in 1928, comprises twenty-six leading professional fraternities in eleven professional fields. These fraternities have initiated over 850,000 men through their more than 1450 student chapters.

District X, having been recently formed, comprises chapters in the southern halves of Illinois, Indiana and Ohio and all chapters in Kentucky.

CLARK HONORED IN WASHINGTON

Justice Tom C. Clark of the Supreme Court of the United States (retired) was honored by the Fraternity on PAD Day at the Supreme Court, June 1, 1970.

Following the Supreme Court Admission Ceremonies a luncheon was held at the Rayburn House Office Building. Mr. Justice Clark was honored as the retiring Director of the Federal Judicial Center and was presented a gift from the Fraternity.

Past Supreme Justice Robert E. Redding made the presentation and in doing so made the following comments:

"It is difficult indeed to make appropriate reference to the high achievement of Brother Tom C. Clark, whether on occasion of PAD recognition or at any other gathering. While it is a high honor indeed to be privileged to make such remarks, the challenge is indeed formidable in preparing and delivering them with sufficient measure of the man.

Someone once said that whatever a man does for himself dies with him. What he does for others lives on forever. It is in this framework that I make my remarks today. This is because Justice Clark has truly typified the truth of such words.

Aside from having become a distinguished national figure while serving as the Attorney General of the United States, Justice Clark made an indelible mark on the walls of history by serving 18 years on the nation's highest bench.

He then became the first Director of the Federal Judicial Center dedicated to the improvement of our judicial system. Chief Justice Burger has spoken highly of his dynamic leadership in that capacity, with the further statement that his contribution to the entire judicial system is 'unparalleled.'

Justice Clark also held leadership positions in many widely known philanthropic activities, including the Boy Scouts of America. He also found time to serve as Supreme Vice Justice of PAD for two years. The Fraternity has since conferred its highest honor upon him by conferring membership in the Distinguished Service Chapter of Phi Alpha Delta.

His activities for others are reflected in a somewhat different manner but with equal impressiveness by a statement on August 15, 1967, when he was presented to the National College of State Trial Judges by Professor Maurice Rosenberg: Professor Rosenberg referred to 'that astonishing vigor of his that combines a billion volts of effective energy with an endless capacity for sheer unaffected human kindness.'

Justice Clark, what you have done for others will indeed live on forever. We treasure your Fraternal fellowship and service and wish you many more years of happiness and good health."

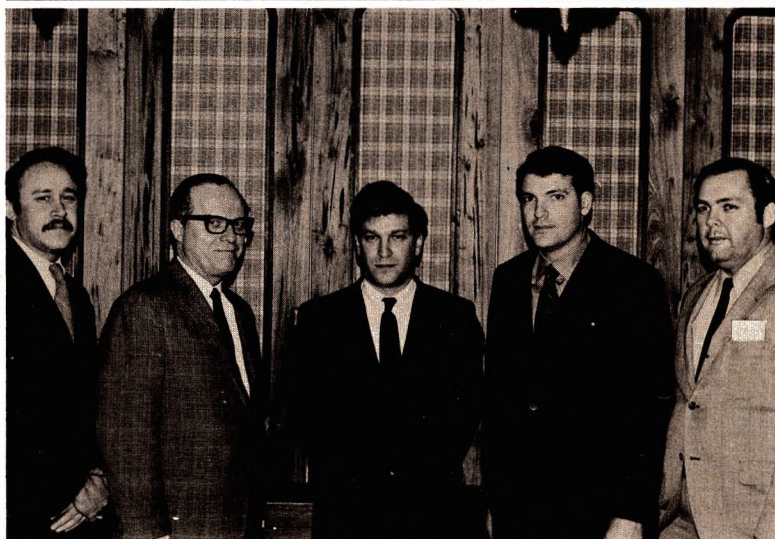

Dean Rasco Dies

Dean Russell A. Rasco, Jr., Dean Emeritus of the University of Miami Law School passed away recently.

Dean Rasco, for whom Rasco Chapter was named, was a builder, in the true sense of the word. He retired as Dean in 1957 leaving behind legacies which were both concrete and intangible. PAD mourns the loss of one of our most outstanding legal educators.

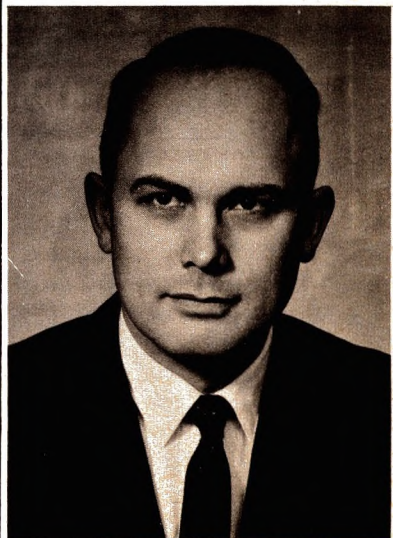

When at such time (a) my said husband shall have died, (b) all my sons and daughters shall have died, (c) all issue of a deceased son or daughter of mine, living at the death of my said husband (or at the death of any son or daughter of mine who shall survive my said husband) shall have attained the age of twenty-one years or shall have died (or at the termination of these trusts under sub-paragraph _____ of this paragraph), these trusts shall terminate and all shares and parts into which the Trust Estate shall have been divided shall go and be distributed to the Phi Alpha Delta Law Fraternity Endowment Fund.

Convention Nominating Procedure Announced

The procedures for nomination of members for elective officers of the Fraternity at the forthcoming Convention in New Orleans, Louisiana are announced as follows:

6. The Convention will select the new elective officers of the Fraternity on the afternoon of Saturday, September 5. All active and alumni chapters in good standing have two votes while members of the Supreme Executive Board and District Justices have one vote.

Alden Chapter Sponsors Symposium

Alden Chapter at State University of New York at Buffalo recently held a Symposium on "Obscenity in the Performing Arts."

The panel discussion followed the viewing of the movie *I Am Curious* (Yellow). The Supreme Court has recently agreed to decide whether or not the movie is obscene.

The panel was composed of Leonard Malentynowicz, attorney and former Assistant District Attorney for Erie County; Dr. Ann Scott, Faculty of Arts and Letters; Al Katz, School of Law and moderator for the symposium; Frank Hoffman, Faculty of Arts and Letters; and Mrs. Fiona Mitchell and Miss Maureen O'Donnell, co-directors of publicity for the Toronto production of *Hair*.

Mr. Walentynowicz cautioned that the Supreme Court could no longer continue to be the "Super-Censor" since its heavy workload does not permit. The panel agreed that the social attitude towards what is and is not obscene needs re-evaluation. Dr. Scott stressed that attitudes, not pornography, is the issue. Mr. Katz stated that a censorship board could not formulate an obscenity test which would not suppress ideas. Co-chairmen for the event were Clarence Gratto and Charles D. McFaul.

1. Contestants will be required to give a five minute oration on a subject of their choice in the first round.

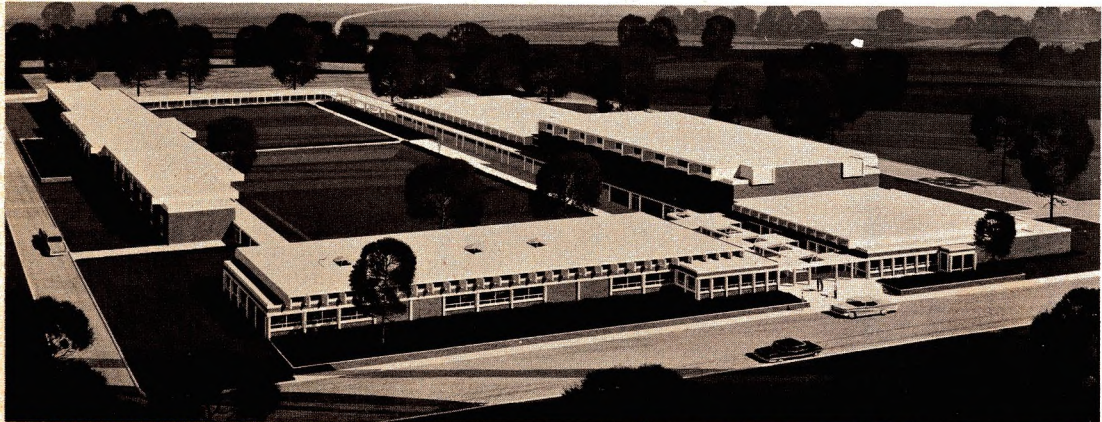
2. The speaking order will be by alphabetical order of chapters within a District.

3. Orations will be judged on content, delivery and adherence to rules concerning the contest.

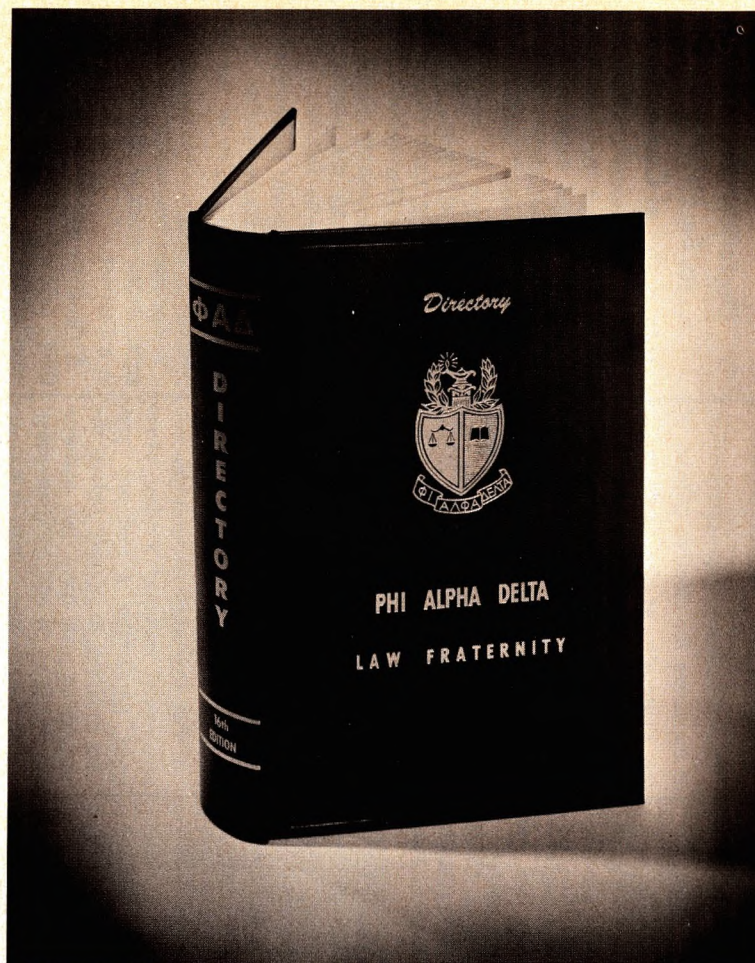
4. Three judges will choose the top three contestants for a final round to be held at the banquet Saturday evening.
