Past Supreme Justice Elwyn Thomas Dies

The Hon. Elwyn Thomas, retired Chief Justice of the Florida Supreme Court and Past Supreme Justice of PAD, died February 28, 1971, after a long illness. Justice Thomas' judicial career was long and distinguished. He retired in January, 1969 after serving 31 years on the State's highest court including two terms as Chief Justice.

skills and maturity, and improved qualification of nonlawyers, cannot be ignored over too long a period in terms of compensation.

Mr. Cantor notes that it would appear that salaries can be determined for new jobs such as a paralegal, an office manager, lawyers at a given level, or a position with a new combination of functions.

In such cases, he advises that the responsibilities and relationships should be adequately described when a salary schedule is set for the new position. The salary should be determined on the basis of comparable jobs within the firm or, if no comparison exists, on the basis of comparable jobs in nearby firms.

Since one of the main purposes of the executive order is to stabilize the economy by providing services at a proper cost, it is in the national interest for each legal office to take this opportunity to review the effectiveness of its organization and the efficiency of its operations.

In Mr. Cantor's opinion, the law office should be prepared with a complete income distribution and salary program. 
Brother Schivera also recently received the good news that he was the winner of one of the forty \$500 PAD Scholarships.

At its recent meeting the Supreme Executive Board appointed Michael B. Harwin as the new Executive Secretary of the Frater-

Born in Brooklyn, New York Mike attended Rutgers University where he majored in political science and graduated with honors. He attended New York University School of Law and became a member of Rapallo Chapter, of which he served as Justice, and was the chapter's delegate to the 1970 Convention. Mike was Articles Editor of the Journal of International Law & Politics at N.Y.U.

While attending law school Brother Harwin was employed as a legal assistant to the Chief Counsel at New York City Commission for the United Nations, a law clerk for Attorney Theodore P. Halperin a New York PAD, and as legal assistant to Chief Appelate Attorney at the U.S. Attorney's Office for the Southern District of New York.

Brother Harwin graduated from N.Y.U. in June, 1971 and took the New York Bar in July.

Hospital Money Plan Benefits Increased

Benefits have been increased for the more than 1,400 members of Phi Alpha Delta participating in the hospital-money plan underwritten by CNA/insurance. Effective now through November 30, 1971 benefits are increased 10 per cent at no additional cost to participants.

In addition, the hospital-money plan now provides a double indemnity provision for hospitalization due to cancer and hospitalization under intensive care.

"The hospital-money plan pro vides cash when it is needed most." explained Fredrick Weit kamp, Executive Director. "Ordi nary living expenses continue even if a person is hospitalized. And while other hospital insurance may pay for the usual costs of a hospital stay, the hospital-money plan provides cash to use as it's needed for rent or house payments, for domestic help if a member's wife is hospitalized, for special services if one of the children suddenly requires hospitalization."

Most other insurance policies have a deductible portion. The hospital-money plan provides cash -\$30 a day plus 10% added benefit for members, and \$20 a day plus 10% added benefit for the insured member's wife and children - to help assure that the deductible and other expenses of a hospital stay will be met.

Cash is paid starting from the first day of hospitalization, up to 365 days. For a month-long stay, the insured would receive \$990; he would receive \$660 if his spouse or child were hospitalized for a month.

Phi Alpha Delta members under age 60 are eligible to apply. Once covered, insurance is renewable for life. Worldwide all-risk protection covers accident and sickness with 24-hour protection, on and off

THE SUPREME EXECUTIVE BOARD **MEETS IN ASHEVILLE**

In August of this year the members of the Supreme Executive Board met in Asheville, North Carolina. In accordance with the direction of the 1970 Convention two students were invited to attend. Their impressions of the meeting follow:

It is indeed an exciting prospect to attend, and, in a very real sense, participate in, a meeting of the Supreme Executive Board. Too often members of the Board are mere names to students at the local chapter level. In person, in spite of their diversity, one factor is immediately apparent to the student brother: these men are dedicated to and extremely active in furthering the purposes of the fraternity, not for amorphous national prestige, but for the benefit of each and every brother on the local level. Although some details of that meeting need not be mentioned, this analysis will not attempt to be a recantation of the minutes of our meeting in Asheville, North Carolina, during August 1971, but rather a general set of impressions from the point of view of a student of the operations of PAD International.

Supreme Justice Hotchkiss, Supreme Vice Justice Rae, Supreme Advocate Judice, Supreme Secretary Hutson, Supreme Treasurer Moore, Supreme Historian Maloney and Executive Director Weitkamp met at the Sheraton Inn in Ashville to spend our days in working sessions. Our host was Supreme Marshal Charles Taylor, who did an extraordinary job of making arrangements and showing everyone present the beauties and points of interest in his native Blue Ridge country. Our social contacts served to enhance the exchange of ideas in working sessions.

It is quite educational and impressive to observe the internal workings of the fraternity. The Board does not try to rule local chapters with an iron hand, but rather to operate for the benefit and growth of all chapters. For example, services for initiates, the life insurance program, scholarships, and the Endowment Fund loan program were all discussed at length with an eye toward the personal needs of students. The role of women in PAD was discussed. Students will be able to voice their opinions in a poll to be taken on possible merger with Phi Delta Delta, the women's legal fraternity. Possible expansion into Canada and Mexico was discussed as increasing service to international law schools and students. Brother Hutson moved for several committees of direct concern to students a commtitee to study professional programming on the local chapter level and a committee to revise the Placement Advisory Manual. The site for the 1972 Convention was set in San Diego, and Board members were quite thorough in getting sentiment on all phases of convention

Outstanding chapters were also selected. Timberlake took the Continuing Excellence Award, and in competition the winners were Rasco, Garland, and McCormick in first, second, and third places, respectively. There were many other thoroughly discussed issues and programs not of general interest to this brief article, but which impressed one with the dedication and intense preparation of Board members.

Our social activities were numerous and enjoyable. We saw the Thomas Wolfe home, the outdoor Cherokee Indiana drama, Unto These Hills, the opera II Trovatore at the Brevard Music Center, and Biltmore, the beautiful Vanderbilt estate. Also there were several enjoyable dinners, including a notable barbecue at Brother Taylor's mountaintop home.

In summary, I realized how fortunate I am to be a brother in Phi Alpha Delta and how ardently the Supreme Executive Board members are working for our benefit. Let us as brothers work just as hard for the fraternity on the local chapter level.


The Supreme Executive Board met for 3½ days and considered a lengthy agenda. Serious attention was given to each matter on the agenda with the purpose of seeking new ways and ideas as to how PAD can be improved so that it can serve its members better. I know that this sounds like an idealistic statement but nevertheless it is true. For example, I was impressed by the board's effort to secure additional funds for our student loan program. A great deal of time has been spent and will be spent to increase the funds available for loans to PADs who need some financial aid in order to finish law

The agenda covered a wide range of matters including financial reports, committee reports, plans for the 1972 Convention, and the PAD Directory. Much time was spent on ways to strengthen the programs of the fraternity, and a new committee was established to study the goals of the fraternity with emphasis on new professional programs and ideas.

The primary purpose of the Supreme Executive Board is to make decisions and plans concerning the operation of the fraternity when the Convention is not meeting. After the Convention has met, the Board is responsible for implementing the recommendations and decisions approved by the Convention. In order to keep the fraternity operating smoothly, the board usually meets twice a year in various places throughout the country.

I have several impressions of our board members which lead me to the conclusion that PAD has strong national leadership. First, our board members are very receptive to new ideas and are willing to recognize that changes need and often have to be made. This quality is especially important since the fraternity and its programs must be

Lawyer Incorporation Increasing

Twenty or more out of the states reporting have made it possible for lawyers to practice as professional corporations in the period 1969-70. And in only eight states are lawyers presently prohibited from forming corporations.

This information was collected for LAWYERS WORLD magazine by the consulting firm of Daniel J. Cantor & Company in May to July of this year. State bar associations and government agencies furnished the information.

As of the time of the study, California reported the largest number of incorporated law offices (256), followed by Michigan (187) and Florida (136). Although specific numbers are not available, it is known that Minnesota and Texas have substantial numbers of lawyer corporations.

Virtually all of the states have now passed an act of legislature permitting the professions to incorporate. In most of the states where lawyers cannot, at present, form such corporations, only an action of the supreme court is needed. (Courtesy of LAWYERS WORLD magazine).

Jeffrey Wentworth, a charter member of Sam Rayburn chapter, Texas Tech University School of Law, was recently elected president of the American Bar Association Law Student Division. Wentworth, a third-year law student and immediate past president of the school's Student Bar Association, was elected to head the 15,000-member national organization at the July ABA convention in New York City.

These brothers added immeasurably to the Conclave's success.







Office, the news media, and the Institute of Paper Chemistry.

Prodded by questions from the audience and co-panelists, a basic theme dominated - "we are working hard at it (pollution control); progress is being made, but it doesn't come easy." Interestingly, it was illustrated, that much of the inaction in abatement enforcement came not from the inadequacy of the enacted laws, but from: (1.) the understaffing of government agencies, (2.) the jurisdictional and bureaucratic quibblings of state agencies.
