

#### **PAD Establishes Placement Office**

Pursuant to 1972 Convention action, a PAD Placement Office was established on January 1, 1973. In order to stay within budgetary limitations set by the Convention and to facilitate Fraternity operations, the office is housed in the Executive Offices in Granada Hills. The initial Placement Director appointed was Michael B. Harwin. Brother Harwin graduated from NYU Law School, where he was reactivation Justice of Rapallo Chapter in 1971. He has since served as Executive Secretary and as such has visited almost all active and many alumni Chapters.

The scope of the intended program will include information on summer, part-time, and full-time jobs.

Since Placement is most effectively organized on a local level, it his been determined to have each Active Chapter form a Placement Committee.

Information has already been sent to each Active Chapter regarding the program. Each Chapter's Placement Committee will be responsible for calling law firms and government agencies in its city and distributing information about availabilities to its members. Forms have been provided each Chapter so that it can keep records of its calls, summarize information obtained and report to the Placement Office. The reports to the Placement Office are necessary so that the office can evaluate the program and so that if Brothers from other geographic areas desire information, it will be available.

Information from the Placement Office will be disseminated to the Chapters through the use of "Placement" Bulletins with a hopefully high degree of frequency.

There will be some information about concrete job openings and also lists of suggested places to apply. This concept of Placement leaves the initiative to the individual applicant. Rather than trying to match thousands of applicants with specific jobs, it was felt that our members should be able to choose where they wish to apply. The Placement Office can serve a worthwhile function as an informa- in Placement for members of PAD.





#### Message from the Supreme Justice

Two interrelated areas of major PAD activity have been developing during the current school year. These involve both placement of law students and clinical education programs. As to the latter, one of the leading exponents of clinical education in this country has been Brother Tom Clark, Associate Justice of the United States Supreme Court (retired). I have had the pleasure of hearing Brother Clark on three occassions expound to PAD groups his views on the future of legal education. To oversimplify his theme which I wish you all could hear him state, it is his position that the third year of law school in the traditional form is expendable. According to Justice Clark, the third year is "like a squeezed lemon." Brother Clark would see it converted into an internship by the great expansion of the clinical education program which now has been adopted with a fair degree of uniformity throughout the nation. Only a few backward states and areas still resist the concept of permitting third year law students to participate in the legal process and deal with real facts and live clients. Brother Clark has suggested that PAD adopt as a goal the leadership of legal education into a new era where the young lawyer will have the opportunity for an internship before he is loosed upon the public.

The second major development is in the field of legal placement. As was reported in a previous edition of The Reporter, the convention in August mandated the establishment by the International Fraternity of a full-time, funded placement office. This has been done with Mike Harwin serving as the first International Placement Director. Although not assuming this position until January 1, 1973 Brother Harwin already has developed a complete and detailed place ment program from both the active and alumni chapter standpoint. In addition, he has collected and published in the first place that I am aware of, a complete list of all major opportunities for young lawyers in government, both federal and state, with details of how to apply for these openings. Whether his program will bear fruit now depends upon the cooperation of the students and the alumni.

Using the program which he has devised, the next step now is up to our members, both student and alumni, to create the local machinery to locate, develop and exploit opportunities for PAD placement.

These two programs — clinical training and placement - are inextricably interrelated. No longer can we wait until the student graduates from law school to concern ourselves about his future employment. No longer can we continue the attitude of the profession that a young law graduate is an economic detriment or that the law clerk is of no benefit to the office. Our practicing brothers have a responsibility to the profession to participate in the educational process by cooperating with local clinical programs. We as lawyers also have a responsibility to ourselves to reconsider the methods whereby we

hire and train our new associates. No system of clinical education can be made effective without the full cooperation of the organized bar. Attorneys are needed to supervise the work of the law students. A partnership must be re-established between the practicing bar and the members of academe to improve the caliber of attorney being graduated from our law schools. In other words, those of us who would return to basics need to consider returning to the original concept of legal education which in the early days encompassed "reading" under the supervision of a practicing attorney. The modern version, of course, is the participation of the law student in the actual practice of law under the firm guidance of a practicing attorney and with the academic enrichment of faculty programming.

Placement no longer is limited to the correlation of job opportunities and qualified law school graduates. It is now encumbent upon practicing members of the profession to volunteer to participate in the education of law students. In my travthe practice of poverty law because the private bar has not provided the openings to gain experience in the many fields of private law practice with which we all wish the law school graduate had some familiarity. A partnership is needed between the private bar and the law schools so that the faculty may structure meaningful and wellrounded educational programs, particularly for the third year students, which can utilize the services of lawyers in providing the clinical experience. The fears of the practicing attorney of temporary economic detriment should he volunteer to participate in such a program may be well-founded. However, in the long run we will all gain by an improvement of our profession and an increased efficiency and ability on the part of the recent admittees whom we hire. In addition, the utilization of law students before graduation will give the private attorney an opportunity to observe the rising class of graduates. No longer will the attorney be forced to hire an associate on the basis of a scholastic record and an interview where personality is judged. The attorney participating in a clinical program will have met a number of law students and had the opportunity of observing their performance. His chances to employ the type of personnel which he desires for his office will be greatly enhanced. It therefore becomes encumbent

upon Phi Alpha Delta to take the leadership in this developing area of the law. A first step is to cooperate with the National Placement Director. The students in the active chapters must be encouraged to appoint a placement director in accordance with the outline provided by Mike Harwin. At the same time, the alumni must volunteer, not only to provide a placement service in the locality, but to protorneys who will participate actively in the training of law school students and in assisting them with finding positions upon graduation. As he has done so often in the past, Brother Justice Clark has pointed the way toward a new field of service to the student, the school and the profession of Phi Alpha Delta International. Let us now take up his challenge. We cannot all have an opportu-

nity to hear Brother Justice Clark present his program in person. Therefore, I suggest to each organized alumni chapter that a program be planned in the immediate future where representatives of the local law schools are asked to present a seminar explaining to the practicing bar exactly what the clinical program being conducted in the community consists of and how the bar may be of assistance to it. In order to assure attendance at such a function, I suggest that the full cooperation of the local members of the judiciary who are PAD's be sought in sponsoring such a program. PAD at the alumni or the active level should become the catalyst between the law school, the judiciary and the bar for a massive program of education of the bar to the importance of the clinical training of young lawyers. The barriers of communication between the bar and the academic world which have grown up only in recent times must be broken down for the good of the profession. Justice Clark has pointed the way for his brothers. If we are effectively to utilize the tremendously increased number of law school graduates and at the same time to follow the mandates of the courts to provide legal service to all who are in need thereof regardless of economic circumstances, we must follow his guid-

#### National D. A.'s Ass'n. and PAD Launch Prosecutor Placement Bureau

The National District Attorney's Association (NDAA) has recently formed a Placement Bureau in conjunction with Phi Alpha Delta Law Fraternity, International, designed to fill the need for matching career-minded school graduates with prosecutors' offices around the country. Law students in their senior or final year are invited to visit their PAD Chapter or write to the Association's Executive Offices in Chicago for a placement questionnnaire which, when completed and returned, will give the complete background of the student applicant, including education, experience and placement interest. These forms will be placed on file and matched with other questionnaires solicited from NDAA member offices around the country. The respective offices will then contact the applicants directly and set up interviews. Effectiveness of the program is virtually assured because NDAA is the only national organization representing the prosecuting attorney in America.

The Placement Bureau is the direct result of the dramatic increase in law student interest in prosecutors' offices that has grown up in recent years. This interest has been fostered primarily by student exposure to such offices in clinical and intern programs and the growing awareness that public prosecution has great potential for community involvement and betterment. Many students have expressed the view that reform of the criminal justice system must begin with reform of the court system, including the office of public prosecutor. The goals of NDAA coincide with that view.

The total program of NDAA encompasses not only the upgrading of the prosecutor's office, but also programs of public education and professional training in the fields of narcotics abuse, juvenile delinquency, consumer protection, environmental law enforcement and the police. These wide-ranging goals and programs in prosecutors' offices around the country and an increased interest in employing graduating seniors and recent law school graduates.

The NDAA Placement Bureau will be available not only to law students, but also to legal interns and already admitted attorneys seeking employment in prosecutor's offices or seeking to change their present positions. Placement questionnaires are being mailed in quantity to members of the National Association for Law Placement and other law school placement officers. Interested students should contact their placement officer or write directly to NDAA. There is a five dollar charge for the placement service but the service is free to NDAA student members. Student membership in NDAA is five dollars per year. Further information and the forms are available from Patrick F. #### **Positions Available** For Alumni

There are currently several openings in the National Credit Union Administration Merit Promotion Program for the position of Staff Attorney in the Office of the General Counsel. Functions will involve advice regarding the effects of provisions of proposed legislation or proposed changes in administration policies or regulations. Also included will be some research with regard to laws, regulations and legal precedents. In addition, the job will require preparation of reports and letters to Congressional Committees, the Office of Management of Budget, and other agencies relative to proposed Federal legislation affecting the National Credit Union Administration. It plays a distinctive role in assuring equal justice under law and provides a representative central body with defined duties and powers for the guidance and assistance of its members. It has two basic constituencies — more than 1,000 legal assistance and defender offices throughout the United States, Canada, Puerto Rico and the Philippines that provide free legal assistance for persons unable to hire a lawyer and the poor themselves. NLADA is supported by over 4,000 individuals, many of them lawyers, state and local bar associations and the American Bar Association it-

About 5,000 attorneys are currently employed in legal assistance and defender offices in this coun-ACTIVE CHAPTERS NOTE try. The road to legal services for all has been a long and arduous one to build. The first organized legal assistance program in the United States was created in 1876 when the German Society of New York incorporated the Deutcher Rechts - Schutz Verein "to render legal aid and assistance gratuitously to those of German birth who may appear worthy thereof, but who from poverty are unable to procure it." This organization evolved into the Legal Aid Society of New York, which today is the largest legal assistance and defender office in the United States. The first organized defender service was established in Los Angeles in 1911, and continues today to be the largest office exclusively devoted to the defense of the indigent in criminal cases.

> By 1964 there were 244 legal assistance offices and 136 defender offices serving the country's poor. By the middle of 1972 the number of civil offices had grown to 736 and defender services to well over 400. The recent proliferation of offices can be attributed in large part to the infusion of federal funds (\$71.5 million in 1972) into civil programs and the last decade's Supreme Court decisions which greatly expanded the right to counsel in criminal cases.

Unfortunately, the services these offices provide are subject to political pressures, and, at times, they have been threatened with extinction. At present it appears the continued federal support of legal services depends upon the creation, by Congress, of a Corporation for care of the Executive Office in Legal Services. NLADA is nating and planning agency for working hard to ensure that the legal assistance and defender work Corporation for Legal Services is created and that increased defender funding becomes a reality.

NLADA, with its national headquarters office in the American Bar Center in Chicago, in addition to providing administrative supportive services to member programs, is conducting a national survey of defender needs. It is anticipated that this exhaustive study will not only reflect the exact extent of the availability of legal services for the indigent in criminal cases, but precisely delineate the areas where services are either inadequate or non-existent.

In 1971, NLADA established a Washington office to become a more effective voice in national

policy making. The Washington staff works with governmental agencies and Congress to ensure independent and quality legal assistance for the poor. NLADA's Washington office also works closely with many other national organizations, including labor unions, citizens' organizations, client groups and public interest law

NLADA's Washington office contains the National Law Office which works for litigative solutions to national problems of the poor. The NLO has recently achieved significant results in reform of correctional institutions, in establishing the right of the mentally retarded to receive habilitative institutional care, and in affirming the right of handicapped children to a public education.

Another division of NLADA in Washington is the Technical Assistance Project which helps programs utilize their resources in the most efficient and effective man-

#### A Student Reports on a Meeting of the SEB

(In accordance with established policy of the Supreme Executive Board, a student member of the fraternity, John E. Maloney, of Webster Chapter, was invited to attend the December, 1972 meeting of the Board. His impressions follow.)

Snow was falling as I parked my car behind the O'Hare Regency in Chicago on December 9th. Little did I realize on that cold Thursday night that I would not reimerge from that circular building until Sunday, December 12th. The work schedule would keep me from my home which lay just three miles away. The first inclination that things would get hectic was when I called Fred Weitkamp. "What time shall I be there for the meeting tomorrow, I said. "We will start at eight o'clock and have all our meals delivered to us," he said. "How early do you think we will finish, tomorrow," said I, thinking about going to see my wife. "Until we are too exhausted to continue," he replied. He wasn't wrong.

The next morning when I came into our conference room there was a book waiting for me. For all the world it looked like the Federal Income Tax Slip Service from the year 1932 till present. Laying next to it was an agenda of about 150 items ranging in issues from a \$22 request for a reimbursement to a \$500,000 student loan program. These items were broken down into about 20 main topics, which corresponded to the literature found in the twenty sections of my aformentioned conference book. Audits, committee reports, merger plans, constitution, convention reports, etc. Everything was there. I have seen briefing books before, but none was as thorough as the one I had just received.

We immediately started into the agenda taking what we thought were some of the easiest items square hole is big enough. There first. "Everyone agrees then," check, another item off the agenda. I was beginning to get my confidence back. "We'll be out of here by Saturday," I thought. Little did I know what lurked ahead. Finally it happened. 


