
Board Announces Scholarship Winners 42 PADs are Law

The Supreme Executive Board has announced the winners of seventeen \$500.00 scholarships for 1973. The awards are made each year to members of active chapters throughout the United States, Canada and Puerto Rico. This year pursuant to Convention direction one scholarship was given to an applicant from each of the Fraternity's 17 districts.

His speech was so inspirational that the delegates unanimously elected him to the Supreme Executive Board as Supreme Marshal. He later served as Supreme Secretary and Supreme Vice Justice, ascending to the highest office in the Fraternity at the 1970 New Orleans Convenfor two years.





benefits of membership, and upon graduation cannot participate at the Alumni level. Lacking a meaningful investment in the fraternity, 'social members" do not contribute to a Chapter's program or leadership, with a resulting rapid drop in its ability to function. Most insidious of all, the practice could not exist without deliberate violation of International Constitution and By-Laws on the part of the Chapter Officers, frequently abetted by falsified books and records. No lawyer, or law student, can countenance activities of these types and retain his self-respect, or the respect of his fellow professionals.

'Social members" really are the result of Chapter officers following the path of last resistance. It takes dedicated effort to "sell" new members on the value of Fraternity. Worthwhile programs are an essential portion of such "selling." Officers who are unwilling to maintain such programs do a disservice to the Chapter, law school and themselves. A successful attorney is a leader and a performer. Law school is the time to develop these traits. Phi Alpha Delta, and the law school, gain nothing from a large group of non-participating nonmembers. Better that a Chapter have 20 dedicated students performing services for the entire school, than claim 100 "associates" and slowly sink into oblivion in a series of poorly attended parties.

In these trying days of National and International crisis, I commend to all Brothers, and particularly to Chapter Officers, a rereading of the Initiation Ritual. It is not just a collection of stilted prose to be dusted off for a cere monial occasion. It is a statement of a way of life, the way of the attorney, the way of the PAD. If a prospective member cannot, or will not, live up to these standards, Phi Alpha Delta does not want him . . . Service is our motto. As PAD's, and as lawyers, we should recall today, as never before these words from our Ritual:

"A lawyer's highest calling, then, is to render Public Service on some basis, be it through participation in community discussion, in a volunteer capacity with small local self-governing units, through accepting Public Service for a reasonable period of time, or through writing, speaking, and encouraging able men to accept such service. Public Service, I submit, is the capstone of the lawyer's essential structure of principles and virtues. Service in every form is the essence of Phi Alpha Delta."

PAD Placement Column

(The PAD Placement Office is now completely functioning. If any alumnus has openings for Alumni or Students in his office, please notify the Placement Office in Granada Hills.)

In the past few weeks active Chapters have received Place ment Bulletins Nos. 18-21.

Bulletin No. 18 contained information regarding the U.S. Foreign Service.

Bulletin No. 19 contained a list of alumni in 10 major hiring areas who have volunteered to serve on committees to give advice with regard to placement. It is urged that the Placement Committee of all Chapters in those areas contact these individuals and set up a meeting with them as soon as possible. This meeting should be used to decide how best to find jobs in your area for your members. If your Chapter is not in one of the major hiring areas, it is suggested you take the initiative and contact local alumni to set up such an advisory committee.

Bulletins No. 20 and 21 are summarized below: (Please inquire from the Executive office at Box 3217 in Granada Hills. Calif. 91344 by number if you are interested in more information.)

Bulletin No. 20

The National District Attorneys Association has received a grant from the U.S. Department of Justice, Law Enforcement Assistance Administration, through the Oklahoma Crime Commision, to operate a summer placement program for law students interns in prosecution and public defender offices.

This new program known as the National Law Student Internship and Placement Program, is being run jointly with the National Legal Aid and Defender Association. It will place a total of 200 law students in prosecution and defender offices around the country for work during the months of June, July, and August, 1974 (100 students in prosecution offices and 100 students in public defender offices). The law students will receive a stipend funded in part under the grant and in part by qualified participating prosecution and public defender offices.

To implement this program, the Association is planning a one day visit to selected law schools around the country, starting around the middle of November, 1973, with teams of experienced prosecutors and public defenders. These teams of speakers will address the student body concerning the duties, responsiibilities and function of their respective groups as they see it, and their roles in the criminal justice system. After the initial visit to the law school, it is hoped that a student representative or member of the law school staff at that law school will be available to distribute a placement form which will be utilized by the program. This form will also be available to law students directly from the project office, whether or not they attend a law school visited by the team of prosecutors and public defenders referred to. Completed forms will be returned to the associations, and placement decisions will be made by the NDAA for prosecution offices and by the NLADA for public year. defender offices. The attempt will of the country outside their home or school jurisdiction to give them the widest exposure possible to the criminal justice system.

The Association is requesting at this time inquiries from law schools and law student organizations which would be interested in hosting a team visit at their law school sometime between November 15, 1973 and March 15, 1974. All that is required is a block of time of approximately two hours in a morning in a large meeting hall or auditorium at the school for the formal presentation and a place for the team to meet students on an informal basis on the afternoon of the same day, such as a student lounge. It is expected that the host school or student organization will make the necessary arrangements for reserving meeting space, posting notices in advance of the meeting (including the student newspaper), introducing speakers and distributsupplied by the program).

A Leader Talks **About PAD**

(Past Supreme Justice Alex A. Hotchkiss passed on recently see page one. His inspirational Keynote Address delivered before the 1962 Convention of the fraternity is reprinted below in his memory.)

> Keynote Address To The Thirty-fourth Biennial Convention of the PHI ALPHA DELTA LAW FRATERNITY AUGUST 30, 1962

"It has got to be the custom of things legal to indicate at the outset something about the scope of the discussion. So with that in mind, I think I should indicate what might be in store for you here. By the very nature of things. You meet here both as members of the Fraternity and also as law students, and whenever such men gather and you have someone who is a little bit beyond the age of law students, it seems appropriate that some comment should be made out of the personal observations of the speaker, and perhaps something might be said by way of counsel and advice and I have some of that in mind.

But most of all, I wish to talk concerning Phi Alpha Delta. You know, the story is told about two men who were walking down the street and a fellow was seen going hurriedly past putting on his hat and coat, and one said, "Who is that?" The other said, "That is an International Civic Club Lunch man on his way to lunch." The first one said, "What do they do?" And the second replied, "They eat and belch and run.'

This crude illustration may serve in part to be directed against us — if we ever get to the place where we permit this organization to become nothing but a mere name and a mere membership. So, in talking about Phi Alpha Delta, I have in mind saying something that most of you have read and have already heard, and some of it may be somewhat repetitious, but I think of all places, that I would be remiss in my duty, if at a national convention we did not recount, remember and recall the principles of our organization. So, in conformity with the duty I consider to be mine in the part that I have on the program, I hope that I may be able to make some suggestion that will guide and even help your deliberations throughout the time that we are here, and perhaps take back home with you. And even though there may be a repetition, I hope that in the re-telling I may be able to give you some new suggestion and perhaps to have some fresh presentation or interpretation.

It seems to me that we are met with two questions, and the first is: Can we do that which is expected of us in Phi Alpha Delta? And the second is: Where do we start? In answer to the latter, I think it is kindred to a simple illustration that comes from an experience I learned of where one of our older eastern schools was celebrating three centuries of its existence, and in connection with that commemorative event they had a reunion of all of the alumni of the institution. And they had in connection with it a contest that each of the individual classes should carry with them in a parade some slogan, statement, or motto, or indication that would give something of their ideas of the hopes, achievements and ambitions of the school. So as they walked down the street in a parade, from the tottering oldest class down to the earliest they carried their banners and statements indicating something of the inspiration and enthusiasm they individually felt. But the one that was the prize was that of the Freshman Class and had on it these words: "For 300 years you have been wating for us."

So I say it is that way with Phi Alpha Delta. That all of the energies and interests and efforts of this organization are focused on this very next pledge class, this next active group to be initiated, as the most immediate prospect of the and purposes of this organization.

But that is not all. In order to flourish and maintain itself in vigor, it is not enough that a fraternity replenish itself in numbers but it also must replenish itself in the practice of the precepts and the tenets of the organization, by the members who compose it. So we have a twofold responsibility, both the new and the old members must become imbued with those things we hold dear as the ideals and principles of Phi Alpha Delta.

I think these fall into three gen eral categories and so I will like to review with you something of the traditions and the tenets and the convictions that we hold. I think the first is historical, and we have an interesting and tremendous history that cannot in my mind be too often recalled. First of all, let me say there is this unusual circumstance that the first of any law fraternity was organized back in 1869 and that was ten years before there was even an American Bar Association. Some years after that, in 1896, a group of law students at the University of Chicago were having some difficulty about requirements for admittance to the bar so they formed the Law Students League and were successful in their endeavors and out of that unity of interest and commonness of purpose there came an organization by the name of Lambda Epsilon which were Greek letters symbolizing Law and Equity.

Some difficulties beset them and after four years they met at South Haven, Michigan, and in July of 1902 they dissolved the organization but realized the purposes and desires that were good in an organized Fraternity, and appointed a committee for that purpose. After some considerable effort and hard labor, such as this fine group up here seem to be always performing in connection with present Phi Alpha Delta, on November 8, 1902, there came forth the constitution and by-laws and the organization basis for what is now Phi Alpha Delta.

In short order there came along Blackstone, Story, Fuller, Webster and Marshall. And by 1910 there were twenty-three chapters and so this organization has withstood since that time all of the vicissitudes and ravages of two world wars and those things that interfere with law schools and the essentials that are required for the continuation of such an organization.

So we come now to having established ninety chapters and have over 40,000 members. I recall what may be familiar history, so you may again remember that among others, there are two important things, and they are these: One is hat first of all, that it indicates that there is a place and purpose for a law fraternity in the scheme of things in legal education. which you have in your local chapimportant and outstanding on a national scale.

I have always been proud to think that I became affiliated here when the fraternity reached what we consider at least in human endeavors, as the age of majority. And I see it has came to a stability and brought about as it has reached maturity, what I think with constant and vigilant attention can insure a continuation of its

The second thing has to do with the standing or lack of standing that lawyers have in the eyes of the public. And, you know, we hear such stories as the one about the inquiry made of a doctor concerning a lawyer who was very ill and the doctor said, "He is lying at death's door," and the reply was, 'That's grit for you, at death's door and still lying.'

Or we hear such tales as the two contending parties, and one said to the other, "If you don't do as I contend, I will see you in court." And the other said, "Well, my lawyer and I will be there." And the first said, "If you beat me in the District Court, then I will see you in the Supreme Court." And the other said, "Well, my lawyer and I will be there." And the first said, "If you beat me in the Suoreme Court, I will see you in hell." "Well, my And the other said. lawyer will be there.'

Now, it is a poor group of people that cannot withstand the fun and the jokes that are pointed at them and perhaps there are some cases of justification, although I say in general it isn't so. And collectively for some reason we do not have the esteem and afffection of the public that we ought to have. And that brings me to the chapter names I don't know where the idea originated but I have always thought it was such a wonderful thing, instead of following the Greek letters, for chapter identity, that is found among social fraternities, that our fraternity has the naming of the chapters after men who have achieved some distinction, and when we were at this meeting that Brother Tony described that he attended I took time out to study something of the background of just three of those men whose names the chapters in that area bore and it gave me an insight and something of the breadth and scope of this organization, because while all of them had been outstanding in their practice, there was one outstanding in the practice of law and the field of government. Another was outstanding as a judge, and the third was outstanding as a law educator. But in my thinking about it. I found that they all—they as well as all this great roster of men that we can call the legal giants of the period-have one thing in common, and that is to the general public they represent the law and its interpreters, and in a favorable light. governs and controls and regulates persons and property and offenses stain. And these men, I think, to the public exemplify that. I think that every chapter and every member of Phi Alpha Delta in each chapter ought to know the history and the career and the life of his chapter namesake with this object, that that esteem and confidence of the public that they achieved — we. by emulating them, can also acquire - and erase what I think is an unwarranted blot to that extent on the legal profession.

You may know, that a few years ago the University of Chicago came out with a series of books they called "The Great Books of Western Civilization." Close upon the heels of these came a study of them by Mortimer Adler and under his charge, and he came up with 102

since the dawn of that period. It ter you belong to something that is was not intended, nor was it claimed, that all of these things, all of the great ideas of the world or all the ideas of the world were embodied in those some 445 books. And there are men that have had a lot of ideas over the years, and Phi Alpha Delta, too, is an idea. We don't have to go into 445 books to find out about the idea of Phi Alpha Delta because the founders and developers of our Fraternity declared the idea in the declaration of purpose, and I think it would be well for us to improve our minds and in convention consideration to recount and remember again something of the ideas that were declared to us.

> And I think I would put first the purpose, "to aid in the development of fraternal and brotherly sentiments." That is just a recognition of something inherent in all of us. manifested in youth and, is the spirit that has provided the basis and support for our youth organizations, as the desire of people to get together. Even primitive man gathered together with folks of his own kind. How much greater reason we have, with the commonness of pur pose in the study of the law to get together in fraternal and brotherly

> One of our noted Kansas editors think best exemplified this kind of spirit that we have, particularly here in America, when he said that if a group of Americans were up in a balloon and some disaster befell it, causing it to fall, that the organization and unity of interest spirit was so strong that before they hit the ground they would have organized, elected a chairman and made badges and had a welcoming committee to meet those present when they got back down to earth

> And connected with this purpose I like to think of the word that we find on our shield. Philos Adelphos. which I think you will also recognize as the root word denoting the City of Philadelphia which was given its name to typify what was the purpose of the founders of that city as the city of brotherly love. But we in our own work give it a more literal translation as, "fond of one's brother." In all the French Revolution they had one great cry, 'Liberty, Equality and Fraternity,' which has lived through the ages But in dealing with it they found they had difficulties in the realization of the first two words and found that it was only within the power of man to control and receive that third one, the practice of and the receiving of fraternity among his fellows.

> Let us in our convention and in our chapters and alumni organization give effect to this great conviction of the organization.

Another purpose is, "to promote social intercourse among the members." A man was walking down the street with a very beautiful and handsome dog, smiling proudly, and his friend met him and said. "You The general public wants to feel look awfully happy today; what that thing we call the law that is the reason for it?" And he said, "I just got a dog for my wife." The other said, "Well, tell me, how did is something good and free from you do it? I would sure like to make a trade like that." (Laughter)

Some of you by reason of having entered graduate school or otherwise have traded a social fraternity for a law fraternity, but that does not mean that with it and because of it you should abandon another very natural element of human endeavor, the desire of people to have social relationships. Parties, smokers and dinners and just even good companionship and conversation are still part of social ideals to be practiced by this organization.

Still another purpose declared is that of, "the promotion of intellectual intercourse, among members.' Now, that is just another way of saying that we approve of good scholarship. I think I am going to take advantage of you for a few organization, in addition to that as covering the thought of man moments by the fact that for some

reason I find myself here among the older generation, but I had a great opportunity I think, in that when I was admitted to the bar there were still among us those men that I like to characterize as the old time practitioner, and I would like to compare them with the present day lawyer and requirements of the present day lawyer.

I mentioned the experience that was had in the State of Illinois with reference to the requirements for the bar. That was back in 1898, but most states were not that early in dealing with the requirements for admittance to the bar. And whether by rule or whether by statute, we found that many times there were not too many instances where any academic requirement was had or at least it was not a requisite, and as a result we found many men who were admitted to the bar with little or no training, and little or no legal education as such. They lived by their wit and oratory. And too many times the forming of a bar of that kind of quality carried with it a type of man who thought a canon of ethics was some military weapon. And, as a result, we automatically developed those kinds of things that brought discredit to the bar that I referred to. But no longer. I think we may safely say generally in the United States that it is true, and that the present day lawyer in order to meet the requirements of the practice of law must have a high quality of scholarship and that is what our fraternity is trying to tell us.

A second thing I think as outstanding lawyers and where you ought to improve your interest among your members is that of a knowledge and understanding of human nature. Here is a don't about that, illustrated with a story. A lawyer was badgering a witness one time who said he saw another man bite off an ear of the named fellow, and in questioning him vigorously with cross examination it developed that the witness didn't fully see it. He said, "How did you know that he bit off the man's ear know that he bite off the man's ear when you didn't see it?" He said, "I didn't see him bite it off, but I saw him spit it out." (Laughter)

The third thing I would say is completeness and thoroughness. Don't ever stop until you have exhausted the subject, whether it be in the research books or in the trial of an action. An incident occurred about a railroad superintendent who was commending his employee for steadfastness in being a witness on the stand, adhering rigidly to testimony that was vital to protection of the case, and the witness said, "That's all right but I was scared." The superintendent said, "You just got up and insisted that you waved that lantern back and forth as the car kept approaching and collided with the train." He said, "I know, but I was afraid the lawyer was going to ask me all the time, "Was the lantern lit?" Don't ever let that happen to you.

Just to hurry along, a further purpose is, "to foster under intimate friendships those principles that tend to form a higher type of manhood" and that is just another way of saying that we believe in legal ethics. You know, something has happened to us, we even have been robbed of those things that surround us to give us some inspiration in legal ethics or in the attitude that we ought to have concerning our profession, and one of these is it used to be that "client" referred to someone who engaged the professional services of a lawyer but now I think its most frequent use is in connection with somebody who is the object of public relief or welfare. "Profession" used to signify some one of the four great professions and originally there were only four, but now it has come to mean anything from a description of a job to somebody in

(Continued from Page 4) the field of sports. And I would like you all to remember that we have had these four basic professions: the clergy, teaching, doctors, and the lawyers. Even in ancient times the wearing of the cloak and the robe was a sign to distinguish the literate man of the time as those were the men who were entrusted with the deciding of the problems of the people, to whom they turned in their governmental affairs, and it was a basis and the foundation for the robe which became abandoned for a long time in all except the clergy - and I am glad to see it has now become a more recent practice of use both in academic circles and by the judi-

In regard to the fee, the background of the fee was not a commercial charge but it was a symbol of tribute and respect to the learning and knowledge of the recipient; and so in a statement I think we can sum up this purpose, and that is, that when a man pays a fee, for it he is entitled to your learning and knowledge and not sharp practice and unethical con-

ciary in particular.

And I think under this heading we should just make one brief comment concerning another area that I feel is so vital to the organization. Think back in your own experience whether it be individually, with your family, or with your community, as to the things that make you feel emotionally, that give you some sentiment, that add to your field of living, and you will recall the customs and usages and traditions of your individual and family life and background. And so it is with Phi Alpha Delta. Naturally, we tend to think in terms of our own experience within this area. I like to think of Founders' Day as a great occasion, and I am glad to see that the men report these over the country. Multiple chapter initiations are also desirable and for some reason tri-chapter meetings always seem to be the magic number — three seems to be the magic number. Down in Brother Gunnels' district, when on my way to the St. Louis convention in 1925, I saw over the mantel a great big scoopshovel, the biggest I ever saw—and there were some unkind words said about him last night-but every year they elect a "keeper of the shovel" . . . but it isn't like what it sounds. It is an expression of honor and distinction, and I am sure that with your creativeness and ingenuity you individually can have something of a similar kind that gives strength both to those who receive and those who observe in those kind of things.

I like to think back in our own chapter of the father-and-son com- school. But let us always remember what is on the back of the envelope that you get, when you get a letter from Brother Weitkamp or in writings from these other officers of the Fraternity, you see printed in the purple and the gold colors of the Fraternity: Service-to the student. to the profession, and to the law a law school, will recognize this important fact, and that is, that in the study of law which is essential to a good lawyer in academic training in the law, that the law schools are crowded with doing just that job alone and it is impossible for them to do all of the other things that are necessary to equip a lawyer for the burden of practice for which he is training. And so our law fraternity provides a vehicle and the method by which that chasm may be crossed, and in a multitude of ways, a great oppor-

tunity is ours. And so, in closing, I would like to have you at least join with me in spirit in the form of a toast that we used to sing after chapter meetings as we gathered together - almost four decades ago:

Here's to Phi Alpha Delta Here's to the purple and the gold, Where the handclasp's always warmest,

And hearts are never cold. It's the fraternity of friendship. It will never lose its hold, Sing for Philos Adelphos, And the purple and the gold.."





Student Observations on the SEB

In July, 1973, a meeting of the Board was held in Atlanta, Georgia and attending the meeting as invited student representatives were John Heath, Justice of Keener Chapter at Emory University in Atlanta and Robert Walker, Justice of Timberlake Chapter at Wake Forest University which was selected as the most outstanding active chapter for 1973). Their impressions follow:

Hundreds of Phi Alpha Delta Brothers pass through the ranks of student membership into alumni chapters each year without ever having the privilege of meeting the spearhead organization which keeps Phi Alpha Delta International the top legal fraternal organization in the world. PAD is a Family Affair


