



The first International Convention in the history of Phi Alpha Delta will convene August 6-9, 1974, at the Inn on the Park Hotel in Toronto, Canada. Delegates representing 137 student and 69 chartered alumni chapters will convene for the four day session of business, entertainment and social activities.

Supreme Officers meetings will commence on Sunday, August 4 when the Supreme Executive Board officers training seminar for all members of the Supreme Executive Board, Supreme Advisory Board and District Justices will take place on Monday, August 5th.

Registration will begin at 2:00 p.m. on Monday, August 5th and continue until 8:00 p.m. that eve-

The convention proper will be called to order promptly at 9:00 a.m. by Supreme Justice Matthew

Our professional objective is service to maintain a free and civilized society in which strife can be minimized and resolved within the framework of law. Our fraternal objective is service to the system of legal education to assure a constant flow of well-trained individuals into the profession.


but substantially because of the economic problems of delivering legal service. Today, the very rich and the very poor receive good to excellent legal representation. The great bulk of the population, the all-important middle-income citizens upon whom the economy and freedom depend, have been priced out of the legal market for all practical purposes. Solutions are being developed, such as group legal services, legal insurance, the use of paralegal personnel and modern technology. But one resource now is underutilized, "people-power," i.e., the great excess of law school graduates over the job openings available. New ideas are required to meet this problem. Traditional concepts of "jobs" and "placement" will not work.

Perhaps part of the problem lies in our having forgotten that we are a profession. Service, not income, is our goal. "Employment" has not been a traditional problem of the law. Not too long ago, and in the span of our past 14 Conventions, a law graduate "hung out a shingle" and commenced serving his neighbors. He was assisted by other lawyers in gaining experience and practical ability. PAD performed a major role in this process, especially in major metropolitan

With the coincidence of law graduates exceeding "job" openings and the legal needs of the middle-income citizens going unmet, there should be means for these complimentary problems to solve each other. PAD Chapters, Active and Alumni, should explore these phenomena with Bar Associations and the educational profession. Maybe the "opportunity to serve" is preferable to the assured wage. Historically, in the "Law," service has been its own reward. Might it not still be the solution?

May I close on a personal note? I hope to see many of you in Toronto. To all of you, thank you for permitting me to have served as vour Supreme Justice. I was at that first post-War Convention in 1946. I have been at every one since. I know from that period of observation and participation that PAD is an essential factor in the growth of legal education and the profession. I also know that it continues to produce leaders for itself and the Bar whose dedication to service assure the continued supremacy of Phi Alpha Delta.



JURY DUTY-Rights and Responsibilities

Richard H. Mills, Circuit Judge of the Eighth Judicial Circuit of Virginia, has been selected to receive the George Washington Honor Medal Award from the Freedoms Foundation at Valley Forge, Pennsylvania. The award followed from the following article written by Judge Mills, a member of Keener Chapter at Mercer University School of Law.

(Many persons try to shun jury service; others manufacture excuses for avoiding it. Some are unaware of the vast importance that it manifests. And still others view the duty only as a necessary evil. Much of this negative attitude can be dispelled if the presiding judge will but take a few moments to tell the new venire of jurors what it is all about! Every juror should be made aware of the vastly important role he plays in our system of justice.)



HON, RICHARD H. MILLS

LADIES AND GENTLEMEN: You have been called to this courtroom today for jury service. And since most of you have probably not served on a jury before, I would like to tell you a little about our jury system, your duties as jurors and the function of the jury as part of this court.

The United States is one of the few nations in the world employing the jury system. We inherited the procedure from the common law of England and there has been little change in it since our nation's birth.

Trial by jury is one of the hallowed and honored bulkwards of our country's great heritage and its concept is jealously guarded by the courts in our judicial process. It is truly the hallmark of our system of jurisprudence.

I am aware that many persons consider jury duty as an unpleasant obligation. But service as a juror is a duty and responsibility of every citizen as well as a great privilege, honor and right of citizen-

A man's relationship with his government is not simply a oneway street, all take and no give; it's a two-way thoroughfare, a common enterprise, where our country asks, demands something of us in exchange for its protection, its services, its bounty. Physical science teaches us that for every action there is a reaction, and political science teaches that for every privilege and right there is a corresponding duty and responsibility. And so it is with citizenship.

Ofttimes I wonder, when prospective jurors ask to be excused for flimsy and shallow reasons, how they would react if told that they could never serve on a jury, whether they desired to or not. Sometimes we can consciously appreciate only that which is denied and forbidden. Yet I view jury service as a prerogative of citizenship a right of immense privilege. Each of you is a member of an elite and select group; for only a citizen of the United States, a citizen of this state and a registered voter of this county is eligible to sit as a juror to determine facts in controversy between man and man, or between man and society.

There are fundamentally two

a vital and integral part of our governmental system, wherein he truly becomes an active and absolute part of this democracy. The first, and most common, is to exercise his privilege and franchise to vote. By exercising that right the citizen becomes a concrete and component part of his government in a very direct and tangible way, casting his ballot to determine his leaders, his representatives, his judges. I sincerely hope that each of you exercise that great privilege and duty at every election, whether it be for the board of education. President of the United States, for or against a local bond issue or in a statewide election. For only when he is behind the curtain of the polling booth is a citizen really the "government of the people," and through the exercise of the ballot he becomes directly involved with the determination of his own future and that of his neighbors.

The other direct way the citizen participates in his government is by serving as a juror. I know of no other way a private person can serve so directly his fellow citizens — and thereby himself.

The jury is the trier of facts and the judge is the judge of the law. The jury is composed of 12 persons _ neighbors in the community. In civil cases, the jury resolves disputes or differences that arise between parties, and in criminal cases it determines whether a person charged with a crime is guilty or

The jury listens to all of the evidence and testimony produced by both sides, hears instructions given by the judge of the law applicable to the case, and then retires to deliberate and reach its verdict, thus deciding the case. Neither sympathy nor prejudice has any role in a jury trial - only the evidence and the law.

The jury system is not perfect and we in the legal profession are the first to candidly admit it. But nothing conceived or created by man is perfect and anything of man's handiwork will always reflect flaws or imperfections. Yet even with its flaws and limitations we have not found a better way. We cannot guarantee a perfect trial; all we can promise is a fair one within our human limitations.

Perhaps for some of you this is your first opportunity to be in court - for any reason. You may have come today with some degree of apprehension and misgivings. Allow me to alleviate your anxiety. A courtroom is not a place to fear: you should enter in confidence confident that every citizen involved will receive justice.

We follow a prescribed degree of decorum with symbols that remind us that our system of fairness and trial by jury commands constant respect. We call the judge "Your Honor." It is of little importance who wears the robe, for it is the system of justice it represents that is respected. Parties in the courtroom stand when the presiding judge ascends or leaves the bench because he is the symbol of equal and fair administration of justice,

legal authority. More importantly, every courtroom displays the flag of our country to constantly remind us of the great heritage of democracy and justice we enjoy, and to charge us all to fulfill with honesty, pride and integrity the individual roles each of us plays in this hall of justice.

I am aware that some inconvenience is entailed in jury service: the businessman must leave his office in the hands of others: the farmer must leave his fields: the mother must find a baby-sitter for her small children. Most all of you have businesses, occupations, vocations or avocations, families and children. In many instances it may be somewhat of a sacrifice or hardship to serve. But I suggest that it is a small price to pay for the privilege of being a citizen of the United States of America.

I say in all candor that those of you who have never before served as jurors - federal or state, grand juror or trial juror - will find it a most provocative, informative and exhilarating experience, confirming your faith in our judicial system. And those who have served before will find new experiences and will. I am confident, renew your pride and confidence in our system of justice and affirm my assertion that jury service is an experience in which every citizen should participate.

I have never had the privilege of serving as a juror. Judges and practicing attorneys are exempt from jury service.

countless jurors who have served here and elsewhere. I say without reservation that you are about to encounter one of the grandest adventures of your civic lives. At the completion of your jury duty I am certain you will harbor a far greater admiration for the jury system and our American way of administering justice.

The demand upon your time will not be unreasonable or unduly prolonged. The period of service for which you have been called is (state period). The mechanics of trials are fairly simple and will be explained as cases proceed to trial.

Before requesting the clerk to draw the names of jurors for the first case any of you who feel you have a legitimate reason because of an emergency, health, or unusual situation justifying a request to be excused will now be heard and ways by which the citizen becomes as his gavel is the symbol of his given due consideration.

Southern Illinois U. installs Douglas Chapter

On the evening of May 2, 1974, the Stephen A. Douglas Chapter of Phi Alpha Delta was installed at the law school of Southern Illinois University in Carbondale, Illinois. Stephen Douglas, best known for his debating ability, was admitted to the Bar of the state of Illinois in 1834. He served as public prosecutor of the first judicial circuit, was a member of the state legislature, secretary of the state of Illinois, a Justice of the Illinois Supreme Court, and a member of the United States Congress and Senate, and was democratic nominee for the United States presidency.

The law school has, this spring, received provisional approval by the American Bar Association and consequently met with the Fraternity criteria for new chapters.









Campbell Holds Mock Placement Interview
