Kansas City Will Host '76 Convention

The 41st Biennial Convention of Phi Alpha Delta Law Fraternity, International, will be held July 29-August 1, 1976 in Kansas City, Missouri. Selected as the headquarters hotel is the Alameda Plaza Hotel which has been termed by many as "one of the world's most beautiful hotels." In attendance will be delegates from some 210 chartered law school and alumni chapters throughout the United States, Puerto Rico and Canada.

the actual cost of one round trip airline coach fare to Kansas City, hotel accommodations and a subsistence allowance for each day of travel to and from the Convention and each day while at the Convention for one delegate from each active and alumni chapter in good standing.

Each active and alumni chapter is entitled to have two delegates and two alternates at the Convention and as many additional persons as desired.

All chapters are urged, however, to send as many members as possible. Many chapters will wish to divide the allowance between two or more delegates so as to be able to send several representatives. Car pools have in the past been formed and buses chartered.

In order for an active chapter to be in good standing and to qualify for the monetary allowance, all fees and forms must have been filed prior to the Convention. Each chapter will receive notification as to any existing deficiency

In order for an alumni chapter to be in good standing, it must have met the following requirements:

1. The annual alumni chapter tax of \$15.00 per year must be paid

The Supreme Chapter provides for the two fiscal years commencing August 1, 1974 and ending June 30, 1976.

> 2. Each alumni chapter must hold at least two meetings during the period from August 1, 1974 through June 30, 1976 with an attendance of at least ten persons at each meeting.

> 3. Each alumni chapter must have elected officers and report the same to the Executive Office.

> The Convention program is just now beginning to take shape but it promises to be an interesting one. Included will be committees to study various aspects of the Fraternity, discussion and action on proposed amendments to the Constitution and By-Laws, Chapter Workshops on items of chapter interest, a workshop on Placement, District breakfast meetings, election and installation of International Officers and other business of interest to all.

> Entertainment will include a cocktail reception, a Western Barbeque and Rodeo, sight-seeing trips, a dinner at the Waldo Astoria, dinner theatre, and a night at the River Kuay.

> Special entertainment is being arranged for spouses and families who will be in attendance.

JUDGE ALFRED P. MURRAH DIES

Supreme Justice 1962-1964

Past Supreme Justice Alfred P. Murrah, one of the most distinguished jurists in our nation, passed away Thursday, October 29, 1975, after a long illness.

Judge Murrah, 71, was the senior United States Circuit Court Judge and a former Director of the Federal Judicial Center in

Washington, D.C.

The Chief Justice of the United States, Warren E. Burger, himself a PAD, said on learning of Murrah's death, "For nearly 40 years, he has been one of the most foremost figures in the American Judiciary and he was a dynamic leader for judicial improvement all that period. Few men have equaled his contributions to the improvement of justice as the second Director of the Federal Judicial Center. His contributions covered the entire range of judicial administra-

Judge Murrah served as Supreme Justice of PAD from 1962 to 1964 and prior to that time served the Fraternity well as a District Justice and as a member of the Supreme Executive Board.

He received his LL.B. at the University of Oklahoma School of Law where he became a member of Harlan Chapter. He practiced law in Seminole and Oklahoma City until he was appointed to the United States District Court for the State of Oklahoma at the age of 32. (At that time, he was the youngest U. S. District Judge ever to be appointed.) At the age of 35 he was elevated to the United States Court of Appeals with the Tenth Judicial Circuit. He became Chief Judge of that Court in 1959.

Section of Judicial Administration

of the American Bar Association which is the highest post which can be conferred upon any Judge in the American Bar Association.

He was a man who literally pulled himself by his own boot straps. He was born in Oklahoma in 1904 and was an orphan early in life and had to make his own way. The obtaining of an education was entirely up to him and his ingenuity. Through hard work and arduous effort, he graduated from law school in 1928, became a member of the Order of the Coif and received an honorary Doctor of Law degree from Oklahoma City University in


The Federal Judicial Center, which he headed for several years, is the research and educational center for the 100 Federal Courts of the country and the 500 federal judges.

"Law," he once said, "must be a living thing, guided by the precedents of history, yet flexible enough to meet the changing conditions without strain from the great historical principles of our herit-

Our country, our Fraternity and the Bench and Bar will greatly miss this outstanding citizen who has contributed so much to the ad-He was a past Chairman of the ministration of justice during his lifetime.

Message from the Supreme Justice

Ever so often a court case arises which contains issues so fundamental that its proper adjudication requires an examination of the fundamental precepts of the issue of law involved — even to the extent of examining the legislative intent of the law itself.

In the same spirit, it is advisable to occasionally re-examine the fundamental precepts of Phi Alpha Delta to reinforce these basic precepts among all of our members.

These fundamental precepts of Phi Alpha Delta are contained in the Declaration of Purpose clause of our Constitution:

The purpose of this Fraternity shall be to form a strong bond uniting students and teachers of the law with members of the bench and bar. . .

Doesn't this simply say that by banding together in an effective organization we can accomplish much for ourselves, for our profession, and for society in general?

". . . in a fraternal fellowship. . ."

Does this not simply mean that the members of our Fraternity enjoy their association one with another and stand ready to aid each other professionally and otherwise.

designed to advance the ideals of liberty and equal justice under law

Is this not an indication of our emphasis on the professionalism and sense of responsibility to which we are dedicated?

". . . to stimulate excellence in scholarship. . ."

A basic foundation in the law is essential to enable any lawyer to properly fulfill the responsibilities demanded by the acceptance of a law

". . . to inspire the virtues of compassion and courage. . ."

The demands of present-day society require a person to maintain a strong sense of justice and intestinal fortitude if that person is to be "of the law - a lawyer.'

". . . to foster integrity and professional competence. . . ."

The most vital characteristic of a member of the legal profession is the reputation maintained among the members of the legal profession; that one's word is one's bond' is a truism especially appropriate among lawvers.

". . . to promote the welfare of its members. . ."

By adhering to the above mentioned precepts, our members can be assured that when referring a cause to another member, located in a distant geographical local, even though a personal acquaintance is lacking, the cause will be handled in a competent, professional manner.

". . . and to encourage their moral, intellectual, and cultural advancement


Does this not refer to the personal qualities to which we, as individuals, should strive to attain in our personal lives: integrity, learning, and a well-rounded personality?

". . . so that each member may enjoy a lifetime of honorable professional and public service.'

By aiding each other, whether through the activities of the active chapters while in law school, the alumni chapters after entering the legal profession, or on an individual basis, the members of Phi Alpha Delta perform a worthwhile professional service not only to ourselves, but to the legal profession, and to society generally.

A true understanding of and dedication to the fundamental precepts of Phi Alpha Delta will enable our Fraternity to fulfill the tasks to which it is dedicated. Think about it — but more importantly, adhere to and promote these precepts in your own professional activities, so that the promise of 'equal justice under law'' becomes a reality for all humanity, wherever located.



PHI ALPHA DELTA: A HISTORY

by C. Raymond Judice, Supreme Justice

(In November 1977, Phi Alpha Delta will celebrate its 75th anniversary. So that all members will have a better understanding of Phi Alpha Delta, the History of the Fraternity is being published in serial form. This is the second installment.)

Part II of IX

The Formative Years

Lambda Epilson Fraternity had ceased to exist. But its death did not signal an abandonment of the close friendships which had developed during the tumultuous

From these individuals, who were determined to re-group and try again, came a close nucleus of former Lambda Epsilon brothers who held their first organization sessions in the Colonial Tavern (more particularly, the bridal chamber of the tavern) in South Haven, Michigan. After "considerable discussion and debate", the committee (as it called itself) prepared and submitted the "Articles of Organization", later to be known as the "Articles of South Haven'

The articles carried the signatures of the following organizers: Alfred Thompkins, Sidney B. Meyer, Shelley B. Neltnor, A.S. Holspe, Mark H. Bell, Elias Mayer, E.G. Henkle, E.N. Sherburne, Roland M. Hollock, Paul C. Meier, H.W. Bloomingston, M.B. Schuster, J.M. Prentiss, Fred L. Ness, C.L. Daly, S.T. Sutton, James R. Garrett, Asahel W. Gage, and George B. Watson.

Minutes from the organizational meetings indicate three months were devoted to detailed planning. thorough discussions, and many meetings. The office of Elias Mayer, 1215 Association Building in Chicago, was the scene of many of the gatherings. Attending the first meeting of the board of the yet unnamed organization were R.M. Hollock, presiding, and Elias Mayer, S.B. Neltnor, M.B. Schuster, and H.W. Bloomingston.

Subsequent meetings saw drafting of the first nine articles for a new constitution. And, a meeting ngust 12, 1902, featured prep aration of a ritual.

The preliminary planning was soon to blossom into productive accomplishment. On Saturday, November 8, 1902, a "Meeting of the Fraternity at Large" was convened at De Jonghe's Cafe, 45 Monroe Street, Chicago, Minutes reflect 40 to 50 members attended with R.M. Hollock presiding.

The name "Phi Alpha Delta" was chosen. The constitution, ritual, and fraternity rules were adopted. A comprehensive plan for governing the new fraternity was enacted, providing for a "National Council", to be composed of two representatives from each chapter. National officers were to be elected by the National Council from among its members. And national conventions were to be held annu-

Phi Alpha Delta was on the way. Soon student chapters were to be chartered: Illinois College of Law became the site of Joseph Story chapter; Northwestern hosted

Melville W. Fuller chapter; Blackstone chapter was chartered for Chicago-Kent. (The charter for each was dated November 15, 1902, making it appear that the founders of Phi Alpha Dela considered the chapters of Lambda Epsilon continuing in existence as separate entities following its dissolution, and automatically becoming chapters of Phi Alpha Delta.)

At year's end, the founders wrote that Phi Alpha Delta was established "far better" than Lambda Epsilon could ever have been. Harmony and enthusiasm were the general rule with dissension the minor exception.

Smoothing out the few remaining wrinkles in the constitution was the next item on the agenda for the founders of Phi Alpha Delta.

The fourth convention (the first for Phi Alpha Delta), undertook the task. At an initial meeting — held at Pistakee Bay, Fox Lake Station, Illinois, brothers John A. Brown, Robert E. O'Brian, Charles L. Daly, Louis C. Garver, and Paul C. Meier were appointed to begin revision chores. (Their efforts were rewarded when revisions were adopted in 1903 at the adjourned meeting of the fourth convention, this time at Northwestern University Building in Chicago.)

One of the accomplishments of this administration was the establishment of the first chapters outside of Chicago. The newcomers were Ryan Chapter at the University of Wisconsin and Magruder Chapter at the University of Il-

Soon afterwards, Phi Alpha Delta was to establish its first chapter in the South. The University of Arkansas was the Scene, as the Fraternity moved across the Mason-Dixon line on April 28,

Close on the heels of the Arkansas chapter came John Hay Chapter, established June 16, 1906 at Western Reserve University in Cleveland, Ohio.

Establishment of the "far distant" chapters in Arkansas and Ohio brought attendant difficulties though. A side notation entered by a conscientious secretary indicates "expenses" were substantial in establishing the "distant" chapters, and the national officers were successful in their efforts to obtain half-fare railway tickets for trips to install chapters at "far distance lo-

At the seventh convention held at the Sherman House in Chicago, May 5, 1906, the subject of a fraternity magazine emerged, and soon afterwards the infant idea blossomed into the Phi Alpha Delta Quarterly magazine.

The ninth convention of Phi Alpha Delta in Chicago, May, 1908, saw radical changes in the constitution. The titles of the national officers were changed; and added were the new offices of Supreme Historian and Supreme Marshal. The

Board of Tribunes was established to hear all appeals from decisions of the chapters.

The convention also was marked by a first, specifically Brother Lawrence W. Ledvina being reelected Supreme Justice.

The twelfth convention was labelled by some delegates the "Insurgent Convention". Dissidents of the status quo condition of the constitution introduced a rash of amendments — but all went down to defeat except three, those being passage of a right to vote in conventions going to alumni chapters, a requirement that only one alumni chapter could be chartered in any one city, and a provision that members who dropped out of school and afterwards returned could resume their active fraternity status.

After disposing of the constitutional change movement, the delegates heard Supreme Justice Carmody report that four new active chapters and four new alumni chapters had been installed during the preceding year.

Incorporation or not? That was the main subject of the thirteenth convention of Phi Alpha Delta when it convened in the summer of 1912 in Chicago. Committeemen appointed at the twelfth convention to study the question reported that incorporation should be best completed on an individual chapter basis, with the basic fraternity structure incorporated under the

law of Illinois. Whether the ritual needed revising also occupied the efforts of the delegates to the thirteenth convention. Solution? Appoint a committee, a popular course of action even in 1912.

The fourteenth convention of Phi Alpha Delta was called to order at the Hotel Sherman in Chicago in June, 1913. Here, a major change in the constitution was enacted. Specifically, the power of any one chapter to veto the petition of a student changed to a more lenient requirement of three chapters dissenting

against a group before that group's application for a charter would be denied.

In other matters before the fourteenth convention, a proposal was introduced seeking to bar from fraternity membership anyone who had been a member of a high school fraternity. Minutes state the proposal was defeated, but its proponents were successful in obtaining the adoption of a resolution condemning high school fraternities.

The first step toward revising the ritual "more accurately in line with the views of lawyers and literary students" was taken at this convention. Minutes reflect that "nothing definite was done (though), except the general discussion of merits and demerits of the existing ritual". The fourteenth convention additionally devoted many hours to the discussion of The Quarterly, to the application for a charter from a group at the University of Oklahoma, and to charter applications from several "minor" colleges. The applications from the "minor" colleges were denied because scholarship standards were deemed not to meet the minimum standards.

The fifteenth convention of Phi Alpha Delta, meeting a year later, was the convention which featured the division of the United States into sections, and each section into districts. Additionally, this convention voted to change the national convention into a biennial affair, instead of annual.

A sidenote on the fifteenth convention indicated that at this time Phi Alpha Delta boasted 29 active and nine alumni chapters.

The call to order of the sixteenth convention of Phi Alpha Delta the last of the annual conventions came in August, 1915, in San Francisco. Chroniclers wrote that it was the most strongly attended convention ever held.

Noteworthy of the sixteenth convention was the mod group applying for a charter, was portation of most of the delegates - a train. But not an ordinary railroad train. Especially for the sixteenth convention, a specific train was designated, and delegates from across the country assembled in Chicago and boarded en masse the "Phi Alpha Delta Express" for the trip to the west coast, stopping en route to pick up additional delegates.

Delegates wrote that once in San Francisco, "... it was a wonder that so much work was accomplished. The brothers on the Pacific Coast had set themselves to make a record which they did". "San Francisco was at its height, with its lure, charm, and fascination (with the convention coinciding with the Panama-Pacific Exposition)."

"After the din of the outings on Mt. Tamalpias, Muir Woods, Tate's, Pisco John's, The Pub, The Bucket of Blood, The Manger, and the Barbary Coast had settled, the new officers took up their duties."

The year 1916 and 1917 continued as years of progress for Phi Alpha Delta. In early 1917 Supreme Historian Joseph P. O'Connell printed a Phi Alpha Delta directory, hailed by members as the most complete ever prepared.

The fall of 1916 and the winter of 1917 featured the first district assemblies. Reports state, "The results of these meetings were anxiously watched by the entire fraternity, and they accomplished much by way of fraternal contact and as-

Phi Alpha Delta was in good shape. It was composed of 37 active college chapters and 15 alumni chapters. It was well administered and its finances were satisfactory. The expansion program was being successfully pushed forward and the future looked bright.

Such a healthy condition was to stand Phi Alpha Delta in good stead in the weary war years right around the corner.

Charter Granted to Cooley Law School

The Michigan Supreme Court was the setting for the installation of a new chapter at Cooley Law School in Michigan on September 21, 1975 and the initiation of 34 charter members. Christiancy Chapter is named after Isaac Peckham Christiancy, a former member of the Michigan Supreme Court. PAD is the first law fraternity to establish a chapter at the school.

The initiation team was led by Supreme Second Vice Justice Donald R. Moore and included members of Campbell Chapter at the University of Michigan who provided assistance in the ceremonies as well as guidance to the newly elected officers.

The Chapter charter was officially presented to Professor Roger A. Needham, Faculty Advisor. Robert Rollinger, the charter Chapter Justice, accepted it on behalf of the membership. Other newly installed officers include Stephen Jordan, Vice Justice; John Marunick, Clerk; Michael Anderson, Treasurer; and Francis Leonard, Marshal.

Following the installation, a re-

ception was held at Cooley Law School for members of the Christiancy Chapter, their families and friends and interested alumni who had gathered for the occasion.

The Thomas M. Cooley Law School, located in Michigan's State Capital, was founded on June 19, 1972. The school received provisional approval from the American

Bar Association on February 25, 1975. The school is named for Justice Cooley, who served on the Michigan Supreme Court from 1864 to 1885.

The school is on a unique tri-term system offering a three year, year round, full time course of study in each of its three divisions. From its initial class of 75 evening students, Cooley Law School has expanded to a full day and evening program, enrolling near 700 students. The law school will graduate its first class in January, 1976.

Since its inception in September, the membership of Christiancy Chapter have been actively recruiting new associates. Since that time some sixteen students have committed to join and have indicated extremely strong interest in the programs offered through PAD. Information tables have been manned by Chapter members during the days of registration in order to provide first hand information on the scope of activities offered by PAD. Additionally, the Chapter has already begun a speaker's program and established communication with several alumni members in the greater Lansing area.

149th Charter Is To Nova University

The first legal fraternity at the Nova University Center for the Study of Law in Fort Lauderdale, Florida, became a reality on November 22, 1975, when the Thomas Farrar Fleming Chapter of Phi Alpha Delta International was installed as the fraternity's one-hundred-forty-ninth chapter.

Supreme Justice Judge C. Raymond Judice flew in from the Lone Star State to preside over the Installation Ceremony of the Fleming Chapter. Also on hand were James E. Freeman, Executive Secretary of the fraternity, who was an instrumental factor in the formation of the Fleming Chapter; District Twenty Justice, Marvin I. Moss, who has also contributed a great deal of time to the Fleming Chapter; son of the chapter's namesake and PAD Alumnus, Foy B. Fleming; Judge Emanuel Siegendorf, who is a local active Alumnus of PAD; and Judge Tillman Pearson, Judge of the Third District Court of Appeals of Florida and the final member to comprise the Installation Team.

Nova University Center for the Study of Law is one of the most recent Law Schools in the United States to receive provisional accreditation, which is a true accomplishment since this is the second year of the law school's existence. Next year the Law School will have its first graduating class and will be preparing 450 students for the practice of law. The school's current faculty consists of fifteen full time professors and the law library houses sixty-five thousand volumes.

The Fleming chapter has a membership of thirty-three members; thirty are second-year students, two are first-year students and Thomas E. Baynes, Jr. is the chapter's Faculty Advisor. Professor Baynes holds LL.M.'s from Emory and Yale Universities and came to Nova from the post of Regional Director of the National Center for the State Courts located at Emory University Law School.

Freeman, Executive Secretary of the Fraternity; Thomas E. Baynes, Jr., Chapter Advisor; Judge Tillman Pearson; and Kendall Phillips, first Chapter Justice.

The Nova Chapter receives its name from Thomas Farrar Fleming, who practiced law in Florida forty years and was known as an outstanding trial lawyer. The firm of Fleming, O'Brian & Fleming, which he founded, has continued under the same name to this date and is comprised of twenty-six lawyers. He served as President of the Broward County Bar Association and was founder of the American National Bank, Sunrise American National Bank of Fort Lauderdale and Southport American National Bank of Fort Lauderdale. These banks are now part of a holding company, First Bancshares of Florida, Inc., headed by his eldest son Thomas Farrar Fleming, Jr., and his other two sons John W. Fleming, also a PAD Alumnus and a member of the American Bar Trial Lawyers Association, one of the two members from the area, and Foy B. Fleming, also a PAD Alumnus and a member of the Board of Governors of the Nova Law Center.

The Fleming Chapter has begun preparations to attend the Districts 19 and 20 Conclave in Gainesville, Florida, in January, 1976, and looks forward to meeting the other PAD's who will be attending from Georgia, Alabama, Florida and Puerto Rico.

Waite's dignity and prestige of the office did not change his fair and ethical interpretation of the law. Waite's life will serve as a good example for the chapter in future times.

The University of Dayton — School of Law began on April 26, 1974 after being closed in 1935 because of the financial hardships stemming from the Great Depression. Local attorneys were instrumental in obtaining much needed financial support, quality library materials, and a complete staff. The Law School received its provisionary accreditation in February of 1975. Full accreditation is pending for 1977. The Law School presently consists of 126 second year students and 160 first year students.

With the newness of the school the Waite Chapter has many opportunities to implement ideas and untried service projects. The Waite Chapter is also the first law fraternity to be chartered at Dayton which will allow us easy access to the student body and professional staff. A drive is being planned to begin a local Alumni Chapter in the Dayton area in order to extend the fraternity into communitywide projects.



James L. Broz, Jr. Dies

James L. Broz, Jr., former Associate Tribune and former District Justice, died August 17, 1975 in Cleveland. Ohio.

"Jimmy," as he was known to hundreds of PADs in the Ohio area, was initiated into Hay Chapter while attending law school at Western Reserve University. After graduation in 1932, he practiced law with a private firm and also served as Attorney for Continental Casualty Company. In 1937, he joined the law department of the city of Cleveland and later served as Commissioner of Purchases and Supplies until 1972 when he resumed the practice of probate law.

Until illness prevented his presence at the Toronto International Convention in 1974, Jimmy had attended every Convention of PAD for approximately 40 years. Most recently, he was instrumental in the reactivation of Hay Chapter in October, 1974.

He had one of the longest tenures of anyone as a District Justice, and served on the Board of Tribunes from 1956 to 1958 and was General Chairman of the 1956 Convention which was held in Cleveland, Ohio.

In addition to his service in PAD, he was an active Mason and was serving as Monarch of Al Sirat Grotto at the time of his death. He was a past President and liaison officer of the National Counter-Intelligent Corp Association, having served in the Army Counter-Intelligence Corp at the headquarters of General Douglas MacArthur during World War II.

The Cleveland Alumni Chapter has established a living memorial as a recognition of his memory.
