The name selected for the chapter is that of Chester Alan Arthur. lation team each spoke about the Chester Arthur was born in Fairfield, Vermont, became a school teacher and later a brilliant lawyer. He won fame in two civil liberties law suits. One, a pre-Civil War case held that a slave brought into New York became free while the other established that Negroes enjoy the same rights on New York street cars as Whites. He served as the twenty-first President of the United States from 1881 to 1885.

The Vermont Law School is located on the White River in the Connecticut River Valey surrounded by New England, Green and White Mountains in the Village of South Royalton in central Vermont.

Vermont Law School is the first law school in Vermont. It was founded in recognition of a widening interest in the study of law and in large expectation as to what law school education can contribute both to those who participate in it and to society as a whole.

The adopted school motto is, "Lex pro urbe et orbe," law for the community and the world.

The law school received in visional approval on February 25, 1975 from the Section of Legal Education and Admissions to the Bar of the American Bar Associa-

PAD is the first law fraternity to be established on the campus.

Monroe Chapter Installed Midwestern School of Law

The James Monroe Chapter of Phi Alpha Delta International Legal Fraternity is now a reality. After nearly two months of planning and preparation the charter chapter was officially installed on May 24, 1975. The ceremonies were held in the Minnesota Supreme Court Chambers at the State Capitol Building.

Presiding over the installation ceremonies was the Supreme Justice of the fraternity, Judge C. Raymond Judice of Austin, Texas.

Dean Richard T. Oakes, of Midwestern School of Law at Hamline, was initiated as one of the charter members. The other initiates were: Lewis S. Bernstein, Kim Eve Bingham, Methuselah Z. O. After the installation a cocktail party with hors d' oeuvres and champagne was held at the home of the Monroe Justice Alan Morris. The party was attended by the guests and initiates of the Monroe

Chapter. The Midwestern School of Law was started late in 1972 as an evening law school of limited enrollment under the terms of a trust agreement. The trust was created by students for the benefit of students. Each student was named individually as settler and as beneficiary.

Two independent trustees were appointed with fiduciary responsibility running to those students. The trust terminated upon the creation and registration of a new nonprofit corporation, The Midwestern School of Law. On a Saturday night in January 1973, thirty-three students collected a pot of about \$50 to start the Midwestern School

of Law.

This new nonprofit corporation was formed under the Minnesota Nonprofit Corporation Act for the exclusive purpose of providing legal education. It is the stated purpose of the corporation to operate a school of law with an educational program designed to qualify its graduates for admission to the Bar. The corporate charter includes the requirement that the corporation act in every way possible to seek full accreditation in order to permit its graduates to take the bar exam. The first incorporators were three full-time students who had started with the institution under the terms of the trust agreement described

The school was formed out of a demand for legal education in Minnesota and in the Upper Midwest region. The aim and purpose of the institution will be to serve the community at large by producing practitioners with a sense of service to that same community. One of the primary reasons for being is to make legal education available to those who for reasons of age, economics, race, sex or culture have been prevented from entry into the legal education system. The aim, albeit ambitious, is to foster legal practitioners from the very communities and groups which find legal services for one reason or another, unavailable or very nearly

The curriculum includes all of the courses that one normally finds in a law school bulletin throughout the United States. The school operates on a full year system consisting of two semesters and summer school. Summer elective courses are in, the main, designed as logical continuations of basic year-long courses. These electives are designed to give realistic experiences to the student and to reinforce the classroom style learning experi-

The law school, now on the Hamline University campus in St. Paul, will have a \$1 million budget next year and has been provisionally accredited by the American Bar Association. Provisional requirements are the same as full accreditation requirements, but they must be maintained for three years of school to become fully accredited.

Of the Legendary 33 as they are known among the 400 students now in the school, thirty-one will be Midwestern's first graduates in June. The original thirty-three students had been among one hundred who enrolled in the Metropolitan College of Law, which was started in the fall of 1972. Before moving to 111 East Franklin in Minneapolis, classes were held in The People's Church, 1001 Penn Avenue, North, which had donated space for classes.

Midwestern's faculty has eight fulltime teachers. Administrators, parttime teachers, and guest

Message from the Supreme Justice

My message in the December, 1974 issue of The Reporter addressed itself to the question frequently asked by prospective members, "Just what can PAD do for me if I join." In this message I would like to share with you several instances involving the flip side of that same coin — first, what can an individual member do for our fraternity to ensure its continued strength and growth so that it in turn can continue to provide its traditional benefits to all of our members, including those who ask "What can PAD do for me?"


On Saturday, April 5, I was scheduled to attend the District IX Conclave in Chicago. Three days before I was to leave for Chicago, I called Brother J. Russell Hughes, a practicing attorney in Detroit, explaining to him that I could be in Detroit on the following Sunday for a few hours. I asked him to get a few alumni together to meet with me Sunday afternoon to discuss our fraternity's position in Detroit. In that short period Russell scheduled a luncheon meeting with several Detroit area alumni, made the necessary reservations, met me at the airport, and provided transportation both to the luncheon and from the luncheon back to the airport. During this luncheon meeting I discussed the fact that the Detroit Alumni Chapter, as well as the Cooley Chapter at Wayne State University and Murphy Chapter at the University of Detroit were currently inactive and asked for the assistance of the local alumni in our reactivation efforts.

That same evening upon my return to Austin, I received a call from Brother Hughes. During the period from the time he drove me to the airport in Detroit and my arrival in Austin, some three hours later, he had made contact with students at both Wayne State and the University of Detroit. In fact, he was meeting with one of the students when he made the call to me, giving me an opportunity to speak to this student. As a result of the dedication of this one member, the Detroit Alumni Chapter was immediately reactivated, and both Cooley and Murphy Chapters were reactivated on May 31, less than two months after my initial request for aid in these projects.

On May 24th the fraternity installed its 145th active chapter, the James Monroe Chapter at Midwestern School of Law in St. Paul, Mn. Midwestern is a new law school and the petitioning group was having difficulty obtaining a court room for the installation ceremonies. I called upon Brother Mike Wagner, the Justice of the Butler Chapter at William Mitchell College of Law in St. Paul, to aid in obtaining appropriate accommodations. Even though Mike is a full time law school student, maintains a full time job, and is serving as a chapter justice, he took time out of his busy schedule, not only to obtain the courtroom of the Supreme Court of Minnesota for the installation ceremonies and to participate in the installation ceremonies, but also to provide almost three hours of transportation during the day so that I could purchase the necessary items for the installation.

Each year our fraternity sponsors PAD Day at the Supreme Court of the United States. This program affords an opportunity for our members throughout the United States to be admitted to practice before the United States Supreme Court. For the past six years Brother William B. Robertson has served as chairman of this program. Robbie not only arranges for the date each year with the clerk of the court, but he also obtains the necessary application forms, makes hotel reservations for our members who are attending, schedules a breakfast and a luncheon for members and their families, and does all the other necessary work to ensure that the ceremony is a pleasant and rewarding one for our members.

This year Senator Claude Pepper (Fletcher Chapter), a former U.S. Senator, and currently a member of the House of Representatives, made the necessary arrangements for the luncheon and spoke to the assembled members and their families. While we were eating lunch Senator Pepper was called away to answer a quorum call on the floor of the House of Representatives. However, he returned, and even though his food had been taken away during his absence and he was thus without lunch, Brother Pepper gave one of the most inspiring talks concerning PAD and public service that it has been my pleasure to hear.

The Justices of Page, MacLean and Starr Chapters travelled to aid Brother Neil Berkowitz, District Justice of District XIV and myself install this new chapter. These chapters are fairly new in our fraternity, and the action of their members in taking time from their own individual studies and chapters reflect the true PAD spirit of service to our members.

In a slightly different aspect of service to our fraternity, the de-Diego Chapter at Catholic University of Puerto Rico has translated the Constitution and rush flyer into the Spanish language. This will enable our fraternity to reach law students in countries where Spanish is the national language and will be invaluable in our expansion efforts.

All of the above members, none of whom are serving as international officers of the fraternity. took time out of their busy schedules to enable Phi Alpha Delta to live up to its motto of "Service to the law student, the law school and the profession.

Sutherland Grows

Vinson PADs Publication

Publication of a new biweekly newspaper founded by three Vinson Chapter PADs will commence this fall at the University of Louisville. An initial issue prepared for the Law School's new library dedication was introduced to the legal community in May and mailed to the school's 2,250 alumni. Called the Louisville Law Examiner, the newspaper will be the first of its kind in the 129 year history of the Law School.

With William B. Bardenwerper as Editor-in-Chief, Donald W. Pearcy as Associate Editor and Thomas G. Karageorge as Business Manager comprising the paper's Managing Board and W. Mitchel Nance serving as Brandeis Brief Editor in charge of soliciting authors for the paper's legal commentary column, the Louisville Law Examiner has currently an all-PAD staff, though the editors will be looking for others to act as department editors and contributors in the fall.

The focus of the newspaper, according to Bardenwerper, will be directed concurrently towards all three elements of the Law School community — the students, faculty and alumni - with news articles, features and in-depth investigative projects written with respect to the interests of each group held separately and in common.

'The key to our purpose," says Bardenwerper, "is the word community". By making aware the uninformed, redirecting the misinformed and further enlightening the informed through this newspaper we expect will follow a shared interest in a common purpose — the betterment of our law school and our profession."

The newspaper will be regularly distributed among the Law School faculty and 650 students as well as mailed to all alumni. Within the near future the present editors hope they can step up publication to a weekly basis.

P.A.D. Day at the Supreme Court a Success

In a special group ceremony held June 2, 1975, 31 members of Phi Alpha Delta Law Fraternity, International, from 16 states and the District of Columbia were admitted to practice before the Supreme Court of the United States. Their admissions to the Bar of the nation's highest court were moved by Miss Alice O'Donnell as the highlight of the Ninth Annual PAD Day at the Supreme Court.

Miss O'Donnell, a PAD, is Director of Inter-Judicial Affairs and Information Services at the Federal Judicial Center and immediate past Chairman of the Judicial Administration Division of the American Bar Association.

Preceding the ceremony, the Fraternity sponsored a reception and continental breakfast in honor of the new admittees, and a luncheon followed at the Rayburn House Office Building. 

teachers equal sixteen other professional positions. Midwestern's library is now up to approximately 46,000 volumes. Plans are now being formulated for a new building which hopefully will be designed on the law center concept.

The chapter takes as its name that of James Monroe, a former President of the United States. Monroe was born in Westmoreland County, Virginia in 1758. He served in the Continental Army in the Revolutionary War and after the war resumed the study of law, was admitted to the bar and engaged in practice in Fredericksburg, Virginia. He served his country in a variety of positions. Besides being the Governor of Virginia, he was a member of the Continental Congress, a United States Senator and a Minister to France and England and Secretary of State under Madison. He died on July 4, 1831.

Kohn Receives National Award

Stanley H. Kohn has been selected to receive the 1974 National Volunteer Award on behalf of a volunteer project he has headed since its inception in 1971. The award, presented annually by the National Center for Voluntary Action, honors the outstanding volunteer organization in the nation during National Volunteer Week, and was presented on April 24 by Vice President Nelson Rockefeller and National Volunteer Chairman George Romney at a reception and ceremony at the John F. Kennedy Center for the Performing Arts. Kohn was escorted and introduced at the presentation by Mrs. Potter Stewart, wife of the associate Supreme Court Justice.

Kohn is Chairman of the Family Court Volunteer program in Columbia, South Carolina. The Family Court Volunteers, previously recognized as recipients of a Citation presented earlier in the year by South Carolina Governor James Edwards, operate a group of projects in conjunction with the Richland County Family Court, all of which are designed to serve the needs of young people. Dealing primarily with children serving a probationary sentence handed down by the Court, the Volunteers serve as one-to-one adult friends and tutors. One project develops community responsibility in the probationers by designating them as volunteers, who in turn are assigned to work with handicapped children. The Family Court Volunteers are currently field-testing three preventive type projects in Columbia, and will operate a summer day camp for the children on probation.

This year's winner was chosen from more than a thousand nominations received from throughout the country. Selection is based on community benefit and value, scope of volunteer participation and achievement and the method of innovation in the program. Among the judges selecting the winner were U. S. Senator Edward W. Brooke of Massachusetts, television star Hugh O'Brian; Carlos Arboleya, president of Flagler Bank of Miami, Caroline Leonetti Ahmanson of Los Angeles, member of the National Council on Humanities; and Elaine Musselman of Louisville, member of the Board of Governors of the American Red Cross.

Then Justice Clark delivered the main address: his topic was "Judicial Modernization." He related some of his personal experiences with problems that exist in the judicial system and with the search for solutions to these problems. The chapter presented Brother Clark with an honorarium; a briefcase to replace the one he received from the Supreme Court when he was appointed by President Truman.

A committee has been designated to work with the local courts and the public defender's office to set up a program whereby P.A.D. members will assist court-appointed counsel on a case by case basis.


