Dickinson Law School Receives **PAD Charter**

The one hundred thirty ninth chapter of PAD was formally installed on Friday, March 7, 1975 when a charter in the name of Mary Vashti Burr Chapter was presented to Dickinson School of Law in Carlisle, Pennsylvania.

Burr Chapter was originally installed as Omicron Chapter of Phi Delta Delta Legal Fraternity on May 18, 1923. However, the merger of Phi Delta Delta with Phi Alpha Delta Law Fraternity, International, made it necessary for the renaming of the chapter and the presentation of a new charter. Mary Vashti Burr was President of Phi Delta Delta from 1934 to 1938 and was an Assistant Attorney General of the State of Pennsylvania.

Robert Sullivan, Jr., was elected first Justice of the chapter. Brother Sullivan was originally initiated into Phi Alpha Delta during the 40th Biennial Convention in Toronto, Canada. Other officers include Charles O'Brien, Vice Justice; G Michael Leader, III, Clerk; Jeff Boswell, Treasurer, and Aimee Toth, Marshal. The students selected Brother John A. Maher to serve as Faculty Advisor.

The chapter was installed and the members initiated in a courtroom of the Cumberland County Courthouse, by Supreme Justice C Raymond Judice, Supreme Second Vice Justice Donald R. Moore and Supreme Treasurer Dalphine Mac-



Message from the Supreme Justice

In my travels as Supreme Justice of Phi Alpha Delta Law Fraternity, International, during the last seven months, I have had extensive communications with our active and alumni members at chapter installations and District conclaves. I am extremely encouraged by the enthusiasm which our members share concerning the growth of PAD at law school campuses throughout the United States, Canada and Puerto Rico. For example, recent chapter installations were held at New England School of Law in Boston, Massachusetts and at Dickinson College of Law in Carlisle, Pennsylvania.

After participating in the recent chapter installations and district conclaves, and listening to the remarks of our active members, I feel that it is appropriate to amplify the philosophy of one of our growing benefits to members - the International Placement Program. As you are well aware, the Supreme Executive Board, in accordance with the directive of the 1974 Convention, appointed an International Placement Director last October. Included within the duties of the Placement Director is the collection of national and regional job placement information, distributing any information received and acquired to all local chapters, furnishing a list of local alumni to local chapters upon request, and continuing solicitation of job placement information. Brother James Freeman, our International Placement Director, is presently working closely with District Justices, alumni and local chapter placement officers to implement the programs which were suggested by the Convention last summer.

In the last year, the total number of alumni PAD's has increased to over 76,000 members. Graduating seniors from 139 active chapters located in the United States, Canada and Puerto Rico add substantially to this number each year. For many, the active association with Phi Alpha Delta during the law school career, is fast coming to an end. Hopefully you, as the law student of today, are ready to become the well prepared, effective, prosperous lawyer of tomorrow. In addition, those of you graduating will also become involved as alumni in partaking of our placement program. Fortunately, you made a wise decision to join the fraternity of Phi Alpha Delta. You now have the combined experience, cooperation, good will and assistance of the better part of 76,000 alumni members and a viable and effective professional placement office to assist you in choosing and finding a suitable position.

It is the purpose of the International Placement Office, working through the active chapter placement officer, to provide meaningful suggestions on how to prepare a resume, suggestions for an interview, and with the assistance of interested alumni, find an appropriate position. The International Placement Director will be able to inform you of the various opportunities which may be available in light of your particular interest and background. He will, with the assistance of district justices and years as a government lawyer.

your active chapter placement officer, also be able to advise you as to local hiring practices and salary schedules. Of course, the active

Only in this manner can the benefits available to our members be effectively communicated to our members desiring such aids.

Nevertheless, when all of these resources have been utilized, the ultimate task of finding the appropriate place and position in which to commence your legal career is your responsibility. It has been said that one chooses law partners with the same care that one chooses a spouse. Whether or not this is true, only you will know what is best for you, where, and how you can make the best use of your legal training.

Student Report of SEB Meeting

The Supreme Executive Board of Phi Alpha Delta met December 6-8 at the Doubletree Inn in Phoenix, Arizona, I was selected by the Board to sit in as a student observer, both to participate in the discussion, and to report to the active chapters on the meeting of the Board.

(In accordance with past policy, the Supreme Executive Board invited Bill Perry, Justice of Knox Chapter at the University of Arizona, to sit in on its meeting held December 6-8, 1974, in Phoenix, Arizona as an observer. The report of Brother Perry follows.)

ered a great deal of ground I will attempt to discuss the highlights. I should point out that the Board was eager to seek out my opinions, and those of Supreme Marshal Jack Miller, the student member of the Board, as well as those of District IV Justice Ken Haber, who also attended as an observer. The Board members worked very hard in attempting to implement the desires of the membership as expressed through the Toronto Convention and a majority of the time was spent on items concerning students.

The Board authorized the Executive Secretaries to develop a pamphlet for general distribution, illustrating the use of the \$30.00 International Initiation Fee, and the benefits derived from it. This action was taken in response to active chapter requests for such a publication for use in rush.

During its consideration of a petition for the New England School of Law, the Board reaffirmed its policy of declining to name active chapters after deceased members of other legal fraternities.

The Board found it necessary to discontinue its sponsorship of the Professional Liability Insurance Program. This action was necesitated by the posibility of cancellation of the plan by the insurers, and the likelyhood of being unable to replace the insurers. Malpractice actions are on the rise. Insurers are becoming increasingly leery of this area of insurance. The Board felt that a cancellation of the policies of a large number of PADs was a real possibility. Were this cancellation to come about it would seriously injure each individual's possibilities of being re-insured. The Board felt that under the circumstances it would work a disservice to the membership to continue the plan. Paul S. Burke, Jr., Administrator of the Fraternity's various insurance plans will attempt to place all PADs with individual professional libility insurers.

The Board authorized the offer of an additional \$10,000 of life insurance coverage to existing insureds with a maximum coverage of \$50,000.00.

Past Supreme Justice Matthew S. Rae was presented with the jeweled Past Supreme Justice Key, for extreme dedication and service to the fraternity.

The Board recommended to the Constitution and By-Laws Committees that past Presidents of Phi Delta Delta Legal Fraternity be made members of the Supreme Advisory Board.

Although no decision was reached regarding the site of the 1976 International Convention prefered dates are August 3-6, 1976. The 1978 International Convention will be held at the Palacio del Rio Hotel in San Antonio, Texas.

The Supreme Executive Board recommended to the 1976 Convention that purple voting cards be utilized at that convention to record the votes of the delegates. This recommendation was made to insure that no extra votes are cast on the floor of the convention, as was possible under the former procedure. The Board further recommended that all members of the Supreme Executive Board, and District Justices be allowed to vote only in those capacities, and not in any other capacities in which they may serve. The Board decided to implement a Most Outstanding Professional Program competition, and to

Chapter Installed at New England School of Law

Nancy Gibbs appointed District 1 Justice

Nancy P. Gibbs, a member of Dunbar Chapter at the University of Washington, has been named District I Justice to succeed Ernest Greco, who was forced to resign because of business commitments.

The new District Justice thus becomes the first woman District Justice in the history of the Fraternity. She was initiated into PAD just after the constitutional amendment was adopted at the 1970 Convention permitting women to become members.

She was born in Vancouver, British Columbia, but moved to Oregon in 1955 and has lived in the Seattle

area since 1961. She was admitted to the Washington State Bar in 1971 and is an associate of Davis, Wright, Todd, Reise and Jones.

Nancy attended the 1972 San Diego International Convention and the 1974 Toronto Convention and played an active role in both conventions. Her husband, Lt. Commander Frank W. Hughes, attended both conventions with her.

She was named as one of the top ten outstanding senior women at the University of Washington in 1968 and presently serves as Treasurer of the Washington Woman Lawyers and Chairman of the Seattle-King County Bar Association, Judicial Selection Committee.

District I includes the states of Washington, Oregon, Idaho, Montana and Alaska, as well as British Columbia and Alberta.

The chapter's namesake, Bertha R. MacLean, was a former Dean of Portia Law School, the predecessor of New England School of Law, and was a charter member of Eta Chapter of Phi Delta Delta, when it was founded at Portia Law School. The former Eta Chapter of Phi Delta Delta was installed in January 24, 1920, 55 years to the day that the chapter was reactivated as MacLean Chapter of Phi Alpha Delta Law Fraternity, International. On hand at the initiation ceremonies at the Law School Moot Courtroom, was Mrs. Richard E. Slowe, who was initiated into Eta Chapter of Phi Delta Delta during the 1930s.

Portia Law School, which later became New England School of Law, was originally established in 1908 as an institution for the education of women lawyers. At the present time, the law school is a co-educational institution located in the downtown Boston area.

Halleck Chapter in Prison

Twenty of Halleck Chapter's fifty members recently spent a few hours in the Indiana State Prison at Michigan City, Indiana — as guests - but behind bars. The tour was arranged through the efforts of Brother John Pera and Mr. Duckworth, Warden of the prison.

Entry into the prison was accomplished by passing through security equipment similar to that used at the large airports. One difference in this equipment, however, was that it detected paper as well as metal. Prison officials stated that the objective here was to prevent messages from being passed to the prison immates.

Most of the prison facility is old some of the buildings were built prior to 1900. Despite its age, however, it was surprisingly clean and well-groomed by the prisoners. A major rehabilitation program is underway at the facility which is designed to teach job skills to those who would otherwise be unskilled laborers in the job market. The kinds of skills taught are heating and refrigeration repair, auto mechanics and body work, electronics, welding and others.

It was interesting to note that the majority of prisoners are permitted a good deal of privacy even to the extent of allowing paper or cloth to be interwoven through cell bars. Many of the inmates had radios and even televisions though it is unclear to what extent such "luxury" items are actually authorized by prison authorities.

Through donations the prison has accumulated quite an extensive law library and so-called "prison lawyers" are in abundance. The library itself is now where the old "death row" and electric chair once were.

From an environmental point of view, the prison facility appeared to be quite satisfactory. However the despair and emotional tension of the inmates was ever-pervading. Halleck Chapter believes that we as students of the law owe it to ourselves and those whom we will serve to see first-hand the conditions of our penal institutions. The tour was enlightening, relieving in some ways and appaling in others.

Adams Chapter Rejuvenated


