

#### Mr. Justice Tom C. Clark Dies

Phi Alpha Delta lost its "ambassador of goodwill" on June 13 when death claimed retired Supreme Court Justice Tom C. Clark at the age of 77.

An enthusiastic supporter of the Fraternity ever since he became an honorary member in 1945 while he was Attorney General of the United States, Justice Clark had served two terms as Supreme Vice Justice (1964-68) and was one of the first members of the Distinguished Service Chapter, election to which is a rare honor in recognition of "unusual and outstanding service" to the Fraternity. In his extensive travels, he had endeared himself to active and alumni chapters in scores of cities throughout the country. Seldom was he in a city having a PAD Chapter without attending a function or otherwise visiting its members or officers.

Numerous members treasure one or more of his warm and gracious hand-written notes - notes of congratulation, notes of sympathy, notes of reassurance, signed simply "T.C.C.

For more than a decade he had been involved in PAD Day at the Supreme Court, when fraternity members from throughout the country go to Washington for a special group admission to the Bar of the Supreme Court. He frequently made the motion for admission and participated in the pre-admission breakfast reception, as well as the luncheon that fol-

Justice Clark was the keynote peaker at three international conventions and also participated in several district conclaves and a variety of individual chapter functions. His contribution to his law fraternity was aptly summarized in a plaque presented to him at the 1976 Convention in Kansas City which described him as PAD's ambassador of goodwill.

When a memorial service was held in Washington on June 22, the Fraternity was represented by International Treasurer Dalphine MacMillan, Past International Justice Robert E. Redding, Past International Second Vice Justice Donald R. Moore, Past Associate Tribune William B. Robertson and, from the National Capital Area Alumni Chapter, Justice Daphne S. Miller, Immediate Past Justice Frank Cacciapaglia, and Ralph Olson. They heard Justice Clark eulogized by his son, former Attorney General Ramsey Clark, and by Chief Justice Warren E. Burger, a fellow PAD.

Attended by some 500 friends, including all of the present Justices of the Supreme Court, as well as three former Justices, the memorial service at the National Presbyterian Church was designed, in the words of Ramsey Clark, "to celebrate the life of a good man" - one whom he finally described as "the best man I have ever known."

He was in New York to sit on the United States Court of Appeals for the Second Circuit. Ever since he retired from the Supreme Court in 1967, he had continued his judicial duties. He was the only person in the Nation's history to sit as a judge in all eleven circuits of the Federal judicial system. Some of the time it was as a trial judge in a United States District Court, some of the time it was as an appellate judge.

It was typical of Tom Clark that, although still vigorous and still enjoying his work as an Associate Justice of the Supreme Court, he stepped down without complaint from the bench when his son Ramsey became Attorney General in 1967. He wanted to avert any appearance of conflict of interest in Government cases.

His "retirement" was shortlived. In 1968 he became the first Director of the Federal Judicial Center, which was established to improve the administration of jus-

#### Burger Is Chief Justice

Brother Warren Burger holds the top judicial position in the United States as Chief Justice of the Supreme Court. A dedicated and enthusiastic PAD, he served as Honorary Chairman and Keynote Speaker for the 1968 International Convention, and has been instrumental in the development of the renown PAD Inns of Court Prog-

tice and to train judges to do a better job. Not only in this post, but also after he retired from it, he traveled widely to work with lawyers and judges in behalf of this cause — a mission that had been foreshadowed by similar work while he was still on the Supreme

Praise of Tom Clark came from leaders of the Bench and of the Bar, from the press, and from countless individuals whose lives had been enriched by contact with this man of great and gentle strength.

Justice Clark had won increasing respect as a jurist who had grown in stature while on the bench. He was also recognized as one who performed a valuable function as an ambassador to the Bar and to the non-legal world, as well as a conciliator on the Court itself. And, judge after his retirement, his most noteworthy contribution was in this field of breathing life into the legend engraved over the Supreme Court building: "Equal Justice

Describing Justice Clark as "unique" in the annals of the Judiciary, One of the hardest-working Chief Justice Burger declared that "No one in the past thirty years has Attorney General Griffin Bell, another PAD, described Justice Clark's endeavors in this field as without equal.'

# **PADs Receive Top Positions** In Carter Administration

Three more PADs have been appointed to key positions by President Jimmy Carter. Judge Wade H. McCree has been appointed solicitor General of the United States and assumed that position on March 28, 1977. Michael Pertschuk was sworn in as Chairman of the Federal Trade Commission at the White House on April 21, 1977, and John H. Fanning has been confirmed as Chairman of the National Labor Relations Board.

President Carter had previously named two PADs to his cabinet in the persons of Griffin B. Bell as Attorney General and Brock Adams as Secretary of Transportation. In addition Warren M. Christopher is serving as the Deputy Secretary of State and in this capacity is the Chief Assistant to Secretary of State Cyrus Vance.

#### WADE H. McCREE

Brother McCree is an honorary initiate of Cooley. Chapter at Wayne State University. He was born in Des Moines, Iowa and received his formal education in the public schools of Hilo, Hawaii, Chicago, Illinois and Boston, Massachusetts.

He earned the degree of Bachelor of Arts at Fisk University and Bachelor of Laws at Harvard Law School. He has received honorary Doctor of Law degrees from Harvard University, University of Detroit, Detroit Collge of Law, Wayne State University, Tuskegee Institute, Michigan State University and the University of Michigan. He served four years in the Army of the United States during World War II and was discharged as a Captain of Infantry after two years of overseas combat duty. He practiced law in Detroit, Michigan and served as Workmen's Compensation Commissioner prior to becoming a Circuit Judge in Michigan in1954.

In 1961, he was appointed to the United States District Court for the Eastern District of Michigan,

where he served until his appointment in 1966 to the United States Court of Appeals for the Sixth Circuit where he currently serves. He has been an adjunct faculty member of Wayne State University Law School, a member of the law faculty of the Salzburg Seminar in American Studies, and a member of the summer faculty of The Law School of the University of Indiana. He is a Trustee (Vice-Chairman) of Fisk University and an Overseer of Harvard College. He serves on the Visiting Committees of Harvard Law School, and Wayne State University Law

He was a founding trustee of Friends School in Detroit. He is a Fellow of the American Bar Foundation, a former Director of the American Judicature Society, and was a Director of the Federal Judicial Center. He is a member of the Institute of Judicial Administration and a member of the Advisory Board of the American Bar Association Journal. He is a member of the American Bar Association Commission on Standards of Judicial Administration and of the Advisory Council on Appellate Justice. He is a member of Phi Beta Kappa and serves on several Michigan and National charitable boards.

He is married to the former Dores M. McCrary and has two daughters, Kathleen (Mrs. David





crime and terrorism of which he said, "I applaud those who so zealously carry forward the banner of individual rights, but I think it is unfortunate that some of them find it necessary to characterize law enforcement as a monster threatening to devour human dignities and liberties.

He said, "We should not under any occasion, be investigating a matter that is political in nature. You have the right of political expression"... and that the FBI has "meticulous regard" for the citizens right to privacy and "their sacred right of legitimate dissent." He added that it is sometimes "difficult to achieve" a balance between crimefighting and the indivual's rights, but the right to privacy will not be violated by his

Responding to a question about FBI files on some political activists, Kelley said many files in recent years have been closed, but cannot be destroyed until Congress passes legislation permitting such a

To another question, Kelley responded that presently the FBI is looking primarily to the fields of law and accounting for new agents, and with a new emphasis on women agents. He said the Bureau encourages applications from law students while they are in their second year. Starting salary is about \$17,000, he

### **152nd Charter Goes To Notre Dame**




Hoynes Chapter is planning another initiation this Fall among its other activities.

# Two PADs Appointed To Fla. Supreme Ct.

Terrell Chapter at Florida State University is pleased to announce that the two newest members of the Florida Supreme Court are PADs.

Frederick B. Karl is an alumnus of Brewer Chapter at Stetson University where he received his LL.B degree in December of 1949. Brother Justice Karl was elected to the Florida Supreme Court in September of 1976.

Justice Karl's background in public service has been extensive. He has served as a state representative from Volusia County from 1956 to 1964 and as State Senator from District 14 from 1968 to 1972, in addition to serving as counsel to the House Select Committee on Judicial Impeachment in 1975.

Further, he is a recipient of the Florida Education Association School Bell Award which is presented to individuals outside of the education profession making the greatest contribution to education in the state of Florida. His colleagues in the State Legislature showed their high esteem for him by voting him as one of the top three members of both legislative bodies; also he was voted the most outstanding first term member of the Senate and the most effective member in committee of the Senate in addition to the most effective debate in the Senate.

Joseph W. Hatchett, an honorary initiate of Terrell Chapter at Florida State University, also won election to the Florida Supreme Court this last September. Justice Hatchett had previously been appointed a Justice of the Supreme Court by Governor Rubin Askew.


Before serving as a Justice of the Supreme Court, Brother Justice Hatchett served as United States Magistrate for the Middle District of Florida, which includes 33 counties from Jacksonville to Ft. Myers. From 1967 until 1971, he served as First Assistant U.S. Attorney for the Middle District of Florida.

As First Assistant U.S. Attorney, Justice Hatchett represented the United States Government in hundreds of criminal prosecutions trials in both trial and appellate courts. He also directed investigations in hundreds of cases by the FBI, Secret Service, Postal Service, Drug Enforcement Administration and the Immigration and Naturalization Service and conducted grand jury investigations.

He received his law degree from Howard University in Washington, D.C. in 1959. After graduation, he engaged in private practice before


entering public service. In 1974, Justice Hatchett was one of five Americans chosen by the Chief Justice of the United States Supreme Court and Director of the Administrative Office of the United States Courts to travel to England to study the pretrial procedures used in English courts.

While Justice Hatchett was appointed to the Supreme Court of Florida on July 8, 1975, he was faced with the statewide election for his office on September 7, 1976. His victory marked an historic first - the first Black to win a statewide election in the South.



According to the most recent listing of schools, as compiled and published by the Association of American Law Schools, 53 PADs are presently serving as Deans of law schools which are on the approved list of the American Bar Association or equivalent accrediting agency in Canada. #### Francis A. Allen Is President of Ass'n. of Amer. Law Schools



# Waite sponsors legal aid to elderly

Waite Chapter's Legal Assistance to the Elderly Program provides greatly needed legal services to Dayton, Ohio's senior citizens and provides invaluable experience to the chapter's members. Using first, second and third year students, the objective of the program is to determine whether or not the elderly client has a legal problem which requires the attention of a practicing attorney. This service is very important since many senior citizens, particularly elderly widows, are unfamiliar with legal and business matters, cannot afford even an initial consultation fee for an attorney or do not know how to select an attorney and therefore do nothing.

The procedure used by Waite Chapter is as follows: a law student visits a senior citizen's housing complex or nutritional center twice a month for two hours; the clients are interviewed at this time, but no

advice is given; before the next has banner year visit the interviewer researches his client's problem to determine what remedies are available and whether a licensed attorney will be required. If an attorney's assistance is necessary, the client is referred to either their own attorney, the legal aid office or the local bar association. But, if as in most cases, the problem is more of a business nature or is an administrative law problem for vhich an attorney is not required, the student handles the case himself.

Furthermore, operational expenses for such a program are minimal. Waite Chapter's program has been able to operate on a \$50 a year budget, with travel expenses being borne by the individual student.

This program can be operated as a separate committee within your chapter; it will greatly increase active participation and is an excellent community relations project.

# Egan Initiates Three Honoraries

The John P. Egan Chapter of Phi Alpha Delta Law Fraternity International initiated Judge William F. Cercone, Superior Court of Pennsylvania, Attorney General Robert P. Kane and State Senator Jeanette F. Reibman as Honorary Members at their annual Spring Banquet held on March 31st. These initiates were recognized for their exemplification of the ideals of the fraternity to foster integrity and professional competence.

Judge Cercone has served in the District Attorney's office of Allegheny County and has held a position on the federal level as Special Deputy Attorney General. Judge Cercone was presented the merit award from the Academy of Trial Lawyers and sat as judge in the Court of Common Pleas until his present position as judge to the Pennsylvania Superior Court.

Judge Cercone during his acceptance speech expressed his concern towards society's attitude that today's social problems be resolved through the judicial system. There is a growing tendency to have the court step into legislative matters because of the demand for expediency in settling legal issues. This places a burden on the single judge who is faced with deciding on issues which in the past were within the purview of the Legislature. Our ever-developing world causes an important interplay between the policy of stare decisis and our changing society. Judge Cercone feels we must carefully evaluate these changes in order to preserve the separation of powers.

Attorney General Robert Kane has been actively involved in human relations work and has had extensive involvement in the Democratic party. Mr. Kane has served as Administrative Assistant to Congressman Nieman Craley, Jr. and was appointed Secretary of Revenue in 1971. He now serves under the Shapp Administration as Attorney General.

Attorney General Kane emphasized the role of the criminal justice system in Pennsylvania. The popular approach to the problem seems to be one of pumping money into penal institutions believing such action provides a

workable solution to crime. We are treating the effect while we evade the problem. Mr. Kane pointed out the man-power and funding available within the Justice Department only supplies an external and after-the-fact approach to curing crime. An important step is to breed an internal upholding and belief in the law within our schools and other social institutions. Each individual must acquire his own respect for the law.

Janette Reibman has had both federal and state experience in various areas. Senator Reibman has served as attorney for the U.S. War Department and the U.S. War Production Board during World War II. She has actively participated in several capacities in the field of education and was instrumental in developing and advancing the PHEAA program. She has also served on an advisory committee on Working Conditions for Women and Children and recently ran in the 1976 primary election for the U.S. Senate.

Senator Reibman was the first female to be distinguished with honorary membership in Egan Chapter. She observed that PAD was the first fraternity to admit women and commented that such action recognizes the growing percentage of highly motivated and qualified women. The Senator stressed that legal training has taken on new aspects of public service rather than restricting itself to preparing the law student to be "judicially trained." There was agreement with Judge Cercone that the law must grow to be responsive to society and this should be done through proper functioning of the Legislature.





ing continuing legal education for judges as well as for lawyers. He was one of the founders and moving spirits in a college for trial judges established by the American Bar Association. He performed yeoman service as the Chairman of an American Bar Association study of lax discipline and shady conduct among lawyers.

In the past two decades, there was seldom any new program to reform the Bench or the Bar which had not been started or moved ahead by Tom Clark. His devotion to duty and to hard work was legendary.

To bar association work and to Fraternity activities, he brought an imaginative and innovative approach. In his keynote address to the PAD International Convention last year, he called for a restructuring of legal education to emphasize clinical training. And, on the very day of his death, he had put the finishing touches on a paper authored by him and Past Supreme Justice Redding outlining a PAD project to promote the development of the clinical concept in law school.

Tall and genial and soft-spoken, with a ready smile above the bow tie that was his trademark, he was described by one writer as the 'traveling salesman of justice.' He was one of the most popular figures in American law.

Whether Tom Clark was a great lawyer or a great jurist may be debatable, but that he was a great man one of the best men many of us have ever known — is unques-

So it was that Chief Justice Burger eulogized Tom Clark as a man "of brilliant humanity," known to be a ready listener for "any person having a problem," a man who taught us all how to 'seem unhurried'' amid "fabulous activity.

And so it was also that son Ramsey found in his father a man who "functioned joyously all the days of his life" — a man who "realized that the true joy of life is being exhausted in a cause you yourself deem mighty" - a man who was guided by the counsel of Saint Paul that "love worketh no ill to his neighbor; therefore, in love is a fulfillment of the law.

The life of Tom Clark challenges Shakespeare's observation that the good men do is oft interred with their bones. An improved judiciary, a better functioning legal system will be a lasting monument to Tom Clark. And his memory will be ever green in the hearts of those who knew and loved him as one who did justice, loved mercy, and walked humbly with his God.

In his keynote address at the International Convention Convention of Phi Alpha Delta in 1976, Justice Tom C. Clark told of a beloved doctor in the little town of Lexington, Virginia, where the Justice had attended Virginia Military Institute. The doctor's office was on the second floor of an old building, reached by an outside stairway. It was marked by a weather-beaten sign: "Doctor Reid White - Office Upstairs," with an arrow pointing upward.

When the good doctor died, the sign disappeared, only to reappear on his grave as a fitting epitaph — "Office Upstairs."

So might be marked the grave of Tom C. Clark, lawyer and judge — "Office Upstairs" . . . an arrow pointing upward. And echoing from some church the old hymn (sung at his memorial service) "Beautiful Isle of Somewhere," with its optimistic opening, "Somewhere the sun is shining

Through the ages men have dreamed of and struggled toward the concept that nothing on earth is more sacred than human personality - that there is in the human soul a place which is inviolate, where no government or man may enter. But not until it became a part of our Declaration of Independence did

#### JOHN H. FANNING

John H. Fanning, the new Chairman of the National Labor Relations Board is an honorary initiates of Cardozo Chapter at Catholic University of America.

He is a 1941 graduate of the law school at Catholic University of America, having obtained his AB degree from Providence College in Rhode Island. He is a member of the State Bar of Rhode Island and the United States Supreme Court Bar. From 1942 to 1957, he served in legal and industrial relations positions with the Department of Labor, Army and Defense.

In December of 1972, he was appointed by President Nixon to a fourth five year term as a member of the National Labor Relations Board. He is the only Board member to be appointed for four successive terms by four Presidents of different political parties. #### MICHAEL PERTSCHUK

The new Chairman of the Federal Trade Commission, Michael Pertschuk, is an alumnus of Calhoun Chapter at Yale University.

The Senate approved President Carter's nomination of Brother Pertschuk on April 6, 1977, for a term ending September 25, 1977, and for a seven-year term ending September 25, 1984.

From 1964 until his appointment to the Federal Trade Commission, Mr. Pertschuk was Chief Counsel of the Senate Committee on Commerce and was instrumental in drafting numerous consumer protection measures including the Magnuson-Moss Warranty — Federal Trade Commission Improvement Act.

He has been an adjunct professor at the Georgetown University Law Center, a professorial lecturer at American University's Washington School of Law, and a lecturer at Brookings Institution public law seminars and at the Sloan School of Management, Msssachusetts Institute of Technology.
