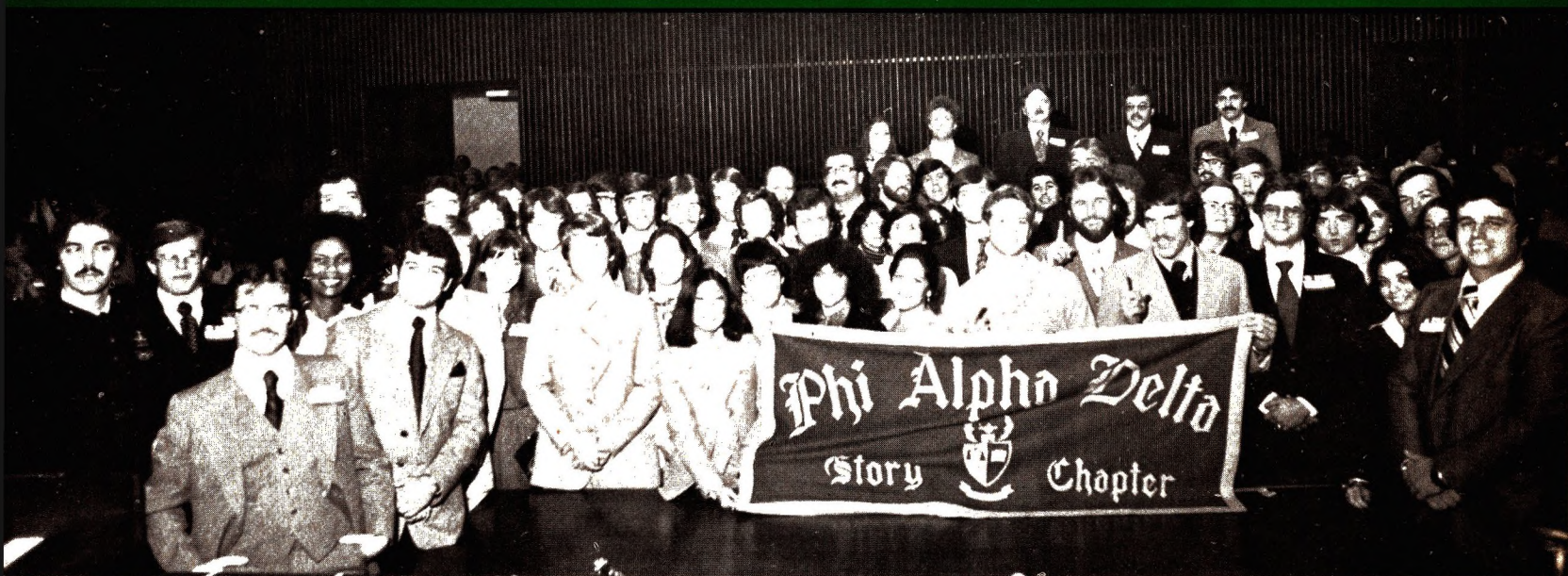

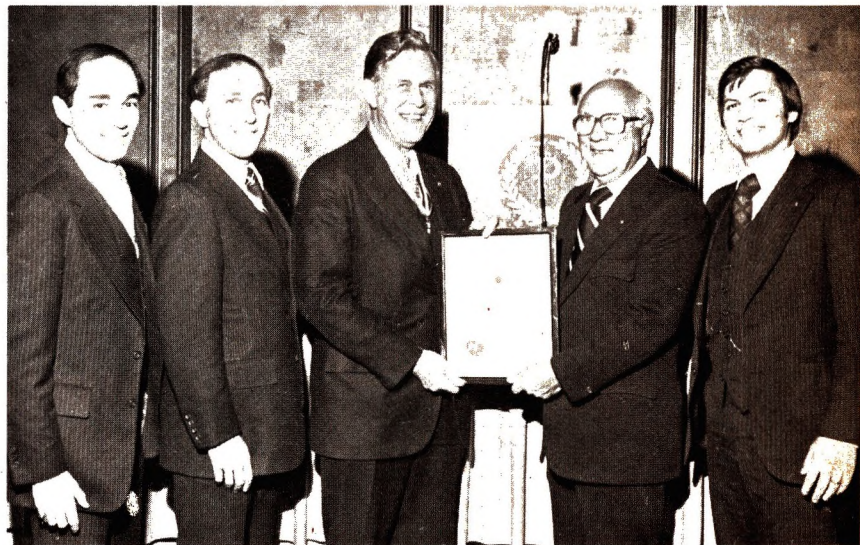

Story Chapter Numbers 189

From the Fall of 1976 to the Winter of 1978 Story Chapter has grown from approximately 40 members to 189. This growth has been unexpectedly rapid. However, the result cannot be attributed to mere good luck.

The current expansion of Story Chapter began in 1976 when a small group of first-year students became active in the Chapter. Since then this group has concentrated its efforts on the development of a complex program which would increase student contacts with practitioners, while providing a forum for students and their partners in law (usually spouses) to build enduring friendships. With these goals in mind efforts were made to increase communication with the Chicago Alumni Chapter and to expand services to the students at DePaul.

Through the Chicago Alumni Chapter, members of Story Chapter have been able to attend various monthly social functions at half price. On these occasions members have gained valuable information from judges and attorneys concerning the practice of law. In addition, the Chapter has sponsored several speaker programs after which students have been able to share cocktails with alumni. These events have improved the Chapter image and have provided an inducement to many to join P.A.D.

Also, Story Chapter has gained new members interested in the Alumni Advisor Program operated by the Chicago Alumni. In February Story Chapter will begin a pilot program with the Chicago Alumni entitled "Rent-A-Clerk." Through this program members will be able to obtain part-time employment for specific tasks while solo practitioners and small partnerships will receive legal assistants without unnecessary overhead.

The smooth communication which exists with the Alumni has been the result of a concerted effort to invite Alumni members to all Chapter functions and to attend many of the Alumni events. The fruits of these efforts have been an improved Chapter image and increased membership.

Story Chapter has also sponsored several programs geared toward increasing positive social interaction between members. This year each of the 400 first-year students received a personal invitation to a cocktail party one week before classes began. At this party several alumni members, including the Associate Dean of DePaul, the faculty advisor and a couple of officers of the Chicago Alumni Chapter, addressed those in attendance. Although only 15% of the class attended, 20% eventually joined the Chapter.

Also, Story Chapter has placed heavy emphasis on its sponsorship of four social events each year (i.e., Fall Party, Christmas Party, Spring Party, Summer Picnic). These events are for members and their guests only. Limiting attendance on these occasions has helped to maintain a group identity separate from the general student population.

Finally, Story Chapter sponsors a Big Brother/Big Sister Program, a comprehensive outline and exam file, and two educational seminars explaining how to study law and take law school examinations. An Annual Christmas Raffle provides income and entertainment for the Chapter.

Burton Reactivated

PAD's Harold H. Burton Chapter at Boston University School of Law was formally reactivated on the evening of November 3rd in ceremonies conducted in the law school's Moot Courtroom. A reception followed in BU's Bar-rister Hall.

Associate Tribune Fredric H. Pearson of Elizabeth, New Jersey, presided as the installing officer for the chapter's 21 "reactivation initiates," who included Ellen Suni, Dean of Student Affairs for BU Law School. Assisting Brother Pearson was an installation team from MacLean Chapter at New England School of Law, led by MacLean Justice David Buczowski.

Brother Carter Holly (Temple), who is currently a graduate tax student at the law school, also took part in the ritual, presenting the greetings of the alumni. Also on hand for the festivities were Boston area attorneys Brothers Martin Greenblatt (Wilson) and Robert Dickinson (Brewer).

The Burton reactivation effort began in September when Executive Secretary James L. McLean visited the school. The interested group of BU students, led by Dean Gordanier, Conrad Cendrowski, David R. Long, Carter Holly and Rachael Dorr, moved quickly to

Sen. Goldwater Initiated

Phi Alpha Delta's most celebrated new member is Barry Goldwater. The Senior Senator from Arizona was honorarily initiated into PAD on October 18th by our Philander Knox Chapter at the University of Arizona.

About 45 PADs, both student and alumni, were on hand at the Doubletree Inn in Tucson to witness the ceremonies. Those present included Brother Lewis C. Murphy (Knox), the Mayor of Tucson, and District XXI Justice Stan Jones.

After the swearing-in, Knox justice Richard Bellah presented Senator Goldwater with a membership plaque and an album of letters of greeting from more than a dozen prominent PADs, including several of his colleagues in the U.S. Senate. Brother Goldwater then addressed those assembled, expressing his deep appreciation of his PAD initiation. He has since stated, "I was highly honored by being made a member of this organization, and I will always retain that pride."

Sandy Rae Receives DSC

PAD's highest award, membership in the Distinguished Service Chapter of the Fraternity, was conferred upon Past International Justice Matthew S. "Sandy" Rae on October 12, 1978. The award was presented by International Justice Frank J. McCown on the occasion of the Los Angeles Alumni Chapter's annual Judges' Night.

Sandy was only the 10th person to receive the award out of the more than 87,000 initiated members of the Fraternity.

Brother Goldwater resides in Scottsdale, Arizona and is currently serving his fourth term in the U.S. Senate, where he serves on the *Armed Services Committee*, the *Commerce, Science and Transportation Committee*, and is the Vice Chairman of the *Select Committee on Intelligence*. He is a member of the Board of Regents of the Smithsonian Institute. The Senator was the Republican nominee for President in 1964 and has been a party leader of wide-ranging influence ever since.

Goldwater is a famous hobbyist, known for his aviation experience, his swimming, his extensive "ham" radio operations, his photographs of Arizona and its people, and his home full of gadgetry. He holds the rank of Major General (Ret.) in the Air Force Reserves and is the author of numerous books, including *The Conscience of a Conservative*, *Why Not Victory?*, *Where I Stand*, *The Conscience of a Majority*, *The Coming Breakpoint* and this year's *Arizona*.

The Senator is an active member of *Sigma Chi Fraternity* and is the recipient of its "Significant Sig" award.

Prior recipients were Supreme Court Justices Tom. C. Clark and Charles A. Whittaker, Frank E. Gray, Charles Tom Henderson, Robert E. Redding, Carl E. Dietze, J. Harry LaBrum, William B. Robertson and Fredrick J. Weitkamp. Membership in the chapter is conferred only upon unanimous vote of the International Executive Board.

Sandy was initiated in 1946 into the Rutledge Chapter at Duke University. He was not only a charter member of the chapter but also first Justice of the chapter. Since that time he has been involved in the installation of some 25 PAD chapters and had a hand in the reactivation of at least 10 others.

In 1946 he attended his first National Convention and he has not missed any conventions since that time. He became a District Justice in 1947 and in 1949 was the Fraternity's first National Field Representative.

He has served as Justice of the Los Angeles Alumni Chapter, National Placement Director and as chairman of a multitude of national Fraternity committees.

At the Convention held in Kansas City in 1966 he was elected to the Board to the position of Supreme Treasurer. Subsequently he progressed through the offices on the International Executive Board and became International Justice at the 1972 San Diego Convention.

One would think that after serving the Fraternity well for some 28 consecutive years he would have diplomatically retired upon completing his term as International Justice. However, such was not to be the case. From that time to the present, Sandy has attended every function sponsored by the chapters in District III to which he has been invited including the range from initiations and conclaves to social events and meetings.

In addition to his outstanding work for the Fraternity, he finds time to practice law as a partner in the Los Angeles law firm of Darling, Hall, Rae & Gute, serve as Chairman of the Probate and Trust Law Committee of the State Bar of California and to be extremely active in politics. He is a past president of Town Hall of California, a former president of Legion Lex and a former Commander of the Allied Post of the American Legion.

He is listed in *Who's Who in World Finance and Industry*, *Who's Who in the West*, *Who's Who in American Politics*, *International Who's Who in Community Service*, *Men of Achievement*, and *Who's Who in California*.

New D.J. Appointments Announced

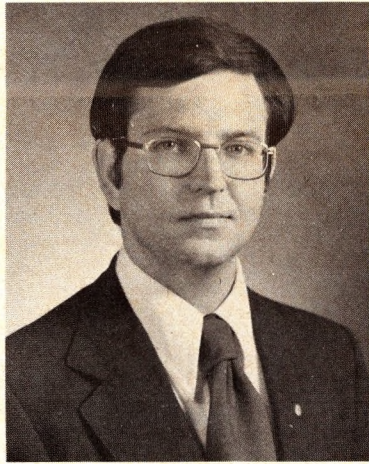
(The International Executive Board has announced a number of new district justice appointments. Space will not allow articles on all of them in this issue. Others will appear in the next issue.)

Stan Jones is the newly appointed District Justice for District XXI which encompasses Arizona and some of the states of Mexico.

Brother Jones was born in 1921 in Omaha, Nebraska and obtained his LL.B. in 1965 from Syracuse University.

He was the Justice of Carmody Chapter at Syracuse University. He worked in the office of the Maricopa County Attorney from 1969 to 1976.

Since that time he has been engaged in private practice in Paradise Valley, Arizona. He attended the 1972 International Convention in San Diego and is the Justice of the Valley of the Sun Alumni Chapter.



George W. Cox

George W. Cox, of Columbia, South Carolina, has been appointed by the International Executive Board to the position of District XIX Justice. He succeeds Jerry Finkel, also of Columbia, South Carolina.

Brother Cox is engaged in private practice and was named in the 1978 edition of the Outstanding Young Men of America.

He was born in 1945, obtaining his Bachelor of Arts degree from Old Dominion University and his J.D. from the University of South Carolina School of Law.

He has served as Regional President of Pi Kappa Alpha Fraternity from 1976 to 1978 and as Treasurer of the Palmetto Alumni Chapter. He has also served as Grand Knight of the Knights of Columbus.

District XIX encompasses the states of South Carolina and Georgia.

Kendall J. Phillips, a member of Fleming Chapter from Nova Uni-

versity School of Law, has been appointed Justice of District XX. He succeeds Dennis Farrington of Terrell Chapter.

Brother Phillips was the charter Justice of Fleming Chapter in 1975 and was named the Outstanding Alumnus of the chapter for the year 1977-78.

He obtained his Bachelor of Arts degree from the University of Miami in 1972 and his J.D. from Nova University in 1977. He is a former Assistant Regional Director of the American Arbitration Association.

He is an Assistant Public Defender in the Office of the Public Defender, a member of the American Judicature Society, the Florida Public Defender Association, the Broward County Trial Lawyers Association and a member of the Board of Directors Nova University Law Alumni Association.

John F. Weitkamp, a member of Ford Chapter at Loyola University School of Law, Los Angeles, California, has been appointed District III Justice to succeed Joseph Deems who was elected Chief Tribune at the 1978 Convention.

Brother Weitkamp served as Justice of Ford Chapter for the year 1977-78, the year in which the chapter was selected as the Most Outstanding PAD Chapter.

The new District Justice is a graduate of Claremont Mens College and obtained his J.D. from Loyola University in 1978.

He is engaged in the private practice of law with his father, Fredrick J. Weitkamp, who is also the Executive Director of the Fraternity.

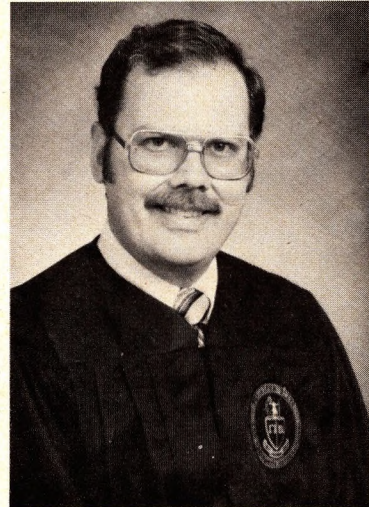

PADs In the News

ARTHUR J. GOLDBERG, former Associate Justice of the Supreme Court, was recently presented the Presidential Medal of Freedom by President Jimmy Carter. He has been serving as an Ambassador at Large to the Belgrade Conference.

DR. EUGENE TUBBS, a former Florida Legislator, and his wife Carole, were killed recently when their single engine plane crashed near Lake City, Florida. As **BRUCE A. MINNICK**, a close PAD brother said, his was a short but unique life. He was an energetic man, a friend of astronauts, a lawyer, an inventor and a physician. He was the flight surgeon for the Gemini astronauts during the mid-sixties. He and four others at the University of Florida later invented the drink Gatorade. He represented Brevard and part of Orange Counties in the Florida House of Representatives between 1970 and 1974. He then entered law school at Florida State University where he became a member of Terrell Chapter. While studying law, he fulfilled shifts as Emergency Room physician at Tallahassee Memorial Hospital.

United States District Judge **EDWIN A. ROBSON** and **PHIL BRENNAN** were honored recently by Story Chapter for 50 years of service. Judge Robson presided over the joint initiation of Story, Dooley, Lincoln, Blackstone and Hoynes Chapters in Chicago on October 13, 1978.

Sheriff **RICHARD ELROD**, Fuller Chapter, Northwestern Univer-

sity, was honored on October 13, 1978 for service to all chapters in the Chicago area.

CHARLES THORN of Reese Chapter, University of Nebraska, was recently elected to the United States Senate as was **DAVID PRYOR**, Garland Chapter at the University of Arkansas.

ALBERT J. BISSMEYER, III, a member of Wormser Chapter at Fordham University, has been appointed Vice President — brand and promotion for Philip Morris USA.

Appellate Judge **DOM J. RIZZI** was initiated by Story Chapter on October 13, 1978.

The Honorable **WILBUR F. PELL, JR.**, Judge of the Seventh U.S. Circuit Court of Appeals, was initiated as an honorary member by Story Chapter on November 21. Participating in the initiation was Past Supreme Justice **ANTHONY DIGRAZIA**, District IX Justice **BEN HYINK**, Chicago Alumni Chapter Justice **JERRY GARDBERG**, and Chicago Alumni Chapter Vice Justice **JOHN PETER CURIELLI**. The event took place at the annual Chicago Alumni Chapter Judges Night. Twenty judges from the U.S. Circuit Court of Appeals, U.S. District Court, Illinois Appellate Court and the Illinois Circuit Court attended the function.

Professor **M. CHERIF BASSIOUNI** of DePaul University has received the Outstanding PAD Alumnus Award for 1978 as presented by Story Chapter. Professor Bassiouni has served Story Chapter as its Faculty Advisor for the past 15 years. Among his many accomplishments, Professor Bassiouni has authored nearly a dozen books and numerous articles. He is an expert in international and criminal law and co-authored the Peace Plan used as the basis for the recent Europe-Israeli peace talks.

A bill has been introduced in Congress to rename the Federal Building in Yakima, Washington for Brother **WILLIAM O. DOUGLAS**, retired Associate Justice of the United States Supreme Court.

Brother **GEORGE MARION ASHFORD**, a member of Benson Chapter at Washburn University,

died recently. He was a retired Court of Common Pleas Judge in the State of Kansas and had presided over 3,000 civil and criminal trials. After retiring in 1965 he directed the Wichita Lawyer Referral Service until 1972.

The Philadelphia Trial Lawyers Association has elected **M. MARK MENDEL**, a member of Roberts Chapter at Temple University, as its President for the 1978-79 year. He presently is Special Counsel to the City of Philadelphia in Public Utility matters and serves the commonwealth as Solicitor for the Pennsylvania Transportation Assistance Authority in addition to a private civil trial practice.

J. STEVEN CLARK, PAD's International Advocate, has been elected Attorney General of the State of Arkansas. He will be sworn into office January of 1979.

JEROME A. KEITH, a member of Coke Chapter at Toledo University, was recently awarded the Diploma of the Hague Academy of International Law at the Peace Palace, The Hague, The Netherlands. While at the Hague, Brother Keith extended greeting to the President of the International Court of Justice, E. Jimenez de Arechaga, also a member of PAD. On October 12, 1978, some 250 PADs attended the Los Angeles Alumni Chapter Judges Night. Presiding was Justice **HERBERT BLANCK**. The featured speaker was renowned legal scholar and PAD **BERNIE WITKIN**.

JUDGE HARRY G. COMERFORD, a member of Story Chapter at the DePaul University, was recently elected Chief Judge of the Cook County Illinois Circuit Court by his fellow judges. As Chief Judge, he will administer what has been called the largest single Court system in the world. Through his control over the Court's multimillion dollar budget, his power to assign judges within the system and his authority to direct the public defender and probation departments, the chief judge is not only a major force in law enforcement, but wields considerable political power as well. Judge Comerford is a past Justice of the Chicago Alumni Chapter.

On September 19, 1978, twenty PAD alumni from eight chapters and five law school members of the Carlos C. Alden Chapter gathered for an informal luncheon in the Executive Dining Room of the Manufacturers and Traders Trust Company in downtown Buffalo, New York, to reactivate the Buffalo Alumni Chapter. Numerous other Western New York alumni indicated their willingness to participate in the reactivated chapter, but were unable to attend the kick-off luncheon due to schedule conflicts.

Judice Receives American Judges Award

Past Supreme Justice C. Raymond Judice has won the 1978 top award of the American Judges Association for Outstanding Contributions to the Administration of Justice in the United States.

Judice is the Administrative Director of the Courts, Office of Court Administration for the Texas Judicial System and Executive Director of the Texas Judicial Council.

The Glenn R. Winters Award, named for the 30 year head of the American Judicature Society, is presented annually by the Association to a person who has made significant contributions to the administration of justice.

Past Supreme Justice Judice was cited for "tireless efforts and contributions toward improving the judicial image." Other recent winners of this award include Judge John Sirica of the Washington, D.C. Federal District Court, Miss Alice O'Donnel of the Federal Judicial Center, and Judge Winslow Christian of the California Court of Appeals.

Judice has also received other honors from the association in the past such as the Outstanding Judicial Service Award for Constitutional Development in 1975; Amicus Curiae Award, 1968; and the Gavel Award for Judicial Leadership in 1966.
