Professionally Speaking

(Most complaints against lawyers by clients are grievances which could often be avoided if lawyers would understand some of the more common client complaints, how they arise, and some of the things which could be done to prevent dissatisfied clients; thus avoiding the grievance. This article is one of a series of articles dealing with the most common causes of client complaints and the more often used remedies.)

COMMINGLING MONEY

Regardless of your good intentions, and notwithstanding the fact that the money is safe in your bank, if a client's money or other property is commingled with that of the lawyer there is a clear violation of the Code of Professional Responsibility, which provides that

All funds of clients paid to a lawyer or law firm other than advances for costs and expenses, shall be deposited in one or more identifiable bank accounts . . . and no funds belonging to the lawyer or law firm shall be deposited therein except as follows: (1) Funds reasonably sufficient to pay bank charges may be deposited there . . . (2) Funds belonging in part to a client and in part presently or potentially to the lawyer or law firm must be deposited therein, but the portion belonging to the lawyer or law firm may be withdrawn when

Most of the complaints involving the manner in which lawyers handle the money of their clients are caused by poor or shoddy bookkeeping practices and improper office management procedures instead of an outright misuse or misappropriation of the client's funds. Usually the lawyer knows that the money or property is properly preserved. Most often it is right in his bank account, but due to clear procedural mismanagement and improper office practice, the lawyer is unable to demonstrate this fact or to make a prompt dispersal of the funds or a prompt disposition of the property.

You should commence using bookkeeping and office management procedures designed to protect and insure accountability for all funds and property of every client. Most attorneys would need three separate bank accounts: a personal account, the general office account, and an account for client's funds, probably referred to as an escrow or trust account. Because your trust or escrow account will contain only client's money commingled with other client's money; you should also set up a ledger system which provides sufficient space in which you can record each transaction as it affects the funds of a particular client. Thus, if your trust account has \$5,000 in it, a thousand dollars each belonging to five different clients, your ledger record would show a credit to each of those clients, by name, of a thousand dollars. When disbursement is made of any sum to any client, the amount is debited to that client. At every instant each client's funds are clearly distinguishable, readily available for disposition, and are not commingled with your money.

Personal property held for a client should be clearly marked by name and safely and securely stored. If you handle stocks and bonds for clients, you should always seal them in a separate envelope with client's name written thereon. The envelope should be stored in a safe and secure place normally used by you to secure

valuables belonging to others. Some lawyers have office safes. I prefer safety deposit boxes at my bank. Most people believe lawyers to be very wealthy, and your office safe may well fall victim to an unscheduled visit by an intruder.

Real property held for others may be held in your name, but your possessory interest should clearly appear on every document as "trustee," "agent," or whatever.

YOU CAN'T REPRESENT BOTH SIDES

Don't undertake the representation of a client when it may appear to you at the outset that the acceptance of employment may involve potential conflicts of interest. Don't fail to disclose to your client that you may face a potential conflict. Many lawyers fail to make such a determination at the outset, and they fail to advise their clients. Then they face a complaint and often a grievance. Very often the grievance results when the lawyer finds it necessary to withdraw when the initial apparent conflict becomes a reality. Sometimes the lawyer attempts to continue to perform incompatible roles to the point where his representation and, finally, his withdrawal cause embarrassment to lawyer and client; and the grievance may surely fol-

Whenever the exercise of your judgment on behalf of a client is likely to be affected by your representation of another client, decline the employment. And if your judgment on behalf of a client may be affected by your own business, financial, personal or property interests, decline the employment.

Notwithstanding the Rules of Discipline, that provide that

a lawyer may represent multiple clients if it is obvious that he can adequately represent the interest of each and if each consents to the representation after full disclosure of the possible effect of such representation on the exercise of his independent professional judgment on behalf of each,

you should exercise extreme care when making such a disclosure to your client and when determining to continue with the multiple representation. The best general rule is to avoid all such situations. Even though the parties, both your clients, may want to keep costs and fees down by using one lawyer, once a conflict arises those same parties may blame you, each of them having felt that the lawyer was his lawyer exclusively.

There are some unique situations in which lawyers should be particularly careful. Suppose you're a partner in the development of a subdivision. Can you thereafter represent a purchaser of a homesite in the purchase and closing of the transaction? This question is much more difficult to answer than one which would concern a regular client coming to you with a request that you sue the maker of a promissory note who is in default, the maker also being a regular client. In this case it is clear that you represent neither.

1978 International Convention To be Hosted by Cleveland

The 42nd Biennial Convention of the Fraternity will convene August 1, 1978, at the Bond Court Hotel in Cleveland, Ohio. In attendance will be delegates and members from 229 chartered law school and alumni chapters throughout the United States, Puerto Rico, and Canada.

The Bond Court Hotel is a luxury 22-story, \$18 million dollar hotel, containing 526 rooms, it combines old-fashioned European style and service with modern facilities, such as computerized guest registration and guest check-out. It is a comparatively new hotel, having opened its doors to the public in 1975.

PAD Conventions have traditionally been exciting, memorable, and large-scale events, and this year's promises to be no exception.

The Convention will offer those attending an unusual opportunity to work and relax with law students, attorneys, and judges from many differ3nt backgrounds, to experience full-scale parliamentary proceedings, and to make a personal contribution to the current programs and future development of our law Fraternity. Further, the long-range benefits to our law school chapters are many, as Convention delegates — having experienced the eye-opening scope of our International brotherhood firsthand — return to their schools with the exhilaration of fresh ideas and new vision of PAD programming at the local level.

MONETARY ALLOWANCES

The International Chapter provides the actual cost of one round trip airline fare to Cleveland, hotel accommodations, and a subsistence allowance for each day of travel to and from the Convention and each day while at the Convention for one delegate from each law school and alumni chapter in good standing.

Each law school and alumni chapter is entitled to have two delegates and two alternates at the Convention and as many additional persons as desired.

All chapters are urged, however, to send as many members as possible. Many chapters divide the allowance between two or more delegates, so as to be able to send several representatives. Carpools in the past have been formed and buses chartered.

In order for a law school chapter to be in good standing and to qualify for the monetary allowance, all fees and forms must have been filed prior to the Convention. Each chapter will receive notification as to any existing deficiency.


In order for an alumni chapter to be in good standing, it must have met the following requirements:

- 1. The annual alumni chapter tax of \$15.00 per year must be paid for the two fiscal years commencing July 1, 1976 and ending June 30, 1978.
- 2. Each alumni chapter must hold at least two meetings during the period from July 1, 1976 through June 30, 1978, with an attendance of at least ten persons at each meeting.
- 3. Each alumni chapter must have elected officers and report the same to the Executive Office.

CONVENTION EVENTS

The Convention, which will be held August 1-4, 1978, promises a full schedule of events and activities, including the following:

— Various committees composed of student delegates to provide input and assistance in drafting recommendations which will ultimately reach the Convention floor for the vote of the entire Convention.



— A major keynote address by a nationally known "prominent PAD."

— A series of chapter workshops conducted by PAD International Officers offering suggestions for improvement and strengthening of chapters in several areas.

 A demonstration of courtroom tactics by a noted trial attorney.

— The premier showing of videotapes from the Hastings College of Trial Advocacy, an introduction to a new pilot program of videotape showings across the country cosponsored by PAD and the Hastings College of Law.

News From the Active Chapters

Corliss Chapter at the University of North Dakota recently initiated Associate Justice Paul Sand of the North Dakota Supreme Court as an honorary member. On the same occasion, five faculty members and 32 students also became members of PAD. In attendance was District Justice Ed Kelly, who flew up from Fairfield, Iowa in his private plane to take part in the ceremonies.

Hayes Chapter at Capital University has completed a successful fall program which resulted in doubling its membership. Programming has included "How to Take An Exam" seminar, dinner theater engagement with alumni, a placement service program, a clerkship training program, and the maintenance of an outlying file for members.

The District I Conclave was hosted by Kent Chapter at the University of Idaho School of Law on October 1, 1977. (It was erroneously reported in the October 1, 1977 issue of the Reporter as being held in Spokane, Washington.)

Fletcher Chapter at the University of Florida Holland Law Center recently spent a memorable day in Tallahassee learning about the state's highest court. The program was one of its professional development projects for the winter quarter and provided an opportunity for those participating to tour the Supreme Court Building, visit with the Justices over coffee, and observe oral arguments of various cases on final appeal. Later the chapter held a judiciary seminar bringing four local judges into the law school for a question and answer session with students and alumni. Other programs have included a trip to a state maximum security prison, a placement resume/photo service, and assistance with a local program designed to help former inmates readjust to the outside world.

District II held what was described as a fun, working and enjoyable Conclave on November 5, 1977. The Conclave was under the leadership of District Justice Roger A. Cartozian. Six of the seven law school chapters in the District were represented with the seventh, that of Engle Chapter at the McGeorge School of Law, unable to attend due to final examinations. Host chapter was Matt Sullivan Chapter at the University of San Francisco. Representing the International Executive Board was International Proctor Norman M. Owen. All in attendance agreed that the Conclave more than adequately fulfilled the purpose for which it is intended . . . a gathering of a group united in the spirit of professional fraternalism to provide service to the student, the law school and the profession.


