AN OPEN LETTER TO PAD MEMBERS

I would have preferred to deliver this message to you — the law student and alumni members of Phi Alpha Delta — in person so that we could have shared our thoughts. But there are so many of you that this letter becomes the only way I can hope to communicate with each of you.

As a lawyer and educator, I have been involved in law-related education (LRE) for more than 25 years. Law-related education, as was so well explained in the July 1979 issue of The Reporter is a program designed to bring the law into the on-going curricula of the elementary and secondary schools of America. If one were to categorize the more than 300 local, state, and national projects, he would find that they tend to fall into at least three groups. The practical or street law approach focuses on criminal law, juvenile justice, consumer law, environmental law, and landlord and tenant law. Conceptual law centers on such ideas as liberty (First Amendment Freedoms), privacy, justice (due process of law), authority, equality, responsibility, and propery. Participatory law aims to involve students in court visits, simulations, mock trials, police ride-alongs.
If your home or law school com-

munity has a law-related education project already under way, there are many opportunities for you to bring your expertise to the assistance of the educator. You can help to plan and to participate in mock trials. You could even play the part of the judge. If you are a judge, so much the better. You can visit classes and assist teachers and students in thinking through clearly tantalizing cases in civil and criminal law. ou can help build support for LRE. You can take the lead in setting up a "Hot Line" which reachers can use in calling you and your colleagues for assistance. You can even try to persuade your bar association to assist in the funding of a local workshop to educate teachers.

Of course, if your community does not have a law-related education program, you have the unparalleled opportunity to become a pioneer by motivating your local bar, local educators, and other community organizations to form a partnership in establishing a program in the local elementary and secondary schools.

Bob Redding and Jim Borchers of your organization stand ready to assist you in every way, as do I and the American Bar Association Special Committee on Youth Education for Citizenship.

It is easy to criticize the weaknesses of our educational system; it requires some personal sacrifice in time, effort, and even in money to contribute to the improvement of our school programs. Each of you

DSC Awarded To John J. McAulay

Brother John James McAulay received PAD's highest honor on December 5, 1980 when he was inducted by International Justice Steve Clark into the Distinguished Service Chapter of the Fraternity. Of the more than 94,000 members of PAD, McAulay is only the 12th to be so honored.

PAD Juvenile Justice Program Receives High Marks

A little over a year and a half ago PAD was awarded a grant from the Law Enforcement Assistance Administration of the United States Justice Department in an amount of almost one-half million dollars.

As one of several grantees (including the American Bar Association) PAD was given a goal of helping our youth understand and respect and conduct themselves within our system of justice thereby reducing juvenile delinquency across the country. PAD was the only law fraternity to receive such a grant.

A Juvenile Justice office was established in Washington, D.C. under the directorship of Past Supreme Justice Robert E. Redding and Assistant Project Director, former Executive Secretary James A. Borchers.

Recently a government sponsored evaluation team was assigned the task of reviewing the program which has been developed and implemented by the Fraternity. That report is now in and the PAD program has received high marks for its program. The report indicates that PAD's record to date shows that it has been able to address with confidence the program's goals. Some of the specific findings are as follows:

1. The Fraternity has mobilized its members as well as other members of the legal profession into law related education service.

2. The Fraternity has helped improve the teaching of law related education in the classrooms of our public, private and parochial schools by enlarging the available pool of resource persons.

3. The Fraternity has assisted in a supportive capacity to establish and maintain additional law related education programs in the United States.

The initial grant period will be concluded early in 1981 and an application for an extension of the project has been filed. It is anticipated that word on action on the application will be received by the February issue of *The Reporter*.

Membership in the Distinguished Service Chapter is attained only by unanimous election of the International Executive Board and is conferred for outstanding contributions to the Fraternity.

Dean McAulay became a member somewhat later in life than most persons when he was initiated at age 53 as a charter member of O'Niell Chapter on December 4, 1965. Since that date he has been one of PAD's most enthusiastic and avid members. He has served as Justice of the New Orleans Alumni Chapter, was District Justice for five years, was General Convention Chairman for the 1970 International Convention, has served on numerous PAD committees, and has been Chairman of the Nominations Committee at the 1976, 1978 and 1980 International Conventions.

He is also quite active in the Association of American Law Schools.

The induction took place at a banquet of New Orleans Alumni Chapter honoring members of the International Executive Board who were holding their Winter Meeting in New Orleans. Chairperson for the event was Miriam Abbott.

Atlanta Alumni Reactivated

On December 5, 1980, the Atlanta Alumni Chapter held formal ceremonies which effected its reactivation.

Speaker for the day was the Hon. George T. Smith, Associate Justice-Elect of the Georgia Supreme Court. Justice-elect Smith spoke on 'The Role of the Judiciary in the 1980s,' looking at the Georgia Judiciary and the changes to be expected in the years ahead.

Justice-elect Smith is the only person in the history of Georgia to have won contested elections in all three branches of state government. He has served eight years in the Georgia House of Representatives, has served as Lt. Governor of the State and has served on the Georgia Court of Appeals.

Brother Smith is a member of Staples Chapter at Washington & Lee University.




