First PAD Pre-Law Chapter Installed at SMSU

On Friday, April 24, 1981, at 7 p.m., the first Pre-Law Chapter of Phi Alpha Delta Law Fraternity, International was installed at Southwest Missouri State University. The installation of this chapter is the culmination of work begun in 1976 by our International Executive Board and two years of intensive investigation and research prior to PAD's entrance into the Pre-Law field.

Development of the PAD Pre-Law program was ratified by our International Chapter at the 1980 Biennial Convention held in Hot Springs, Arkansas. By Convention action, a new class of PAD membership was created for undergraduate students contemplating the law as a career. The purpose of the Pre-Law program is to utilize PAD law school and alumni members as speakers and panelists, together with printed materials, to provide our Pre-Law members with a better understanding of law school and the legal profession than is currently available. The goal of the PAD program is to provide our Pre-Law members with sufficient information in these areas so that they may properly evaluate the legal profession in light of their individual career goals and thereby make an informed decision as to whether or not to pursue law as a profession.

Southwest Missouri State University was the first undergraduate school to submit a petition for a Phi Alpha Delta Law Fraternity, International Pre-Law Chapter Charter. The petition was reviewed and

subsequently approved by our International Executive Board. The installation of the Pre-Law Chapter was held on April 24, 1981, and representing Phi Alpha Delta Law Fraternity on this occasion were: International Justice Steve Clark, Attorney General of Arkansas; Past Supreme Justice Don Hutson, chairman of the interim PAD Pre-Law committee; International Secretary Jack Miller, an SMSU adjunct faculty member and organizer of the Pre-Law Chapter; District Justice Scott Spiller; two PAD state court trial judges; and several PAD attorneys from the area. Jack Miller served as Master of Ceremonies and introduced Steve Clark who installed the Southwest Missouri State University Pre-Law Chapter of Phi Alpha Delta Law Fraternity, International, and inducted thirty-nine undergraduate students into Pre-Law membership. Southwest Missouri State University was represented on the occasion of the installation by: Professor Holt V. Spicer, Dean of the School of Arts

PAD Receives New Federal Grant For Juvenile Justice

The office of Juvenile Justice and Delinquency of the Law Enforcement Assistance Administration has announced a supplemental grant award to PAD for its national program to improve Juvenile Justice and reduce juvenile delinquency.

The Fraternity's Juvenile Justice Office located in Washington, D.C. has spent a busy year organizing, planning and administering the first phase of its Juvenile Justice and Delinquency Prevention Grant to develop and implement a National Law-Related Education Program. Under the direction of Past International Justice Robert E. Redding, the program staff has worked to use the Fraternity's resources to foster and assist local Law Related Education programs throughout the country.

From the Washington office, the project has:

- organized a Juvenile Justice and Delinquency Prevention Advisory Council composed of education leaders and law professionals,
- published and circulated a "Prospectus for Juvenile Justice and Delinquency Prevention Through Law-Related Education" to all PAD chapter and Fraternity leaders,
- coordinated program activities with five other OJJDP grantees, and
- launched local demonstration and experimental projects in 16 metropolitan sites.

Other first-phase efforts included:

- circulation of press releases to all law school newspapers and legal publications in the country;
- making progress reports directly to the PAD membership directly through the Fraternity's newspaper, *The Reporter*;
- conducting briefing sessions at Fraternity District Leadership Conferences;
- issuing catalogues of possible law-related education activities for law school and alumni chapters; and
- making extensive contacts with law students and alumni members and leaders of almost 70 law school chapters.

The Juvenile Justice Office now has four resource manuals in production: two provide information and materials to assist legal professionals in making classroom presentations, another is a guide to generate community support for

Willamette Chapter Reactivated

Phi Alpha Delta has returned to Willamette University College of Law in Salem, Oregon. Willamette, the second oldest law school in the West, witnessed the reactivation of PAD on March 15, 1981 at an initiation ceremony held in the courtroom of the Oregon Supreme Court. Established in 1927 as the Upsilon Chapter of Phi Delta Delta, Willamette acquired a PAD chapter with the merger of PAD and Phi Delta Delta. The initiation team, composed of International Justice Steve Clark, District Justice Ernie Greco, Oregon Supreme Court Justice Ed Peterson, Llewellyn Chapter Justice Steve Todd, and chapter advisor Professor David Freeman, conducted the ceremony that saw fourteen of the nineteen new members initiated. Vice Justice Steven Taylor of the Llewellyn Chapter assisted in the capacity of Marshal for the ceremony.

local law-related education activities, and the final volume is designed to assist law school chapters which want to initiate such programs. All are slated for publication shortly.

Federal Evaluation

The Fraternity's first year efforts received high marks from government evaluators recently. Citing positive accomplishment in its programming, the evaluators commended the Juvenile Justice Office for

- mobilizing Fraternity members and other legal professionals to support law-related education programs,
- helping improve law-related education teaching in public, private and parochial schools by enlarging the available pool of resource persons, and
- helping establish and maintain additional law-related education activities throughout the United States.

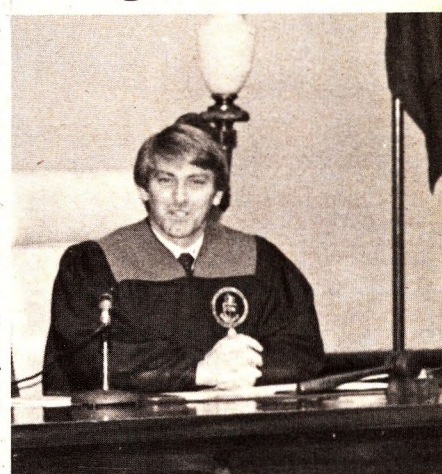

The 1980-81 School year has concluded. It has been a successful year for PAD. The excitement of the 1980 Convention carried through with increased initiations, installation of new chapters and increased activities and services for our alumni. The continuing direction of PAD is professional service and commitment. A new lend-lease program of CLE tapes has been made available to alumni; an additional Executive Secretary has been employed to serve the law school chapters; and, increased commitment by chapters to the PAD Juvenile Justice efforts. Moreover, International expansion has been hiked because of increased interest demonstrated both in Mexico and Canada.

The 1981-82 school year presents even greater challenges. Federal funding of our Juvenile Justice Program is being restricted. The PAD Pre-Law Program has been ushered in making us once again, first among legal fraternities in service to those who believe they desire the law as a career.

We hail our Fraternity as the foremost professional legal Fraternity in the world. To be worthy of that epitaph, PAD must be innovative and energetic. Improved service to law school chapters, alumni, and our profession, is the challenge you each individually face. Remember, the total worth of any organization is only the worth of each of its individuals. We gather in convention in St. Louis in 1982. Meet me there bringing a message of work, creativity and success. Meet me there with evidence of accomplishment and achievement so PAD will continue in the 80's as the FOREMOST PROFESSIONAL LEGAL FRATERNITY.

The Pre-Law charter officers were also installed at the meeting and they are: Eric Hutson, President; Alisa Morgenthaler, Vice President; Dennis Trask, Secretary; Doug Boatright, Treasurer; Dr. Alice Fleetwood Bartee, Chapter Advisor; and International Secretary, Jack Miller, PAD liaison. At the conclusion of the installation ceremonies, those present adjourned to Hooten's Restaurant in Springfield, Missouri for a multi-course dinner and socializing.

Our first Pre-Law Chapter is well organized, has planned its Fall activities, and has appointed committee chairpersons: Steve Guthrie, membership; publicity Sherry Vernon; Mike McAtee and Aaron Sachs, professional and social programming; and Mike Miller, finance.

The installation of our first Pre-Law Chapter provides PAD with an additional dimension. Phi Alpha Delta Law Fraternity, International, was created to meet the particular needs of a group of law students in 1902. As the years passed, the needs of law students changed and grew and Phi Alpha Delta was there to meet those needs and challenge. As our members graduated from law schools, their needs as alumni became a part of PAD and our fraternity strove to meet those needs as well as those of our student members. In 1978, PAD instituted a Juvenile Justice program under a Federal Grant to assist teachers in conveying a basic understanding of our legal system to students in the primary and secondary school grades. Now, with the establishment of our Pre-Law Program, Phi Alpha Delta will virtually be providing services of a law related nature to individuals "from the cradle to the grave."

A large number of other undergraduate schools are currently being examined to determine the possibility and feasibility of

Second Phase Efforts

Second phase programming is expected to continue and expand the Office's school adoption and linkage arrangements, its solicitation of bar association and community support, its fund-raising efforts, and its recruiting and training of classroom resource persons.

During the first phase of the program, the Office conducted activities in sixteen cities. An additional forty potential sites have been evaluated and will be used for various activities if sufficient funding is available.

These projected activities include:

- bringing teams of local lawyers and educators together in conferences,
- developing state-level programs through coordination with state bar associations,
- staging implementation conferences emphasizing linkage and community resources,
- convening regional implementation conferences,
- generating intra-Fraternity activities, and
- developing an on-going publications and public information program.

The Juvenile Justice Office's second-phase continuation grant is now pending with the Office of Juvenile Justice and Delinquency Prevention. The expected funds will allow the program to work through next November to implement the Office's second-phase plans.

PAD Announces Free Cassette Lending Library

The Fraternity has acquired a library of CLE cassette tapes dealing with various areas of practice. The tapes are produced by the American Bar Association — American Law Institute and are extremely valuable to the practitioner who does not have the ready availability of a law library.

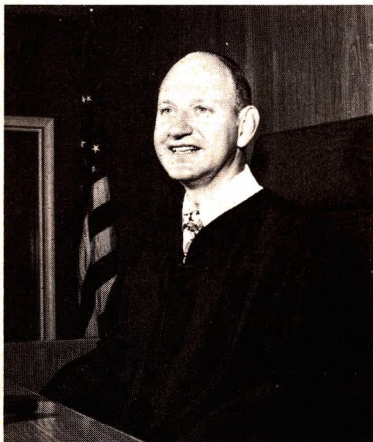

Lawrence S. Margolis, U.S. Magistrate for the District of Columbia (Washington, D.C.), was recently installed as chairman of the Judicial Administration Division, an affiliate of the American Bar Association. Flanked by a two-tiered head table seating the chief judges of the 50 states, Margolis took over as head of the organization following a keynote address by then PAD U.S. Attorney General **Benjamin Civiletti**.

The Judicial Administration Division of the American Bar Association is the largest judges organization in the United States. Other Division Chairmen have included PAD U.S. Supreme Court Justice **Tom C. Clark** and former PAD Attorney General **Griffin Bell**. Margolis is a member of Jay Chapter at George Washington University.

Wade H. McCree, Jr., U.S. Solicitor General in the Carter Administration, is teaching classes at the University of Michigan Law School. McCree is a member of Cooley Chapter at Wayne State University.

Criminal Court Judge **Gerald L. Sbarboro**, Circuit Court of Cook County Illinois, has been elected the President-Elect of the American Justinian Society of Jurists. The Society is composed of over 1,200 judges from throughout the United States. Its purpose is to improve the administration of Justice and promote historical scholarship among the judiciary. He is a member of Cardozo Chapter at Catholic University of America.

Another member of Cardozo Chapter, **Francis John Lorson**, has been promoted to the office of Chief Deputy Clerk of the Supreme Court of the United States, the fourth person in history to hold that office.

Donald N. Ruby, Livingston Chapter, Columbia University, and a former Assistant United States Attorney for the Eastern District of New York and head of the litigation division of Wolf, Popper, Ross, Wolf and Jones in New York City, passed away on September 29, 1980.

Harold W. Youmans, former Clerk of Fletcher Chapter, University of Florida, graduated on the Commandant's List with honors from the U.S. Army Command and General Staff College, Ft. Leavenworth, Kansas. He is a major in the U.S. Army Reserve.

Laurence P. Simpson, Professor Emeritus, New York University School of Law, died in January, 1981. He was a professor at NYU for 35 years and then taught at Loyola University Law School in Los Angeles for 11 years. Among his published works were the Hornbook on contracts, Hornbook on Suretyship, Cases on Contracts, Cases on Suretyship, Law for Engineers and Architects, Law of Business and he co-authored Cases on Security Transactions and New York Contracts Law.

Virginia Supreme Court Justice **Lawrence W. I'Anson** retired recently from that states highest court. I'Anson, a member of Jefferson Chapter from the University of Virginia, is a past President of the National Center for State Courts and a past Chairman of the Conference of Chief Justices.

Former Kansas lawmaker **Blake A. Williamson**, died at the age of 79

recently. He was a former member of the Kansas Legislature, Speaker of the House, and Edwardsville City Attorney. He had practiced law since 1923.

Robert R. Marquardt, a member of Robinson Chapter at the University of Arkansas and presently Justice of the Buffalo Alumni Chapter, has been selected as the Outstanding Judge Advocate of the Year by the U.S. Air Force Major Air Command. He is Counsel to the Industrial Plastics Group of Hooker Chemical Company and past Justice of Robinson Chapter.

Robert M. Holschuh, formerly Chase Chapter Justice, has been appointed a Federal Judge for the Southern District of Ohio. A leadership role seems to follow naturally for him for he was President of the student body at Ironton, Ohio High School, graduated first in his law school class and was editor of the Cincinnati Law Review.

Carlos Romero Barcelo, an honorary member of PAD was recently re-elected Governor of Puerto Rico.

Civil Rights champion **Emanuel Celler**, former Representative from New York, passed away recently at his home in Brooklyn. Celler, a member of Livingston Chapter, Columbia University, was the Congressman chiefly responsible for the enactment of the first civil rights laws since Reconstruction.

Indianapolis Attorney **Evelyn Pitschke** has been honored as one of the 10 Distinguished Women of the Year by the Northwood Institute. Miss Pitschke, who has her own law practice, is a Phi Delta Delta who became a PAD upon the merger in 1972. She has served as legal advisor and public relations advisor for Stop ERA and anti-Equal Rights Amendment organization.

One of the drafters of the Uniform Child Custody Act, **Brigitte M. Bodenheimer**, died early this year. She was the chief draftsman of the Uniform Child Custody Jurisdiction Act, which deals with domestic child snatching and which has been adopted by 45 states. She was an emeritus professor of law at the University of California Law School at Davis.

New Hampshire PAD Chief Justice, **Frank R. Kenison**, died recently in his beloved home state. He was a former Attorney General for the State of New Hampshire and served for more than a quarter of a century as that state's Chief Justice. He was twice under consideration for appointment to the United States Supreme Court.

Three PADs, who have been members for 50 years or more, received the Senior PAD Award at the December 16, 1980 Annual Christmas Party of the Chicago Alumni Chapter. They were former Chief Judge of the Circuit of Cook County **John S. Boyle**, **Eugene E. Dornbough** and former Illinois Appellate Court Justice **John T. Dempsey**.

Richard C. Shelby, a member of Morgan Chapter at the University of Alabama, was re-elected to the Congress of the United States last November. Congressman Shelby is a member of the House Energy and Commerce Committee, the Veterans Affairs Committee and the Subcommittee on Housing, the Congressional Steel Caucus, and

Jeffrey S. Weiner of Blackstone Chapter, Chicago-Kent College of Law and a partner in the Miami, Florida law firm of Weiner, Robbins, Tunkey & Ross, has been elected Chairman of the Criminal Law Section of the Academy of Florida Trial Lawyers.

Orville O. Gold, a member of Benton Chapter at the University of Missouri in Kansas City and a longtime enthusiastic PAD supporter in Kansas City, Missouri, passed away recently.

Cornelius Roach, Jr., former President of Wadell & Reed, Inc., died recently. He began his career at Wadell & Reed as general counsel and later was chairman of the board. He was president of the firm from 1967 to 1971.

Los Angeles attorney **Edward L. Compton**, a member of Hughes Chapter, University of Denver, died last December. He was an active member of the Los Angeles Alumni Chapter.

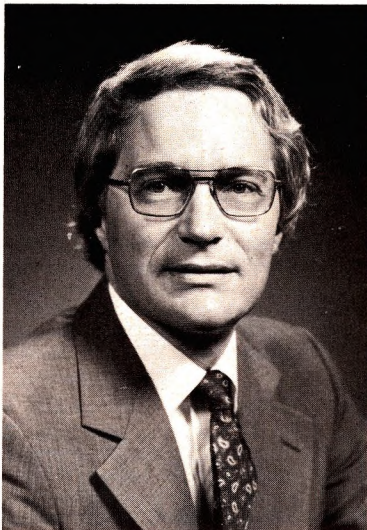
Vernal Riffe, Speaker of the Ohio House of Representatives, was initiated February 27 by McKinley Chapter as an honorary member of the Fraternity. He presently is serving his third term as Speaker and his eleventh consecutive two year term as a State Representative. As Speaker he is the presiding officer of the Ohio House of Representative and the leader of that Chamber's Majority Party.

Dean **Walter Ray Phillips**, former Chairman of the International Tribunal and former District Justice of the Fraternity, has authored a new book entitled "Liquidation Under Chapter 7 of the Bankruptcy Act."
