

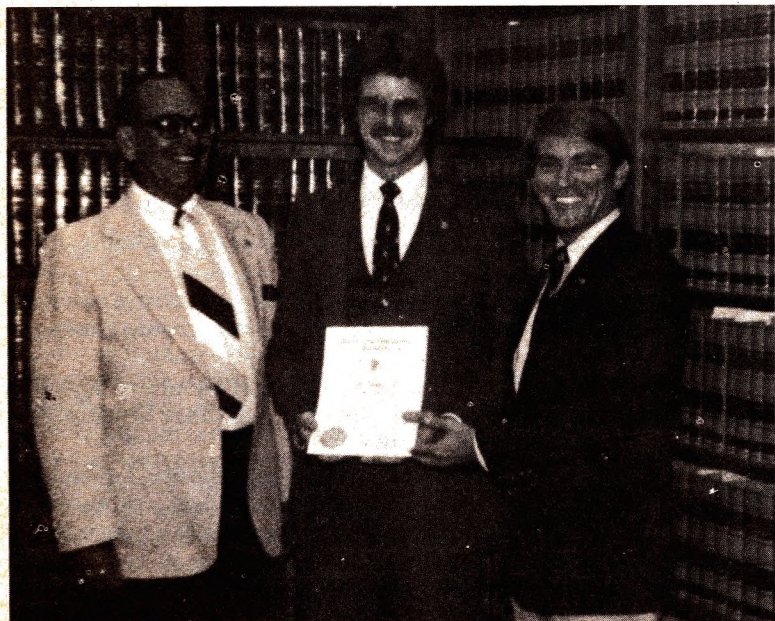
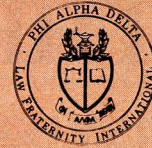

Winter Named Justice Of Year

The International Executive Board has selected Ronald J. Winter as the Recipient of the Alex A. Hotchkiss Award as the Outstanding Justice of 1981. Their decision was made at the PAD Summer Board Meeting in Lexington Kentucky in July.

Ron is a graduate of the Law School of the State University of New York at Buffalo where he was a member of the 1978 reactivation group. He served as Marshal of the Alden Chapter before being twice elected to the position of Justice. Under his leadership, Alden Chapter increased its membership from 17 to 78 and became the top chapter in District XIV.

Ron twice served as the First Delegate to the National Convention from Alden Chapter. He was a member of the Publications Committee at the 1978 convention in Cleveland, Ohio, and served on the Constitution & By-Laws Committee at the 1980 convention in Hot Springs, Arkansas. He also assumed the duties of Acting District Justice in Hot Springs in the absence of Joseph Tringali, who was called away on a personal matter. In addition, Ron has attended two District Leadership Conferences, one in Albany in 1980, and the other in Ithaca, New York in 1981, where he was a member of the installation team for the reactivation of Wilson Chapter.

"Much of the credit for this award," said Ron, "goes to District Justice Joe Tringali for his continued support and encouragement. And, of course, I was fortunate to have a great group of people to work with at Alden Chapter. They made my job that much easier to deal with."

Following graduation in May and the New York Bar Exam in July, Ron accepted a position with the National Office as Executive Secretary. In addition, he now serves as Director of the Pre-Law Chapter Program, a new project designed to assist pre-law students.

A native of North Tonawanda, New York, Ron still makes his home there, and served as Administrative Assistant and Secretary to the Mayor in 1979. He is active in local politics and served on several city committees while in law school. He also plays recreational league football, softball, volleyball and basketball in his spare time.

Juvenile Justice Program Reduces Delinquency

A national evaluation, in which the PAD Juvenile Justice Office was a participant, has determined that law-related education (LRE) can significantly reduce delinquency behavior. This affirms the belief that led the International Executive Board to establish the PAD Juvenile Justice and Delinquency Prevention Program in 1979. The PAD Juvenile Justice Office has recently undertaken several new types of activities which capitalize on the Fraternity's ability to marshal resources and organize various groups into common efforts. In all these contacts, the intent has been to make the existence of LRE efforts known and to suggest specific ways in which educational organizations and PAD can work cooperatively.

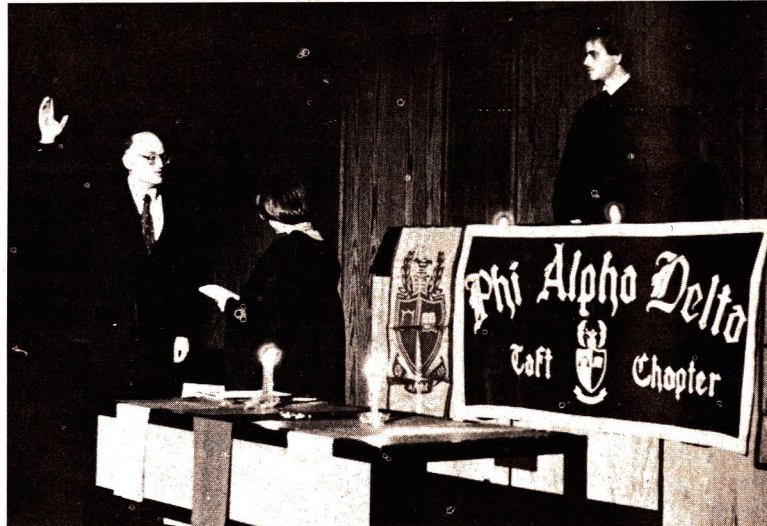
The PAD Juvenile Justice Office awarded five Program Grants and five Mini-Grants to LRE sites nationwide this fall. Program activities and grantees include:

- expanding a teacher-intern program and developing a mock trial videotape to be used to train teachers in Oregon,
- training lawyer-educator-student partnership teams at conferences in Maryland,
- continuing a legal research training/job placement program for high school students in Ohio, and
- initiating legal agency and court representatives participation in classrooms in Indiana.

Mini-Grant recipients in West Virginia, Arkansas, Massachusetts, Rhode Island and Arizona will implement mock trial competitions; training conferences; teacher inservice awareness workshops, field trips, and other LRE activities with funds provided by our office. The information and expertise gained from these activities are institutionalized through the development and dissemination of resource materials, lesson plans, curriculums, etc., which enable these programs to be replicated.

Three new PAD LRE resource manuals are currently available for purchase: two provide information and materials to assist legal professionals in making classroom presentations (one for kindergarten through eighth grade and the other for the secondary level), and another is a guide for how to generate funding support for local LRE activities. A PAD Law School Chapter Manual on implementing an LRE program at the chapter level is in the works. It is hoped that law school and alumni chapters will actively contribute to this Manual by responding to the recent questionnaire requesting information about their LRE activities. The manual is expected to be available early next year.

PADJJO anticipates increased awareness of law-related education through involvement in the upcoming Bicentennial of the Constitution and the Bill of Rights. Robert E. Redding, Director, filed a statement before the Senate Subcommittee on the Constitution on behalf of the Fraternity concerning the commemoration of the Bicentennial of the Constitution in 1987. At its July 11 meeting the International Executive Board voted to support legislation that would mandate the establishment of a special Commission to coordinate Bicentennial activities.

Brandeis, Jay, Taft Chapters Initiate 100 Students

The Brandeis (American University), Jay (George Washington University) and Taft (Georgetown University) Chapters joined in the program, held in Georgetown's Moot Court Room and followed by a champagne reception.

Dr. Isadore Starr, eminent leader in the field of law related education, was honorably initiated into Brandeis Chapter. An attorney, Dr. Starr is a member of the American Bar Association's Special Committee on Youth Education for Citizenship. He is Professor Emeritus of Education at Queens College in New York and a former President of the National Council for the Social Studies.

Dr. Mark Cannon, Administrative Assistant to United States Supreme Court Justice Warren

Burger, was honorably inducted into Jay Chapter. Cannon, the first non-lawyer ever admitted to the American Bar Association under its judicial associates program, holds his MA, MPA and PhD from Harvard University. He was first appointed the Chief Justice's administrative assistant in 1972 and is the first person ever to hold that position.

As this is being written a new Directory is being compiled and will be published in the next several weeks. This effort alone is of great value to all our membership professionally and personally.

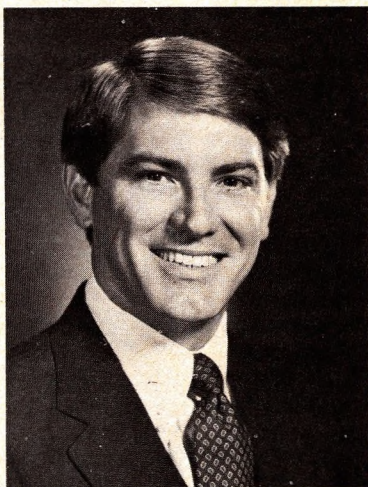

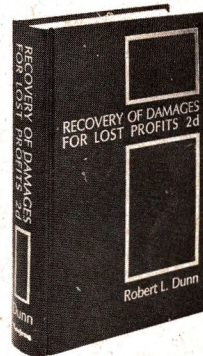
