# First PAD Pre-Law Chapter Denver Alumni **One Year Later**

On Friday, April 24, 1981, at 7 p.m., the first Pre-Law Chapter of Phi Alpha Delta Law Fraternity, International was installed at Southwest Missouri State University.

One year has now passed since this new class of PAD membership offically began in Springfield, Missouri last April. In that time, PAD has witnessed the expansion of the Pre-Law Program into undergraduate schools in Ohio, Kentucky and California. The momentum continues to build, however, and we anticipate further growth in Florida, New York, North Carolina and Illinois before too long.

More importantly, the development of the Pre-Law Program at the individual schools where such chapters have been established has been most encouraging. In keeping with our purpose of the Pre-Law Project — to utilize PAD law school and alumni members, together with printed materials, to provide our Pre-Law members with a better understanding of law school and the legal profession — our maiden chapter at SMSU has made great strides toward educating its members. The chapter is very well organized and has provided services to the school and its students, both members and non-members, covering a wide range of interests.

December 3, 1982 was designated Law School Day at SMSU. A large number of pre-law students gathered to speak with representatives from law schools at St. Louis University, Washington University, University of Missouri-Columbia, University of Missouri-Kansas City and University of Tulsa. These students were also obtain information and admission materials from law schools throughout the country which were unable to send spokespersons.

The chapter also held a PAD Pre-Law Rush Week this year on February 8-14. The schedule of events for that week included an information table in the Campus Union Lobby, an open chapter meeting, a lecture by Springfield attorney and PAD Tom Carlson on First Amendment Rights, and a rush party, with PAD International Secretary Jack Miller and past Vaught Chapter (Oklahoma City University) Justice Charles Curless as guest speakers. Rushees and new members were then introduced to the local PAD chapter and the national organization. A dinner/speaker presentation rounded out the slate of activities for Rush Week.

Perhaps the most successful program in terms of tangible effectiveness and direct student benefit is the LSAT Study Session. Modeled after the commercial courses now available, the sessions have proven to be quite beneficial to those students who have participated to date. Recent test results have revealed scores consistently above 650, with a top score of 760. Though not conclusive on the subject, the LSAT Study Sessions are certainly a salient feature of the SMSU Pre-Law program.

The chapter holds monthly meetings and bi-weekly executive committee meetings to continually plan and discuss upcoming events. This Spring the group is hoping to sponsor a field trip to the Missouri Supreme Court and to the UM-Kansas City Law School.

At the local level, the members at SMSU have conducted a T-shirt Sale and Raffle to raise funds, using the proceeds to award an annual service scholarship to an underclass member. Another yearly feature, a Fall Cookout, was held in November and gave those in attendance an opportunity to speak with fellow students, faculty and alumni in an informal setting.

The PAD Pre-Law Project is the program of the future for the Fraternity. Our goal is to provide the Pre-Law members with sufficient information about law school and the legal profession so that they may properly evaluate the legal profession in light of their individual career objectives and thereby make an informed decision as to whether or not to pursue study in the field of law. The formula has produced favorable results at Southwest Missouri State, and we salute their officers and members for a job well done.

Bierce.

Judge Bierce presided over the installation ceremonices, attended by the twenty student petitioners, KSU President Brage Golding, and KSU Trustee and Akron attorney Robert Blakemore. Charter officers include Donald W. McClellan, Jr. President, and Katherine M Wozniak-Treasurer.

One week later, our fifth pre-law chapter was installed at Ohio University in Athens, Ohio. Under the direction of past International Justice Frank J. McCown, sixteen petitioners gathered to establish the Ohio University Pre-Law Chapter on May 4, 1982.

Brother McCown was assisted by Dean John Stinson, Professor Arthur J. Marinelli and Pre-Law Advisor Mary Keifer. The new officers of the Ohio University Chapter are President Terry Julian, Vice President John Ring and Treasurer Anne Smith.

The following day, May 5, 1982, the Drury College Pre-Law Chapter was established in Springfield, Missouri. Springfield is also the site of our first pre-law chapter, Southwest Missouri State University.

## **PAD Juvenile Justice Program Awarded New Grant**

The Department of Justice (DOJ) has awarded \$166,978 to the PAD Juvenile Justice Office to continue its work in educating young people about our system of

The PAD Juvenile Justice Office, located in Washington, D.C. is one of six grantees of the DOJ involved in a program which strives to increase participation of the legal profession in nationwide lawrelated education (LRE programs for elementary and high school students. This year, concentrated efforts by the six grantees will take place in three states: California, Michigan and North Carolina. An attempt will be made to institutionalize LRE in the public schools in these developmental sites so they can be used as models for other states.

The Juvenile Justice Office has been encouraged by the degree of Chapter involvement in LRE, Projects on the Chapter level take a variety of creative formats:

- Washington and Lee (Staples Chapter) law students teach eighth-graders a crash course in the basics of juvenile law.

University of Denver (Hughes Chapter) law students organize an annual Mock Trial Competition.

University of Utah (Sutherland Chapter) law students teach a consumer education program for elementary school stu-

University of Bridgeport (Douglas Chapter) law students conduct a law-exploring post to aquaint high school students with law as a career.

- Cleveland-Marshall College of Law (Meck Chapter) participates in a "Street Law" program teaching basic legal research, general facts about court procedure, legal terminology, and how to look at problems from a legal perspective to high school students.

The Juvenile Justice Office has produced a manual specifically for the use of law students in designing adn implementing programs. This manual will be introduced at a special workshop to be conducted by the Juvenile Justice Office at this year's annual convention.

This program is a cost-effective, viable approach to exposing young people to social and civic responsibilities and for preventing delinquency.

# Haynsworth Is **Most Senior** Fed. Ct. App. Judge

Brother Clement F. Haynsworth became a Judge of the Fourth United States Circuit Court of Appeals in 1957. In 1964 he became Chief Judge and has served in that capacity since that time.

With 23 years of service and at age 68, he is the most Senior Chief Judge of a Federal Court of Appe-

His opinions have been marked with clarity and precision and he has earned the respect, admiration and affection of the lawyers that practice before him, as well as his colleagues throughout the Federal Judiciary.

His Fourth Circuit has been among the leaders in adopting innovations in internal and administrative improvements within the courts. He feels strongly that such are one means of improving judicial productivity. For a number of years after he went on the court, the circuit handled a caseload of less than 80 cases for each active circuit judge per year. The circuit is now capable of handling a caseload of over 220 for each active circuit judge. He does not feel that the innovations have in any way affected the disposition of cases without full briefing and argument.

One of his most recent proposals is the creation of a new national court to provide direct review of convictions coming from federal and state proceedings and thereby abandon current reliance on the use of collateral proceedings to review such matters. The purpose of this proposal is to expand the appellate capacity so that under the supervision of the Supreme Court one federal national court in deserving cases could provide direct review of state court convictions without the intervention of lower federal

Judge Haynsworth, when asked if he would have objections to the use of television in the district or appellate courts, indicated that he certainly would. He fears that even though television cameras can now be operated so unobtrusively that their presence during a trial would not be disruptive, nevertheless the participants in the trial would know that the proceedings were being taped and in almost every case some participant would be tempted to play to the television audience. To the extent that one or more participants did that there would be distraction from the trial process.

Haynsworth is a member of Jef-
