Plan Now To Attend 1982 **International Convention In St. Louis**

Members are urged to make their airline and hotel reservations early for the 44th Biennial Convention of the Fraternity which will convene at the Radisson St. Louis Hotel in St. Louis, Missouri on August 4 - 7, 1982.

St. Louis PAD's under the leadership of local arrangements chairman and District VI Justice Scott Spiller are hard at work to assure that members and their families attending the Convention will have a most enjoyable time. The Convention will offer members an unusual opportunity to work and relax with law students, attorneys and judges from many different backgrounds, to experience full-scale parliamentary proceedings and to make a personal contribution to the current programs and future development of the world's largest law fraternity. Long range benefits to law school chapters will be many as delegates will experience the scope of our International Fraternity firsthand and return to schools with the exhilaration of fresh ideas and a new vision of PAD programming at the local level.

A new feature at this Convention take place on the floor of the Conwill be a continuing legal education program specially designed to interest alumni members in attendance. The program will also be offered to St. Louis attorneys. Although a fee will be charged those enrolling in the program, no fee will be charged to PAD alumni who register into the Convention.

Convention Program

Delegates are urged to arrive in the afternoon or very early evening of Tuesday, August 3, 1982. The International Justice's Reception will be held that evening and will provide all with an opportunity to meet other delegates and the International Officers.

The Convention is scheduled to be called to order at 9:00 a.m. on Wednesday, August 4 by International Justice Steve Clark. A historical fim strip of the Fraternity will be presented and a brief keynote address will be made by a PAD speaker of national reputation.

Monetary Allowances

The International fraternity provides the actual cost of one round trip airline fare to St. Louis, hotel accommodations and a subsistence allowance for each day of travel to and from the Convention and each day while at the Convention for one delegate from each law school and alumni chapter in good standing.

The airline allowance is computed on the basis of supersaver fares in existence as of February

Each chapter is entitled to have two delegates and two alternates at the Convention and as many additional persons as desired.

Qualifications

In order for a law school chapter to be in good standing and to qualify for the monetary allowance, all fees and forms must have been filed prior to the Convention. Each chapter will be notified of any deficiencies.

In order for an alumni chapter to be in good standing, it must have met the following requirements: the annual alumni chapter tax of \$15

At Harvard Law School

On November 14, 1981 PAD installed its 164th chapter at Harvard University Law School. PAD thus becomes the first law fraternity to establish a chapter at Harvard for many decades.

Leading installation efforts were District Justice Dan Halpin and Executive Secretary Robin Blumfield. The initiation and installation ceremonies were presided over by International Justice and Arkansas Attorney General Steve Clark.

The chapter took as its name that of George Lewis Ruffin, who was Harvard's first black law student as well as the first black student to ever graduate from a lawschool. After graduation in 1869 he was elected to the Massachusetts legislature for the 1870 and 1871 terms. He specialized in criminal law and established a successful law practice in Boston. He later was appointed a judge of the Charlestown Municipal Court.

In a letter welcoming the chapter into PAD, Chief Justice Warren Burger of the Supreme Court of the United States said, "My affiliation with PAD over some 15 years has been most satisfying. I commend to you our lofty declaration of purpose . . . and I challenge you to emulate and surpass other chapters in establishing programs that will help translate these ideals into the daily practice of our profession. If you keep these goals before you, I am confident that the members will find PAD to be a useful and stimulating adjunct to your law school studies as well as a satisfying lifetime affiliation with members of the bench and bar throughout the world.'

International Executive Board Meets — A Student Reports

A meeting of the International Executive Board was held January 7 - 10, 1982 at the Peabody Hotel in Memphis, Tennessee. It is the custom of the Board to invite a student member from a local law school chapter to attend each meeting of the Board as a student observer. The student observer for this meeting was Mary Rich, Vice Justice of McKeller Chapter at Memphis State University. Her observations of the meeting follow:

Introduction

As a student observer from the Cecil C. Humphreys School of Law at Memphis State University, I attended several sessions of this meeting of the Executive Board of Phi Alpha Delta. Due to conflicts with previously scheduled activities at the law school, I was unable to attend the Thursday sessions and the Saturday morning session. However, the following comments will indicate my observations and impressions on several broad areas discussed by the Board.

Field Operations & District Matters

I found the Board's discussions on the problems and strengths of the districts very perceptive and thorough. The Board seemed in touch with the problems of chapters having low ratings or which have recently dropped in ratings. The reporting system on which the evaluations are based seems to function effectively and provide a good basis for these evaluations. However, there does seem to be a problem in the Fraternity with chapters failing to promptly report initiations, which often left questions unanswered as to a few current chapter memberships.

The Board's analysis of the performances of the District Justices was conducted in a thorough manner given the limited time available. The comments of the Board members on their personal knowledge of the strengths and weaknesses of the District Justices and their aware-

communication is maintained between the Board and the District Justices.

In regard to the Pre-Law Chapters, I agree with the Board's intention to accelerate the formation of these chapters in the districts. As a student, I can see that these chapters can be a real benefit to undergraduate students with aspirations of attending law school. They can also benefit universities with law schools if the interaction between the law school chapters of Phi Alpha Delta, and the Pre-Law Chapters attracts good students to the local law school. Most importantly, the creation of these chapters can boost future Phi Alpha Delta membership as these students enter law school and become initiates. The Board's resolve to push formation of the Pre-Law Chapters seemed one of the most potentially beneficial results of the meeting

The report on the 1982 convention in St. Louis was exciting to hear. The plans for social events were thoroughly researched and seem certain to please students and alumni who will attend. I thought it was an excellent idea to allow students to give their input through committee participation on the budgeting problems for the 1984 convention. Scott Rassler, Treasurer Michael Petrik, Clerk Kay Pfister, Marshal Carlos Pena and Faculty Advisor Burt Sparks, Rutledge Chapter at Duke University has increased its membership from five to 40 members during the Fall semester. Activities included a rush barbecue, initiation banquet, participation in the District Leadership Conference, a wine and cheese party for the Law School's Foreign Students, and a dinner meeting featuring Steven Emanuel, author of the Emanuel Law Outlines as guest of honor. In addition, members have played an active role in the law school community serving on The Law Journal and as elected officials of the Student Bar Association, as well as printing up the orientation program for first year transfer and foreign students

approach to problem solving; especially since the future effect of any changes in transportation allowances on students demands student input in the decision making process. I also think the proposed C.L.E. program on Professional Responsibility will be an interesting and beneficial attraction to Phi Alpha Delta alumni and other attorneys in the St. Louis area. This is a topic that can be expanded by Phi Alpha Delta in other programs and fulfill the Fraternity's goal to serve the legal profession in a practical way.

General Impressions

In summary, I found the Board enthusiastic, thorough in its operations, and dedicated to the Fraternity's welfare. The most impressive attitude expressed during the Board's deliberations was its desire to continue being beneficial to Phi Alpha Delta alumni and student members in the face of greater operating costs for the organization. If the attitude and qualities possessed by the Board members can be generated to District Justices, students and alumni at the convention in St. Louis, I feel the Fraternity can accomplish many of its goals in the upcoming year.

I greatly appreciated the opportunity of meeting with the Board and learning of the inner functions of the fraternity which are so ably handled by these dedicated mem-




