# Vice President Bush Lauds PAD

The Vice President of the United States, George A. Bush, was unable to attend the 44th Biennial Convention in St. Louis, Missouri but did send a message of greetings and commendation to the Fraternity by video tape.

The following is the message sent by the Vice President:

"It gives me great pleasure to send greetings to the 44th Biennial Convention of Phi Alpha Delta Law Fraternity. Phi Alpha Delta is one of those vital institutions in our nation. It's a voluntary association. They do so much to promote a better quality of life and higher standards for all Americans.

I'm impressed by the fact that you and the Convention represent a hundred thousand men and women in the legal profession who are leaders in their communities throughout the United States. You are a force for order, for law, for justice — a valuable national resource.

### Pad Awarded Grant For Constitutional Bicentennial

PAD has been awarded a \$24,790.00 Planning Grant by the National Endowment for the Humanities to develop a program for the proper observance of the 200th Anniversary of the Constitution of the United States (1987) and of the Bill of Rights (1991).

In announcing the Grant, International Justice Charles H. Taylor said that the program "is designed to increase citizen understanding of the profound historic issues, philosophical principles and jurisprudential foundations of the Constitution in general, and the first amendment in particular." The objective is to develop a "working partnership of volunteer members of the Bench and Bar, of humanities specialists and of committed civic leaders to help plan and observe these Bicentennials as national educational events," Brother Taylor added.

Professor David M. Schimmel, a PAD of the School of Education at the University of Massachusetts, has been designated Project Director. Professor Schimmel said that "the goal is to educate all citizens — in our schools and communities about the importance and function of the Constitution and the Bill of Rights in our individual lives and our international life." He observed that despite the fact that for almost 200 years, a major purpose of the public schools has been to teach students to understand these basic legal documents, "there is ample evidence — in educational surveys, opinion polls, and public events — that many Americans have not yet been educated to live according to these documents."

Another PAD, noted Constitutional Scholar and Author, Professor Emeritus, Isadore Starr of Phoenix, Arizona, will serve as Chairman of the Bicentennial Program Advisory Council.

### PAD JUVENILE JUSTICE PROGRAM PRAISED AT CONVENTION

Major attention was given to the PAD Juvenile Justice Program, not only in the Convention proceedings but also by the International Executive Board before and after the Convention concluded in early August.

During the Convention all delegates and alternatives received a briefing in a chapter workshop on PAD's work since 1979 in the field of juvenile justice and law-related education. The presentors included Linda Riekes, PAD Community Resource Consultant; David Schimmel, PAD Education Consultant, Patricia Millard, Juvenile Justice Office, and Robert E. Redding, Director of the Juvenile Justice Office.

On the basis of the workshop and additional contacts made during the convention, the Juvenile Justice Office reports that a total of 56 law school chapters indicated interest in either expanding present LRE programs or starting them. During the Convention, there was also distributed a new Juvenile Justice manual to law school chapters to assist in building effective LRE programs. Additional copies are available from the Juvenile Justice Office.

Chief Justice Burger said "The Fraternity's Juvenile Justice Program, which is involved now in planning for the Constitution is to be commended." Vice President George A. # Charles H. Taylor Becomes International Justice

As the last item of business of the 44th Biennial Convention, Charles H. Taylor, a member of Timberlake Chapter at Wake Forest College of Law was elected International Justice of Phi Alpha Delta Law Fraternity, International.

His election culminated many years of outstanding service by Brother Taylor to our law Fraternity.

While at Wake Forest he served as Justice of his law school chapter which was selected as the Outstanding Chapter in the nation under his leadership. He subsequently served a number of years as District Justice and was elected to the International Executive Board in 1970. In that year, he chaired the Constitution and By-Laws Committee of the International Convention, which amended the Constitution to admit women into membership. He has served on the International Executive Board since 1970 in various capacities and was International Vice Justice from 1980 to 1982.

In his senior year in law school, he was nominated as a candidate to the North Carolina House of Representatives and was elected that Fall after graduation. He was re-elected twice to the North Carolina House and served for six years, four years as the Minority Leader of the House. He was then elected to the North Carolina Senate where he became Minority

Brother Taylor founded the Western Carolina Bank and Trust Company in 1973 and has served as Chairman of the Policy Committee and as Vice Chairman of the Board of Directors. In 1977 he co-founded Cary Savings and Loan and Blue Ridge Savings and Loan.

In 1979 he co-founded Financial Guarantee Insurance Company, a private mortgage insurance company and Financial Title Insurance Company, a title insurance com-

pany. He presently serves as Board Chairman of both institutions.

As if the foregoing were not enough, he is also a licensed forester and founded Transylvania Tree Farms to own and grow hardwood timber in 1959. In 1963 he founded Southeastern Real Estate Company with three divisions for commercial, apartment, and permanent and recreational home development ownership holdings.

### Kohn is Vice Justice

Stanley Kohn, a member of Pinckney Chapter from the University of South Carolina School of Law, has been elected to the office of International Vice Justice. He was first elected to the International Executive Board in 1976. While in law school, he served as Justice of Pinckney Chapter and was named its outstanding member in 1967.

He founded the Family Court Volunteer Program, which was named the Outstanding Volunteer Project in the nation in 1974 and organized the Richland County Council on Child Abuse and Neglect and served as its first chairman.

He presently is the General Counsel to the South Carolina Department of Social Services. He previously was engaged in private practice for 13 years.

Miller is Second Vice Justice Jack L. Miller of Lebanon, Missouri, was elected to the office of Second Vice Justice of the Fra-

In addition after alumni chapters are organized and have programs underway, the International Officers have an obligation to monitor, recognize, and reward those chapters performing out-

standing service and to motivate those chapters with only limited activities. Of course the ultimate goal of the reactivation and organization is to enable Phi Alpha Delta as a growing legal organization to staff and carry on the increasing programs of service for the community and the profession. Our pre-law chapters need alumni support. Our nationwide juvenile justice program has been successful because of the alumni support for the program, and many of the new service programs which the fraternity will be providing during the next two years will depend upon the support of alumni.

Most alumni would welcome a further opportunity to serve the law school, the student, and the profession, and the need is there. Most law schools would appreciate an alumni chapter taking on a specific program to enhance the school: funding a guest professor, providing a piece of equipment for the school, or supplementing the library. Organized alumni schapters could perform an invaluable service for Phil Alpha Delta law students by holding job fairs and other employment opportunities even if that alumni chapter is not near a law school student chapter, and many of the continent wide programs now being carried on or that are planned, whether Inns of Court, planning for the bicentennial celebration of the United States Constitution and the Bill of Rights could have a broad impact upon the community and the profession.

Thus all Phi Alpha Delta members have a stake in the strengthening of the alumni chapters. If you want to help, let me hear from you.







# 44th Biennial Convention **Highlights**

The 44th Biennial Convention of PAD was held at the Radison Hotel in St. Louis, Missouri on August 4-7, 1982. Some 300 persons attended representing 164 chartered law school chapters and 79 chartered alumni chapters.

A pre-Convention reception was held for our officers on Monday, August 2nd at the lovely and historic St. Louis home of Linda Riekes. Linda was presented a PAD Sweetheart Pin for her outstanding work with PAD Juvenile Justice Program.

All officers attended a Convention Orientation Session on the morning of August 3rd and that afternoon a Blue Ribbon Panel consisting of Past International Justice Frank J. McCown, Past International Justice Don Hutson, Chief Tribune Joseph E. Deems, and Senior District Justice Dan D. Halpin, put on a presentation on the topic "The District Justice — Our Strongest Link.'

Registration was held on Tuesday afternoon and was followed by a poolside reception for all members and their families. The function provided an excellent opportunity for delegates to become acquainted before the Convention officially convened.

Wednesday morning, August 4th, everyone gathered in the Foyer outside of the Convention Meeting Hall for coffee and rolls. Delegates enjoyed an extensive number of displays, which had been prepared by members of the Executive Office Staff. The displays showed Outstanding World Leaders who are PAD's, Outstanding Women Leaders who are PAD's, Chapter Publications, Fraternity Publications, a large map of PAD Chapters, and other displays of interest. At 9:00 A.M. the International officers processional officially opened the 44th Biennial Convention. The processional was followed by a showing of the filmstrip on the History of the Fraternity, which told the origin of PAD and traced its history over the years and up until the convening of the 44th Biennial Convention.


International Justice Steve Clark called the Convention to order and the Invocation was given by past International Justice Don Hutson.

At the closing banquet of the 44th Biennial Convention in St. Louis, PAD presented its prestigious Tom C. Clark Award for outstanding exemplification of "Equal Justice Under Law" to Federal Circuit Judge John Minor Wisdom of New Orleans.

Judge Wisdom, himself a PAD, of the United States Court of Appeals for the Fifth Circuit, was presented the award in recognition of his significant contributions to equal justice. The award is a memorial to the late Justice Tom C. Clark of the United States Supreme Court who served as Supreme Vice Justice of the Fraternity for two terms.

The presentation was made at the closing banquet at the Radisson Hotel August 7th by International Vice Justice Charles H. Taylor.

The award plaque states that Judge Wisdom has been called "an unlikely hero" because he "shared a quiet passion that reacted to injustice and translated the Supreme Court's basic school desegragation decision into a broad mandate for racial justice and equality under the Judge Wisdom and other Fifth Circuit Judges "shaped and validated the Civil Rights Act of 1964 and the Voting Rights Act of 1965", and "fought the popular pressures at great personal sacrifice and discomfort", according to the citation on the plaque.

Judge Wisdom was first appointed to the United States Court of Appeals for the first circuit in 1957 and has served since that time.

He received his LLB from Tulane University in 1929, served in the United State Army Airforce from 1942 to 1946 where he attained the rank of Lt. Colonel and was The opening session adjourned at awarded the Legion of Merit and Army Commendation Metal.









# 1982 Convention Keynote **Address** "Man's Search For Meaning"

(The following is the 1982 Keynote Address as delivered by the Honorable Mary S. Coleman, Chief Justice of the Michigan Supreme Court)

In "Man's Search For Meanthe famous psychiatrist Victor Frankl wrote about his tortured experience in a death camp during WW II. He said "We who lived in concentration camps can remember the men who walked through the huts comforting others, giving away their last piece of bread. . . . They offer sufficient proof that everything can be taken from a man but one thing: The last of the human freedoms - to choose one's attitude in any set of circumstances, to choose one's own way.'

I shamelessly adopt those profound words of another as the underlying theme of these remarks concerning professional responsibility. I firmly believe that your personal attitude toward your professionn and the persons you profess or will profess to serve can make the difference between an ennobling experience and a constant urge to take a bath. Collectively, your attitudes will determine the future of justice in a democratic society.

Professional persons variously nave been praised, damned and chided over 100s of years from Shakespeare to Ogden Nash. The latter tongue-in-cheek poet wrote, as an example:

"The doctor gets you when you're

The preacher, when you marry, And the lawyer lurks with costly

If too much on you carry.

Professional men, they have no cares;

Whatever happens, they get theirs.

- And, of course, Shakespeare often is gleefully quoted — out of context — as writing, "The first thing we'll do, let's kill all the lawyers.'

Comments lately have been more specific. Although I am perhaps in ordinately proud of being a lawyer, I cannot afford to hide my head in the sand so I can neither see nor hear our critics — nor can you.

Our profession is founded upon public confidence and from each of us it must expect the assumption of professional responsibility upon admission to practice before the bar. I say "each" because every

one of us bears responsibility for the reputation of the whole (the 'rotten apple' theory).

Therefore, let us look at us before we ascend to "cloud 9" for an overview of our profession. In other words, I encourage you first to look inward, to indulge in some self-examination. (I have been impressed by Buddhist's, and to some extent, Hindu's statuary and paintings depicting the normal two eyes, but with an additional eye in the forehead. It is said to be the eye which looks inward to the mind). After these short exercises, we can raise our eyes for a glimpse of the possible future.

It is far from easy in today's turbulence to remain steadfast in the commitments to our profession after we solemnly declare our lawyer's oath — and I hope you have or will take the traditional oath. Those of you who have not yet reached that point, think on it. Who and to what end are we who profess (professional) to the high standards of intellectual and ethical training and dedication to the higher aspirations of man? Perhaps the most soul-searching inquiry is: Does my commitment take me past self-interest — and perhaps even past the insidious growth of arrogance or sterile enjoyment of posi tion without reference to commit-

Admission to the bar is a passport neither to heaven nor hell but today, more likely to that mythical place suspended betwen, called chaos.

Within this century, society in America has been reorganized from predominantly rural to an urban basis. The speed of travel has multiplied incredibly. The telephone, films, television and the have saturated computer communication. Government has mushroomed. Production technology of all kinds has been revolutionized. Education has exploded. On a global basis, nuclear fission has rearranged energy and world power equations. At home, broadended perceptions of individual rights have retulted in storms of litigation testing the limits of statutes and state and federal constitutions against personal needs or aspirations.

No wonder, then, that tempestuous change has thrown the legal profession into some disarray. No wonder that public opinion polls almost uniformly reflect disillusion with the various professions as they compete with one another to climb further from the bottom rung in popular rankings. (e.g., one Gallup Poll I saw had lawyers ranked with undertakers on a very low rung.)

However, sharp criticism is nothing new for the nation's lawyers. I was privileged to attend the 70th Anniversary Conference of Roscoe Pound's 1906 speech to the ABA Convention in Minneapolis: "The causes of popular dissatisfaction with the adminis-tration of justice." The subject could be one for today. Since that time, President Carter, Chief Justice Burger and many others have urged us to address our shortcomings.

We have strong incentives to seek and hold status as a profession. The very idea of a profession. or a professional, suggests classification — a setting apart. The concept is inherently one of public favor, rather than disfavor, in that it implies recognition of characteristics that are useful and good.

In the essence — or chemistry of our profession we can isolate various elements. For instance, as legal professionals we are specially trained, supposedlyi learned and sometimes erudite in our field. We are expected to serve the public interests in its pursuit of justice for all. We are expected to be accomplished in writing, reading, and speaking — in the ability to communicate and use our husbanded knowledge to the benefit of clients and of the legal community. Are you or will you be prepared to assume these responsibilities?

While you test some of your own attitudes, I will share with you some of the complaints I most frequently hear and read about lawyers. What do you feel about these criticisms of our legal professionals?

1. Some no longer perceive themselves as "officers of the court," trails are battles of 'gamesmanship' designed to trap the judge, build in error or confuse the jury. This is what is known as Truman's Law, "If you can't convince them, confuse them." I have noted that red herrings abound.

2. Some lawyers are seen as greedy, not willing to take a case unless the prospects are excellent for a large or even exhorbitant fee. (e.g. medical malpractice, products liability, etc.).

3. Repetitive exposure of some lawyers to the sentencing of a defendant to prison may produce a detachment resented by the lay client. ("dehumanization," some critics call it). In this pervasive reordering of society and the advancement of technology, the economics of delivering services has changed dramatically. In the struggle to pay the overhead, including modern machinery for research, typing, duplication, and skilled personnel, we sometimes are accused of losing the "human touch" of the traditional professional.

4. For want of a better word, some critics note a "dilution" of standards.

Of course, I could go on and on, but I urge you to examine your perception of what kind of a professional you are or wish to be.

As our "inward eye" examines these and other problems flowing from our response to the times, let us now look outward to the dilemmas facing our profession gener-

I have noted in passing the effects of economic demands upon the delivery of professional service. It is difficult to avoid involuntary servitude to the cash flow. The computerized aids to your work must be measured against quality in translating those benefits to the aid of your client. Too much, too fast may result in a de-personalized response to your clients' needs. There is room for measureing these competing values.

Next, we should note government intrusion into our profession following the flow of what is sometimes in jest called "free money" and with it, regulation. This intrusion is reflected primarily in the

subsidizing of certain categories of legal services. I believe that no one disputes the genuine need for government to assist an indigent defendant accused of a serious crime by providing legal counsel, transcripts, etc. The conflicts now raging concern the outer limits of taxpayer responsibility — traffic tickets for moving violations? What categories of civil cases? At a recent count, there were over 320 federally-funded legal service agencies devoted solely to civil cases — wholly apart from national aid to ciminal defendants.

Now that federal funds are being diminished, the profession must engage in some soul-searching regarding its responsibilities. For instance, are you or will you be willing to accept some pro bono cases?

Awhile ago, I mentioned the need for each of us to look inward and consider whether we are contributing to the percept on that there is a "dilution" of standards among lawyers.

This request leads to mention of another pervasive influence upon our profession — the changed religious and moral climate of our country. I suggest to you that a delicate thread of spirituality runs through, or should run through any profession's ethical creed. It is an expression of an attempt to attain, and adhere to, a higher standard of conduct than is applied by law to the generality of citizens — a keener sense of moral responsibility. It is a sign of our times that we now try to legislate ethics.

Having lived through more years than the great majority here, I can attest to the fact that the attitude of an alarmingly increased number of lawyers is indeed diluting standards of ethics and competence in the courtroom and diminishing respect for an honorable profession.

I hasten to say that as our profession grows numerically, it is not surprising that unevenness of performance should appear more often. There are roughly well over one-half million lawyers in the nation, with over 30,000 being added each year through admission to the practice of law.

Incidentally, in Michigan, the board of law examiners comes under the umbrella of the Supreme Court's responsibilities. We are constantly amazed at the number of incredible - and even unreadable essay answers. We will not mention pelling punctuation or the lack of whole sentences — which are not counted — but the inability to express and idea, much less isolate the issues, has brought us to few conclusions: (1) from the early gades upward, education has failed in one of its prime purposes (2) colleges and universities are graduating some so-called functional illiterates and (3) law schools too often are not weeding out those who are unlikely to pass a bar examination (a tragic waste of the student's time and resources).

These observations are nationwide. The conference of chief justices has a special committee studying this pre-bar phenomena on the one hand and on the other, the maintenance and enhancement of ultimate lawyer competence.

Now, for a moment, let us look to the future. How can we enhance and at the same time help to produce a widespread understanding of and respect for a Democratic society under law?

First, I suggest that we must start at the beginning. A seed planted in winter is not likely to thrive. Phi Alpha Delta is engaged in a program of fundamental importance the vigorous promotion of lawrelated education in kindergarten through the 12th grade curriculum. am happy to report that our own Bob Redding has managed to stir up a great amount of enthusiasm in my state of Michigan. An agreement has been signed by the department of education, state police, the state bar of Michigan and others towards developing, and incorporating law related education into the K-12 curriculum. This commences with the training of teachers.

With your leadership, we can revolutionize the attitude of our citizens as they grow in age and hopefully — wisdom. Certainly we can hope for an institutionalization of those values which made our country great.

At the same time, we can hope for increased skills in fundamental education as a platform for success experiences in whatever road our children will choose to follow.

In the field of education, law school admission policies and content are now under the microscopes of several national associations. A task force of the conference of chief justices has just submitted for our review a report with recommendations regarding lawyer competence. It is premature to reveal its contents, but it is detailed and suggests some forthright and exciting remedies. Inherent in professional responsibility is competence, commitment to high standards of ethics and to a system of justice which demands our dedication to the highest principles of our calling.

It is said that responsibility is proportionate to opportunity. If so, you will be or are those persons responsible for some answers to tough questions.

For example:

1. Should a practicing lawyer, like a licensed physician, be required to take refresher courses each year or at set intervals?

2. Should we institute on a wider scale a system leading to specialization in the law, such as criminal defense, products liability, worker's compensation?

3. Can we preserve the high standards of professionalism in prepaid legal services similar to Blue Cross/Blue Shield coverage? If part of an employment contract, should a "closed end" legal services plan be acceptable — where a salaried battery of lawyers line up to serve dues-paying clients? Or would the profession and the employee be better served if the client retained the right to choose an attorney ("open-end" contract)? General Motors has the first Michigan contract which includes prepaid legal services. It is a

'closed-end' plan.
4. Should a system be devised whereby new lawyers have ready access to given experienced lawyers for voluntary assistance?

5. What limits should be placed upon lawyer advertising to curb what is sometimes called "creeping commercialism" of the profession by comic books, tasteless ads, graphics and TV commercials?

6. What policies should govern the limits of government-paid (taxpayer financed) legal services?

7. How can we divert more litigation from our beseiged courts?

8. In the increasing pressure to pay the overhead and earn a living in a competitive field, what kinds of measures would you take to prevent overextension - or, conversely, to assure each client adequate time and preparation?

My brothers and sisters of Phi Alpha Delta (I am happy to learn that 43% of us are women), we have a challenging future in which to test our concepts of personal and professional purpose against the realities of the practice of law.

For instance, after a moot court competition in a law school of excellent repute, the students gathered around and we discussed some of te fine points of ethics. Some could not perceptualize their future roles as "officers of the court." However, this dilemma is not confined to students.

There is now heated debate concerning the proposed ABA model rules of professional conduct as they concern attorney-client privilege when assistance is sought as an aid to crime or perpetration of a fraud. (e.g., should a lawyer reveal that his client is committing perjury?). The duty of disclosure has met with mixed revues. — but as Robert Kutak says in the July ABA journal, "The notion that lawyers have no responsibility for the integrity of judicial process, that lawyers are morally blind actors on a valueless stage, will evoke the righteous anger of society.'

Other proposals of controversy concern a rule which would require

pro bono work of each attorney and probably a "sleeper" — that an attorney must inform a client of the

progress of a case. Perhaps the attorney is working on the case, but the client feels forsaken. Because the legal profession is

the only truly self-regulating profession — and if it will remain so a revision of the model rules of professional conduct after so many years of neglect is a salutory project of the ABA.

However, in the modern game of courtroom tactics, some perceive a tension between fully representing a client and that portion of the lawyer's oath which says: "[I] will never seek to mislead the judge or jury by any artifice or false statement of fact or law.

In my experience, the more successful, reputable lawyers appareently find excellent representation of clients consistent with their obligation to be "officers of the court." Aside from my own "view from the bench" both as a trial and as an appellate judge, I can attest to that statement from experience on the other side of the bench.

I had some superior mentors as a practicing lawyer, one being a partner who was a long-time chairman of the Michigan bar grievance board (ethics) and then state bar president. Another one was also a very successful lawyer. Each of us was retained as "local counsel" in our respective areas by the New York Central Railroad. (At the time, I was the only woman so retained in the United States.) Toward the begining of that association, I was called upon to be cocounsel with Mr. Badgley in a very important railroad crossing case involving terrible injuries. After plantiff's case was closed, Mr. Badgley moved for a directed verdict, arguing the applicable law and rules of procedure. He quoted excerpts from caselaw as decisive of our position. After a very short recess, the judge granted the motion. On a later date, I asked the judge how he had decided so quickly. I shall always remember his reply: Well, when Mr. Bddgley cites from precedent, I never have to check to see if it is in context, I never have known him to mislead the court," honesty is a great virtue in anyone, but in the competitive, adversarial existence of a practicing lawyer, it is the springboard to greatness. We cannot attribute shoddy ethics to today's environment. We have the freedom to exercise our own free will. As our PAD tribunal has so wisely and well stated in its recent report on a professional responsibility program, and as your efforts toward law-related education in all grades in all schools recognize, understanding and attitudes are best affected by long-range exposure to facts and philosophies basic to life under a system of laws, the most precious product of which is free-

I think it a healthy habit once in awhile to recall one of my favorite short stories, which I will tell in

In ancient times there was a king who summoned his prime miniser and said, "I have been observing out of this window for several days and I perceive the country is in serious trouble.'

# **Summary of Convention Action**

The following is a summary of action taken by the 1982 Inter-

national Convention: **CONSTITUTION AND BY-LAWS** 

1. Rejected a proposal to reconstitute the composition of the International Executive Board with an International Justice, International Vice Justice, International Advocate, International Secretary, International Treasurer and four Directors.

2. Rejected a proposal to increase the initiation fee to \$40.00 effective January 1, 1983 and to \$45.00 effective January 1, 1984.

3. Adopted a proposal to increase the Alumni dues for persons who have been out of law school from three to five years from \$25.00 per year to \$30.00 per year and to increase the alumni dues for persons out of law school over five years from \$35.00 per year to \$45.00 per year.

4. Adopted a proposal requiring law school chapters to keep initiation fees in trust accounts.

5. Adopted a proposal that all funds paid to the International organization should be paid in United States dollars or the equi-

6. Adopted a proposal which deleted the requirement that The Reporter be distributed to all members of record and substituted in its place instead a provision that the Fraternity should publish and distribute such publications in such format, under such conditions and at such cost as the International Executive Board or the International Chapter may determine.

7. Deleted the Contingency Fund which provided for loans to local chapters and provided monies for other uses and needs as the International Executive Board, might in its discretion, approve.

8. Adopted a proposal to establish a Council of Distringuished Members consisting of not more than thirty-five members who shall be persons who service in public, professional or fraternal affairs shall qualify such person to serve in an advisory capacity to the International Justice and the International Executive Board.

### **PUBLICATIONS**

1. Recommended that the Executive Office prepare a new manual, the purpose of which to provide chapters with guidelines for developing individual job placement programs at their respective chapters.

2. Recommended that all manuals, brochures and publications utilize printing on both sides of the paper whenever possi-

growth of regulation. By the end of 1981, more than 2,500 regulations had been reviewed under the new procedure. The number of pages in the Federal Register for 1981 was reduced to 2/3rds of the number in 1980. These simple facts symbolize the results of our efforts to improve the regulatory process. Our goal is to insure that the regulations which are adopted are necessary, that they provide the greatest benefits to society, that they don't impose unreasonable costs on consumers and that they are in the public interest.

Finally, I want to send my best wishes for the success of your convention. It's an important instrument for attaining the goals of Phi Alpha Delta. People, ideas, concern. These three ingredients make Phi Alpha Delta a strong force for the legal profession and for the nation. You have my best wishes for a most productive convention.

Law-related education in our secondary and elementary schools can stop juvenile delinquency and lawlessness before they take hold of young lives and destroy the promise of youth. The program shows great potential and with the support of 100,000 members of Phi Alpha Delta, the Juvenile Justice Program can have a great impact on the problem of crime throughout America."

In addition, the Board, following the Convention, adopted a resolution responsive to a visit from a top official of the Office of Juvenile Justice and Delinquency Prevention to the effect that PAD would be willing to take an expanded role in the juvenile justice.


