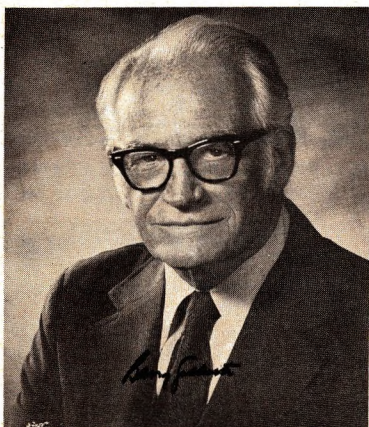

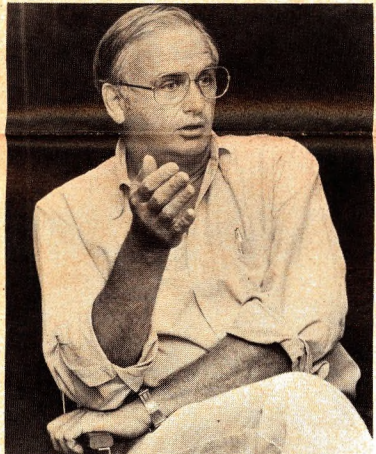

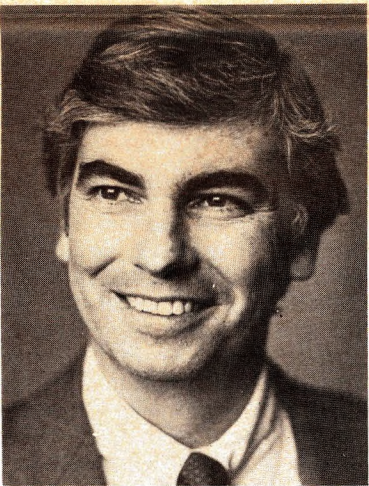

Florida To Host '84 Convention

The International Executive Board has selected Miami Beach, Florida as the location for the 45th Biennial Convention of the Fraternity which will convene August 1-4, 1984.

Headquarters hotel will be the luxurious Ramada Renaissance Hotel which boasts that every room has a view of either the Atlantic Ocean or the bay. The Ramada Renaissance was at one time the Playboy Hotel in Miami Beach.

Members of the newly chartered and installed Ft. Lauderdale Alumni Chapter as well as members of the Miami Alumni Chapter are making plans to assure that the 1984 Convention will be one of the most outstanding in the history of the Fraternity.

Very special rates have been negotiated with the hotel and all rooms will be priced at \$38.00 whether single or double, for members attending the Convention. Attractive rates will also be furnished for suites.

Although Convention programming is still in the planning stages, it is anticipated that features will include the International Justices reception, a keynote address by a member of national reputation, chapter workshops, a model initiation, various committees composed of student and alumni delegates to deal with matters of Fraternity importance, nomination and election of International officers, extensive social events and the annual International Awards Banquet which will serve as the closing event of the Convention.

Family Entertainment

Special entertainment will also be arranged for spouses and families in attendance so as to assure a most enjoyable time for everyone.

Financial Arrangements

The International Fraternity will provide the actual cost of one round trip airline fare to Miami Beach, hotel accommodations and a subsistence allowance for each day of travel to and from the Convention and each day while at the Convention for one delegate from each law school and alumni chapter in good standing.

It is anticipated that the airline allowance will be computed on the basis of supersaver fares in existence as of February 15th.

Each chapter is entitled to have two delegates and two alternates at the Convention and as many additional persons as desired.

Loyola (L.A.), Seton Hall, And Cal Western Are Most Outstanding For 82-83

Winners of the first, second and third place awards in the International Outstanding Chapter Competition for 1982-83 were, as announced in the October issue of the Reporter, Ford Chapter Loyola School of Law Los Angeles, Patterson Chapter Seton Hall University and Beaumont Chapter California Western School of Law.

Ford Chapter, 244 strong, maintained a list of professional and social activities which was truly outstanding. Among these were Attorney Speakers Programs on law practice in varied fields of practice, a debate on "Does the Adversary System Corrupt Justice?", panel discussion on How to Use PAD to Further Your Law Career, fall and spring student/faculty mixers, a trivia guide publication which is a compendium of information of local school, community and legal services and resources, an open house for prospective law students, providing law school tour guides, a program designed to acquaint high school students from minorities with an insight into the law, a prefinals party, a spring barbeque reception, a fall post initiation banquet and an Alumni Bench and Bar Night.

The chapter maintains an elaborate system of committees on subjects such as Rush, Professional, Faculty Liason, Alumni, Inter-chapter, Service, Publicity, Social, Elections and By-Laws and Finance.

During the past year the chapter initiated Dean Arnold Siegel, Registrar Frank Real and Professors Stanley Goldwin, Carol Rose, Linda Mullenix and Joseph Sliskovich, Grace Tonner and Curt Garbesi.

Members of the chapter have been active in the law school serving as SBA President, Secretary, Treasurer and First and Third Representatives. The chapter also had 19 members on the Law Review and had many members who participated heavily in law school organizational activities.

Paterson Chapter

Paterson Chapter at Seton Hall University increased its membership in 1983 from 14 to 81. Among its programs were First Year Study Seminars with second and third year PAD members meeting with first year students to discuss and develop study groups, a trip to the US Supreme Court, development of Law Related Education Programs and various speaking affairs. Social events included the sponsoring of an Alumni Cocktail Party, a holiday party and a number of rushing events.

The chapter also has a well organized system of committees dealing with subjects such as Placement, Social, Professional, Supreme Court, Law Related Education, Publicity and Finance.

Beaumont Chapter

Beaumont Chapter California Western, 107 strong, continues its record of excellence in the law school.

Among its programs were extensive speaker programs, seminars by local financial planners and computer companies on fringe benefits, Advertising Within the Boundary of the Code of Professional Responsibility, PAD Meets San Diego attorneys Night, orientation programs, publication of a law school student, faculty and staff directory, maintenance of a bar review and exam outline library, maintenance of a book recycling program and various sports functions. Social functions included a Casino Night, hospitality suites at the Barristers Ball and various rushing mixers and functions.

Committees maintained by the chapter are Rushing, Professional, Student Directory, Liquor Control, Athletic committee, Speaker Committee and Executive Officers.

Fort Lauderdale Alumni Chapter Installed

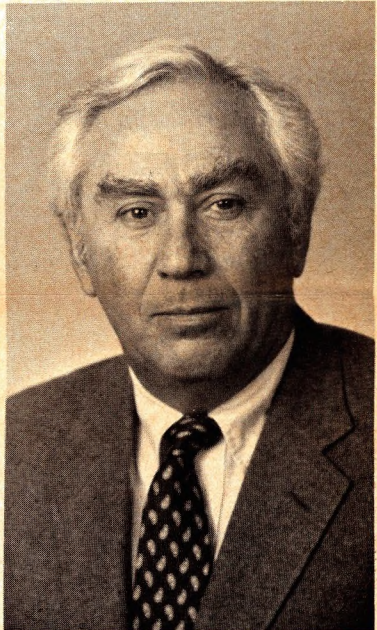

News From The Law School Chapters

Jay Chapter, George Washington University in Washington, D.C., has sponsored several events to help first year students to adjust during the first few weeks of school. Several days before the first day of class, Jay Chapter held an "Anxiety Breaker" for all first year and returning law students. The event was held on the Quadrangle outdoors behind the law school. A keg, mixed drinks and munchies were served with about 200 persons in attendance. On the first day of school the chapter held a "Surviving Week One" program which was attended by some 400 first year students. The officers handed out a first year survival kit containing PAD handouts on "How to Brief a Case", "The Gilberts First Year Pamphlet", various pamphlets about things to do in Washington, D.C. such as a restaurant guide, apartment guide, a book on the Supreme Court, etc. Each officer gave a talk to the first year students on study guides & outlines, study groups, how to brief a case, plus an introduction to PAD and what it is about. During the first and second week of school Jay Chapter sponsored a T-Shirt sale with 3 different T-Shirts for sale. Over 240 were sold making it a very successful fundraiser. The chapter later held a "Legislative Veto Panel Discussion" with panel members from Congress, the White House Counsel's Office, the Justice Department and Law Professors. The chapter has also held a mixer after school during recruitment week for first year students so that they can mingle with members of the Fraternity and ask questions. Finally, during the third week of school, Jay Chapter sponsored a reception for first year Professors and held a meet your professor party for all first year students. Eric Hutson and his wife Ann Hutson are serving as Justice and Clerk of the chapter respectively.

Last April **deDiego Chapter** of Catholic University of Puerto Rico held its installation of newly elected officers, a piano concert and cocktail party. Over 100 persons were in attendance.

A new district, **District XXIV**, has been created by the International Executive Board. The new district consists of **Butler Chapter** at Mitchell College of Law, **Dooley Chapter** at Lewis University, **LaFollette Chapter** at Marquette University, **Mitchell Chapter** at the University of Minnesota, **Monroe Chapter** at Hamline University, and **Ryan Chapter** at the University of Wisconsin.

Christianity Chapter at Cooley Law School initiated 19 new members last June.

District XXIII Justice, Hector Mendez-Loucil, presented **deDiego Chapter** recently with the award for Outstanding District XXIII chapter for the year 1982-83 and for the achievement of the greatest ratio of chapter membership to law school student body membership in the Fraternity as well as a plaque and recognition of membership increase of 100% or more.

The law school chapter at Whittier College of Law recently effected the change of its name from Charles Whittaker Chapter to that of **Judge Albert Lee Stephens, Sr.** The ceremonies which took place last March saw the culmination of several years of work by chapter members to effect a change in the International By-Laws. Previously the International By-Laws prohibited the naming of two chapters with the same surname. The chapter at the University of Georgia was installed with the name of Stephens back in 1947 and Whittaker Chapter members desired to honor Judge Albert Lee Stephens, Sr., former chief judge of the 9th U.S. Circuit Court of Appeals and a loyal and enthusiastic PAD. At the 1982 Convention chapter members were successful in effecting the change of the International By-Laws. In attendance at the ceremony were the late judge's two sons, **Clarke E. Stephens** and **Albert Lee Stephens, Jr.**, both of whom have established themselves as distinguished members of the Bench

in the Los Angeles area.

New officers of **Pinckney Chapter** at the University of South Carolina School of Law are: **Jane Fender** - Justice; **Dana Wilkinson** - Vice Justice; **Miller Shealy, Jr.** - Clerk; **M. Arthur Smith** - Treasurer; and **Jenny McGurk** - Marshal.

Lincoln Chapter at John Marshall Law School co-sponsored a faculty student picnic and softball game this past summer. The event was organized as a fundraiser for the March of Dimes. The chapter has also taken an active part during freshman orientation this past Fall.

The members of the John Hickman and Samuel Houston Chapters of **PHI ALPHA LAW FRATERNITY, INTERNATIONAL** combined forces this past November 10, 1983 and prepared their first joint initiation and reception. The initiation resulted with approximately 20 and 25 new initiates for the Hickman and Houston Chapters, respectively. The ceremony was attended by several distinguished members of P.A.D. and the Texas Judiciary Branch. The Honorable **Franklin S. Spear**, Texas Supreme Court Justice; Judge **Robert A. 'Bob' Gammage**, Court of Appeals - Austin (PAD District VII Judge); **Raymond C. 'Ray' Justice**, Texas Administration of Courts (PAD's last Supreme Justice) and **John F. Ensle**, Assist. Dean, South Texas College of Law, were present to assist in administering the oath of membership and address the new inductees of PAD.

Immediately following the initiation, a cocktail reception at the Shamrock Hilton, Continental Room, highlighted the evening. The reception is an annual event for alumni members of P.A.D. in the Houston and surrounding areas. This year invitations were extended to all Harris County District and County Judges. Much success was realized from this function. It provided an opportunity for students to interact with fellow alumni and judicial members who share in the goals and ideals of P.A.D.

A tentative agreement has been reached by the present officers of the respective chapter to jointly undertake this event again next year.

Paterson Chapter at Seton Hall University School of Law, winner of second place in the Outstanding Chapter Competition for 1982-83, continues to enjoy prosperity. On October 26th the chapter initiated 76 new members and 15 others have been carried over to a later date. The chapter has organized a U.S. Supreme Court trip which will be held March 26, 1984 and a Pre Law Committee which will oversee the establishment of a Pre Law Chapter at Seton Hall University.

District III held its annual District Leadership Conference on October 23, 1983, at Loyola Law School in Los Angeles. All eight chapters in the district sent delegates. District III includes Pepperdine, UCLA, Loyola, USC, Whittier, California Western, University of San Diego, and Southwestern Law Schools.

The conference included workshops on all facets of PAD activities, from rushing to programming to awards and initiations. Special presentations were given by: Matthew "Sandy" Rae, Past Supreme Justice, on "How to Network Within PAD"; Joseph Deems, International Marshal, on "Using the Key Person System to Build a Chapter"; and by Lawrence Matthew, Justice of Beaumont Chapter, on "Publicity Techniques."

Free Life Insurance Program Continues

In 1982 the Fraternity adopted a trial program of furnishing \$10,000.00 of Group Term Life Insurance for new graduates.

The program has proved so successful that it is now being continued and has recently been offered to 1982-83 graduates.

Under the provisions of the program, Group Insurance Activator Cards were sent to all 1982-83 graduates. All the member has had to do is fill in a permanent mailing address and other statistics and return in a postage pre-paid envelope. Certificates of insurance were then returned to the applicant.

PAD has paid the premium for such insurance and there's actually no cost or other obligation to the member receiving the insurance.

At the end of the first year of coverage, the member's insurance will automatically increase from \$10,000.00 to \$30,000.00 without any evidence of insurability. Such coverage may continue of a member desires of PAD's special low group rates.

The program also has a special feature in that triple benefits are paid if death occurs in an automobile accident.
