PAD Mobilizes Grassroots In Support Of LRE

The PAD Juvenile Justice Office is undertaking a new effort to mobilize its members in support of law-related education (LRE) on the grassroots level. The Office is in the process of establishing a network of Statewide PAD LRE Coordinators who will help to generate community support for LRE within their prospective states, particularly among PAD alumni and law students. The LRE Coordinator, a PAD alumnus, will serve as a liaison between the PAD Juvenile Justice Office and members of PAD with his/her state. The network is now capable of reaching out to PAD's in 23 states.

The potential of this new effort has been beautifully demonstrated through the efforts of PAD State Coordinator C. Joseph Roof, of Columbia, South Carolina. Brother Roof has been working closely with other members of the Palmetto Alumni Chapter to generate interest and support of LRE in South Carolina. He has received invaluable technical assistance from Jack Hanna, Esq., Project Director for the Carolinas' LRE Consortium and Project Director of Ways of the Law (South Carolina Educational Television Network).

Since November, 1982, Brother Roof and members of Palmetto Alumni Chapter have been able to reach at least 13 high school districts across the state through presentations to 6 regional school district meetings. School districts have responded enthusiastically and the Palmetto Alumni Chapter is actively working to develop a PAD "partnership" program to respond to requests from teachers for lawyers who can be available to act as resource persons in the classroom.

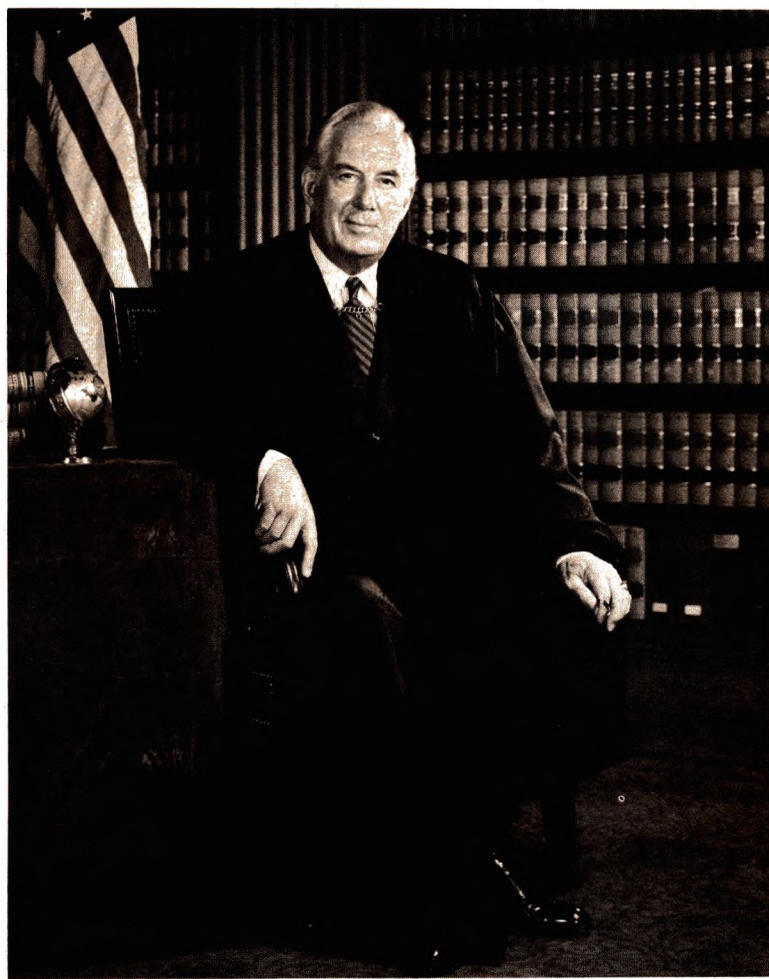
Roof made a presentation on LRE March 13, 1983, to the Richland County Bar Association, of which he is an Executive Committee Member. Members were very supportive and excited about the LRE concept. Richland is the largest County Bar Association in the state with an excess of 1300 members. Brother Roof is hopeful that LRE involvement by this Bar will provide a catalyst to other area bar associations. Palmetto Alumni Chapter plans to ask each County Bar Association to appoint a standing committee on LRE to help make lawyers available on a continuing basis to act as resource persons to teachers in their respective counties.

Mr. Roof and Jean Bergeron, Palmetto Vice Justice, attended a conference of the Carolinas' LRE Consortium in mid-February designed to promote LRE among school superintendents from North and South Carolina. Mr. Roof also appeared before a teachers training conference in Lexington, South Carolina on March 1, 1983.

The Juvenile Justice Office is hopeful that similar activity can take place in other states and would like to encourage interested PAD's to call 202-737-5151 for more information (collect calls will be accepted).

Law students from Rockefeller Chapter began their first week of providing resource assistance to local law-related classrooms in Albany, New York March 28, 1982.

Justice Louis W. Pierro received the valuable technical assistance of Eric Mondschein, Director of the Law, Youth, and Citizenship Project of the New York State Bar As-

sociation in organizing the project. Mr. Mondschein coordinated an LRE workshop for the Chapter and local teachers March 21, 1983.

Twenty law students are now actively involved in the project which will provide resource assistance to ten local high schools.

Henry Chapter members (University of Richmond, T.C. Williams Law School) have been providing resource assistance to three major public school systems in the Richmond, Virginia area since March 1, 1983. They have been able to obtain office space for the LRE project through T.C. Williams Law School Dean Thomas A. Edmonds and funding for a brochure to be distributed to local teachers and for a resource library from the Young Lawyers Bar Association in Richmond, Virginia.

Pre-Law Chapter Chartered at OSU

On February 20, 1983, Ohio State University established a new PAD pre-law chapter. The chapter was formed from the membership of the Ex Lege Pre-Law Club of Ohio State University.

Ceremonies took place at the OSU Law School with members of McKinley Chapter of PAD attending. Past International Justice Frank McCown served as installing officer for the 32 member group.

Faculty Advisor will be Joan E. Long, coordinator of judicial programs at Ohio State. Serving as Alumni Advisor will be attorney James Gallagher, an alumnus of OSU Law School now practicing in Columbus.

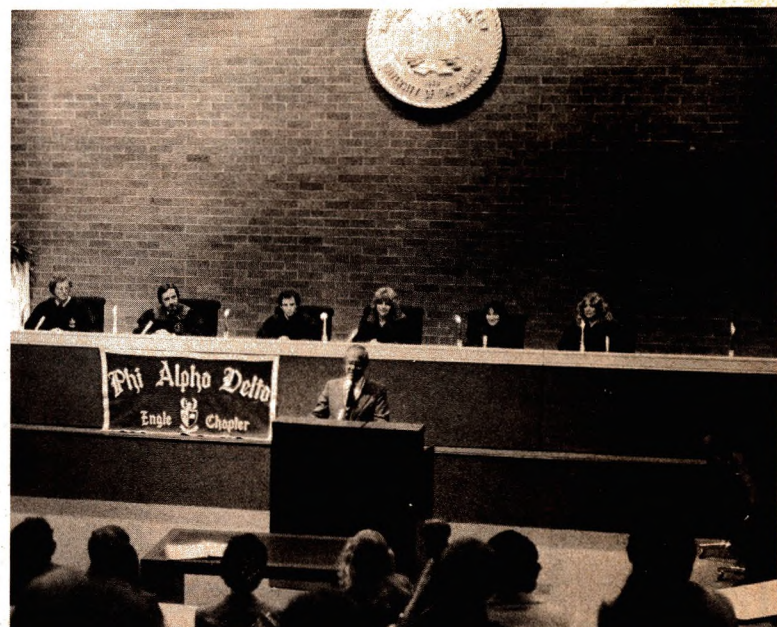

PAD's Public Awareness Dialogue Program

Phi Alpha Delta now has over 100,000 members and its number of living members makes it the largest law fraternity and the second largest law related organization in the nation, second only to the American Bar Association. It has long been the policy of the fraternity to refrain from partisan political campaigning or endorsements. That is, I believe, a sound policy and should be continued. There is room, however, for our organization to promote discussion of issues pertinent to the law and to the legal community.

It was for this reason that I appointed a committee last fall to prepare a list of current legal issues and a program outline for board adoption. Don Hutson, a past International Justice, was appointed chairman of the committee and at the winter board meeting the board adopted a "Public Awareness Dialogue Program to present current law-related issues of moment to the student, the law school, the profession, and the community." With the program authorized it is my hope that we will be able to present to the nation for review, discussion, analysis, and debate some two topics per year.

I would envision that the forum for each topic might vary. For instance one particular topic might better be presented by gathering a number of topic experts together for the production of a statement or paper that could be disseminated by the fraternity to the nation's law schools, faculty, and various publications for review and discussion. The topic might be presented by a P.A.D. sponsoring a discussion or by a debate between opponents and proponents of a particular questions. It is hoped that such discussion or debate would be covered by the media, perhaps public radio or television in order that a maximum number of people might be aware of the ideas brought out.

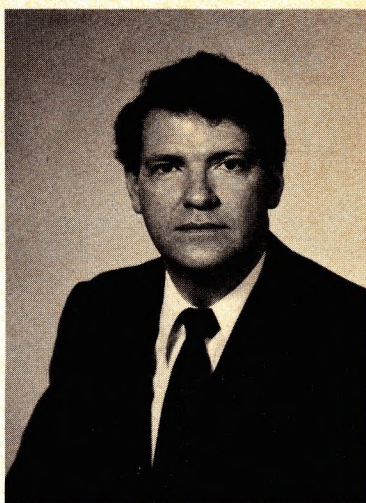
One of the first topics I hope our forum will cover is the direction of legal education in the nation. We have some 50,000 students entering law school each year. It has been estimated that what we generally think of as the practice of law or "hanging out a shingle" will absorb only half that number and even those 25,000 openings will decline in numbers over the next few years.

Will state bars automatically eliminate the other 25,000 graduates after they have spent three years and thousands of dollars to attend law school? Will an ever growing number of graduates increase the number of frivolous lawsuits clogging the court system thus adversely affecting the image of the legal profession? Is there a need for more specialization to be fostered by the law schools? Does the British system offer any advantages for us? Does the Canadian system offer any advantages for the states? These questions are all part of the general topic of legal education in the nation that need to be discussed.

Whatever the forum topic the goal would be for Phi Alpha Delta to use the "clout" of its membership to see that an issue important to the legal community and the nation as a whole be given a hearing. Careful planning and selection of topics to be considered is essential. But I believe that it is our duty as the leading law fraternity in the nation to see that issues of interest to the law school, the student, and the profession are given the forum they need to enable widespread discussion and debate of that issue's merits.

Edmonds Chapter at the Univer-



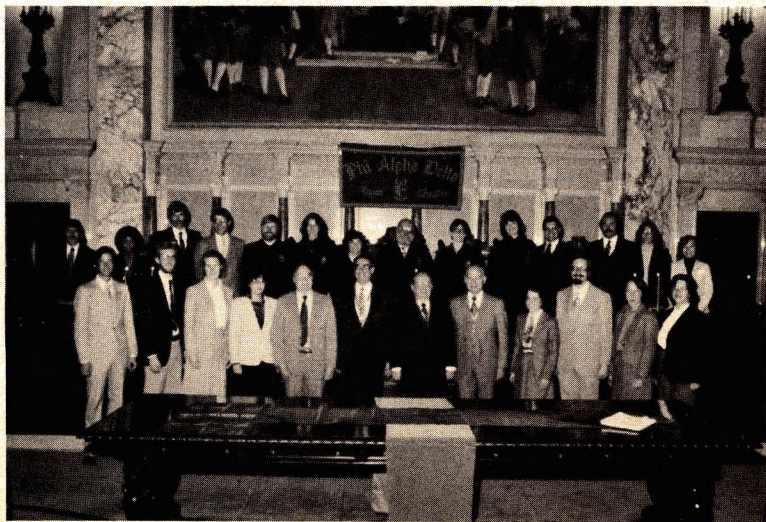

sity of Santa Clara School of Law sponsored a career planning seminar in Labor Law November 18, 1982. The purpose of the event was to provide information and guidance for students interested in pursuing a career in labor law. Conducting this seminar was attorney **Patti White**, representing management, and attorney **Robert Jesinger**, representing labor. The chapter has also initiated a Ride a Long Program with the San Jose Police

Department. Chapter Justice **Linda S. Anjoorian** has been nominated by the school to Who's Who Among Students in American Colleges and Universities for 1983.

Burr Chapter at Dickinson School of Law is sponsoring a program which provides free income tax assistance to area taxpayers who need help with preparing their tax returns for 1983 and who cannot afford to pay for professional assistance. **Mark Morrison**, a second year students, states that 45 law students had been trained in basic income tax return preparation and have qualified for the program by passing an examination prepared by the IRS.

During the Spring semester **Fletcher Chapter** at the University of Florida Law Center is hosting a wide variety of professional events. Probably the most popular of which is a field trip to the Florida Supreme Court in Tallahassee. There PAD's will have the opportunity to speak with Justices over coffee and donuts and to listen to oral arguments before the bench. Also scheduled is a field trip to state prisons. In addition, the chapter regularly provides seminar programs open to all students. These

include a helpful presentation for freshmen on their professors presented by students booking the class, seminars on how to prepare for final exams, where to look for clerking opportunities and what to expect. During the upcoming year, Fletcher Chapter is committed also to establishing a pre-law chapter.

The Fall semester provided the **Raymond Watkins Chapter** of Phi Alpha Delta, located at North Carolina Central University in Durham, North Carolina with an opportunity to provide energetic service to the law school community and the Durham area. After the Fall rush was over, 24 initiates were installed as members.

"Lawyers and Politics" was the first forum of the year. Panel members, all of whom are members of the North Carolina Bar, consisted of a city councilman, the city prosecuting attorney and two state representatives; a United States Congressman scheduled to participate was unable to appear due to airline reservation problems. The forum, attended by city residents and students addressed issues involving moral and ethical considerations confronting politicians who are members of the Bar.

The chapter also conducted its annual Thanksgiving Food Program to assist needy families in the Durham Community. This year, two families in the Durham Community were assisted through chapter efforts.

The Winter semester commenced with a memorial service commemorating the birth of the late Dr. Martin Luther King, Jr. This program was developed in conjunction with the Student Bar Association to honor the memory of the slain civil rights leaders.

The Watkins Chapter will also involve itself with the Law-Related Education Program. The chapter has made itself available to the Durham Public Schools to provide resource persons for classroom discussions as it relates to specific areas of the law. In addition, members will serve as coaches for Durham's entry in the statewide Mock Trial Competition which is sponsored by the North Carolina Board of Education for the state's high school students.

The **James Iredell Chapter** of P.A.D. and Campbell University School of Law in Buies Creek, N.C. hosted its fourth annual Iredell Banquet and Award Dinner on October 28th, 1982 at the Velvet Cloak Inn in Raleigh, N.C. The Iredell Award is given by the Chapter to the individual voted to have contributed the most to the entire legal community of N.C. The event was attended by the Justices of The North Carolina State Supreme Court and those of The North Carolina Court of Appeals. Also in attendance were **Jim and Linda Gill** (District Justice of P.A.D. District XXIII), the Faculty of Campbell School of Law, the recipient of this year's award, **Dr. John J. Broderick**, his wife Louise and their daughter, Mary Frances Kennedy; along with the members and guests of Iredell Chapter. The Guest Speaker for the evening was the Hon. **Rufus Edmisten**, Attorney General of North Carolina.

This year's honoree, Dr. Broderick, is a former Assistant Dean and Professor of Law at Notre Dame University where he served brilliantly for over 25 years. He came to Campbell at the School's inception and was its first Full Professor of Law and Assistant Dean. He is a nationally-recognized author and lecturer in the fields of Labor Law and Arbitration, having served as an arbitrator and member of the American Arbitration Association. A Phi Beta Kappa graduate of Washington and Lee, Dr. Broderick also holds degrees from St. John's and New York University, and gives annual lectures at the London School of Economics, Oxford University and the University of Paris. Affectionately known to hundreds of former students, colleagues and

firmed as "Chief," Dr. Broderick embodies the motto of P.A.D. with its daily service to the student, the school and the profession. Over 120 persons joined with Dr. Broderick as he received an engraved plaque and a Book of personal letters from well-wishers which included; Gov. James Hunt, Governor of N.C.; President Norman Wiggins of Campbell Univ. and Father Theodore Hesburgh of Notre Dame; and International Justice Charles Taylor.

Murphy Chapter at the University of Detroit School of Law held its PAD Federal Motion Day last Spring in the law school Moot Court Room. Presiding was U.S. District Judge **John Feikens**. The purpose of the function was to appoint first-year students with federal judicial procedure and also to enable them to hear motions made by attorneys in actual cases before the Bar. Dean **Carl Selinger**, and Assistant **Dean Lea Vaughn** and other faculty members also attended.

Fleming Chapter at Nova University School of Law held its Spring cocktail party last April at the beautiful home of one of its members.

Woodrow Wilson Chapter at Cornell University Law School sponsored a birthday party last October to celebrate the 50th anniversary of the law school building which bears the name of Myron Taylor Hall. Over 150 people attended and enjoyed festive balloons, champagne, punch and a table full of sheet cakes. Toastmaster was **Dean Peter W. Martin** gave a toast as follows: "Two weeks and 50 years ago, a distinguished group met here — but no more distinguished than this group." He told the crowd that Myron Taylor spoke of his hope that the building would bring alive an education that causes students to be leaders. Dean Martin held up his glass and stated "A toast to this 50 and to the next 50."

District XV has enjoyed an outstanding year of initiations. The District has excelled with creative programming, reactivation of chapters and the firm establishment of the Juvenile Justice Program at **Kennedy and Patterson Chapters**.

Leader of the district has been **Paterson Chapter** with 80 new initiates, and making a name for itself also has been **Kennedy Chapter** which increased its number of initiates from 3 last year to 44 last semester.

Jackson Chapter at Rutgers Newark Law School has doubled its membership rolls, thanks to the good work of Justice **Bruce Blanco**.

DeBracton Chapter's traditional Holiday Food Basket Drive for the needy has also been very successful.
