PAD Receives New Federal Grant For Law-Related Education

Phi Alpha Delta has been awarded its seventh consecutive grant of federal funds by the Department of Justice in Washington for the continuation of its law-related education program on a nation-wide basis. By the signature of Alfred S. Regnery, Administrator of the Office of Juvenile Justice and Delinquency Prevention, the PAD grant program will continue until August 1985. This action brings the federal funding support to a level exceeding \$1 million over the period of the Fraternity's service in this field which began in February 1979.

11 Host States

The 1984 LRE program will concentrate Fraternity program efforts in 11 host states, including the states of California, Colorado, Florida, Hawaii, Illinois, Indiana, Michigan, Nevada, Oregon, North Carolina, and Tennessee.

Since the Miami Beach convention last August, PAD chapters in the 11 host states have been urged to adopt and operate local LRE programs. Both law school and alumni chapters in these states are being supported by the network of PAD Statewide LRE Coordinators, who now serve in almost 40 states of the union.

An excellent example of such leadership is that of Marvin Moss, of Ft. Lauderdale, Florida, who also served as co-chairman of the summer convention. Recently, a statewide LRE conference was held in Miami on December 13, 1984. PAD organized and paid for community teams to attend this conference from St. Petersburg, Gainsville, Tallahassee, Ft. Lauderdale and Miami, cities where PAD law school chapters are located. Such teams included law students, faculty advisors, alumni lawyers, and local educators. Training workshops to assist them in developing local LRE programs were conducted by Brother David Schimmel, who travelled to the conference from Amherst, Massachusetts. His workshop on commuity participation was highly successful. Marvin Moss was assisted by Martha McQuade of Washington, D.C., who also serves as the PAD Statewide LRE Coordinator for Maryland.

Chapter Interest Heightened

The October 1984 Reporter carried a lead story on page one, urging law school and alumni chapters to establish LRE programs. This encouragement, coupled with the Convention workshop in August on lawrelated education, "has led to an unprecedented creation of chapter interest in law related education," according to Robert E. Redding, past International Justice and Project Director of the Juvenile Justice Office in Washington, D.C. Letters, telegrams, telephone calls and conferences have demonstrated a very strong interest of law student and alumni PAD members in the LRE program. Examples include the recent requests for LRE materials from (1) Waite Chapter at the University of Dayton; (2) Murphy Chapter at the University of Detroit (which did mock trial work in 1983-84); (3) Hoynes Chapter at the University of Notre Dame; (4) Lawson Chapter at the University of Missouri; (5) S. Douglas Chapter at Southern Illinois University; (6) Harlan Chapter at the University of Oklahoma; (7) Kenison Chapter at the Franklin Pierce Law Center in New Hampshire; (8) Rockefeller Chapter at Albany Law School; (9) Touro Chapter at Touro Law School in Huntington, New York; and many others.

Symposium Held

On October 13, 1984, a three-state symposium on law-related education was held in Washington, D.C., attended by PAD law school and alum-

ni chapter representatives from Virginia, Maryland, North Carolina, and the District of Columbia. This symposium included a special report on the activities of the Office of Juvenile Justice and Delinquency Prevention by Terry Donahue, then-Director of the National Training Division which was in charge of the LRE program. At the conclusion of this symposium, coordinated by an effective team of Lisa Lahrman, Martha McQuade, Colin Connelly, and Joe O'Brien, all such chapters committed themselves to conduct an LRE program during the current school year.

Story Chapter at DePaul University in Chicago held a "Juvenile Justice Day" for all kindergarten-toeighth grade classrooms in a nearby public school on November 8, 1984. In addition to PAD activities in the 11 host states, PAD has participated this fall in special LRE workshops in non-host-site states, such as Rhode Island, Massachustts, and Pennsylvania. Phi Alpha Delta has also succeeded in generating support for lawrelated education by the government of Puerto Rico through the assistance of District Distict Justice Hector Mendez-Loucil and other alumni of San Juan. In the spring, workshops will be scheduled to train teachers and resource persons who will provide LRE to the ninth grade students of the Commonwealth.

South Bend Model

Of Special interest is the development of a "South Bend Model" by Hoynes Chapter at Notre Dame, that will help other chapters carry out such projects as (1) using high school students on law school moot court juries; (2) arranging police ridealongs for teachers and students; (3) conducting local field trips to visit juvenile justice facilities; (4) providing resource persons services in local classrooms; and (5) assisting in coaching local mock trial teams in the high schools.

The expanding PAD program in law-related education has also received the key support of volunteer alumni who serve as PAD Statewide LRE Coordinators in some 40 states of the union (list enclosed if space is available).

Deans To Play Role

Phi Alpha Delta has also played a lead role in seeking to stimulate support for LRE by the law school deans of America. In cooperation with the National Institute for Citizenship Education in the Law, PAD has extended an invitation to all law school deans to attend a special breakfast on law-related education on January 4, 1985 at the annual meeting of the Association of American Law Schools at which it is hoped to generate a support resolution for lawrelated education. Brother David McCarthy, former Dean at the Georgetown University Law Center and pioneer in LRE for the Fraternity, will be a major spokesman. Personal invitations have been extended by Director Redding to the 33 PAD law school deans expected to attend the AALS breakfast session.

PSJ John L. Griffith Dies

John L. Griffith who served as Supreme Justice of the Fraternity from 1958 to 1960, died recently in Denver, Colorado

Brother Griffith, long a mainstay of PAD in the Denver area and a member of Gunter Chapter at the University of Colorado, was still practicing law at the time of his death and had practiced for some 55 years. He was in partnership with his sister Mary and maintained offices in the Midland Savings Building.

He served a number of years as District Justice for the areas of Colorado and Utah and served as Second Supreme Vice Justice from 1954 to 1956 and as First Supreme Vice Justice from 1956 to 1958.

He was also a past Potentate of the El Jabel Temple Nobels of the Mistic Shrine, past President of the Council of Churches of Colorado and well known for his prominence in Denver civic affairs.

in recent Washington sessions sponsored by the Freedoms Foundation at Valley Forge relating to citizen rights and responsibilities. These VIP conferences were addressed by Brother Waren D. Burger, Chief Justice of the United States; Brother Strom Thurmond, President Pro Tem of the United States Senate, and Edwin Meese, Assistant Counsel to the President. It will be recalled that the Freedoms Foundation conferred a highly prestigious award on PAD in 1983 for its work in law-related education.

Sports And Law

A new and intriguing LRE program has been developed by PAD consultant Linda Riekes of the St. Louis Public Schools and others for use in 7th grade classrooms, called "Sports and Law." Materials about this new curriculum, involving local professional sports teams, have been distributed to all PAD Statewide LRE Coordinators.

The Fraternity is also developing additional resource materials for use early in 1985 by the legal profession and school systems in LRE classrooms. They will include resource guides on law enforcement officer training, judicial training and jury education, PAD Partnership (lawyereducator) Program, and the best usage of resource persons by educators.

Recognition Received

What is clearly evident from this summary of PAD activity is that the Fraternity has achieved an increasingly higher visibility in the circles of government and the private sector for its contributions to juvenile justice and delinquency prevention. In a new brochure published by the American Bar Association about law-related education, PAD is quoted as asserting its support for LRE because it "encourages all local communities to join the trend toward nationwide law-related education. Local leaders in education and the law should give priority to offering this low-cost program to all school districts.'

It is now widely accepted that the long-term success and continuity of law-related education in the local communities of America is dependent on the grassroots leadership and support of local community leaders, a role for which Phi Alpha Delta is particularly suited.

News From The Law School Chapters

U.S. Sen. Simpson Honorarily Initiated

PAD's newest law school chapter, Blume Chapter at the University of Wyoming, initiated United States Senator Alan Simpson as an honorary member of the Fraternity on October 8, 1984. Representing the International Executive Board at the initiation was former District IV Justice Doglas Tisdale who is fast gaining a reputation as one of Colorado's most outstanding trial attorneys. Also participating in the ceremonies was chapter Justice Colin Simpson who took particular pleasure in bringing his father, Senator Simpson, into the brotherhood of PAD.

Other dignitaries who are honorarily initiated on the same occasion were Wyoming Supreme Court Justices Joseph Cardine and Charles Brown


