Student and alumni members are being urged to make airline and hotel reservations early for the 45th Biennial Convention of the Fraternity which will be held at the Konover Ramada Renaissance Hotel in Miami Beach, Florida August 1-4, 1984.

Florida PAD's under the leadership of local arrangements cochairpersons Marvin Moss and Richard P. McCully are sparing no efforts to assure members and families attending the Convention a most enjoyable time. Moss is a former District Justice for Florida and McCully, a former Executive Secretary of the Fraternity. Also assisting will be members of the newly chartered Ft. Lauderdale-Broward County Alumni Chapter and the Miami Alumni Chapter as well as local law school chapters.

Hotel reservations may be made by writing the Executive Director at P.O. Box 3217, Granada Hills, California 91344-0217. Extremely favorable rates for the luxurious Ramada Renaissance have been negotiated. All rooms will be priced at \$38.00 whether single or double.

Members are urged to arrive late afternoon on Tuesday, July 31st in order to attend the International Justice's reception which will be held that evening. Opening ceremonies and keynote address by a PAD of national reputation will take place at 9:00 Wednesday, August 1st.

The 45th Biennial Convention will offer members an unusual opportunity to work and relax with law students, attorneys and judges from many different backgrounds, to experience full scale parlimentary proceedings and to make a personal contribution to the current programs and future development of the second largest legal organization in the world. Long range benefits to law chapters will be many as delegates will experience the scope of our International Fraternity firsthand and return to schools with the exhilaration of fresh ideas and a new vision of PAD programming at the local level.

Chapter Workshops

In the past a series of 4 chapter workshops have been conducted by International officers of the Fraternity and have proved to be the most popular aspect of the Convention. Tom C. Clark Award

The annual Tom C. Clark Award for Equal Justice Under the Law will be presented at the closing banquet. This coveted award is given annually to a member of the profession who has made a significant contribution to "Equal Justice Under the Law" and is made in memory of former United States Supreme Court Associate Justice and PAD International Vice Justice Tom C. Clark.

Family Entertainment

Special entertainment is being arranged for spouses and families in attendance.

Monetary Allowances

The Fraternity will provide the actual cost of one round-trip airline fare to Miami Beach, hotel accommodations and a subsistence allowance for each day of travel to and from the Convention and each day while at the Convention from one delegate from each law school and alumni chapter in good standing.

The airline allowance is computer on the basis of Supersaver or the most economical fare available as of March 1st.

Chapter Delegates

Each law school and alumni chapter is entitled to have two delegates and two alternates and as many additional persons as desired.

Qualifications

Certain qualifications must be met for a law school chapter to qualify for the monetary allowance. Basically all fees, forms and reports must have been filed with the Executive Office prior to the Convention. Each chapter will be notified from time to time of any deficiencies.

In order for an alumni chapter to qualify for the monetary allowance it must meet the following requirements: Have paid the annual alumni chapter tax of \$15.00 per year for the two fiscal years commencing July 1, 1982 and ending June 3, 1984; Must have held at least two meetings during the period of July 1, 1982 to June 30, 1984 with an attendance of at least 10 persons at each meeting; Must have elected officers and have reported the same to the Executive Office.

Pan Am Official Convention Airline

PAN American World Airways has been selected by the Fraternity as the official airline carrier for the 45th Biennial Convention to be held in Miami Beach, Floria.

PAN AM has arranged with PAD to provide special discounted fares from cities it services subject to space availability.

PAN AM offers members a discount of \$20.00 off its Supersaver fares and a waiver of restrictions for Supersaver fares.

In addition, PAN AM will provide a complementary drink coupon to each person flying PAN AM to the Convention, as well as each person flying PAN AM home from the Convention.

For reservations and ticketing, PAN AM offers you a special nation-wide toll free telephone number to their Convention desk. Reservations may be made by dialing 800-327-8670 outside of Florida and giving Convention number CVN34203. For those within Florida, the number is 800-432-2533, Convention number CVN34203. It should be noted that the special Convention fares will be available only for those making air reservations through the tollfree 800 numbers.

Although reservations must be made through the PAN AM Convention desk, reservations may be made by members directly or through their travel agency. Tickets may be charged to any major credit card or paid for through one's travel agency.

PAN AM will also co-host an orientation program with the Miami Convention Committee for spouses attending the Convention. The program will include information on shopping and attractions to visiting Miami Beach.

PAD is pleased to be working with PAN AM to assure that our 1984 Convention is a successful and memorable one.

Juvenile Justice Office News

Members of the Rockefeller Chapter at Albany Law School in Albany, New York have met with Eric Mondschein. Director of the Law. Youth & Citizenship Program (LYC) of the New York State Bar Association in order to coordinate a joint law-related education into the classrooms. The New York State Bar Association is sponsoring a banquet in conjunction with the training session for the law students and teachers on February 28, 1984. The Phi Alpha Delta Juvenile Justice Office is supplying the Resource Guides that will be used by the law students and the teachers.

Paul Austin, Justice of the Vaught Chapter at Oklahoma City University, has received permission from the local school district to begin a law-related education project in all of the local schools, including 4 high schools and 8 junior high schools. Approximately 20 chapter members will participate in the initial project and Justice Austin reports that members are very excited about getting the project underway.

Virginia Schmult, Co-Chairman of the Juvenile Justice Program at Washington & Lee University, has reported to the Juvenile Justice Office that Staples Chapter is continuing its successful LRE program in 1984. Presently, chapter members are visiting six area schools acting as LRE resource persons and conducting in-class mock trials. Additionally, they have area high school students come to the University to act as jurors for their trial practice classes..

Two new PAD alumni members have agreed to assist the Fraternity as Statewide LRE Coordinators, Anthony List for Pennsylvania and Sam Fowler for Tennessee.

Tony List is a practicing attorney in Media, Pennsylvania and served as a highly effective District Justice in 1968 to 1970. He has volunteered to assist PAD in its Constitutional Bicentennial program to be initiated in Media this year.

Samual F. Fowler, Jr. was a member of Jefferson Chapter of PAD at the University of Virginia in the early 1950's who became a prominent practicing attorney in Knoxville. He had agreed to coordinate the Fraternity's Constitutional Bicentennial program in Knoxville that will get under way this year.

of Instruction about initiating a lawrelated education program throughout the Commonwealth of Puerto Rico. Such plans are currently under active development, and will be coordinated by Hector Mendez-Loucil, PAD's District Justice in Puerto Rico.

In October 1983, the Office of Juvenile Justice and Delinquency Prevention approved a supplemental grant award to PAD in the amount of \$60,000. This award included \$30,000 of Federal funds and \$30,000 of matching non-Federal funds (\$5,000 by the North Carolina State Government and \$25,000 by the Michigan State Bar Association). This funding has been used to pay for a continuation of the Jury Education program in North Carolina using computer software for 9th grade students and also to finance the continuation of the Michigan statewide LRE program in 1984.

The Juvenile Justice Office encourages all those chapters that are currently participating in law-related education programs to contact the Washington Office and report on the status of such programs. Pictures are also welcome for inclusion in FOCUS ON YOUTH, the Juvenile Justice Office's newsletter or *The Reporter*.

The Executive Director, Fred Weitkamp, has announced that a law-related education workshop will be held at the PAD Biennial Convention to be held in Miami, Florida next August. All law school chapters active in LRE projects this year will be invited to bring information about their programs to facilitate a continuing expansion of law student involvement in the field of law-related education.

PAD Audio Cassette Library Expanded

The PAD lending library of audio cassettes on continuing professional education has been substantially enlarged.

The cassettes which are professionally produced by the American Law Institute — American Bar Association Committee on Continuing Professional Education are available to dues paying alumni free of charge with the member only being required to pay costs of postage.

Among the many courses of study which are now available are the following: Buy-Sell Agreements with Life Insurance Funding, Computers in the Law Office, Professional Incorporation of Law Firms, Managing your Law Firm in the 80's, A Practical Guide for Young Lawyers, Law Practice Management, Federal Income Taxation and Estate Planning after ERTA, Pension Plans and Compensation for the Small Employer, and Will Drafting.

Other courses available include Real Estate Taxation and Planning after ERTA, Time Sharing — a New Dimension in Real Estate, Courtroom Evidence and Tactics, Extensive Courses on the Trial of an Action in the Federal Courts, Jury Selection, Cross Examination, Sentencing Procedures, Motion Practice, Direct Examination, and Fundamentals of Secured Transactions.

Still others include Tax and Business Planning for the Small but Growing Business, Advance Tax Planning for Real Estate Transactions, Arbitration in the Law, Products Liability, Condominium Conversions, Environmental Law and Basic Law of Pensions and Deferred Compensation.

PAD and the Constitutional Bicentennia

In the summer of 1981 Phi Alpha Delta's Board adopted a resolution stating that as the second largest organization in the legal profession, behind only the American Bar Association, it was fitting for the fraternity to volunteer to become associated with all other participating organizations in the planning and development of observances of the bicentennial celebration of the signing (September 17, 1787) and ratification (June 21, 1788) of the United States Constitution.



In 1982 Phi Alpha Delta submitted a proposal to the federal government and was the only legal organization to receive a pilot grant to plan a national program of celebration. The Phi Alpha Delta plan calls for the use of its full fraternity resources. including its student and alumni members along with other community leaders, to carry out an education program about the first amendment.

We feel a duty to contribute to the public's understanding of the constitution for two reasons: (1) the document is the foundation of our legal system, and (2) there is an appalling lack of understanding of the Constitution.

In December, 1979, a Gallup poll revealed that 76% of those polled did not know what the first amendment is or what it deals with. The breakdown of the poll was even more appalling. The national figure of 76% was worse when broken down into groups or individuals who may most need the protection of the first amendment. The following percentages of the population did not know of the contents of the Constitution or else their knowledge was inaccurate: 80% of high school students, 85% of non-whites, 89% of those below the \$10,000.00 annual income level, 81% of women, and 80% of those over the age of 50.

Preparation for the 1987 celebration will need some of your time. Help Phi Alpha Delta make the 1980's a decade of constitutional literacy. With 1984 already here, the United States Constitution is a great strength of the free world. It can be an even greater strength if the majority of Americans know what it is and what it means.




Fred McClure, Baylor Chapter, Baylor University, has been appointed Legislative Director and Counsel to United States Senator John G. Tower.



In a recent publication he stated, "There is reason, on occasion, to view and evaluate legal education through the eyes of the law student. From this viewpoint one of the functions of legal education is to change the thinking and acting of the student from the lay to the professional level. One of the features of this change is increased emphasis on the responsibilities of the lawyer. In the process of legal education both student and instructor have functions to perform. If the operation of these functions is cooperative rather than adversary the desired results are more frequently achieved.

Judge Mildred L. Lillie, Associate Justice of the Court of Appeal of the State of California for the past 25 years, recently received accolades and congratulations from members of the Bench and Bar throughout the State of California. 
