45th Biennial Convention a Resounding Success

The 45th Biennial Convention of the Fraternity held at the Konover Ramada Renaissance Hotel in Miami Beach, Florida, August 1-4, 1984, has been acclaimed as one of the finest Conventions ever.

Over 300 persons were in attendance representing 168 chartered law school chapters and 85 alumni chapters.

A pre-convention reception was held for all officers on Monday, July 30th and appropriate gifts were presented to International Justice Charles Taylor.

Registration was held Tuesday afternoon and was followed by the International Justice's Reception for all members and their families. The Ramada Renaissance Hotel sponsored the reception which served as an ice breaker for all delegates and

Wednesday morning, August 1st, the Foyer outside of the convention meeting hall was the site for all members to gather and enjoy coffee, milk, tea and sweet rolls. It also provided delegates with an opportunity to view the numerous displays which had been prepared by members of the Executive Office Staff. The displays depicted Outstanding PAD Women Leaders, Chapter Publications, a large map of PAD Chapters, Outstanding World Leaders who are PAD's, PAD Governors, and other displays of considerable interest.

At 9:00 a.m. the International Officers processional led by International Justice Charles Taylor officially opened the 45th Biennial Convention. The processional was followed by a showing of the filmstrip on the history of the Fraternity which told of the origin of PAD and traced

its history over the years and up until the convening of the 45th Biennial Convention.

After welcoming comments by various dignitaries and the introduction of the 40 International officers and District Judges seated at the twotiered head table, the keynote speaker was introduced. The Fraternity was extremely fortunate to have an outstanding keynote speaker in the person of the Honorable Howard T. Markey, Chief Judge of the Court of Appeals for the District of Columbia. Judge Markey, a member of Webster Chapter, was escorted to the podium by an honor guard. He spoke eloquently and had a message for all in attendance. His entire address is reprinted elsewhere in this issue.

New Chapters Recognized

Law school chapters which were recognized as having been chartered since the 1982 Convention were Blume Chapter, University of Wyoming; Ramos Chapter, University of Puerto Rico; Russell Chapter, Georgia State University; and Touro Chapter, Touro Law School. Law School and Alumni Chapters Urged to Adopt LRE Programs

Robert E. Redding, past International Justice and Project Director of the Juvenile Justice Office, urges all law school and alumni chapters to develop LRE Programs.

Steps which may be followed by law school chapters in establishing a program are as follows:

- Chapter Justice should present idea to members at next chapter meeting. Be sure to stress the following:
 - a. Need for law-related education: to improve citizenship skills of young people today and to make them more knowledgeable of their legal rights and responsibilities.
 - an important method of reducing juvenile delinquency which has been proven to be effective.
 - b. Benefits to the Chapter and to law students who get involved:

 Satisfaction in serving community and helping young peo
 - Helpful to Chapter image; generates publicity and encourages membership.
 - Law student makes contacts in community which may be beneficial in transition from school to work world.
 - Law student learns to translate "legalese" into layman's language a skill which will be helpful in future dealings with clients.
 - —Interaction with young people through classroom instruction or other LRE activities helps law student synthesize legal knowledge gained in school.
 - —It's fun! Working with young students can be a truly enjoyable diversion from the daily pressures of law school (Continued on Page 8)

Stanley H. Kohn Is Elected International Justice

As is customary at PAD Conventions, the last item of business for the 45th Biennial Convention was the election of International Officers.

Heading an outstanding slate of officers for the 1984-86 biennium is Stanley H. Kohn of Columbia, South Carolina who was elected to PAD's highest office, that of International Justice.

Stan Kohn has served as a member of the International Executive Board since 1976 and served a number of years as District Justice.

He graduated from the University of South Carolina School of Law in 1968 and while in law school was Justice of Pinckney Chapter which named him as its Outstanding Member in 1967.

He founded the Family Court Volunteer Program which was named Outstanding Volunteer Project in the Nation in 1974. He served as a resource consultant to the Legislature in the drafting of South Carolina's statutes of child abuse and neglect. After graduation from law school, he engaged in private practice for 13 years and then joined the South Carolina Department of Social Services where he is serving as General Counsel.

Miller, New Vice Justice

Jack L. Miller of Lebanon, Missouri was elected to the office of International Vice Justice. He was first elected to the International Executive Board by the 1974 Toronto Convention. At the time of his election, he was a 2nd year law student at the University of Missouri — Kansas City School of Law. He has served on the Board as Marshal, International Secretary, International Treasurer and International 2nd Vice Justice.

He is a prosecuting attorney for Laclede County, Missouri and is in a law partnership with former International Justice Don Hutson.

Taft, 2nd Vice Justice

Homer S. Taft of Bay Village, Ohio, a practicing attorney in the suburbs of Cleveland, Ohio was selected to the office of 2nd Vice Justice.

Brother Taft was initiated into Hay Chapter at Case Western University where he served as chapter Justice.

Following graduation, he served as Law Clerk to the United States Supreme Court of Appeals for the Sixth Circuit and in 1971 opened his office for the practice of law.

He is a former Justice of the Cleveland Alumni Chapter, former District XI Justice and served as Convention Arrangements Chairman for the 1978 Cleveland Convention. He was elected to the International Executive Board as International Advocate in 1980 and has served four years in that position. Crigler is new Advocate





11:00 a.m. and was followed by an orientation session for families attending the convention.

Chapter Workshops

Three chapter workshops were held that afternoon, which covered topics designed to assist law school chapters in their organization and development.

The workshops included the following: "Utilizing Services Available from International" - Executive Director Fredrick J. Weitkamp, Chairman, International Treasurer Norman Owen and Executive Secretary Karen Onifer, Panelists; "Increasing Chapter Membership and Improving Chapter Image'' - Coordinator of District Operations John F. Weitkamp, Chairman, International Proctor Ben Hyink and former Executive Secretary Ron Winter, Panelists; "Organizing and Programming Your Chapter" - International Vice Justice Stanley Kohn, Chairman, International Historian Rick Pearson and Executive Secretary Nora Barson, Panelists.

Booklets were distributed to all workshop attendees which detailed the topic covered by each individual workshop and provided indepth discussions of the subjects which were presented. Each delegate was urged to take the materials back to his or her chapter for future use.

That evening, everyone boarded busses and traveled to Ft. Lauderdale to the waterfront where they boarded the "Jungle Queen" and journeyed among the Ft. Lauderdale waterways along Millionaires Row to the Jungle Queen Island. At the island everyone was served an "all you can eat" dinner consisting of ribs, chicken and shrimp.





Convention Action

Action taken by the 45th Biennial Convention included the following:

Initiation Fee Increase

After hearing reports predicting an extensive budget deficit for the current fiscal year, the delegates by an overwhelming majority adopted an amendment to the International By-Laws increasing the initiation fee for law school chapters to \$45.00 per person effective October 2, 1984 and to \$50.00 effective July 1, 1985. A By-Law Amendment was also adopted which provided that the initiation fee for alumni should be \$10.00 more than the law school initiation fee then in effect.

Publications

- 1. Recommended that the International Executive Board study the feasibility of charging for the Business Reference Directory.
- 2. Recommended that the International Executive Board study the feasibility of soliciting advertising in the Directory.
- 3. Recommended that available funds first be channeled to the publication of the Directory then to the publication of the History.

Alumni Advisors

- 1. Changed the title of Alumni Advisor to Alumni Coordinator.
- 2. Determined that a new manual should be drafted for the Alumni Coordinator position.

Professional Programming

1. Recommended various changes to the Professional Programs Manual

PAD Concerns

- 1. Recommended that the International Executive Board appoint one or more voluntary Regional or District Alumni Liaison persons for districts to reactivate alumni chapters and promote alumni participation.
- 2. Recommended that there be included in the next Biennial Convention a workshop designed to enable alumni delegates to share ideas on participation and activities in their alumni chapters.
- 3. Recommended that the Board consider the possibility of allowing delegates to select Convention chapter workshop meetings to be attended.
- 4. Recommended that a "How to" workshop be included in the next Convention to address the needs of troubled chapters.

Resolutions

1. Recommended the adoption of various resolutions of appreciation for outstanding services rendered to the Fraternity.

Professional Responsibility

- 1. Recommended that the editor of **The Reporter** be encouraged to include items within the area of Professional Responsibility in **The Reporter** on a semi-annual basis.
- 2. Recommended the adoption of suitable slogans and logos to remind members of the need to maintain high standards of professional responsibility.
- 3. Recommended that the Board prepare appropriate language to be added to the alumni representative portion of the initiation ceremony defining and exemplifying the concepts of professional responsibility, ethics, confidency and integrity.
- 4. Recommended that the International Executive Board reaffirm its commitment to the use of the Ritual at the opening and closing of all chapter meetings.









On Love and Law — The Lawyer as Peacemaker

By Chief Judge Howard T. Markey, U.S. Court of Appeals, District of Columbia, Webster Chapter

(The following keynote address was delivered to the 1984 International Convention by Judge Markey)

It is an honor to appear before my own beloved PAD. In my almost 40 years of membership, PAD has earned the allegiance of more law students and lawyers than any other fraternity and has become the largest international legal organization honored for public service and looked to for leadership. PAD is not best, however, because it is biggest; it

Contrary to popular canard, Shakespeare put the words, "The first thing we do, let's kill all the lawyers," into the mouth of Dick, the butcher, who knew that if even one lawyer remained alive the peoples' rights would have a defender and Cade's plan for dictatorship would fail.

That responsibility of the lawyer has never been more needed. The triumph of good over evil must come from those privileged to have been educated. The extent of the lawyer's responsibility comes clear when it is realized that we have been privileged to join the 1/4 of 1% of the world's people who have ever set foot in a college — and the 1/100 of 1% of the world's people granted a juris doctor degree.

Certainly we face problems massive problems — in meeting our responsibilities. But solving problems is the sparkle in the wine of life and law — the fun of living. Life with absolutely no problem would be a total bore. I propose to visit with you for these few moments about just one problem, but it is a big one. On our solving it much else will depend. That problem can be stated as "how can we put more lovin' in our lawyerin'?"

A favorite song of my youth was 'Love Makes the World Go Round.' It was and is a sweet thought, if we mean love for human beings. It is not so sweet if we mean love of power, of money, or of "winning." There is no question that love makes the world go; the only question is, "which way?" If our families, our society, and the administration of justice be the objects of our love, we can help move our part of the world toward sunlit uplands of peace and harmony. If money, power, and winning be the sole objects of our love, we move the world back toward the caves.

The problem of bringing love to the practice of law is rarley if ever discussed. As far as I know, there are no law school courses entitled "Love and Law — The Lawyer as Peacemaker." Yet I put it to you that nothing is more important to the continued life of the legal profession. For the legal profession is not an abstraction. It is people.

That the administration of justice is people-intensive adds a special importance to that part of PAD's Constitutional Statement of Purpose that reads: "To inspire the virtues of compassion and courage.

What is our daily, constant attitude toward clients, adversaries, partners, judges, magistrates, professors, witnesses, secretaries, clerks, and all the other people with whom we must work as we practice our profession?

land last year. At that rate, assuming no duplication and no increase in filings, every human being and every business in America would be involved in a lawsuit in the next five years. We re rapidly exchanging that fine advice, "Love thy Neighbor" for the command "Sue thy Neighbor."

Not all those lawsuits were unnecessary, but far too many were. Not every unnecessary lawsuit was caused by unloving lawyers, but far too many were. What a practical and magnificent contribution we can make to our society's most vital and precious need - justice — if we forego the blind and immediate rush to court — if we refuse to serve as merely a conduit to the nearest courthouse — if we refrain from the legalunacy apparent in so many of our frivolous cases — if we delay a reach for the gladiator's sword, while we serve first the gloried role of the peacemaker.

Giving love a chance does not mean abandoning the vigorous advocacy for which we are trained. Peacemaking is not surrender. On the contrary, it takes a special skill, a thorough knowledge of the facts and the law, first to see that the best true interest of the client lies outside the courtroom, and then to serve that interest as peacemaker. Indeed, peace itself requires advocacy. To grasp the sword is easy. To bring peace between disputants is hard, requiring the highest form of advocacy. In advocating peace with opposing counsel and with our own clients, we should remember that the transcendance, the integrity, and the majesty of the law can be as well exemplified in a lawyer's office as it can in a courtroom.

In our increasingly technological world, a world of big governments, big businesses, and big institutions, the individual's need for equality, consideration, and fair procedures for justice itself — can get more easily lost. The threat is insidious, for it walks on little cat feet of separate, individual denials of the respect due the humaneness of this person here and that person there. But of all professionals, ours should be above denying the humaneness of any person. Of all persons, lawyers are especially charged with the promotion of human freedom, for as history teaches, only law can save freedom without revolution. But just being lawyers is not enough. After all, Hitler had lots of lawyers.

So, it seems to me, we have a choice. We can go on making us a nation of nothing but statutes, a lawdrenched, legalistic, litigious society. We can go on putting more and more of the peoples' eggs into the judicial basket until it collapses and with it the judicial process and the administration of justice. Or we can elect to exercise the lawyer's highest calling. We can become peacemakers. We can seek always and first the calming grace of settlement. We can help our society soften its cutting edges. We can help our fellow Americans reconcile their rights and realize their re-

sponsibilities. We can place conciliation and consensus before conflict. And, when all else fails and we must go to court, we can bring our love to bear against wasteful delay, abuses of discovery, and actions unfair to a just result. We can show that when winning requires abuse of the judicial process, winning isn't worth it — for then everybody loses, including the lawyer who thought he or she won. Though no lawyer can expect always to win, every lawyer can remind us daily that if we lose our dedication to justice nothing else will matter.

You have all studied the Declaration of Independence and the Constitution. Look again and you will find role models among those who started our nation. Note that they pledged their lives, their fortunes, and their sacred honor - not to a higher standard of living, not to a larger gross national product, not to the interest of any pressure group — but "to each other." So too may we pledge our professional lives, our fortune, and our sacred honor, to all those with whom we come into contact in the practice of law. If we do, we can help bring to our profession a rebirth in an atmosphere of concern for each other not unlike that in which our nation was born just 200 years ago. In a very real sense, I am proposing that our profession be given a new start — a new start in which lawyers choose to bring their love to the law and to serve the role of peacemaker — a new start that can revolutionize

our profession. But if we would make our maximum contribution to the preservation of justice, peace, and freedom, we must define for ourselves a personal philosophy of the law. What is law? Is it merely a means of controlling conduct? How does it relate to love? To ethics? To conscience? To morals? How does our concept of law relate to our concept of society and community? Does law rest only on interest, force, and fear? Is lawyering merely a job, a means of getting, requiring of the lawyer no great contribution to society? We must choose carefully, but choose we must.

For a lawyer with no philosophy of life and law is but an empty shell – a tinkerer with scraps of law that may come along. And I cannot imagine why empty shells want to be lawyers. They could certainly get more elsewhere with less effort.

Ah, but to be truly a lawyer is to be different, to carry a special re-

sponsibility. Where cynicism is rampant, the lawyer must hold and exemplify ideals. Where patriotism and love of community is passe, the lawyer must show dedication and love to fellow citizens. Where the easy life and the fast buck are goals, the lawyer must serve unstintingly the jealous mistress of law. Where the ripoff and the slick grab are admired, the lawyer's dedication to principle and love of others must stand out as a constant rebuke. When the client says, "Don't just stand there, sue somebody," the true lawyer must in a proper case counsel restraint. The true lawyer must ever counsel what should be done, not just what can be gotten away with. The true lawyer must serve as peacemaker first, as combatant second. Only then will public respect return to the profession of law. Only then will lawyers truly serve the causes of justice and freedom. Only then will the lawyer as lawyer be happy.

If we can infuse our professional lives with our love, then when our time has run and our work is done, it will be said of us that freedom and justice were glad we lived.


