## PADs Admitted To High Court in Special Ceremonies

A number of members of PAD were admitted to practice before the Supreme Court of the United States at the annual PAD Day at the Supreme Court on June 3, 1985. Their admissions to the Bar of the nation's highest court were moved by Miss Alice O'Connell as the highlight of the 19th annual PAD Day at the Supreme Court.

Miss O'Donnell is Director of Inter-Judicial Affairs and Information Services at the Federal Judicial Center and Past Chairman of the Judicial Administration Division of the American Bar Association.

Preceding the ceremony, the Fraternity sponsored a reception and continental breakfast at the Court in honor of the new admittees and a luncheon followed at the Rayburn House Office Building. Participants in the program were Chief Justice Warren E. Burger; International Justice Stanley H. Kohn, past International Justice Robert E. Redding; and Dr. Mark Cannon, Administrative Assistant to the Chief Justice.

Administrative Law Judge (retired) Donald R. Moore, a past International Vice Justice of the Fraternity, acted as Chairman and toastmaster for the day. Sheldon C. Hoffman, past Justice of the National Capital Area Alumni Chapter, delivered the invocation.

Other members of the Arrangements Committee included District XVII Justice Marni Byrum and past alumni chapter Justices Frank Cacciapaglia, Jr., Dennis D. Kirk, and William B. Robertson.

# L.A. Alumni Claim a First

The Los Angeles Alumni Chapter recently claimed a first in the history of PAD when it initiated two members into the alumni chapter pursuant to amendments to the International By-Laws which were adopted at the August, 1984 International Convention. Prior to the By-Law amendment, only student chapters could initiate members.



# Professor Duane L. Faw (Former Marine Landau Becomes **Corps Brigadier General) Retires**

Duane L. Faw, Professor of Law at Pepperdine University School of Law and Faculty Advisor to Shepherd Chapter, was recently honored by Shepherd Chapter on the occasion of his retirement.

Professor Faw is a former Brigadier General, United States Marine Corps retired. A native Texan, he rose from Seaman Second Class in the Navy to become the first Marine Corps lawyer promoted to Brigadier General. He became the Staff Judge Advocate for the Commandant of the Marine Corps and headed the Judge Advocates of the Marine Corps from August, 1969 until his retirement from the Corps in September,

Along the way he was a Naval Aviator with 179 combat missions in World War II. A commanding officer of two battalions and a regiment (infantry) and a Deputy Chief of Staff of the Third Marine Amphibious Force in Vietnam.

Professor Faw has been an enthusiastic supporter of Shepherd Chapter and the following is an address which he delivered before Shepherd Chapter some ten years ago. That address is still applicable today.

We Americans have a tendency to look down upon the man who works with his hands instead of his head.

We look down upon the woman who provides cleanliness to our immediate environment.

We look down upon those who work where it stinks, where it is hot, where it sounds bad or looks bad. We do not see in these menial tasks

the noble mark of service. I suspect there is no such thing as menial work! There are only menialminded people.

I suspect all honest work is sacred, ennobling, exhilarating. To those who see it in proper light.

But to see any beauty in work one must first see the virture in service. Service by its very nature is to subordinate one to another.

It assists someone in some man-

It places another's interests above one's own!

It recognizes that service is always

a part of a greater whole. It is therefore a wise and noble fraternity which builds its corner-

stone on service. We members of P.A.D. should be proud that our fraternity recognizes, specially, the law student and his or her needs, the law school and its needs, and the legal profession and its needs, and holds them up as wor-

thy of our service. What P.A.D. has said is that these three things are worthy of our investment of our time; indeed, of our expenditure of our life.

In a sense, P.A.D. has chosen to become a microcosm of the brotherhood of man. In fact, the word "fraternity" means "brotherhood." We have chosen to serve our closest fellows.

A wise Galilean Jew taught that service to one's fellows is the highest concept of brotherhood. He cast himself in the role of the suffering serv-

The highest honor which a state can bestow is not a gift, but a recognition: a recognition of service to the brotherhood which is the state.

What greater way to "spend" one's life than in service? And what greater training for service than P.A.D.?

It was a great Supreme Court Justice, Hugo Black, who captured the essence of what I am saying in a few words. Black said "At the end of life we shall not be asked how much pleasure we had in it, but how much service we gave; not how happy we were, but how helpful we were, not how ambition was gratified, but how, in love, we served.'

For it is really true: "He who would be greatest among men, let him be server of all."
