

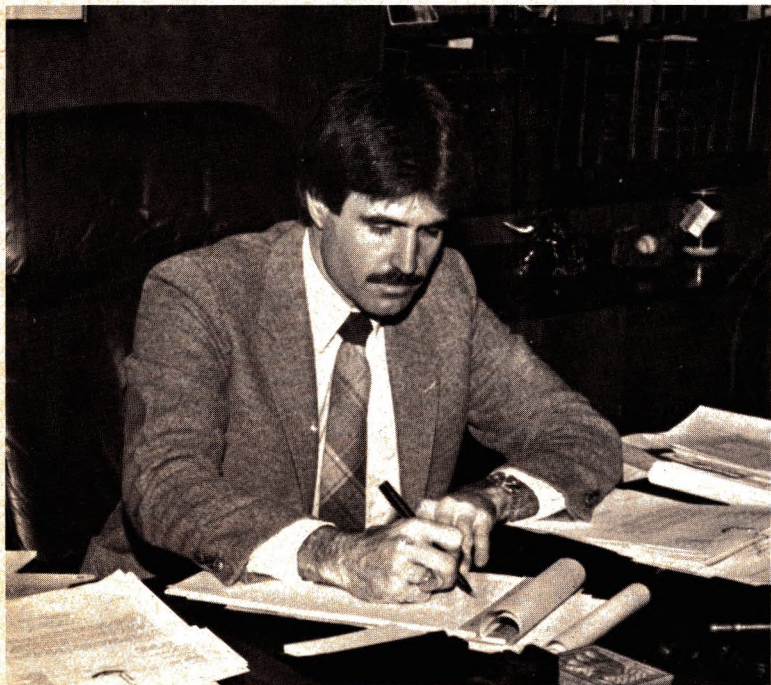

JACK L. MILLER — NEW INTERNATIONAL JUSTICE

Jack L. Miller Becomes International Justice

Upon the untimely death of Stanley H. Kohn, the position of International Justice became vacant and pursuant to the provisions of the International Constitution of the Fraternity, the International Vice Justice Jack L. Miller of Lebanon, Missouri, automatically became International Justice on November 24, 1985. Also, according to Constitutional provisions, International Second Vice Justice Homer S. Taft automatically became International Vice Justice. A vacancy presently exists in the office of International Second Vice Justice.

Our new International Justice is one of the youngest International Justices in the history of the Fraternity. He was first elected to the office of International Marshal at the 1974 Convention in Toronto, Canada. At the time of that election, he was a 2nd year law student at the University of Missouri-Kansas City School of Law where he was the Clerk of Benton Chapter.

Subsequently, he was elected to the office of International Secretary at the 1976 International Convention in Kansas City, Missouri; to the office of International Treasurer at the 1978 Convention in Cleveland, Ohio; re-elected as International Secretary at the 1980 Convention in Hot Springs, Arkansas; became International Second Vice Justice at the 1982 St. Louis Convention; and was elected International Vice Justice at the 1984 Miami Convention.

He earned his B.S. Degree from Southwest Missouri State University in Springfield, Missouri and his J.D. from the University of Missouri-Kansas City Law School in December, 1975.

He is the prosecuting attorney for Laclede County, Missouri, and is a partner in the law firm of Miller and Hutson. His partner is Don Hutson, former International Justice.

Brother Miller's memberships include Board of Directors of the Laclede County Child Welfare Council, the Executive Committee of the Missouri State Prosecutors Association, the Missouri Bar Association, and the American Bar Association.

To assure that there is no hiatus in the activities and progress of the Fraternity, our new International Justice has moved quickly to establish new committees and to assure the completion of the many projects which the Fraternity has undertaken under the leadership of Stanley H. Kohn.

A meeting of the International Executive Board has been called for January 9, 1986, in Los Angeles, California. International Justice Jack L. Miller will preside over a heavy

The following are excerpts from messages of International Justice Stanley H. Kohn and provide an excellent insight into the man, who though he served as International Justice for only slightly more than a year, has had a tremendous impact on the philosophy and progress of PAD.

"Love is an emotional feeling that many adults find difficult to express . . . but I was privileged to witness a great outpouring of love for Phi Alpha Delta as member after member in attendance at the 45th Biennial Convention in Miami Beach stood and publicly announced her and his love for our Fraternity . . . this personal emotional outpouring exemplifies the true meaning of fraternalism and brotherhood."

(October, 1984)

"Community service by attorneys is of substantial importance. In prior years, before the advent of lawyer advertising, lawyers generally paid lip service to community service by joining a service club like Kiwanis and by paying dues to the Chamber of Commerce. That attitude won't cut it in 1985. True and meaningful contributions of ideas, time, energy and leadership in all areas of voluntary community service is now required in order to improve the quality of life in every home town, right where most lawyers are earning their livings. And law school members and chapters are setting the pace. Law school studies have the positive effect of developing the brain; PAD community service program participation will do nothing but develop your heart, into a very big one!"

IN MEMORIAM

STANLEY H. KOHN, INTERNATIONAL JUSTICE
APRIL 25, 1931 - NOVEMBER 24, 1985

International Justice Stanley H. Kohn Dies

International Justice Stanley H. Kohn died suddenly November 24, 1985, in Columbia, South Carolina. His death came as a shock to thousands of PADs throughout the world.

Brother Kohn was elected to PADs highest office, that of International Justice, at the 1984 International Convention held in Miami, Florida. His death came in the middle of what many had felt was going to be one of the most outstanding PAD administrations in the history of the Fraternity. During the first year of his term in office the Fraternity achieved a record number of initiates, 4,229.

He was a graduate of Clemson University and received his law degree from the University of South Carolina in 1966, where he was Justice of Pinckney Chapter and also was named as its outstanding member.

In law school, he served as business manager of the Law Review from 1966 to 1968 and was on the Formation Task Force of the first intern program at the school and served as first chairman of the clinic's program. He was chairman of the Greater Speakers Program, Editor and Chief of the Criminal Law Research Organization and a member of the Moot Court Team.

He was engaged in private practice in Columbia, South Carolina for 13 years until he became general counsel to the South Carolina Department of Social Services.

In 1975, he received the National Volunteer Award in Washington, D.C. from Vice President Nelson Rockefeller and National Volunteer Chairman George Romney on behalf of the Richland County Family Court Volunteer program which he founded.

He organized the Richland County Council on child abuse and neglect serving as its first chairman. He served as a resource consultant to the legislature in the drafting of South Carolina's statutes on child abuse and neglect.

Brother Kohn served in the United States Army from 1952 to 1954 and was on the faculty of the Infantry School in Ft. Benning, Georgia. He was elected President of the Charleston Jaycees in 1957. He was Co-Chairman of the 13 State Dixie Institution being the only Jaycee to earn the Jaycee Key Award in 1956 and 1957. He served as Worshipful Master of Friendship Lodge #9 AFM in Charleston.

He was Chairman of the Community Service Committee of the local Jewish war veterans. He was also a member of the Unauthorized Practices Committee of the South Carolina Bar and a faculty member of the Family Court Judges CLE program.

His service to PAD was long and faithful. He served for a number of years as District Justice of District XIX and was first elected to the International Board in 1976. He served continuously on the Board and as Chairman of various Board and Convention committees until his election to the office of International Justice in 1984.

Services were held on Monday, November 25, in his hometown of Charleston, South Carolina at the B'Rith Shalom - Beth Israel Cemetery.

Attending the services were a host of Fraternity members, including In-

All of us at the Miami Convention remember Stan's speech regarding Fraternity financing that raised over \$6,000.00 in an outpouring of love from the members present.

Our Fraternity has suffered a tremendous setback in the death of International Justice Stanley H. Kohn. Stanley has become symbolic of all that the Fraternity stands for and has exhibited to all of our membership a warm smile and a strong hand of friendship. I am now faced with the task of picking up where Stan left off, of committing myself as did Stan, and of leading the Fraternity into 1986. It will be difficult and challenging but serving with Stan since 1976 will make it easier for me. I accept the challenge, and pledge, that with the help of each member, we can realize Stan's dreams and accomplish his goals.

Steve Markman Wins Top Federal Position

Brother Stephen J. Markman, Chase Chapter, has recently taken office as Assistant Attorney General for Legal Policy in the Department of Justice. Following his nomination by President Reagan for this position, he won unanimous Senate confirmation on October 18, 1985.

The Office of Legal Policy is the main policy-initiating branch of the Justice Department. It develops and coordinates policy initiatives pursued by the Attorney General. Examples of its work projects in fiscal year 1984 were export controls, trade law revisions, international telecommunications policy, international copyright protection, national security issues, revision of Federal Rules of Civil Procedure, regulatory reform, disclosure and use of grand jury materials, and regulations under the Freedom of Information and Privacy Acts. The OLP also serves as Attorney General liaison with the Federal Legal Council and other various inter-Cabinet, interdepartmental agencies.

Of great interest also is the function of the OLP as the focus of the judicial selection process. It coordinates the process of selecting and recommending new Federal judges for vacancies that may develop from time to time. This includes the recruitment, interviewing and evaluation of qualified candidates ultimately recommended to the President for judicial appointment.

In Brother Markman's confirmation hearing he was faced with spirited questioning regarding his opinion of the judicial selection process. As to the qualities important for a Federal Judge, he stated that, "Ob-

viously, there is a large catalogue of qualities that one would look for in a Federal judicial candidate. The more obvious ones are that we would look to individuals who have a reputation for a high degree of legal competency; for people who have been experienced in the practice of law; certainly to the extent that an individual has experience on some prior judicial panel. That would weigh very heavily in their favor." "We would certainly look to determine the judicial temperament of an individual . . . , one's sense of judicial restraint, one's sense of fair-mindedness, one's sense of justice, and one's commitment to work hard in the position."

The hearing made it quite clear that Steve is held in the highest esteem by the Senate Judiciary Committee. Individual Senators said "We have confidence in you. It is our observation that you are a highly intelligent man. We know you will do a fine job. I think he is going to make a fine public servant in the Department of Justice and am pleased to be able to vote for him. Fair and square. Honest and upright. Recommend him very highly."

These strong expressions of support were based in part on his advisory role to Senator Orin G. Hatch, Committee Member, in helping the Senator vote on approximately 400 to 500 judicial nominations.

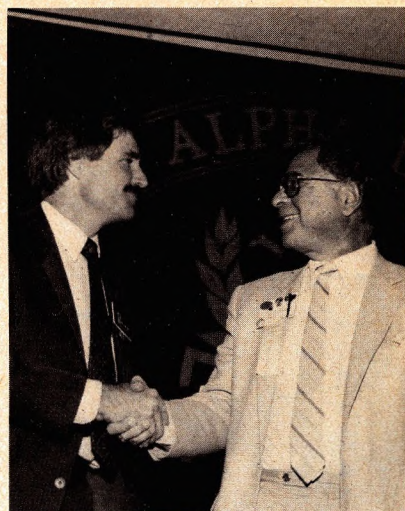
Prior to serving in this new post, Steve worked for seven years as Chief Counsel to the United States Senate Subcommittee on the Constitution. During this time, he was involved in some of the most controversial and divisive debates within the Congress on constitutional and civil rights matters, including abortion, school prayer, school busing, balanced budgets, voting rights, affirmative action, Equal Rights Amendment, housing discrimination, and criminal justice issues.

Brother Markman has also served as Deputy Chief Counsel to the Senate Judiciary Committee and before that as Legislative Assistant to Congressman Hagedorn, ranking member of the House Judiciary Committee.

Steve indicated his strong interest in PAD and remarked that "I would like very much to help the Fraternity."

Hertz Increases Discount to PADs

PAD Continues National Leadership In Law-Related Education

Phi Alpha Delta is concluding six straight years of national leadership in supporting the expansion of law-related education on a nationwide basis. In the late 1970s, the Fraternity sought to establish new public service programs, using our widespread membership network on a volunteer basis. As a result, we were initially successful in gaining a half-million dollar grant from the Office of Juvenile Justice and Delinquency Prevention for an LRE program in February 1979. The *pro bono* services rendered by PAD members since that auspicious beginning have been recognized by this Department of Justice agency by making ten consecutive awards to continue the program.

The Fraternity's goals adopted in 1979, listed herein, are just as valid today as they were six years ago.

Our international standing in this field has been repeatedly commended by leaders in the law, from the President and Chief Justice of the United States down to community level. One of the most noteworthy actions of this nature was a November, 1985, personal letter from Brother Arlen Specter of the United States Senate to his 3,400 PAD Brothers in Pennsylvania, in which he commented as follows:

"Phi Alpha Delta offers law students and alumni the opportunity to participate in a national program to help reduce crime and juvenile delinquency. In 1984-85, PAD focused its law-related education efforts in 11 states; I am advised that in 1985-1986 the program will add five additional states, including Pennsylvania. I encourage all Members to support PAD's new 1985-1986 program in our state."

"I have held PAD in high regard since my initiation into the Fraternity's Calhoun Chapter at Yale University over 30 years ago. As the former District Attorney of Philadelphia, I had the opportunity to observe PAD's contributions at Pennsylvania law schools."

"I commend PAD for its significant contribution to help reduce juvenile crime and delinquency through its law-related education programs. Please be assured that I will continue to support crime and delinquency prevention programs like PAD's throughout Pennsylvania and nationwide."

We appreciate Brother Specter's remarks, particularly because he has

direct oversight responsibilities over the OJJDP programs as Chairman of the Senate Subcommittee on Juvenile Justice. We encourage all Brothers — law student and alumni — to make personal commitments in 1986 — your time, service and financial support — to support the Fraternity's LRE program.

We also want all PAD Members to be aware of the limited administrative structure which has been established at state level to help the LRE program. As described by Brother Douglas M. Tisdale, Colorado Coordinator: "My current function, at least as I view it, is to assist Bob Redding's Office and any Colorado-based LRE people in providing an interface with PAD, in providing resource suggestions, in coordinating activities involving PAD lawyers in LRE, and other special tasks assigned to me by Bob Redding's Office."

We invite each interested PAD to call the Coordinator of your state and become involved in LRE. We would welcome volunteers to perform this role in the few states lacking a PAD Coordinator.

PAD Long and Short Term Goals in Law-Related Education

1. Encourage the membership of Phi Alpha Delta to participate in the nationwide program for the prevention of juvenile crime and delinquency in America.
2. Serve the nation by helping children to improve their lives and become better citizens.
3. Help increase the effectiveness and stability of our juvenile justice system.
4. Help strengthen our nationwide elementary and secondary school system, the paramount institution in maturing of youth, by enlarging the pool of local resource persons to be of assistance to teachers.
5. By the above actions, help abate

are necessary to the preservation of our own legal system, our governmental and political system and that unique equality of justice which permeates the language and intent of our Constitution. Lawyers are the sentinels of the entire American system of government, and each bad-apple-lawyer weakens the chain of national protection. This very minute there are approximately 10,000 PAD law students preparing to become licensed lawyers. While law schools toil to assist each in becoming a competent practitioner, there is minimal emphasis on Professional Responsibility and Ethics . . . Phi Alpha Delta must move into this void to increase the formal stress upon the importance of Professional Responsibility and Ethics and the necessity of each lawyer to remain constant to the Canons."
