District Justice Stan Jones Dies

Stan P. Jones, District XXI Justice and long a mainstay of PAD, passed away unexpectedly on March 15, 1985.

Stan was initiated in 1963 into Carmody Chapter at Syracuse University which he served as chapter Justice. After practicing law in the Syracuse area, he then moved to Orange County where he was a moving force and the chapter Justice for the Orange County Alumni Chapter. He later moved to Phoenix, Arizona where he established a law practice which continued until his death.

Stan was an enthusiastic PAD, always on hand to offer advice and to encourage chapters and individual members in his district.

Terrell Chapter at FSU Reactivated

The Glenn Terrell Chapter at Florida State University was reactivated on March 25, 1985 when 16 persons were initiated by Brother Joseph A. Boyd, Jr., Chief Justice of the Florida Supreme Court. Chief Justice Boyd has lent his support to the chapter since election to the Florida Supreme Court in 1968 and has been an invaluable source of inspiration and guidance to many PAD's.

His daughter was among the group petitioning for reactivation of the chapter.

Others instrumental in the reactivation were District XX Justice Dave Murray, Executive Secretary Nora Barson and Alumni Advisor Paul Watson Lambert.

PADs In the News

Suzanne Littlefield, Neenah, WI, and Charles Kenyon, Tomah, WI have been selected as national coordinators to two computer user groups. Littlefield is the national coordinator of the ABA's Radio Shack Computer Users Group and Kenyon is the national coordinator for the independent MultiMate Law Office Users Group. Both Littlefield and Kenyon are past Justices of Ryan Chapter at the University of Wisconsin and the Madison Almuni Chapter

Patricia Roberts Harris, former Secretary of Housing and Urban Development in the Carter administration, died recently in Washington, D.C. Patricia Harris was a member of Jay Chapter at George Washington Law School. She was the first black woman to serve as Cabinet Secretary, the first black woman to be a United States Ambassador and the first black woman ever named dean of a law school. In services held at the Washington Cathedral, she was eulogized by former President Jimmy Carter and House Speaker Thomas P. (Tip) O'Neill.

William J. Corbett, a member of Wormser Chapter, has been installed as Associate Justice of the Village of Floral Park which he has served for the past ten years as Village Prosecuting Attorney.

U.S. Claims Court Judge Lawrence S. Margolis, a member of Jay Chapter at George Washington University, recently received the Alumni Achievment Award of the George Washington University at its Winter convocation. He was cited for his outstanding contributions to the law in particular and to society in general, contributions "that reflect distinction upon the university." He was selected from among 75,000 living graduates world-wide. He was appointed by President Reagan to the United States Claim Court in December, 1982.

Mervin Rehrer, a member of Brewer Chapter at Stetson University, has authored a book entitled "My Will Be Done." The publication is a common sense guide to preparing a will and is an attempt to treat a legal subject in a non-legal manner. The publication is available through Vantage Press, Inc., 516 W. 34th Street, New York, New York 10001.

The new Dean at Yale University Law School is **Guido Calabresi**, a member of Calhoun Chapter at Yale University. One of the nation's leading law educators, Professor Calabresi (now Dean Calabresi) has been a member of the Yale faculty since 1959 and is an authority on torts and on the relationship of law and economics in American society. He is also an authority on law and medicine.

In 1974, Time Magazine named him as one of the 200 men and women under age 45 considered the future leaders of the country. In 1977, Time Magazine picked him in its list of ten influential law teachers in the United States. He formerly served as law clerk to the United States Supreme Court Justice Hugo Black.

Frank J. Creede, Jr., a member

of Matt Sullivan Chapter at the University of San Francisco, has been appointed by PAD Governor George Deukmejian of California to the Fifth District Court of Appeal in California.

Appointed to the Municipal Court Bench in California are **Frederick Mandabach**, Ford Chapter at Loyola University of Los Angeles, and **Marvin G. Haun**, Temple Chapter at Hastings College of Law.

Recently appointed to the Securities and Exchange Commission is **Aulana Peters**, a member of Ross Chapter at the University of Southern California. She is the first black woman lawyer named as an SEC commissioner.

Norman F. Meyer, a member of Chase Chapter at the University of Cincinnati College of Law, passed away January 22, 1985 in Phoenix, Arizona. Prior to establishing a law practice in Phoenix, he was General Electric Lamp Representative in Arizona.

Jeffrey L. Gunther, a past Justice of Ford Chapter at Loyola University in Los Angeles, has been appointed by PAD Governor George Deukmejian as a Municipal Court Judge for the Sacramento County Judicial District. He has been serving as Chief Counsel for the Department of Personnel Administration and prior to that time was a Deputy Attorney General for the Department of Justice for the State of California.

Philip G. Schrag, a member of Calhoun Chapter at Yale University, has been appointed Visiting William J. Maier, Jr. Professor of Law at West Virginia University College of Law for 1984-85.

Dean Thomas D. Morgan, a member of Magruder Chapter at the University of Illinois, who has been serving as Dean of Emory University School of Law, has announced his resignation as of July, 1985.

Charles W. Gamble, a member of Hull Chapter at Cumberland University, is the newly named law school Dean at the University of Alabama.

Dr. Thomas Brad Bishop is acting Dean at Stamford University Cumberland School of Law. He is a member of Hull Chapter at that school of Law.
