Hon. John J. Sirica Receives "Equal Justice Under Law" Award

Phi Alpha Delta Law Fraternity, International, has awarded to United States District Judge John J. Sirica of Watergate fame its prestigious Tom C. Clark Award for outstanding exemplification of "Equal Justice Under Law." The presentation was made by Stanley H. Kohn, International Justice of the Fraternity, Thursday, October 17, in Judge Sirica's courtroom in the U.S. Courthouse.

Judge Sirica, now a senior judge on the United States District Court of the District of Columbia, and a member of the Fraternity, is the fourth person to receive the award, which was established five years ago to recognize individuals who have made significant contributions to equal justice. The award is a memorial to the late Justice Clark of the United States Supreme Court, who was Supreme Vice Justice of the Fraternity.

Previous recipients have been the Honorable Kenneth Taylor, who was Canadian Ambassador to Iran, for his heroic role in the hostage crisis in Iran; Federal Circuit Judge John Minor Wisdom, of New Orleans; and Congressman (former Senator) Claude E. Pepper of Florida.

In making the presentation to Judge Sirica, Mr. Kohn hailed him and Justice Clark as "great Americans" and "famous jurists."

After briefly reviewing the careers of each and citing the honorary degrees and awards that "reflect the national esteem" earned by Judge Sirica, Brother Kohn stated:

"United States District Judge John J. Sirica presided over the most important criminal case ever to be tried in an American court. It involved the most powerful men in government and precipitated a constitutional confrontation

between the executive branch and the judiciary more important than any other in our history. From the first indictments against a bizarre band of 'third rate burglars' through a series of legal altercations with the President of the United States, to the final judgment against the high-level conspirators, Judge Sirica maintained full control of his courtroom and of the integrity of the judicial processes of the United States of America. He dedicated a full five years of his professional life to insuring to those Watergate defendants 'equal justice under the law.'

"His past experiences as a professional prize fighter and his training and experience as a lawyer obviously sustained him to remain constant to his duty in the face of constant courtroom harassment and argument.

"The Honorable John J. Sirica, a national and international hero to all who honor and obey laws, and known around the world as a judge who places the laws of his country above personalities, honors his Law Fraternity, Phi Alpha Delta, by receiving the Tom C. Clark Award for 'equal justice under law'."

Mark Cannon Given Key Bicentennial Appointment

Brother Mark W. Cannon, Administrative Assistant to the Chief Justice of the United States since 1972, has become the key coordinator of the nation's Bicentennial commemoration of the adoption of the U.S. Constitution and Bill of Rights. At the August 22nd meeting of the 23-member Commission on the Bicentennial of the United States Constitution, Brother Cannon was designated Staff Director of the Commission.

The Commission's work will be highlighted in the next issue of *The Reporter*. PAD members include Chief Justice of the United States Warren E. Burger, Chairman and Senators Strom Thurmond and Edward M. Kennedy.

Brother Cannon has also become a very prominent author and journalist in addition to his Supreme Court duties. It will be recalled that he addressed the Southwestern Judicial Conference of Judges in June 1981. His remarks, entitled "Crime and the Decline of Values," included support of law-related education, and was published by PAD in monograph form and was widely distributed. It was also printed in "Great Speeches." PAD plans to reprint such remarks, which will include a foreword by past Secretary of Education Terrance Bell.

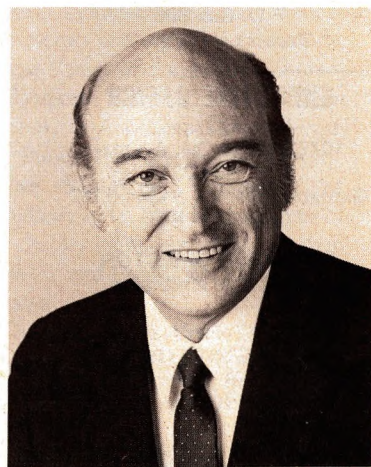
Brother Cannon also served as Guest Editor in compiling articles by 16 distinguished authors on the Con-

Mark W. Cannon is the first person appointed as Administrative Assistant to the Chief Justice of the United States, a position created by Congress in 1972. He assists the Chief Justice in planning, leadership, administration, and liaison responsibilities for the Federal Judiciary outside of the area of case decision-making. Dr. Cannon received his B.A. from the University of Utah where he served as Student Body President. He received his M.A., M.P.A., and Ph.D. from Harvard University.

Prior to serving as Administrative Assistant to the Chief Justice, he was Director of the Institute of Public Administration, New York, a private non-profit think tank that assists American and foreign agencies to improve planning, management, and training. He was previously Chairman of the Department of Political Science at Brigham Young University. He also served as Administrative Assistant to Congressman Henry Aldous Dixon (R-Utah) for five years, and was on the staff of Senator Wallace F. Bennett (R-Utah).

Dr. Cannon has lectured at over 70 universities and other institutions throughout the world, traveling in more than 60 countries. He has written numerous articles and books on the administration of justice and public policy, including being guest editor of a special issue of *Phi Kappa Phi National Forum* on "Toward the Bicentennial of the Constitution." He is co-editor of *Views From the Bench: The Judiciary and Constitutional Politics* and co-author of *The Makers of Public Policy: American Power Groups and Their Ideologies*.

Dr. Cannon is married to the former Ruth Dixon. They have three children, Lucile, Mark, and Mrs. Kristen Brown; all three are students at Brigham Young University.

stitution Bicentennial, published in the fall of 1984 by the Honor Society of Phi Kappa Phi co-sponsored by the American Bar Association. This issue, entitled "Toward the Bicentennial of the Court," has been widely distributed and is available from the PAD Public Service Center in Washington.

Most recently, Brother Cannon served as co-editor, having collected and edited 28 articles written by distinguished jurists, entitled "Views from the Bench: The Judiciary and Constitutional Politics." This anthology provides an unique view of judicial politics. It presents the views of members of the Supreme Court and leading federal and state judges on the judicial process, the function of judges, and the role of courts in our increasing litigious society. Included are selections by Chief Justice Burger and Justices William J. Brennan, Jr., Sandra Day O'Connor, Lewis F. Powell, William H. Rehnquist, and John Paul Stevens. Articles are also included by Brothers Howard T. Markey of the Court of Appeals, Federal Circuit and J. Clifford.

1986 PAD Day At U.S. Supreme Ct.

If you have not been admitted to the Bar of the U.S. Supreme Court, you will have an opportunity next June to make the event a memorable occasion by joining with other PADs from throughout the nation for a special group admission ceremony.

Monday, June 2, 1986, is the date for the 20th annual PAD Day at the Supreme Court, according to Past Supreme Vice Justice Donald R. Moore, chairman of the Arrangements Committee.

Judge Moore reported that participants in the 1985 event were enthusiastic, particularly because of the presence of Chief Justice Warren E. Burger and Dr. Mark Cannon, his Administrative Assistant (both PADs) at the coffee hour, along with International Justice Stanley H. Kohn and other prominent PADs. Chief Justice Burger spoke informally with the admittees, answered questions, autographed their programs, and posed with them for a group picture. He urged PAD participation in a new Inns of Court program.

At the luncheon that followed, International Justice Kohn gave a brief report on "The State of the Fraternity."

The motion for admission will again be made by Alice O'Donnell, long-time aide to Justice Tom C. Clark, and not an official of the Federal Judicial Center. At the 1985 ceremony, Miss O'Donnell told the group that she had a few copies of a small pamphlet edition of the Constitution that were among the papers of Justice Clark at the time of his death. Like Justice Hugo Black, Justice Clark almost always had a copy in his pocket, and he delighted in handing copies to students and others. Miss O'Donnell made available a copy which, in a random drawing, went to Arlyce Ruth Stearns, of Fort Wayne, Ind.

Professional Responsibility & Ethics

The practice of Law has always been an honorable profession, and many of us are prone to look back at Watergate as the start of the erosion of the reputation of the legal profession. No other profession lost as much as ours when the general reputation for honesty and fair-dealing by lawyers was first publicly besmirched.

Every lawyer has a full-time obligation to uphold the integrity of our profession, for lawyers are necessary to the preservation of our own legal system, our governmental and political system and that unique equality of justice which permeates the language and intent of our Constitution. Lawyers are the sentinels of the entire American system of government, and each bad-apple-lawyer weakens the chain of national protection.

This very minute there are approximately 10,000 PAD law students preparing to become licensed lawyers. While law schools toil to assist each in becoming a competent practitioner, there is minimal emphasis on Professional Responsibility and Ethics (PR&E).

The single PR&E course offered by most law schools is taught in a vacuum, without being directly related to any other field of law; yet, PR&E should always be directly related to every single legal matter undertaken by lawyers. Law students preparing for State Bar exams often remark that finally their entire legal education begins to become interrelated, except for that course in PR&E. PR&E remains in its vacuum.

As law schools continue to expand curriculum to include The Philosophy of Natural Law, the History of the European Court System and Biblical Appellate Theories, no new or expanded emphasis will ever come to PR&E. Phi Alpha Delta must move into this void to increase the formal stress upon the importance of PR&E and the necessity of every lawyer to remain constant to the Canons.

Prior to the end of this Biennium the International Executive Board will grasp this initiative by considering several programs in PR&E designed especially for our Prelaw members. Within a short span of months, we will thereafter be ready to move that initiative into our law school Chapters. It could be our largest contribution to the profession.

Donald R. Moore Inducted Into Distinguished Service Chapter

In ceremonies attended by members of the International Executive Board, International Tribunal, District Justices and members of the National Capital Area Alumni Chapter on August 2, 1985, Donald R. Moore of Washington, D.C., was inducted into the Distinguished Service Chapter of PAD.

Membership in the Distinguished Service Chapter is the highest honor conferred by the Fraternity other than election to International Office. Membership is conferred only after unanimous election by the International Executive Board.

In the entire history of the Fraternity, only 14 members have been awarded this high honor.

Brother Moore has been active since his law student days at Georgetown University, when he was Justice of Taft Chapter. After graduation he helped reorganize the then dormant Washington Alumni Chapter and later became its Justice. He served as District Justice of former District XII (then embracing Delaware, Maryland, the District of Columbia, Virginia, North Carolina and South Carolina) and was instrumental in the chartering of three new active chapters and of three new alumni chapters as well as a reactivation of a fourth active chapter.

He was elected to the Supreme Tribunal in 1962 and served on the

Tribunal until his election to the International Executive Board in 1968. He served on the Board in various

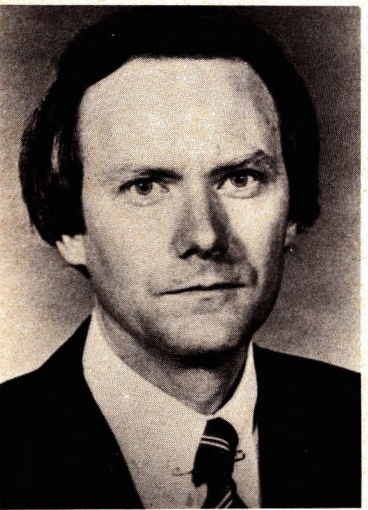

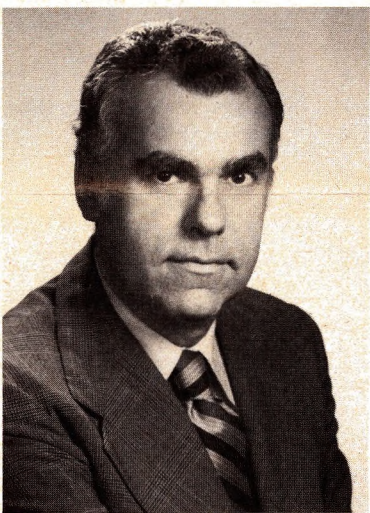

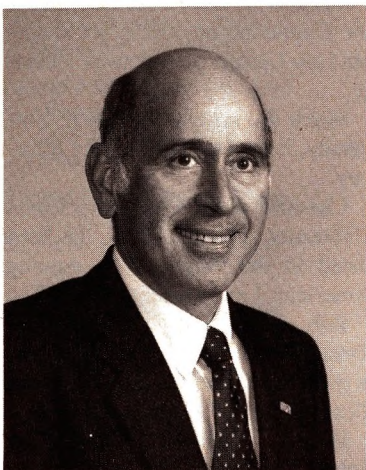
