Integrity — PAD Makes A Difference

With a theme of "Integrity — PAD Makes A Difference", the 46th Biennial International Convention of Phi Alpha Delta Law Fraternity, International, will convene at 9:00 a.m. on Wednesday, August 6, 1986, at the newly renovated Omni International Hotel in Baltimore, Maryland. Some twelve million dollars have been expended in making the facility into one of the finest in the city.

Advance reservations indicate that this will be the largest Convention in the history of the Fraternity. Attending will be delegates representing 168 law school chapters and 87 alumni chapters.

Kohn Memorial Reception

The first official Convention event will be the Stanley H. Kohn Memorial Reception. Customarily the reception the evening before the International Justice's gavel calls the Convention to order is held in honor of the outgoing International Justice. However, International Justice Stanley H. Kohn, who was elected to that high office by the 1984 Convention, passed away in November of 1985 and the International Executive Board has elected to hold the opening reception in memory of our recently departed International Justice. In attendance will be members of Brother Kohn's family who will be presented a memorial plaque to be placed in the school of law of the University of South Carolina, where Stanley became a member of Pinckney Chapter.

Other pre-official Convention events include a dinner for all members of the International Executive Board and Executive Office Staff on the evening of Sunday, August 3, a meeting of the International Executive Board on Monday, August 4, an International Officers Reception on the evening of Monday, August 4, an orientation session for all members of the International Executive Board, past International Justices, International Tribunal and District Justices on Tuesday, August 5, an orientation meeting of all chapter workshop panelists and committee chairpersons, vice chairpersons and resource persons on Tuesday, August 5th, and a meeting of District Justices on the same date.

Opening Session

At the official opening session of the Convention on August 6th, PAD Maryland Attorney General Steve Sachs will extend words of greeting and members will hear an inspirational address by a PAD keynote speaker of national reputation.

Wednesday afternoon all delegates will attend the "meat and potatoes" session of the Convention known as Chapter Workshops. Workshops this year will be presented on "The International Fraternity", "Chapter Recruiting and Continuity", "Chapter Programming and Finance", "Chapter to Chapter — A Student Dialogue", and "An Effective Alumni Chapter".

Wednesday evening delegates will be treated to a Maryland crab feast at the University of Baltimore given by all chapters in District XVII. The crab feast will be followed by a cruise of the harbor and other areas.

Committee Meetings

Each delegate will be assigned to a committee which will meet on Thursday, August 7th. Committees which have been established are Constitution and By-Laws, Credentials, PAD Public Service Corporation, Pre-Law Materials, Professional Programming, Professional Responsibility and Ethics, Publications, Resolutions, and Rules.

Thursday afternoon, delegates will

board buses for a tour of Washington, D.C. A special visit has been arranged to the Supreme Court of the United States where special ceremonies have been arranged for members of the Fraternity.

All districts will convene in breakfast meetings on the morning of Friday, August 8th, which will be followed by a full day session of Convention business. The Nominations Committee will also conduct its deliberations during the day.

What is being billed as the social highlight of the Convention will be held that evening and will be known as "Party Night at the Power Plant". The Power Plant is an old six-story power plant building in which the Six Flags Entertainment Organization has expended some thirty-three million dollars. PAD Convention delegates will have the exclusive use of the main hall for dining, dancing and enjoy a Broadway Revue.

The final day of the Convention will be highlighted by Convention business on Saturday, followed by the election of new International Officers.

As is customary, the Awards Banquet will be held that evening with International Justice Jack L. Miller presiding. Among the awards presented will be those for the Outstanding Law School Chapter Competition, the Outstanding Law School Chapter Justice, the Outstanding Law School Chapter Clerk, the Most Outstanding Professional Program, Service Scholarship winners and various individual chapter awards.

Following the close of the 46th Biennial Convention, the newly elected International Executive Board will convene for a day and a half of deliberations in planning for the coming biennium.

PAD Becomes First Woman Named To Florida Supreme Court

Judge Rosemary Barkett of the Fourth District Court of Appeal in West Palm Beach made history recently when she was named by PAD Florida Governor Bob Graham to be the first woman appointee to the Florida Supreme Court.

She is a graduate of the University of Florida School of Law, where she was a member of Beta Zeta Chapter of Phi Delta Delta Legal Fraternity, which was subsequently merged into PAD.

Justice Barkett exemplifies one aspect of the American dream... an immigrant who works to achieve success. Born in Mexico of Syrian parents, she was raised in Miami and became a naturalized citizen in 1958. She served for a time as a nun and teacher in a St. Augustine Catholic school, received her law degree from the University of Florida and worked as a civil lawyer in West Palm Beach.

A Review of "Views From The Bench"

Mark Cannon, Administrative Assistant to Chief Justice Warren Burger, and David O'Brien recently authored a book entitled *Views From The Bench*.

United States Senator Orrin Hatch, Chairman of the Senate Committee on Labor and Human Resources and also Chairman of the Senate Judiciary Committee on the Constitution, has prepared a book review of this publication.

That review follows:

Views From The Bench

A Book Review By U.S. Senator Orrin G. Hatch

The Federalist Papers declared that the judiciary would be the weakest of the three branches of government. Publius could have added that the judiciary would also become the least understood, at least, among the general public.

Too few people understand how the courts operate or how judges view their role in society. Mark W. Cannon and David O'Brien have edited a book, entitled, *Views From The Bench: The Judiciary And Constitutional Politics*, which is destined to significantly increase the public's understanding of the legal system in America.

Views From The Bench is a collection of 28 articles written by many distinguished jurists in America. The anthology is a welcomed and valuable collection of shorter articles on judicial review, the dynamics of the judicial process, the judiciary and the Constitution, federal regulations, the Bill of Rights and the states, and the judicial role in a litigious society.

The judges have communicated more candidly than they normally do in their written opinions, thereby making the anthology particularly readable, instructive and useful.

Views From The Bench is divided into six divisions. Part I places the power of judicial review in historical and political perspective. It begins with an essay by Chief Justice Warren Burger on that most important of all cases, *Marbury v. Madison*. He successfully captures the high drama of that landmark ruling, which is followed by a classic essay on the political role of the court by one of its past justices, Robert Jackson.

Part II, then, contains some remarkably candid and insightful discussions of the contemporary operation and problems confronting judges and the judicial process. Marvin Frankel discusses the experiences of trial judges and how they often become embattled in the adversary process. Frank Coffin, of the First Circuit, then, discusses the work of Appellate Court Judges with particular attention to the growing use of law clerks. This theme, or rather the growing concern about "bureaucratic justice" due to increasing case-loads, is further examined by Alvin Rubin of the Fifth Circuit. These are followed by several detailed essays on the operation of the Supreme Court by Justices Lewis F. Powell, Jr., John Paul Stevens, and William Rehnquist. In addition, there is a critical essay by Walter Schaefer of the Supreme Court of Illinois on the value of Supreme Court opinions. Finally, the late Judge Edward Tamm and State Supreme Court Justice Paul Reardon provide a most useful overview of the managerial problems facing our complex and expanding fed-

eral judiciary as well as recent improvements in judicial administration.

The next three parts deal with the art and craft of constitutional and statutory interpretation and the relationship between state and federal courts in protecting fundamental liberties. On these matters there is a good deal of controversy and widely different judicial philosophies. Included here are the views of Justices William J. Brennan, Jr., Sandra Day O'Connor, and William Rehnquist, as well as two classic essays by Justices Hugo Black and Felix Frankfurter. No less important are the views of leading state and federal court judges, like Robert Bork, William Wayne Justice, Hans Linde, Dallin Oaks, Carl McGowan, Antonin Scalia and J. Clifford Wallace.

The final part provides diverse perspectives on the contemporary role of courts and the debate over judicial activism versus self-restraint, along with the causes and potential cures of judicial expansionism. All of the contributors are members of federal appellate courts: Ruggero Aldisert, Henry Friendly, Frank Johnson, Jr., Howard Markey and Ralph Winter.

Views From The Bench provides not only rare glimpses of the heart of the judicial process, but also revealing testimonials that invite lawyers and laity alike to critically examine the roots of American jurisprudence.

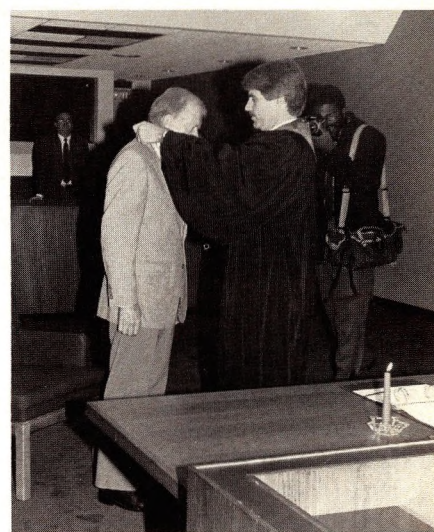
PHI ALPHA DELTA DEPENDS ON YOU

She was Justice of Dirksen Chapter in 1980 and became Justice of the San Francisco Alumni Chapter in 1985.

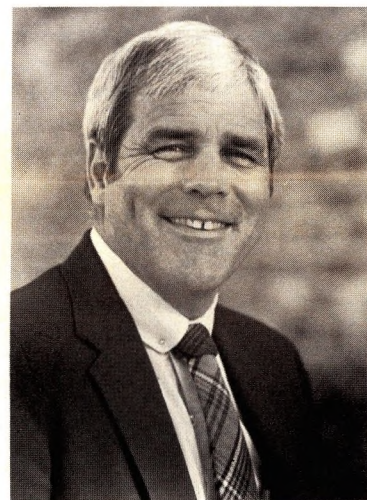
Oklahoma City Alumni Chapter Reactivated

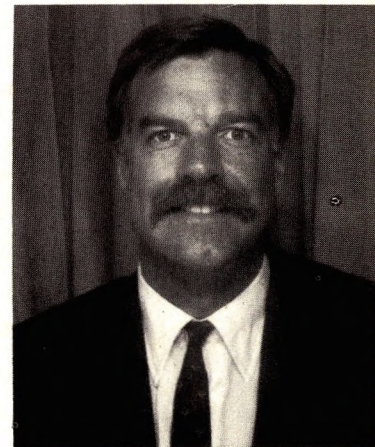
Mark P. Miller Becomes District VI Justice

Legal Ethics in the World After Watergate

During the months after 29 lawyers involved in Watergate were jailed, disbarred or both, U.S. law schools turned their attention as never before to teaching professional responsibility or legal ethics. The American Bar Association, also alarmed at the scandal of so many lawyers being implicated in the obstruction of justice at the highest levels, virtually mandated courses in legal ethics in America's 160 law schools.

A decade after the trauma of Watergate, it is fair to state that the legal profession has paid more attention to legal ethics in the past 10 years than it did in the previous 100.

Preexisting rules and standards for the legal profession were consolidated into the Model Rules for Professional Conduct ratified by the American Bar Association at its Atlanta meeting on August 2, 1983. A national bar examination on professional responsibility is now required of all applicants, and the level of activity and enforcement of legal ethics at the state level has reached an unprecedented high.

The revolution in legal ethics that occurred over the last dozen years has had its impact on Georgetown University Law Center. Veterans on the faculty recall that Professor Sam Dash, counsel to the Senate Watergate Committee, urged the faculty in 1974 to institute a course on legal ethics; his motion was passed by acclamation.

Legal ethics is now the one course required of all students after first year. Some nine sections with 60 students apiece receive 30 hours of instruction each year. Some 5,000 graduates of Georgetown Law Center, have had courses in professional responsibility since Watergate. Those who have taught this course in professional responsibility, like this writer, hope that these alumni will be aware of and sensitive to the ever more complex ethical issues that lawyers cannot avoid or evade. Not a few of those involved in writing about or teaching professional responsibility sometimes wonder whether the really important moral and ethical problems which lawyers regularly confront are given adequate attention in law school courses on professional responsibility. Before turning to the difficult and still emerging issues not regularly discussed in courses on legal ethics, notes should be taken on the issues which do receive extended treatment.

ABA Model Rules of Professional Conduct

The ABA Model Rules of Professional Conduct, about 100 pages in length, were the final product of a commission headed by the late Robert Kutak. Points of disagreement and dissatisfaction with the 1970 Model Code of Professional Responsibility with its many ethical considerations and disciplinary rules were debated over a period of some four years. Rule 1.6, relating to the confidentiality of information received by an attorney from a client, posed particular difficulty; it was compromised out in a way which still poses great programs for the bar associations in the 50 states which are now struggling to discover a consensus by which to accept, reject or modify the ABA Model Rules.

Despite the controversies over a few provisions of the model rules, there appears to be a consensus among lawyers that the Kutak Commission and the ABA did about as well as could be expected. Law students do not have enough experience in the legal profession to come to such a judgment, but they appear to be intensely interested in, even fascinated by, the contemporary attempts of the 600,000 lawyers in America to define their role, and to refine their ethical standards in a society which uses lawyers for more and more tasks all the time.

Some of the issues that bother lawyers who have been at the bar for a generation or so seem of little con-

sequence to many law students. They welcome the right of lawyers to advertise although, interestingly, each year when I circulate in the class several pages of ads from lawyers which appear in the Yellow Pages of the Washington phone book, not a few are revolted. One student said she could not imagine herself allowing her name as an attorney to be included in such ads. Student opinion was mixed about the attorney who noted in his half-page ad that he was a graduate of the Georgetown Law Center.

Students are always relieved to learn that some 80 percent of all lawyers who are disciplined or disbarred practiced in firms with five or fewer attorneys. But the students are disturbed by the astonishing number of cases where lawyers sue to disqualify opposing counsel because of an alleged conflict of interest. They are also upset that the number of cases where lawyers are charged with conflicts of interest is surprisingly large.

Many students in the class in professional responsibility who are seniors have had opportunity to work in a law firm the previous summer. Their revelations and their reflections as they learn about legal ethics for the first time are sometimes memorable. One student seemed astonished that his employer let him perform in several important capacities for the summer but never mentioned his or his law firm's liability for malpractice. Another student felt that her firm had to be in violation of several of the model rules. Others, probably the majority, expressed admiration that the lawyers with whom they had been associated with observed the mandates of the model rules although they seldom referred to them as such.

Emerging Issues In Professional Ethics

One of the issues which arouses particular and increasing interest is the question of the conflict which might exist when both a husband and wife are attorneys practicing in the same community. Are the rules and customs governing this relationship the same as those that control the situation when a father and a son practice in the same area, or when two brothers are attorneys in the same firm or community? Opinions on the new area of husband and wife conflicts are being issued by the various state legal ethics committees. The ultimate resolution may tell us something about what lawyers think about the marriage relationship, as well as the sometimes mystical conflicts of interest which are imputed to individual lawyers and the disqualifications which are placed on them and the firms in which they practice.

The students are intrigued with the "Chinese wall" which law firms try to build between partners with obvious conflicts of interests. The students, like all the lawyers of America, hope that something more satisfying than an oriental metaphor may be forthcoming.

The questions in the class on legal ethics keep increasing in number and complexity. Can or should the federal government do more to control the "revolving door" so that lawyers who acquire an immense amount of knowledge about a federal agency may not then use it to help clients defeat the objectives of the same regulatory agency? Is it appropriate and fair to a defendant for a U.S. Attorney to hold a press conference and appear on television when he an-

Clark Papers Presented

Although Alice L. O'Donnell, longtime aide to Justice Tom C. Clark, was unable to be present for PAD Day at the Supreme Court, she nevertheless made her contribution to its success.

Miss O'Donnell, an official of the Federal Judicial Center, obtained from Justice Clark's widow one of a few pocket copies of the U.S. Constitution that were among his papers, for presentation to one of the new Supreme Court counselors. As the result of a random drawing, the recipient was David L. Mui of Las Vegas, Nev.

Like Justice Black, Justice Clark almost always had a copy in his pocket, and he delighted in handing copies to students and to young lawyers.

To the 11 women among the admittees, Miss O'Donnell gave copies of a Supreme Court Historical Society Yearbook containing an article she authored, entitled "Women and Other Strangers at the Bar." She did so, she wrote, "in the belief that the women being admitted . . . will be interested in learning what other women did to make all this possible."

Miss O'Donnell is a member of the PAD Supreme Court Committee.

PAD Day At The Supreme Court

In a special group ceremony on June 2, 1986, 52 members of Phi Alpha Delta Law Fraternity, International, from 22 states and the District of Columbia, were admitted to practice before the Supreme Court of the United States. Their admissions to the Bar of the Nation's highest court were moved by PAD Arthur J. Goldberg, former Associate Justice of the Supreme Court (1962-65) and former Ambassador to the United Nations, as the highlight of the 20th annual PAD Day at the Supreme Court.

Preceding the ceremony, the Fraternity sponsored a reception and continental breakfast at the court in honor of the new admittees, and a luncheon followed at the Rayburn House Office Building. There, an audience of over 100 heard a talk by Stephen J. Markman, Assistant Attorney General for Legal Policy, and witnessed the initiation of Cornelius B. Kennedy, Executive Director of the Supreme Court Historical Society, as an honorary member of the Fraternity. Mr. Markman was introduced by Dennis Dean Kirk, past Justice of the National Capital Area Alumni Chapter. Mr. Markman's talk focused primarily on the selection process for federal judges.

The initiation ceremony was conducted by Jack L. Miller, of Lebanon, Missouri, International Justice of the Fraternity; Robert E. Redding, of Washington, past International Justice, now Executive Vice-President of the PAD Public Service Center; and Randall V. Griffin, Justice of the National Capital Area Alumni Chapter.

Following the admission ceremony, Justice Goldberg returned to the West Conference Room and spoke informally with the admittees and other Brothers and Sisters of PAD. He recounted anecdotes regarding the Chief Justices whose portraits adorned the room; gave some tips on advocacy before the Supreme Court; answered questions; autographed programs; and posed for photographs.

Margeton, Supreme Court Librarian; Douglas McFarland, Acting Administrative Assistant to the Chief Justice, now Staff Director of the Commission on the Bicentennial of the United States Constitution; Leonard Johnson, of the Office of Juvenile Justice and Delinquency Prevention, Department of Justice; and Homer S. Taft, Lake-

wood, Ohio, International Vice Justice of PAD.

nounces an indictment? Is it proper for a state commission to require a judge to abstain from sitting on the bench for four months without pay because the judge allegedly gave the "appearance of impropriety" by associating with some of his former clients who may be associated with criminal activities? How difficult or easy should it be for a disbarred attorney to be reinstated as a member of the bar?

These questions — and countless others — arise in the ever more numerous cases noted in the BNA Reports on Professional Responsibility. The case law everywhere is expanding, even exploding. New lawyers 10 years after Watergate will face challenges which lawyers in a previous generation never required to meet.

Towards the end of each semester in the course on professional responsibility, many students express the feeling that the model rules, while valid and helpful for specific situations, are not especially helpful in the recognition and resolution of the larger questions which lawyers must confront almost daily. Seniors who have experienced a summer of legal work express a desire for some guidelines as to what to do when they feel that the legal work they are asked to do is useless or even harmful. If an attorney comes to think that a corporate merger or a leveraged buy-out is not productive of anything good (except large legal fees), what should he or she do? The model rules make it as clear as they can that a lawyer is not a "hired gun," but what does a young associate in a law firm do when he or she reaches the conclusion that legal work to achieve the objective sought by the client may be legal but is unproductive and even harmful to many people? That may be a classic dilemma confronted by lawyers on a regular basis. But seniors in law schools with a background of only 12 weeks of summer law practice find it disturbing, even frightening. They are further disturbed when they realize that even a 30-hour course in legal ethics has given them few specific norms by which to formulate their basic approach to the practice of law.

Issues of Responsibility Outside of Court

The Model Rules for Professional Responsibility seek to guide the lawyer when he deals with a client with a traditional problem or goes to court to represent him. The model rules give all too little guidance to the lawyer when he acts as negotiator, mediator or business agent for his client.

The authors of the model rules recognize this limitation. In fact, the American Bar Association has in place a new committee mandated to plot out the next issues in the area of professional responsibility to which the ABA should direct its attention. In recent testimony before that group I sensed the wide ranging issues in which that committee is involved. It is not anticipated that any new proposal would be forthcoming until the 1983 model rules are agreed to by most of the states. But the ABA in its Committee on Professional Responsibility (of which Professor Sam Dash is a member), is pondering diligently what the organized bench and bar should do about their respective ethical roles in American society in the century to come.

I do, however, point out to students that the bar has a moral role not always appreciated even by lawyers, much less the public. In the Canons of Professional Ethics which were the only and the controlling statement on legal ethics for the bar of America from 1908 to 1970, the lawyer is reminded that he belongs to a profession which "is a branch of the administration of justice and not a mere money-getting trade." The lawyer must support his client's cause "with undivided loyalty" but the lawyer "must obey his own conscience and not that of his client." The client, the canons state in another place, "cannot be made the keeper of the lawyer's conscience in professional

matters."

Canon 31 states this basic principle in another way:

The responsibility for advising as to questionable transactions, for bringing questionable suits, for urging questionable defenses, is the lawyer's responsibility. He cannot escape it by urging as an excuse that he is only following his client's instructions.

Canon 32, entitled "The Lawyer's Duty and the Last Analysis," is probably the strongest statement ever made in all of the canons, codes and rules set forth by the American Bar Association. It is a bit rhetorical but worth quoting:

No client, corporate or individual, however powerful nor any cause, civil or political, however important, is entitled to receive nor should any lawyer render any service or advice involving disloyalty to the law whose ministers we are, or disrespect of the judicial office, which we are bound to uphold, or corruption of any person or persons exercising a public office or a private trust, or deception or betrayal of the public.

After that vivid description of what a lawyer must never do, the canons have this prescription of what he should do:

... [A lawyer] advances the honor of his profession and the best interests of his client when he renders services or gives advice tending to impress upon the client and his undertaking exact compliance, with the strictest principles of moral law. (emphasis supplied)

The professors of legal ethics for the 35,000 law students who become lawyers each year are undoubtedly urging in diverse ways that lawyers must urge their clients to "exact compliance with the strictest principles of moral law."

The lawyers who brought shame and disgrace to the legal profession in Watergate probably never heard of Canon 32. The law schools of America and the American Bar Association are doing their best to make certain that no lawyer ever forgets it again.
