



## **Touro Initiates 51**

Touro Chapter initiated 51 new members on October 8, 1986. The chapter now boasts 180 members, an all-time high.

The outstanding success Touro Chapter has enjoyed can be attributed to the many social and professional activities offered by the chapter.

Students have been particularly interested in the educational benefits sponsored by the chapter. As an example, a question and answer session recently allowed the students to mingle with professors in an informal atmosphere. Professors explained what they expected of first year law students and methods of preparation.

A persuasive legal writing seminar was presented by attorney Stanley Chess, who is a Director of BAR/BRI. He offered tips to assist students in writing effective briefs and memoranda. Members of the Touro Law Review presented an exam and outline seminar which discussed how to distill the semester's work to produce concise outlines and to convey knowledge on law school exams.

## The Family And The Law

PAD has embarked on a six-year program to help commemorate the 200th anniversary of the U.S. Constitution. It is multi-faceted in nature, with principal emphasis on an outreach to the communities of the nation to educate local citizens about key aspects of the Constitution as they apply to daily living.

One of these projects involves the organization of local intergenerational discussion groups to discuss the newest publication of the National Council on the Aging entitled "The Family, the Courts and the Constitution." Such groups will include both senior citizens and high school students.

The first such discussion group was held in Amherst, Massachusetts, in August, 1986. As a result of this experience, the following article was written by a high school student who participated in the session. The author, Joanna Schimmel, heard about the program from her father, University of Massachusetts Professor David M. Schimmel.

Her article provides enlightenment about the exchanges of viewpoints shared by senior citizens and young people in our school system on Constitution related subjects.

'During the summer before my senior year in high school, I took part in an intergenerational discussion group on 'The Family, the Courts, and the Constitution.' I began the experience believing that most older people are conservative and inflexible. Over a five-week period, our group of 15 students and seniors explored a variety of challenging and complex issues, such as the rights of grandparents, the role of the state as parent, and whether terminally ill patients have a right to die. The candid and sometimes contentious discussions shattered my preconceptions about the views of senior citi-

"Our discussions, which were cosponsored by the Senior Center of Amherst, Massachusetts, and the Phi Alpha Delta Law Fraternity, International, were based on materials prepared by the National Council on the Aging. We began with a seemingly simple question — "What is a family?" I immediately thought of a mother and father and one or more children, or perhaps a single parent and his or her children. But others had far different ideas. They men-

tioned 'families' in a monastery or convent, a 'family' of unrelated older people living together, and even a homosexual couple with adopted child. To my surprise, these unconventional ideas came more often from the elderly than from the youth, and I realized that I was more tied to tradition than most of the seniors.

'The most thought-provoking session for me concerned the government's role in marriage. Our discussions focused on an old Supreme Court decision allowing Utah to outlaw polygamy among the Mormons. The question was whether the constitutional right to freedom of religion should allow individuals to choose polygamy. At first, I was adamantly against polygamy. It seemed wrong, sexist and degrading to women. And all but one in our group agreed. 'But,' asked our discussion leader, 'what if a woman wanted to marry a kind, wealthy Morman who already had one wife? Shouldn't minorities be able to freely practice their religions if they don't harm others?' These questions were difficult for me to answer since I believe that people should have the right to live as they desire if they don't interfere with the rights of others. Thus, the arguments raised on behalf of the Mormons made me realize that I had two strong beliefs in conflict. Like others in the group, I began to question my initial position.

"Finally, I reluctantly concluded that if Morman adults freely chose polygamy, then the First Amendment should provide an exception to the state's monogamy laws for religious reasons. Although the vote was much closer at the end of our discussion, the majority of our group was still against polygamy. But, after a tough intellectual struggle, I found myself on the side of the minority. Perhaps I had gained more sympathy for unconventional religious minorities, or a better understanding of the First Amendment.

"Another topic was Education and the Family, and the problem of school discipline. Several of the seniors recounted their personal experiences with unfair corporal punishment. Yet, they — unlike the students — still felt that teachers should have authority to use physical punishment. 'The problem today,' said one older participant, 'is that school





## SPRING RUSH — 1987

I congratulate all chapter officers, and members on an outstanding effort this fall in rushing new members. As of December 12, 1986, we had approximately 3,100 new members, which puts us on line with a 4,000-plus year. While I am pleased with these numbers, I feel we have the opportunity to achieve a goal that few of us ever felt possible; to initiate 5,000 new members in one school year. To do this, we will have to dedicate ourselves to work as hard in the spring semester as we have in the fall. We must have at least one spring initiation and possibly two or three. We can't be satisfied with an initiation of five or 10 students, but must work to get 30 or 40 in the spring. After we have initiated these new members, we can't stop, but rather get their initiations reported within 10 days after they occur. (Some initiations weren't reported for three or four months this fall.)

Traditionally, our initiations decrease drastically in the spring. Many first year students are rushed in the fall but not in the spring and by the time they start their second year, we have lost them forever. When we lose a student by not making PAD available to them, we lose their drive, their input, their direction, and their support. They lose the opportunity to associate with PAD and benefit from all that we have to offer.

I call on all of our membership to accept the challenge. To set a spring initiation goal and dedicate our efforts to achieving that goal. To make all law students, pre-law students and attorneys, aware of the attributes and goals of PHI ALPHA DELTA. To ask them to join us in our effort to better our fraternity, our law schools, but most of all, our profession.

Thank you again for your membership in PHI ALPHA DELTA and I hope 1987 is all that you desire it to be.

rules aren't strict enough.' 'I think it's absurd that students should be permitted to smoke on school grounds,' said another.

"Although the students agreed that smoking should be discouraged, they did not feel it should be prohibited. 'If schools didn't allow students to smoke outside,' explained one of the teenagers, 'they would smoke in the bathrooms. Rules can't prevent smoking; they would just cause people to smoke secretly.' On this issue students and seniors disagreed. But it was the only topic we discussed where disagreement seemed to be based on age.

"Through participation in these intergenerational discussions, I gained a better understanding of how the Constitution affects family life. Equally important, I found that on many issues, I was more tied to tradition than they were. Most of the older people in our group seemed able to look at complex issues from a broader perspective and were often less limited by convention. The discussions enabled me to test my ideas and get challenging 'feedback' from my peers and from seniors. As a result, I felt a barrier between the ages had been broken. For the first time, I had talked with seniors (other than relatives) about important questions. I now believe that intergenerational discussions should be part of every student's education.'

## 300% Hull Membership Increase
