

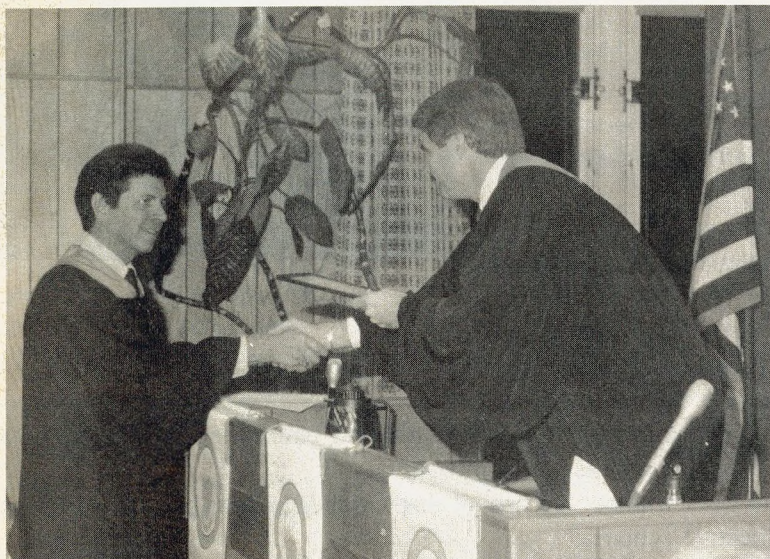

Ascutney is known as the Vail of the East, and the spectacular fall colors helped to attract officers from five chapters, International Proctor Clifford Schechter and International Field Representative Maree Wiggins. Chevy Chase, the famous comedian, was also there, but it has not been determined whether it was the PAD Conference that attracted him, or just the beautiful countryside of Vermont.

The weekend began with an ice-breaker reception Friday night from 5:30 to 8:30. This initial event was held in the "Winner's Circle", a very comfortable private room with a panoramic view of the Vermont mountains and colorful foliage. Very favorable rates have been negotiated with the Registry Resort Hotel, one of the nation's premier resorts. The Registry is located in Scottsdale, which is on the outskirts of Phoenix.

Plans are presently being formulated to assure members in attendance of an outstanding social program which will be coordinated with matters of extreme fraternity interest. Subsequent issues of *The Reporter* will carry more details.

Be Sure To Return Data For Directory!

All dues paying alumni should have received a request for the essential information required to assure complete data in the new Alumni Directory tentatively scheduled for release in July/August 1988. We sincerely hope that everyone has replied.

Publication of the directory will be handled by Harris Publishing Company of White Plains, New York. This company is the sole authorized agent for the production and marketing of the directory, and assumes all financial obligation, including the compilation, editing, billing and distribution of the volume and will cover its costs through individual book sales to alumni only.

During the next several months, alumni will be contacted by telephone for verification of the information to be printed in the directory. PAD Installs 170th Chapter

The John B. McManus, Jr., Chapter at the University of New Mexico became PAD's 170th Chapter on Friday, November 6th in the courtroom of PAD Alumnus The Honorable Richard Blackhurst at the Bernalillo County Courthouse in Albuquerque, New Mexico. Presiding at the Installation were International Justice Jack Miller, District V Justice Jerry Landau, Albuquerque Alumni Chapter Justice Peter Moughan, Jr., PAD Judges Richard Blackhurst and Joseph Baca, and Professor John Laflin.

Sixteen Charter members were initiated into the John B. McManus, Jr., Chapter. Installed as Charter Officers were: Justice Cheryl Moberly, Professional Vice Justice Manuel Lucero, Social Vice Justice Roxanna Prelo, Treasurer Dan Pick, Marshal Loretta Berman, and Historian Tricia Crane. Charter Clerk Doug Cordova was unable to attend the ceremony and was installed separately by Justice Moberly. Acting Clerk at the Installation was Troy Pritchard.

The McManus Chapter is named for the late Chief Justice John B. McManus, Jr., of the New Mexico Supreme Court. Throughout his legal career, the late Chief Justice McManus embodied the principals upon which Phi Alpha Delta was founded: integrity, compassion, courage, and professional competence.

Among the honored guests present at the Installation were Terry McManus Sterner (widow of the late Chief Justice McManus) and her husband Don Sterner. Other special guests included PAD Alumnus William (Bill) L'Esperance, John Speer, International Field Representative Maree Wiggins, and family and friends of the Charter members.

Following the Installation, a banquet was held at the Sheraton Old Towne Inn. The celebration continued in grand PAD style at The Cantina.

The McManus Chapter has among its goals working with the Albuquerque Alumni in the field of law-related education helping to teach the youth of New Mexico about our legal system. In addition, the McManus Chapter has begun plans for its Spring rush.

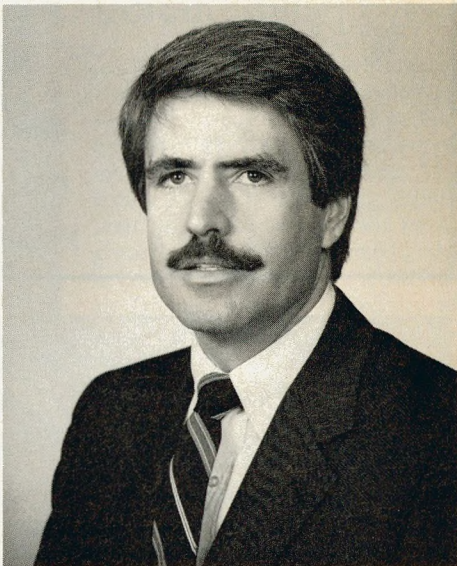
So what are our goals for 1988 and the 1990's? I propose the following:

Before going to law school, she was a Social Studies and English Teacher at Grace King High School.

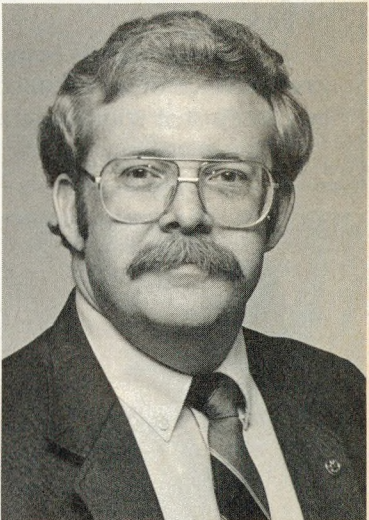

ALABAMA

THOMAS B. OSKER, Story Chapter, DePaul University, passed away recently in Montgomery, Alabama. A past Justice of Story Chapter, he never practiced law but utilized his legal education as Executive Assistant Manager of the Conrad Hilton Hotel for more than 20 years.

ARIZONA

DAVID ROBERT POSEGATE, Field Chapter, University of California, is serving as Corporate Counsel with MicroAge, Inc. in Arizona.

CALIFORNIA

HONORABLE KATHLEEN PARKER, a member of the Los Angeles Alumni Chapter, has been honored for her 30 years as a trial judge. She was selected as the Person of the Year by the Metropolitan News published in Los Angeles County. The presiding judge of The Los Angeles Superior Court stated, "She has always carried out her judicial tasks in a most exemplary manner and with the highest of praise from both sides of the criminal bar as well as her fellow judges. She possesses a great judicial temperament and unquestioned dedication to the law, and above all, a sense of humor."

Reports are that **HOMER HENDERSON**, Holmes Chapter, Stanford University, 1923, and a retired judge of the Superior Court in Contra Costa County looks every bit as vigorous and witty as he did on the law steps at Stanford University School of Law many years ago.

Another Holmes Chapter alumnus, **JUDGE BENJAMIN COSHING DUNIWAY**, passed away recently after a brief illness. He was one of Stanford's most illustrious graduates having distinguished himself in private practice, government service and ultimately as Senior Judge of the U.S. Court of Appeals for the 9th Circuit.

JOHN A. SUTRO, Temple Chapter, Hastings College of Law, has been given the 1986 Distinguished Service Award from the National Center for State Courts. This award recognized his outstanding contributions to court administration and to the National Center. Sutro is currently chairman of the senior advisory board of the Ninth U.S. Circuit Court of Appeals, and works extensively with many court related organizations.

DAVID HAZELKORN, McKenna Chapter, UCLA, had an article published recently in the Akron, Ohio, Law Review. The article was titled, "In re Barzak: Access to Children's Services Files", and explains in detail the legal implications of a state law which was created in the interest of protecting the privacy of children and their parents in child abuse and neglect actions.

JUDGE NORMAN EPSTEIN, Justice of the Los Angeles Alumni Chapter, McKenna Chapter, UCLA, recently received an award from the California State Legislature for his work on the new California Discovery Act. Judge Epstein was instrumental in formulating the sweeping discovery act designed to eliminate discovery abuse and streamline litigation.

Los Angeles Superior Court **JUDGE JUDITH C. CHIRLIN**, Ross Chapter, University of Southern California, has been elected to the Executive Committee of The American Judicature Society. A representative of the society stated that she was elected for her interest and involvement in improving the judicial system.

PROFESSOR MURRAY L. SCHWARTZ, McKenna Chapter, UCLA, will become UCLA's Executive Vice Chancellor in September of 1988. Schwartz, a former dean of the law school, has been with UCLA for 30 years. He will be the Chancellor's principal deputy with primary responsibility for UCLA's academic programs.

CONNECTICUT

RICHARD M. MARANO, Patterson Chapter, Seton Hall University, has been elected Alderman in Waterbury, Connecticut. He is a partner in the law firm of Marano & Diamond with offices in Waterbury and Cheshire, Connecticut.

DISTRICT OF COLUMBIA

TIMOTHY C. FINTON, Brandeis Chapter, American University, and former trade policy advisor to the Office of Telecommunications, International Trade Administration, has been appointed policy advisor to Ambassador Dougan, Coordinator for International Communications & Information Policy, Department of State.

United States Claims Court **JUDGE LAWRENCE S. MARGOLIS**, Jay Chapter, George Washington University, has been elected president of the Rotary Club of Washington, D.C. He is the first federal judge to ever hold this position, and he will take office in July of 1988.

BOLON B. TURNER, Jay Chapter, George Washington University, former chief judge of the U.S. Tax Court, died recently. He was named to the Tax Court in 1934 and served as its chief judge from 1945 to 1949, and took senior status in 1962 officially remaining with the court until his death at age 90.

EDWARD BENNETT WILLIAMS, Taft Chapter, Georgetown University, joined the president of Georgetown University and the dean of the Georgetown University Law Center recently in hosting a reception at the United States Supreme Court to celebrate the start of construction of the new Georgetown Law Library. Williams spoke of his affiliation with Georgetown that spans four decades. He emphasized that with its location in the nation's capital and the resources at its disposal no school can match the talent or diversity that Georgetown attracts.

ROBERT R. STATHAM, Hamill Chapter, University of Indiana, and the fraternity's tax counsel for a number of years, passed away recently. Brother Statham had rendered outstanding service to the fraternity as its tax counsel and had attended various meetings of the International Executive Board. He previously chaired the Greater Washington Board of Trade's taxation policy committee and was a former taxation department manager of the U.S. Department of Commerce.

FRANK A. KREIDLER, Terrell Chapter at Florida State University, is practicing in Lake Worth, Florida, and is Lt. Commander in the Naval Reserve JAG Corps.

BRUCE ALEXANDER MINICK, Terrell Chapter, Florida State University, is presently Chief Advocate for the Florida Commission on Ethics. He is also Chief of the Attorney General's Personnel and Labor Litigation Branch in the Florida Department of Legal Affairs.

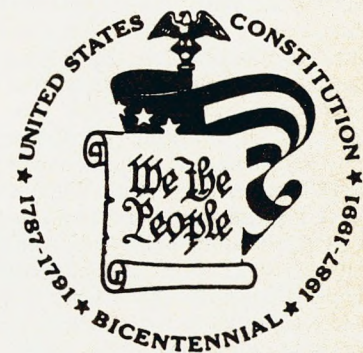

former PADs, judges, and prominent attorneys were present to talk with the visiting PADs.

The business meeting began at 9 a.m. with the introduction of International Proctor Cliff Schechter and International Field Representative Maree Wiggins, who contributed greatly to the Conference, followed by introduction of each chapter's participants. The business began with a "Thought of The Day" being discussed and utilized to motivate each participant. The quote, by Jean Jacques Rousseau, the famous French philosopher, was: "Few people know that anything is possible". In addition, the winner of last year's Most Outstanding Chapter in the District award was announced. Ilona Besseney of Arthur Chapter at Vermont Law School received the honor of best Chapter in the District. With the thought of the day, honors and inspiring talk of the unlimited potential of District XVIII in mind, participants began the day's work.

International Proctor Cliff Schechter spoke on the State of the Fraternity and Organization of the Fraternity, an important part of every Conference, but especially important to District XVIII because there had not been a District Conference for several years, and the members were particularly excited about PAD International. Chapter Status Reports from each chapter then revealed the strengths and areas of concern at each chapter. Each chapter in the District demonstrated that its school has several positive activities which are solely due to the success of PAD. For example, Chapter Justice of Ruffin Chapter at Harvard Law School, Lynn Gerber, explained that they have organized a security escort service, and Rex Guinn, Chapter Justice of Kenealy Chapter at Boston College Law School, shared that PAD produces the student directory

at B.C. Law, two examples of student services that PAD successfully provides in District XVIII.

The Chapter Organization workshop was very helpful and valuable. Information was given by several chapters, as well as by International Field Representative Maree Wiggins. The workshop was organized into several areas of importance, the first being Committee Operation and Delegation. Chapter Justice of Arthur Chapter at Vermont Law School Ilona Besseney explained the ultimate in Chapter Operation. Arthur Chapter has a General Meeting every two weeks where they vote on the major events of the Chapter. However, in the meantime, a Service Committee, Scholastic Committee, Public Relations Committee, Executive Committee, Speaker Committee, Social Committee, Budget Committee, and Membership Committee each meet within their small groups to plan and organize events. The committee chairpersons then report at the General Meeting on the plan. In this way the chapter is operating successfully on several different levels and in many areas of programming.

The addition of Delegation as a topic of discussion was District Justice Peter McGrath's idea. This is a new twist added to the frequently covered area of Committee Operation, emphasizing the importance of distributing the workload within the chapter to the committees and then to each member. Peter explained that a good event utilizes as many members as possible and allocates responsibilities to them all. Most will rise to the occasion, and the others will have committee chairpersons (not Chapter Justices) following up the delegation. The more people that are involved the higher the stakes; each person will then have his/her personal reputation involved with the success of the event and each will work hard for that success. It is very important for each chapter officer,

especially in smaller chapters, and for the Justice to not assume all the duties. Jobs *must* be shared, as well as the credit and exposure.

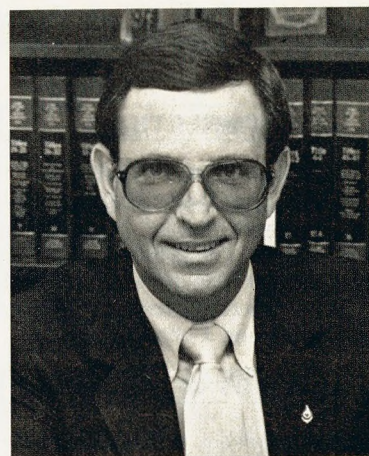
The importance of Faculty and Alumni Advisors was explained, and the role of the District Justice was demonstrated by Peter's discussion. In addition, the International Office support was made clear by International Field Representative Maree Wiggins who spoke on the vital importance of form filing. Another topic under Chapter Organization was *Meetings and Notice*. The importance of notifying members of all events was discussed. Arthur Chapter conducts phone banks, where each member of the sponsoring committee telephones a certain number of other members personally to remind them of the event. One other point about Chapter Organization was that members must be treated special: they should receive special benefits, such as discounted admission to events, etc., and Chapter Officers should be good to their members. Arthur Chapter sends all members holiday cards from the officers; at Christmas they gave out candy canes to all members. It is important to remind the present membership how special they are.

Chapter Image and Communication discussions emphasized the importance of publicity and working with staff and faculty of the school to maintain the positive impression of PAD. Arthur Chapter conducts an Alumni Phone-A-Thon to raise money for the endowment of the school and also conducts an Admissions Phone-A-Thon to contact prospective students. In turn, the school helps PAD advertise and conduct events. The spirit of cooperation is important in the success of Arthur Chapter's vigorous agenda of events. Talk of inter-chapter events was lively, with the Boston area chapters literally only a subway ride away from one another. In fact, Kenealy Chapter from Boston College invited the other Boston chapters to an initiation planned for October 21.

Maree Wiggins spoke on rushing and the audience was fascinated. Her ideas were numerous, and her Southern charm emanated as the participants grasped the many rushing techniques. Chapter officers also shared ideas between themselves and discovered methods to rush that had been successful elsewhere.

After a hearty breakfast and a stroll on the porch overlooking the Vermont mountainside, the participants posed for a group photo and just generally stretched their legs in anticipation of the afternoon's business. The first workshop of the afternoon was another original idea from Chapter Justice Peter McGrath, *Chapter Names*. In preparation for this workshop, each chapter was notified before the Conference to research their chapter's name. Each chapter was then asked to report to the Conference for five minutes on who the chapter was named in honor of. This proved to be most interesting and fun. The chapter titles ranged from United States presidents to the first black law student and prominent women legal scholars to law school deans. It also served to encourage each member to form some identity with the chapter name, and to remember their chapter name and others in the District.

Other topics of interest at the Conference were Chapter Programming, Fundraising and the Future Conven-

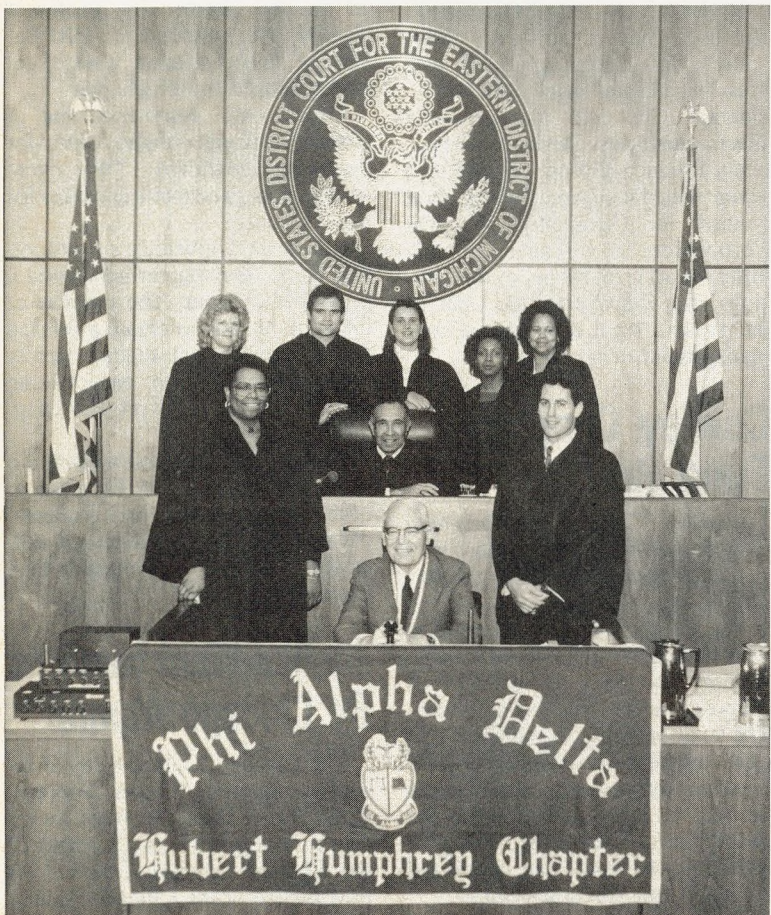
