New Grant Will Offer LRE For Preschool Children

The Office of Juvenile Justice and Delinquency Prevention (OJJDP) has, for the first time, authorized the Service Center in its 1987-88 LRE grant to develop a program to reach three- and four-year-old children. This experimental initiative was generally triggered by the November 1986 remarks of Brother Webster L. Brewer, Criminal Court Judge in Indianapolis, Indiana. In addressing the State Coordinator training session in Baltimore, Judge Brewer offered the following challenge:

"Our nation is third after South Africa and Russia in terms of our jail population, with half a million people now occupying our penal institutions.

"In 1970, the count was 174,000. In 1980, it had increased to 225,000. Today, it has reached the half million mark. By the turn of the century, I predict the count will reach one million criminals. I say this with a heavy heart. Therefore, we must do drastic things to reverse this trend.

"Two years ago a Rand Corporation report asserted that work must begin at the preschool level.

"By the time children reach the first grade, there begins an erosion of privacy and lack of respect for authority. By the 7th grade, our youth have turned truant and then to more serious offenses. By age 16, many have been expelled from school!

"I say to you that preventative efforts must begin at the preschool level. If we don't get the message and a constructive set of values across by the fourth grade, we are not likely to ever get them across. Law-related education begun at this early age offers some hope."

The preschool LRE program will be offered in the St. Louis, Missouri, metropolitan area, which currently maintains 28 preschool facilities as an integral part of the community public school system. These preschools have already developed a national reputation for effectiveness by showing impressive educational gains in young peoples' language arts and reading readiness skills.

This pilot project will offer additional advantages because the St. Louis school population includes a substantial number of minority students, many of whom are from poor families and single-parent families. Working with parents on this project, which may be done at home with their preschool children, will be very important to a successful program. A unique component in this program will be training law enforcement officers to participate in LRE activities

in the preschool classrooms. Along with these officers, lawyers and law students will share in the community resource lesson activities as a part of the overall preschool training. St. Louis is also the ideal city for this program because it will be managed by the Law and Citizenship Education Unit of the St. Louis Public Schools. This Unit is already working closely with local preschool teachers and staff, holding workshops and conferences, and working with parents. The Unit is managed by Ms. Linda Riekes, assisted by Ms. Armentha Russell, both of whom are long-time PAD consultants on law-related education.

Huber Is Pres.-Elect Of AALS

Professor Richard Huber of Boston College of Law has been selected as President-Elect of the American Association of Law Schools. He will assume the office of president in 1988.

Huber, a member of Hammond Chapter at University of Iowa, served as Dean at Boston College from 1970 to 1985 and has also taught at the University of South Carolina and Tulane University.

All Justices Of Cal. Sup. Ct. Are PADs

All members of the newly constituted California Supreme Court are members of Phi Alpha Delta Law Fraternity, the Executive Office announced recently.

Heading the Court is Brother Malcolm M. Lucas, a member of Ross Chapter at the University of Southern California. Other members of the Court who are members of Ross Chapter are Justice David N. Eagleson, former presiding Judge of the Los Angeles Superior Court, and Justice Marcus M. Kaufman. Justice Edward A. Panelli is a member of Edmonds Chapter at the University of Santa Clara; Justice Stanley Mosk is a member of Engle Chapter at McGeorge School of Law; Justice Allen E. Broussard is a member of Field Chapter at the University of California at Berkeley, and Justice John A. Arguelles is a former Justice of McKenna Chapter at UCLA and a former Justice of the Los Angeles Alumni Chapter.

PAD Chief Justices

Fourteen members of Phi Alpha Delta are serving as Chief Justices of state courts. As *The Reporter* goes to press, plans have been completed for the initiation of two additional Chief Justices on an honorary basis who are the Honorable W. President Carter Receives Clark Equal Justice Under Law Award

On September 14, 1987, in ceremonies conducted at The Carter Presidential Center in Atlanta, Georgia, President Jimmy Carter received the Tom C. Clark Equal Justice Under Law Award of PAD.

Presentation of the award was made by International Justice Jack Miller. Also in attendance at the ceremonies were International Second Vice Justice Larry Crigler, International Marshal Mike Bearden, International Proctor Cliff Schechter, Executive Director Fredrick J. Weitkamp, United States Attorney Robert Barr, former Tribune Shelley Weinstein, and District Justices Dolores Hand, Peter McGrath and Eric Hutson, and Fish Chapter Justice Chris Nicholas.

In accepting the award, President Carter stated:

"This is a very great honor for me for many reasons. First of all, the Phi Alpha Delta membership, more than 100,000 strong, has evidenced your personal commitment to equal justice under the law. Secondly, Tom C. Clark was a neighbor of mine. With his courageous commitment to equal justice under the law, he brought about changes in the law to the benefit of both black and white . . . this award is dedicated to principles that have guided the founding fathers of our country. I am very honored to be the recipient of this award named for such a great man and bestowed on me today by a wonderful organization that keeps alive these principles which have guided our country and I hope will guide my own life so long as I live."

In making the presentation, International Justice Jack Miller stated:

"It is only fitting that the largest international legal organization in the world should gather during the Bicentennial of our Constitution to honor two great Americans. As our Constitution was founded on Equal Jus-

tice for all Americans, so have the lives of our honored recipient, President James Earl Carter, and the outstanding jurist for whom the award is named.

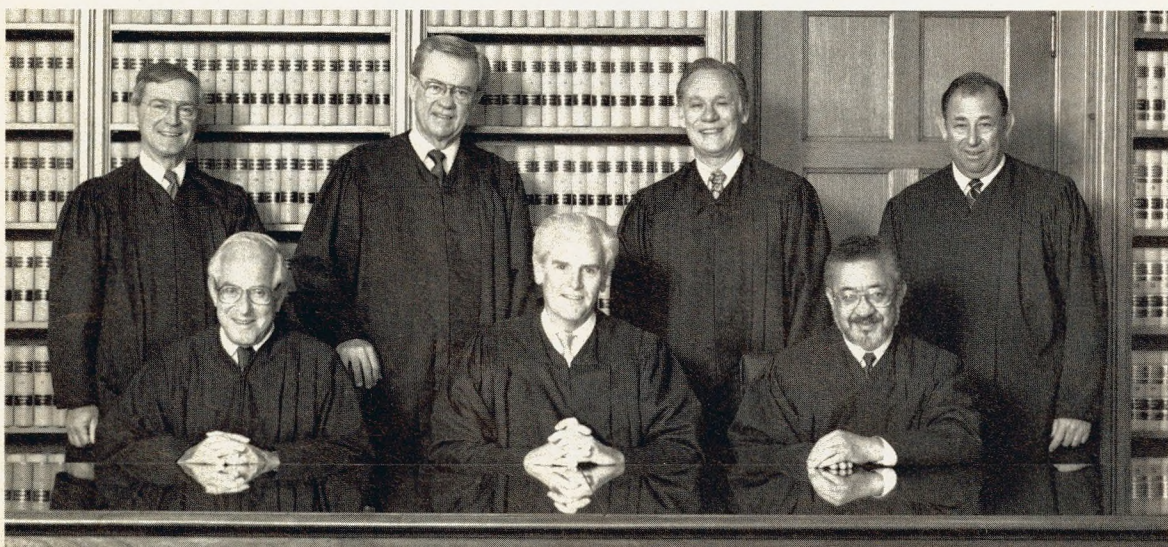
"The Tom C. Clark Equal Justice Under Law Award was named after a dear Fraternity Brother who distinguished himself in the legal community and who served our country as a member of the United States Supreme Court. His dedication was to the principles upon which the Fraternity was founded, principles of integrity, compassion and competency.

"During his term as a member of the Supreme Court, his decisions knew no prejudice, his ideals and morals were never compromised and through his devotion to the Constitution, he upheld the premise that this country would not survive without the application of Equal Justice Under The Law.

"In showing our love and the high esteem in which we held him, in his memory, we have named our highest award after him.

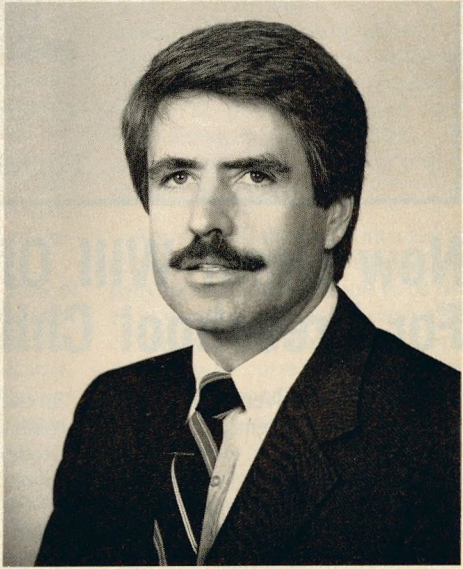

1986-87 LRE Grant Accomplishments

The law-related education program in effect during 1986-87 produced many good results for the Fraternity and the nationwide LRE program. The principal accomplishments during the 11 months ended June 15, 1987, were the following:

1. The management of the program was strengthened by gradually expanding our network of PAD Coordinators in all 34 target states. Their function is to work with state and local leaders in the promotion and implementation of LRE activities at all levels. Such Coordinators provide a desirable linkage between educators and leaders of the legal profession and justice system. They also contribute to the attainment of community support and the ultimate institutionalization of LRE in local school systems. The PAD Coordinators attended a highly successful training session in Baltimore, Maryland, in November 1986.

2. Additional resource manuals were published to facilitate resource person training, followed by local leadership in classroom and field trip activities. They include:

- a. The reprinting of our secondary education resource guide, entitled "A Resource Guide on Contemporary Legal Issues . . . for Use in Secondary Education".
- b. The printing of a new resource guide entitled, "The Lawyer-Teacher Partnership Program, a Resource Guide for Attorneys in Law-Related Education".
- c. The printing of a new resource guide entitled, "State Courts and Law-Related Education".
- d. The printing of a new resource guide entitled, "The Law

Enforcement Officer-Educator Partnership . . . A Model for Using Law Enforcement Officers in Law-Related and Citizenship Education Classrooms".

- e. The reprinting of a PAD Monograph entitled "For Value Received: Community Law Program Benefits to Law School Students".

- f. The reprinting of a PAD Monograph entitled "Crime and the Decline of Values".

- g. These publications and other PAD descriptive materials were widely disseminated to interested parties during the grant period, including all PAD law school chapters.

3. For the first time, the Kentucky State Bar Association and Administrative Office of Courts approved the use of PAD resource materials for purposes of continuing legal and judicial education.

4. Strong endorsement of LRE by PAD member Steve Clark, Attorney General of Arkansas and President, National Association of Attorneys General, was conveyed by personal letter to all Attorneys General of the LRE target states.

5. A variety of technical assistance training in various target states including lawyer-teacher partnerships, judicial training, law student training, and mock trial support.

Thomas Completes Term As ABA President

Brother Eugene C. Thomas, senior partner in the Boise, Idaho law firm of Moffatt, Thomas, Barrett and Blanton, has just concluded a very successful term as President of the prestigious American Bar Association.

Thomas, a member of Livingston Chapter at Columbia University, was also President of the Idaho State Bar in 1971-72. He was licensed to practice law in Idaho in 1954 following his graduation from Columbia School of Law.

In a message directed to the 1986 Convention of the Fraternity, Thomas stated, "The Fraternity has long been identified with the idea of fostering integrity and professional responsibility among lawyers around the world."

Thomas is also a past Chairman of the House of Delegates of the ABA, which is the policy-making body, and also chaired the association's Audit Committee and the Steering Committee of its Public Education Division.

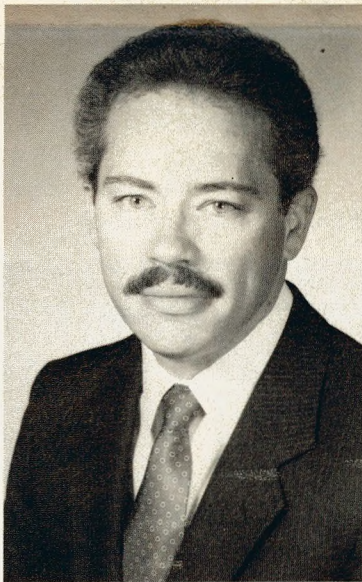

U.S. Atty. New District XVII Justice

Bob Barr, United States Attorney for the Northern District of Georgia has been appointed as the new District XVII Justice. The District includes Fish, Hull, Keener, Morgan, Russell, and A.H. Stephens Chapters.

Barr, who was confirmed by the U.S. Senate in October, 1986, heads a staff of 40 assistant U.S. attorneys and is responsible for prosecuting all federal offenses in the 46-county Northern District of Georgia.
