### Sen. Edward M. Kennedy Speaks Out On LRE

Sen. Edward M. Kennedy, a member of Jefferson Chapter at the University of Virginia, was a guest speaker at the Law related Education conference held at Boston College Law School in June of this year. Of Law related Education he said:

"Law-related education is one of the few programs that has been proved effective in reducing juvenile delinquency. A good civic education program involves young persons as genuine participants. The interaction between students and judges, lawyers, police officers and local government officials can produce vast changes in the attitude of young people toward their surroundings and in the opportunities they have to make positive contributions to society.

'As my brother Robert Kennedy liked to say, each individual can make a difference. As he told the students in South Africa on his visit there in 1966:

"Each time a person stands up for an ideal, or acts to improve the lot of others, or strikes out against injustice, he sends forth a tiny ripple of hope, and crossing each other from a million different centers of energy and daring, those ripples build a current that can sweep down the mightiest walls of oppression and resistance.

"Young persons can make a difference too, when they learn how to speak out effectively against injustice, to work for change, and to send out the ripples of hope of which Robert Kennedy spoke.

"Law-related education can also be a powerful weapon against one of the most pressing problems now facing society, the epidemic of drug abuse

"Illegal drugs are killing children, destroying families, and corrupting governments. Vast profits from the sale of narcotics have created a new criminal underworld which feeds on violence and sudden death. The lost productivity from drugs costs society tens of billions of dollars each year. There is no way to put a dollar value on the agony of a family whose dreams have been destroyed by the drug addiction of a child.

'At a time when federal dollars are scarce, it is no comfort to learn that South American drug traffickers gross more dollars annually than our combined federal, state and local law enforcement expenditures in the war on drugs.

In Bolivia, a drug dealer proposed to pay his country's \$3.8 billion national debt, in exchange for the Bolivian government turning a blind eye toward his illegal narcotics operation.

"In response to the public outcry, Congress is now making a new attempt to develop comprehensive drug legislation. We intend to examine every aspect of the problem, ranging from international cooperation, crop eradication, and military interdiction, to more effective local programs for education, prevention and treatment.

"We need to work more effectively on both the supply side and the demand side, if we are to deal with the staggering quantities of drugs and drug related violence plaguing our society. It is estimated that seven tons of heroin, 90 tons of cocaine and 9,000 tons of marijuana are used annually in the U.S. To combat that menace, we need law enforcement programs that work, and education programs that work.

'In law enforcement, we are developing three initiatives of particular interest — drug strike forces, special courts for drug disaster areas, and enhanced authority to seize drug

profits.

"We need to provide more investigative and prosecutorial resources, in order to encourage swifter resolution of drug cases. We also need additional prison facilities, and surplus federal property is an obvious place to put them. No convicted drug dealer should have the benefit of a reduced stay in prison because of overcrowded condtions. No convicted drug dealer should be permitted to return to the criminal activities that put him in jail in the first place.

"We need to take those who are convicted for all they are worth literally. Those who face charges should not be able to hide their ill-gotten profits. These criminals have no regard for the value of human life, but they do value money. Comprehensive seizure and confiscation law will strike at what they prize most - the profits from their illegal enterprise.

'And resources from seizure and confiscation will also yield needed funds for treatment and education, as well as additional assistance for the state and local governments that are fighting in the front lines of the war (Continued on Page 4)

The Honorable Russell G. Clark served as host for the evening's ceremonies. In his remarks to the attendees, Judge Clark charged the members and officers of the new Alumni Chapter to take seriously the Phi Alpha Delta ideals of professional service and outreach to the community. He noted that PAD could play a vital role in the Southwest Missouri Area. Judge Clark is known as an outstanding and courageous jurist not hesitant to advance constitutional principles. ### **Profiles In Excellence**

The profile of excellence for this issue of *The Reporter* is of Kennedy Chapter at Hofstra University, winner of the Stanley H. Kohn award for 1988, which is bestowed upon the law school chapter selected as The Most Outstanding PAD Chapter for the Year.

#### **Kennedy Chapter**

For 1987-88 Kennedy Chapter conducted an outstanding agenda of professional programs, among which were included the fol-

1. Career Opportunities in International Law. This program featured a panel of three practitioners specializing in various areas of International Law and was preceded by a dinner. The purpose of the program was to introduce students to fields of International Law and help promote attorney-student relations.

2. Trial Practice in New York State. This program featured the President of the New York State Trial Lawyers Association, who discussed the practice of trial law in New York and spoke about career opportunities for law students.

3. Career Day: Sports and Entertainment Law. This program featured a sports attorney who talked about sports and entertainment law, as well as specific instances involving his clients such as Reggie Jackson, Dave Raghetti, Liz Smith, and David Merrick. A wine and cheese reception followed the speech.

4. Dress for Success: A number of upperclass PAD members mod-eled the "do's" and "don'ts" for successful, professional appearance. The director of the placement office spoke about proper and improper attire. The purpose was, of course, to show students how to dress for an interview and in the office.

5. Interviewing Skills Seminar — Mock Interviews were staged by three PAD alumni. The purpose of the seminar was to enlighten the students on the interview process and to make them more at ease before going into an interview and to avoid some of the pitfalls.

6. Lawyers as Leaders - This was a lecture given by an Associate Justice of the New York State Supreme Court, who was subsequently, honorarily initiated into the Fraternity

7. Dinner-Lecture Series — This function generally took the form of a cold buffet dinner, followed by a speaker or panel. Topics included current legal topics and career opportunities.

8. Career Day — This was a onehour lecture focusing on specific ca-

reer opportunities. 9. Juvenile Justice/Law Related Education.

10. Judging of Moot Court program for first-year students.

11. Served as law student representatives for the continuing legal education program of the New York State Bar.

12. Organized and coordinated 10-hour review courses for criminal law, torts, civil procedure, and constitutional law.

The chapter also conducted an array of social programs for its members including the following:

**Chapter Oganization** 

Kennedy Chapter utilizes an excellent organizational system. The Executive Board consists of 15 elected or appointed officers who work together to organize and administer various PAD functions and committees. The Executive Board is vital because the Chapter conducts several events each week and implementation of such is important.

Each first-year PAD member is re quired to serve on a committee which is chaired by a member of the Executive Board. Committees which are utilized are Juvenile Justice/Law Related Education, First-Year Orientation, PAD Library, Newslettter, and Fundraising.

The Chapter is well-financed through numerous fundraising events, including raffles, bagel sales, Met games, student government association contributions, and chapter

One of the strengths of Kennedy Chapter is its Faculty Advisor Professor Linda Galler. Professor Galler attends chapter meetings and events, encourages other faculty members to attend functions, and is always available for consultation either on PAD or personal matters.

The Chapter also makes good use of the services of its Alumni Advisor Steve Luongo. Steve, a former Justice of the Long Island Alumni Chapter, attends chapter functions and his input and advice is often solicited. As the chapter states, "He is only a phone call away.

During the past year, Kennedy Chapter initiated the Vice Dean and three law professors, together with the law school Registrar.

Eleven members of Kennedy Chapter serve on the Editorial Board of the school's law review. The law school newspaper, "Conscience" is literally run by PAD's who hold positions of Co-editor-in-Chiefs, Business Manager, Layout and Production Manager, Managing/Copy Editor, and Staff Contributors.

PAD's are Editors-in-Chief of the Hofstra Labor Law Journal, the Hofstra Property Law Journal, and the Hofstra Entertainment and Copy Law Digest.

#### **New Record Set**

During the school year 1987-88, Kennedy Chapter set an all-time PAD record for the largest number of persons initiated in one year -157. Its rushing program was well calculated to establish this record. In early August, 1987, a letter was personally sent to all incoming first-year students, welcoming them to the law school and introducing them to PAD.



### A Review Of . . . DISTRICT XX

"IN SEARCH OF THE REPUB-

Public Virtue and the Roots of American Government" Richard Vetterli and Gary Bryner

A Book Reviewed by Hon. Howard T. Markey

Unlike Alex Haley's "Roots", this book will not serve as a basis for a successful TV movie. It is, however, no less deserving of the attention of all who are sincerely interested in our government and our society. Ours has always been a seeking and searching, not a settled society, but our searching and seeking can be a fevered floundering when done in ignorance or misperception of our roots.

Straightforward and up-front throughout, the authors of In Search of The Republic state what they are about in their first three sentences: "The idea of virtue was central to the political thought of the Founders of the American republic. Every body of thought they encountered, every intellectual tradition they consulted, every major theory of republican government by which they were influenced emphasized the importance of personal and public virtue. It was understood by the Founders to be the precondition of republican government, the base upon which the structure of government would be built." The authors then proceed to establish exactly that premise from the mouths and pens of the Founders themselves.

The book is an erudite, scholarly exposition, not a polemic. Massively documented with 777 footnotes and as many sources, it lets those who wrote and ratified the Constitution, and who observed its earliest days, speak for themselves. Organized in eight close-knit chapters and 229 pages of text, it is that rarity, a scholarly work that is a distinct pleasure to read. The metamorphosis of the idea of virtue from subservience to the state through renaissance humanism and puritanism, the relationship of virtue and religion, the separation of church and state, the relationship of faction to republican virtue, and the relationship of virtue to the commercial spirit and self-interest, are all set forth, not in the authors' words alone but in those of the Founders and near-time commen-

The sources quoted and cited begin with Aristotle and close with De Toqueville. Not a word is said, therefore, about contemporary American government, politics, or societal problems. Nor is anything said of the future. Indeed, the only flaw, and it is minor, is the use of "Modern" to mean a period ending around the turn of the 19th Century. Having echoed the voices heard in this land between 1787 and 1840, the authors simply leave to the reader any question on whether, and if so how far, we have strayed from our roots.

The book deserves a place in the libraries of lawyers and judges, as well as those of legislators and political science teachers. Though Beard's analysis of the Founders' motivations has been disproved, interim histories have simply ignored what is here so thoroughly set out.

In these days, when we are celebrating the 200th anniversary of the signing and ratification of the Constitution and the beginning of our government in 1789, an explication of our roots fills a critical void. It is at least difficult to do the best charting of our course if we don't know where we have been. Professor Adrian begins his excellent Forward with "Can the Nation's government as we know it today survive into the indefinite future?'

reminding us that it has existed for but "a brief, shining moment in recorded history". The authors do not attempt to answer the question, but their display of the role of personal and public virtue as the strongest of our roots is a major contribution, deserving of study and discussion in schools, churches, legislatures, and families.

Virtue as one of our principal roots and an essential basis of our freedom has been substantially absent from public discourse in an era when much has for years been heard in praise of pragmatism, when some are fully satisfied with "situational ethics", and when it is not universally recognized that no society can be free — and dishonest. In a free society, disputes are endemic and taking sides is a national sport. Hence there will and should be debate. The authors of Search for The Republic have rendered an outstanding public service in supplying grist for a debate on the meaning of virtue and how it and the Republic can best be preserved.




