PAD PSC Officials Attend Bicentennial Meeting

The Executive Vice President of the Phi Alpha Delta Public Service Center Robert E. Redding and the Center's new Assistant Director Brian A. Swerine joined leaders of Bicentennial Commissions from the 50 states, Puerto Rico, the Virgin Islands and the District of Columbia in Washington to plan the continuing commemoration of the 200th anniversary of the United States Constitution. The meeting held February 5-6 at the Hotel Washington, was sponsored by the Commission on the Bicentennial of the U.S. Constitution.

"Many people believe that the Bicentennial celebration ended last September 17," said Chief Justice and PAD Brother Warren E. Burger, Chairman of the Constitution Bicentennial Commission. "The signing of this great document on September 17, 1787, was the beginning of the process toward a new government. Events denoting the signing were only the beginning of our celebration."

A series of workshops brought state leaders together with staff members of the National Commission, as well as representatives of national organizations and associations involved in the Bicentennial celebration. Special emphasis was placed on educational programs, including "Adult Education."

Also a part of the weekend's activities was a Bicentennial Fair at which the National organizations were able to display their respective programs for the attendees. Phi Alpha Delta had a display in this fair, with which Brother Burger was much impressed.

The Commission also hosted a reception for the attendees on Friday

Past Supreme Justice August Rendigs, Jr. Dies

August Rendigs, Jr., who served as Supreme Justice of the fraternity from 1919 to 1921 died recently at the age of 93.

His career in the law spans some 50 years. Today a law partnership known as Rendigs, Fry, Kiely and Dennis bears his name.

A partner in the law firm stated that "he was dedicated to the practice of law, his family, and to the community."

He was the founder of United Cerebral Palsy of Cincinnati, worked closely with the Children's Dental Care Foundation, was on the advisory board of the Salvation Army and 32nd degree Scottish Rite Mason.

The 47th Biennial Convention of the Fraternity will convene at the Registry Resort in Scottsdale, Arizona, August 3-6, 1988.

Rates will be \$42 per room whether they are single, double or twin, which rate is far, far less than the normal rates of The Registry.

Plan Now To Attend

The Fraternity's 47th Biennial Convention promises to be the most outstanding in the history of the Fraternity.

It will offer members the opportunity to work and relax with law students, attorneys and judges from varied backgrounds, to experience full scale parliamentary proceedings, and

to make personal contributions to the future development of the world's largest law fraternity.

Law School Chapter delegates will experience the scope of the fraternity first hand and be furnished with fresh ideas and programs to take back to their chapters.

Convention Allowance

Law School and Alumni Chapter delegates will be provided a convention allowance based on the actual cost of least expensive commercial airfare as of March 1, 1988, hotel expense and subsistence allowance for each day of travel to and from the convention and each day while at the convention for one delegate. All chapters have been previously advised of the amount of the allowance.

Delegates

Each law school and alumni chapter in good standing is entitled to

have two delegates and two alternates at the convention and as many additional persons as desired. In order for a law school chapter to be in good standing and to qualify for the monetary allowance, all fees and forms must have been filed with the executive office prior to the convention. Each chapter has been previously notified of deficiencies.

In order for an alumni chapter to be in good standing and to qualify for the monetary allowance it must meet the following requirements:

1. The annual alumni chapter tax of \$15 must be paid for the two fiscal years commencing July 1, 1986 and ending June 30, 1988.
2. The chapter must have held two meetings during the period of July 1, 1986 to June 30, 1988.
3. The chapter must have elected officers and report the same to the executive office.
4. Each delegate must have paid international alumni dues.

Convention Program

The first official program item will be the reception which will commence at 7:30 p.m. on Tuesday, August 2, 1988. The reception will be held in memory of International Justice Stanley H. Kohn who passed away in November of 1985.

The convention proper will be called to order at 9:00 a.m. on

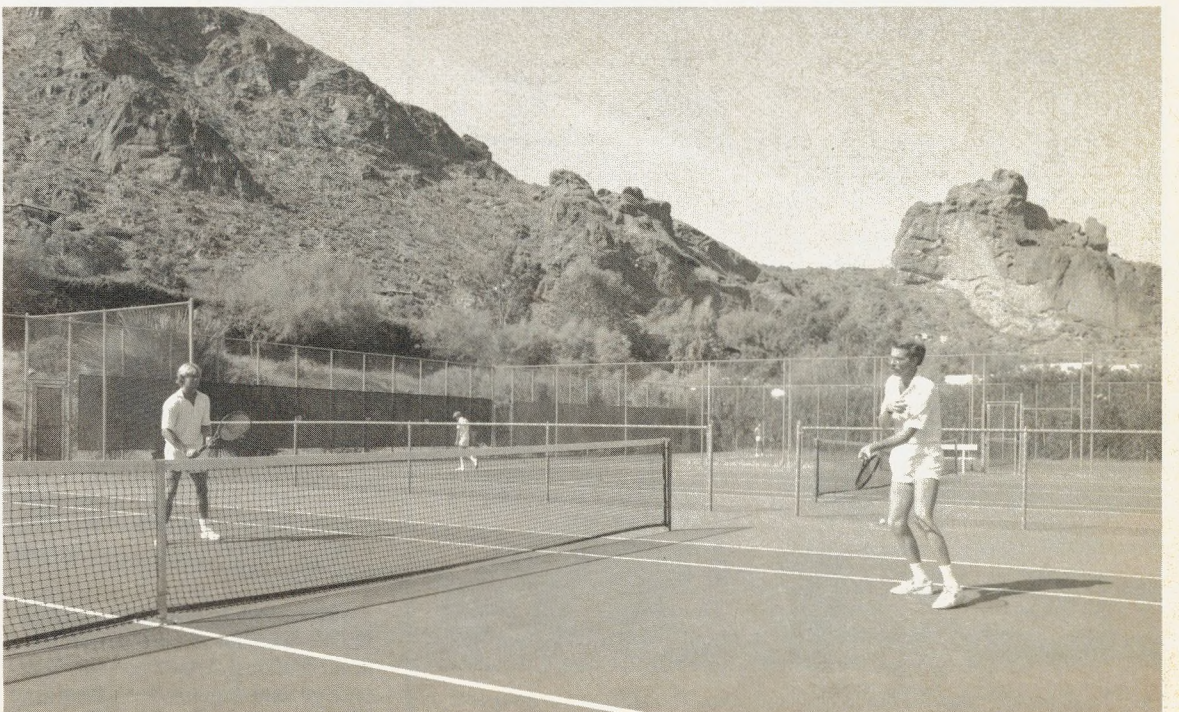

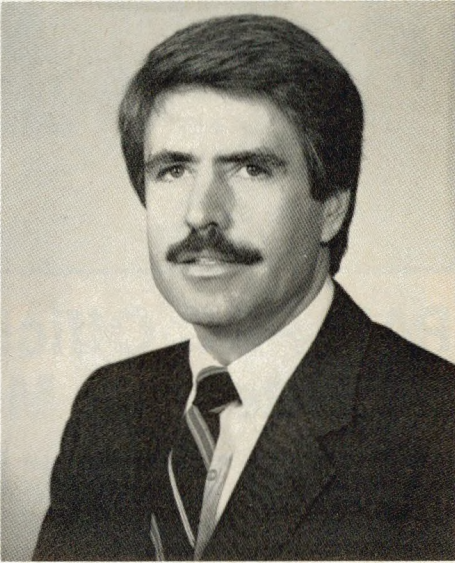

Hamill Chapter's 40th Anniversary

The 40th Anniversary of the chartering of the Ralph Hamill Chapter of PAD at Indiana University Law School, Indianapolis, was celebrated at the Columbia Club on Monument Circle in Indianapolis on March 25, 1988.

A marvelous scrapbook going back to 1948 was on display. It contained pictures and mementoes of the law school, people and activities of PAD over the years. The event was attended by students of the chapter, by alumni and their guests.
