## **PAD Public Service Center Report**

The 1988/89 fiscal year was a very busy one for the Phi Alpha Delta Public Service Center (PAD/PSC). Among the accomplishments of note are the following:

The management of the PAD PSC LRE program has been strengthened by the progress in the establishment and improvement of the nationwide network of PAD LRE Coordinators. Their function is to work, on a volunteer basis, with state and local LRE leaders in order to promote, implement and institutionalize LRE in all states. These Coordinators provide an important link between state and local educators, and members of the legal profession and the justice systems.

A training session was held for these PAD LRE Coordinators, as a part of the National Training of Trainers Seminar, in Washington, D.C., in July 1988. This Seminar also offered these Coordinators an opportunity to meet with "team" members from their respective states and thus extend their circle of links in LRE.

The Center continues to improve its computer capacity with the introduction of accounting software as an addition to the work processing program put in during the last grant year. We have also improved our communications system with the addition of a "voice mail" system, and we now have a FAX transmission and reception capacity.

The Service Center's efforts in the solicitation of support from national organizations in the legal profession continued during this grant period. These groups included the American Trial Lawyers Association of American Law Schools, Chamber of Commerce of the United States, Federal Bar Association, League of Women Voters, National Association of State Judicial Educators, National Criminal Justice Association, and National District Attorneys Association.

PAD co-sponsored the National Training of Trainers Seminar, July 6-10, 1988, mentioned earlier. We also helped to plan, and participated, in the ABA National LRE Leadership Development Seminar, November 14-16, 1988, putting on three different workshops sessions on Lawyer-Teacher Partnerships, Preschool Law Related Education, and LRE-focused Drug/Alcohol Education.

During the award period to date, the Service Center conducted or assisted 15 states in conducting their LRE Training of Trainers sessions, PPC's or in-service workshops, contributed over 100 hours of training or presentation time at these 15 sessions; and coordinated activities in 21 states with PAD LRE Coordinators.

Perhaps the most important and most interesting accomplishments was the Service Center's development, writing and publication of a new resource guide in the area of drug/alcohol education, entitled A Resource Guide to Assist Law Students for Participation in a High School Law-Related Education Drug/Alcohol Education Program. This guide was a comprehensive coolaborative effort of Brian A. Swerine, Assistant Director of the Service Center; Linda Riekes, PAD Consultant and Director of the Law & Citizenship Unit, St. Louis Public Schools; Armentha Russell of the same Unit; and St. Louis attorney, Judy Cromwell. Many other legal/education professionals also assisted and have been acknowledged in the guide as well. Published during this grant period in a "field-test version," the guide is being distributed to PAD law school chapters across the country

Another important factor, as a part of the drug/alcohol education program, is the training of law students. During this grant period, materials have been distributed at 15 different awareness sessions. Such awareness sessions were held in the 10 states of Arizona, Florida, Kentucky, Minnesota, Missouri, Pennsylvania, Texas, California, Delaware and New Hampshire.

Progress of this program will be monitored by Service Center Staff through the completion of evaluation and report forms, which are a part

Finally, the PAD PSC continued its efforts in the Fraternity's Bicentennial of the Constitution Program by sponsoring a visit by "Patrick Henry" at the Convention and by obtaining copies of video tapes on the subject for loan to PAD chapters for showings.

### **SUCCESS DOES NOT ASSURE ENJOYMENT**

Many lawyers are finding the stresses and pressures of the practice of law overwhelming, causing them to enjoy the practice much less than they once did.

At a recent ABA conference, it was determined that many of the nation's lawyers are earning more but enjoying it less. Complaints about professional burnout, stress and disenchantment in the legal field peppered discussions at the conference.

In a recent survey of 1,000 Maryland lawyers, it was found that:

Two-thirds of those polled are "definitely glad" they re lawyers but one-third are thinking of leaving the profession.

80% say "an increasingly negative public view" of lawyers is the big cause of the dissatisfaction.

These lawyer reactions at the ABA conference and in the Maryland survey are typi-

cal. I believe that service in a meaningful program of a professional organization can not only help to relieve the stresses within the practice of law, but can additionally enhance the public perception of lawyers.

I'm pleased that Phi Alpha Delta and the American Bar Assocition, the world's two largest legal organizations, have joined hands to participate in many new meaningful professional programs. PAD and the ABA are now joint participants in endeavors to enhance the profession in the professional program areas of Ethics; Professionalism; Law Related Education in our nation's elementary and secondary schools; and drug and alcohol abuse programs. These are all programs in which you as a lawyer can participate and that cannot only be meaningful to you, but also meaningful to the profession, the other program participants and the public. Lawyer participation in a successful professional program whether PAD sponsored, ABA sponsored or jointly sponsored can be a source of relieving stress and enhancing the public view of our profession.

Brother Stanley Chauvin, newly elected president of the ABA, and the members of the Phi Alpha Delta International Executive Board are both committed to continue programs that will help lawyers deal with the stresses and pressures of the practice of law and to enhance our image with the public we serve. I hope that many more new programs and endeavors will be mutually pursued by our two great organizations and the spirit of professional co-operation between our organizations will continue for years to come.

## Writing The Resume That Sells Law Practice

The preparation of a good resume takes time. Each individual has a different background with particular points which should be emphasized, and different job objectives which could be stressed. Therefore, you should do some self-evaluation and professional orientation to identify your job objectives before you begin to write your resume.

First, make a written list of your educational background. Break it down according to outstanding accomplishments, articles written and published, awards and scholarships received.

Make a list of potential references. Include those former employers, professors, deans or friends who will be able to help you in "selling your-

self to the public." Include 3 professional references in your resume. Finally, list your past legal employment as well as any professional experience you have had in business or the military.

Planning: Be sure to place the items in a logical sequence. Be brief and accurate. Visualize a format and adapt it to your own personal history and specal circumstances. Your resume should be short enough to tell your own story, but short enough to avoid unnecessary detail.

Writing the Resume: In addition to any special marginal headings, your resume should include information under the following headings:

Personal Data

 Job Objective: State as specifically as possible the field or occupational area of your choice, and the business function you are best equipped to perform.

 Education: List the schools attended, dates and types of degrees received in reverse chronological order. If you have not yet graduated from law school, indicate that you are a candidate for the degree. List your class standing/grade point average as appropriate. If your grade point is a C or lower, it would be advisable to leave out any references to class standing/ grade point. Point out the area(s) of concentration in your academic work in order to strengthen your job objective. If you have no actual professional experience, your educational background represents your greatest selling asset.

• Employment: List in reverse chronological order along with dates of employment and the positions held. If the title is not self-explanatory, include a brief description of your activities and responsibilities. Your professional experience is a strong asset worth careful preparation.

#### Points to Remember:

- 1. Your resume is a reflection of you. Be truthful and accurate throughout the entire document. Do not exaggerate. You can easily focus on your more impressive qualifications without being untruthful or unethical.
- 2. If at all possible, your resume should be professionally printed. 3. Be succinct. Use one line descriptions. They are easier to read than paragraphs. Your eyes tend to scan paragraphs seeking something worth reading.
- 4. A "cover letter" should accompany your resume when sent to a law firm or agency. This brief letter should state your law school and class year, and interest in being considered for a position in the firm or agency.

The first paragraph may end, "A copy of my resume is enclosed." The next paragraph should state when you will be available for a personal interview. The remainder of your letter should state any special qualifications offered for the particular position.

5. PROOF READ your resume THOROUGHLY before it is reproduced.

- States with the most lawyers: California: 82,646; New york: 75,-733; Texas: 41,320; Illinois: 37,520; Pennsylvania: 34,880.
- Total Lawyers nationwide: 676,852 — almost double the number in 1970 (355,242). By the year 2000, there will be an estimated one million lawyers.
- Highest lawyer-to-population ratio: District of Columbia: 1 to 25; New York: 1 to 280; Alaska: 1 to 297; Massachusetts: 1 to 309; Colorado: 1 to 334. Nationwide: 1 to 418.
- What lawyers do: (using 1980 figures): Government: 50,490; Judicial: 19,160; Individual private practice: 179,923; Group private practice: 190,187; In-house corporate: 73,862; Private industry: 54,626; Educational institutions: 6,606; Other private employment: 12,630; Inactive/retired: 28,582.
- Billable hours: The average for partners, 1,680; for associates -1,840. Ten years ago, the average billable hours for partners was about 1,525. (Still, more and more firms are requiring 2200-2500 hours to justify present salaries and yield desired returns to partners.)
- Lawyer income: The average is \$101,455. The median is \$65,995. The average attorney's net worth is \$512,300. — ABA Journal, October 1987.
- Trends for House Counsel: A survey by Arthur Young & Co.'s Law Firm Consulting Group, found the average general counsel earns about \$235,000; senior attorney, \$91,500; and new law school graduate, about \$45,000. The number of law departments that handle all or part of their litigation in-house has doubled in five years, from 37% to about 75%. — National Law Journal, 9/5/86.



In 1972 he transferred to the Judge Advocate General's Corps where he rose to the rank of Commander. In February, 1981, he was detailed to the White House as Assistant Counsel in the office of Counsel to the President. He retired from the Navy in 1981. In 1983, he returned to the White House as Associate Counsel to the President of the United States. He served as General Counsel of the Department of Defense from 1986 to 1987 and as Under Secretary of the Navy from August of 1987.

In response to a congratulatory letter from PAD's International Justice, Brother Garrett wrote:

## **Edward Bennett**Williams Dies

Brother Edward Bennett Williams, a member of Taft Chapter at Georgetown Law Center and one of our country's best know lawyers, passed away last August.

His great national accomplishments in law, sports, and political affairs have been a legend for a number of years. His graduation from Georgetown Law Center in 1944 launched one of the great legal careers of the 20th century.

But not only was Williams a truly outstanding lawyer, but he was also a professor and mentor to thousands of Georgetown law students. Among his students were: Robert Drinan, later to be Father Drinan, U.S. member of Congress from Massachusetts and now a member of the Law Center faculty, A. Kenneth Pye, Dean and Chancellor at Duke University and now president of Southern Methodist University, and Vincent J. Fuller, another outstanding trial attorney with Williams' firm.

Edward Bennett Williams taught at the Law Center during a period of remarkable growth and change for the school. In a speech to PAD in 1964, Edward Bennett Williams called upon legal education to create a new curriculum that included extensive opportunities for actual courtroom experience, to impress upon young lawyers their obligations to defend the Bill or Rights in legal practice. That call mirrored the Law Center's emergence as a leader in clinical legal education.

In 1981, Williams returned to the lecture halls of Georgetown to deliver an address and issue the challenge "Law, Equality and Order: An impossible dream?" He reminded his audience of lawyers, law professors and students of their responsibilities as custodians of the American system of justice, to resolve the national plagues of crime and inequality. "The challenge for the law in the twilight of the 20th century is the restoration of domestic order and tranquility with the tools of liberty and freedom, while maintaining equality of opportunity." In recognition of his outstanding contributions to the law, Williams' law firm donated the sum of \$1,000,000 to Georgetown's new law library which has been named "The Edward Bennett Williams Law Library.

In a speech he gave in 1981, his life's philosophy was reflected when he said "I believe the really great people of each generation are those who have a commitment to excellence — a commitment that transcends every other facet of their being ... to be at all times, in all places, under all circumstances, the very best that they can be ... they are the people who have made this country great."
