California Supreme Court **Retains 100% PAD Membership**

Readers of The Reporter will recall that early in 1988, an article appeared in *The Reporter*, indicating that all members of the California Supreme Court were members of PAD

Recently, Justice John Arguelles resigned from the Court, and a PAD, Governor George Deukmejian appointed Joyce Kennard to fill the vacancy.

On June 14, 1988, the Los Angeles Alumni Chapter initiated the newly appointed Justice as an honorary member of that alumni chapter. Thus, the California Supreme Court continues to be all PAD in law fraternity membership.

Over 150 persons attended the banquet at which the installation took place. Among dignitaries in attendance were:

California Supreme Court Chief Justice Malcolm Lucas, California Supreme Court Associate Justice Edward Panelli, United States District Court Justice Albert Lee Stephens, California Court of Appeals Justices

Armand Arabian, and Herbert L. Ashby, and retired Court of Appeals Justice James Kobee.

A large number of Los Angeles Superior and Municipal Court Judges were also in attendance, as were Executive Director Fredrick J. Weitkamp, Pre-Law Director Maree Wiggins, and Immediate Past District Justice Alexandra Mells.

Presiding at the banquet was Los Angeles Alumni Chapter Justice Michael B. Harwin, Judge of the Los Angeles Municipal Court and a former Executive Secretary of the Fraternity. Past International Justice Sandy Rae administered the Oath of Honorary Membership.

Any eligible member interested in being admitted to practice before the United States Supreme Court in these special ceremonies may obtain an application form from the Executive Director by submitting the form below or calling the Executive Office at (818) 360-1941. APPLICATIONS MUST BE RECEIVED BY THE CHAIRMAN BY APRIL 15, 1990. The maximum number of members that can be accommodated is 50. Therefore, the first applications received will be the ones accepted.

A Tribute To Claude D. Pepper

One of our nation's outstanding leaders, Brother Claude D. Pepper died at the age of 88 on May 30,

Past Supreme Justice Robert E. Redding delivered the following tribute to him during the luncheon at PAD Day at the Supreme Court of the United States on June 19, 1989:

"Born poor in Alabama, he paid for college by working from 4 a.m. to 7 a.m. hauling coal and ashes at a power plant, not seeing a paved road until he went to college. He waited tables to help pay his way through law school, and still managed to graduate among the top six in the class.

"He became a member of Fletcher Chapter of the University of Florida, joining the chapter in the year of its creation - 1934.

"In a short time, he was elected to the Florida legislature. His first bill as a Florida legislator in 1929 waived fishing license fees for those

"'I am a Southerner and a Democrat, like my ancestors before me. But I consider this resolution out of place as an act of this body.' So he voted against a resolution to censure

Mrs. Herbert Hoover. "He was elected to the United States Senate in 1936, just one year too late to vote for the original Social Security bill; however, he supported all its extensions and in the 1970s and 1980s became the chief advocate of raising Social Security benefits and establishing Medicare.

"Although known for his support of older Americans, his first bill in Congress was to help handicapped children. His last project was to fight drugs and dropouts and keep American families together. Also, he was a leading voice in the call for greater freedom and democracy in Latin America.

'On June 4, 1940, four full years before the Allied D-Day landing in France, he introduced a resolution calling on America to lease its old warplanes to Great Britain. As a result, Congress enacted the Lend-Lease program the next year, providing a major boost to the Allies in Eu-

rope.
"He spent 14 years in the Senate. In 1950, he was opposed by former protege George Smathers, who (Continued on Page 4)

Profiles in Excellence

This issue's Profile of Excellence features the winner of the Stanley H. Kohn award as the Outstanding Chapter in PAD for the school year 1988-89 . . . Rasco Chapter at the University of Miami.

This year's Most Outstanding Chapter is truly representative of the statement that "it is not best because it is biggest, but rather that it is biggest because it is best."

The chapter ended the school year 1988 with 261 members, but then came back very strong in the succeeding year to increase its membership to a total of 304 members.

It provides its members with a highly organized program of rushing events and professional programs.

Rushing Programs:

Fall rushing started with members greeting first-year students at information tables and generally assisting in registration. Each organization is given an opportunity to display its presence at the law school activities fair. Rasco Chapter engaged in extensive planning over the summer to insure a special presence . . . the fair area was inundated with PAD members and officers wearing chapter shirts and spreading the word of PAD. Tables were covered with PAD banners and rushing paraphernalia ... prospective members were given access to PAD rushing materials and aids. Fall rush continued with PAD rushing tables, co-sponsorship of an orientation party and the PAD "Good Bye Life, Hello Law School" party. Rushing culminated with the chapter's first meeting which featured a "Hornbook raffle to entice attendants. Fall rushing was ultimately responsible for 108 new initiates.

Not content with this success, the chapter engaged in Spring rushing with the major event being a Luau on the Bay party.

Professional Programs:

Among a multitude of professional programs, the chapter sponsored the following:

- 1. Publication of a law school directory.
- 2. Presentation of \$500 scholarships to worthy students.
- 3. Lectures on Health Issues and the Legislative Process, Tort reform in Florida, prosecution and defense of DUI cases, Due Process and Florida Bar applicants, summer clerkships and legal careers in public interest, "What can I do to be selected by a law review," the Moot Court or Bar & Gavel, group discussions, etc.
- 4. Oral arguments before a mock Supreme Court.
- 5. Big Brother/Sister in Law pro-
- 6. Mock job interviews and placement board.
- 7. Examination packets.
- 8. Compilation and distribution of course outlines.
- 9. Various community service programs including nursing home visits, Thanksgiving and Easter food
- 10. Auctions to raise scholarship funds.

Social Programs:

A variety of social programs were sponsored by the chapter throughout the year and included the following:

- 1. A tailgate club at University of Miami football games.
- 2. Initiation party banquet. 3. Beach vollyeball tournament.
- 4. PAD movie night.
- 5. Auction and cocktail party.
- 6. Halloween party. 7. Railgate club (similar to a tail-

- gate party, but for basketball).
- 8. An awards luncheon.

Leadership Positions:

Members of the chapter held virtually every position in the law school student body and class affairs, including SBA President, Vice President, Treasurer, Secretary, Bar & Gavel President and Vice President, Corporate Law Society President, ATLA Director, Budget Allocation

Eighty-one members of the chapter served on the editorial board of the University of Miami law review. Fifty-seven served on the Board of Editors of the Inter-American Law

Members of the chapter ranked very high scholastically in the law school. The class of 1991 boasted the first, second and third place scholars.

Three members of the chapter served as editor of the University of Miami Law School newspaper, while eight others served in other po-

Members of the chapter participated heavily in Law Related Education by conducting class sessions, participation in career day and/or conducting mock trials in 18 junior and senior high schools, interaction with the local Bar, projecting a positive school and chapter image to the community at large, and providing students an opportunity to improve their speaking skills.

Chapter members also engaged in PAD's Drug/Alcohol program.

New Projects:

The chapter adopted several new projects during the year recently concluded. After attending the PAD International Convention in Scottsdale, Arizona, several members brought back the idea of publication of a chapter newsletter. That letter has now become a reality and is known as "The Legal PAD." The chapter also inaugurated visits to a nursing home close to the campus. This program has been a success with chapter members and is a positive contribution to the community.

It is seldom that such a large chapter is able to so thoroughly involve its members in its activities. Because of Rasco Chapter's outstanding success in this regard, The Reporter is pleased to present Rasco Chapter as the Profile of Excellence for this issue of The Reporter.

L. Stanley Chauvin Becomes American Bar Assoc. President

Brother L. Stanley Chauvin, Jr., a member of Vinson Chapter at the University of Louisville, took office as President of the prestigious American Bar Association at its annual meeting last August.

Brother Chauvin served on the Board of Governors of the ABA from 1974 to 1977 and chaired its House of Delegates from 1982 to 1984.

PAD honored him at a reception sponsored by the Chicago Alumni and the Northern Illinois alumni chapters on Friday, July 28, 1989.

In addressing those assembled, Brother Chauvin stated that he had been a member of PAD for over 26 years, having joined as a law student at the University of Louisville School of Law. His pride in his PAD membership was exemplified by the fact that he wore his 26-year-old PAD pin at the reception.

Also present at the reception were members of PAD's International Executive Board, three Past International Justices, the Executive Director, the Pre-Law Director and the International Field Representative.

Brother Chauvin addressed those assembled, elaborating on the ambitious programs his administration would undertake.

PAD Day at the Supreme Court

In the annual PAD Day at the U.S. Supreme Court ceremonies held June 19, 1989, members of the Fraternity from a number of states were admitted to practice before the Supreme Court of the United States. Their admissions to the Bar of the Nation's highest Court were moved by Miss Alice O'Donnell as the highlight of the 23rd annual PAD Day at the Supreme Court.

Miss O'Donnell is Director of Inter-Judicial Affairs and Information Services at the Federal Judicial Center (FJC) and Past Chairman of the Judicial Administration Division of the American Bar Association. She was a long time aide to the late Tom C. Clark, while he was U.S. Attorney General, then Associate Justice of the Supreme Court, and finally the first Director of the FJC. Justice Clark was an international officer of the Fraternity.

Preceding the ceremony, the Fraternity sponsored a reception and continental breakfast at the Court in honor of the new admittees and a luncheon followed at the Rayburn House Office Building. The luncheon program featured the initiation of Noel Augustyn, Administrative Assistant to the Chief Justice, as an honorary member.

The initation ceremony was conducted by Eli W. Bizic, Justice of the National Capital Area Alumni Chapter, after Mr. Augustyn was introduced by Brian A. Swerine, Deputy Director of the PAD Public Service Center.

Another feature of the luncheon program was an eloquent tribute to the late PAD Senator Claude D. Pepper by Past Supreme Justice Robert E. Redding. Brother Pepper, who died May 30, was a frequent participant in PAD Day activities.

The program also included talks by PAD Chief Judge Howard T. Markey of the U.S. Court of Appeals for the Federal Circuit; Joseph F. Spaniol, Clerk of the Supreme Court; and Clifford Schechter, of New York City, International Marshal of the Fraternity. A light note was furnished by Brothers Redding

and William B. Robertson, who, in the course of the "Redding and Robertson Show", presented memorabilia and suprise gifts to the admittees. Brother Robertson, Past Associate Tribune, chaired the PAD Day Committee for 14 years.

Continuing a long-standing tradition, hostesses at the coffee and tea urns at the continental breakfast were Virginia Redding and Maxine Moore.

Peter McGrath, chairman of the PAD Day Committee, acted as toast-master at the luncheon, and Dennis Dean Kirk, past Justice of the National Capital Area Alumni Chapter offered the invocation.

charged him with being a liberal. He lost the election and retired to a lucrative Miami law practice. His comeback came at age 62 in 1962 when elected to the U.S. House of Representatives; where he served for 26 years. His Congressional career spanned six decades.

"He was married 42 years to his loving wife, Mildred. When cancer claimed her a decade agao, he intensified his lifelong efforts on behalf of research. He helped create the National Cancer Institute. Also, the World Health Organization. Also, the National Institutes of Health. In life, Brother Claude gave of himself. In passing, he gives us a gift more precious than gold or gems or precious stones. His legacy is that service to the many transcends service to self.

"He was a small man in stature but he was a legend in his

"He was a gentle man, with a passion for justice.

'He was a serious man, who could laugh at himself and the rest of us on this planet.

"He was a champion of champions - for civil rights, a strong America to defeat Nazi tyrrany, and for dignity for older Americans.

"He was born in Alabama in September of 1900

'He died in Washington on May 30, three weeks ago.

"At the age of 88, his verve and energy was as inspiration to us all. Our grief at his passing is not the best way to honor this individual. Instead, our greatest tribute to Claude Pepper will be to emulate his character and integrity while carrying on his dreams and convictions.

'It will be up to us to live a life of public service, to which we committed ourselves when we took the PAD oath of membership.

"Brother Pepper will be watching, expecting, admiring.

"Farewell, Brother Claude."
