Another "First" For PAD

The last decade of Phi Alpha Delta's history has seen major strides forward in the area of becoming an instrument of service to the people of our nation as members of a leadership role in helping to develop a better informed society about the structure and function of our diffrent levels of government and how we as a people are guaranteed important legal rights with correlative responsibilities. We are truly democracy ar work.

One of the Fraternity public service projects began in June 1981 when the Executive Board adopted a resolution to become an active participant in the upcoming bicentennial celebration of the 200th anniversary of the U.S. Constitution. While there is a proud history of events and activities during succeeding years, this is a story about our most recent commitment in the Bicentennial area, funded by the Bicentennial Commission in Washington. It involves a unique teaching function for our lawyer and law students members as they help elementary and middle school classroom students understand the Bill of Rights.

Evidence that our young people are growing up without a working knowledge of their historical and civic heritage is well-documented. Special surveys have confirmed that nearly one-third of the high school juniors in the U.S. cannot idenify the purpose of the Declaration of Independance or say in which 50 year period it was signed. As long as 10 years ago, only 3 percent of 9-year-old students named social studies as their favorite subject, compared to 48 percent selecting mathematics and 24 percent language arts.

We have also come to realize that teachers at the elementry and middle school levels don't receive the specialized training they need to teach about U.S. Construction and Bill of Rights. As a result, they lack the historical and legal knowledge to transmit this information to their students in legally and historically accurate ways.

This need was recognized last May by the Bicentennial Commission because Phi Alpha Delta had proposed a plan to help satisfy this need. The Public Service Center asserted that with special training, lawyers and law students can help elementry and middle grade students (and teachers) to gain a better understanding of their rich civic heritage, and the effect that history has had on their present, their future, and the future of our democratic society. The Bicentennial Commission unanimously approved the PAD proposal.

The project is called "Lawyers and Law Students: The Bill of Right in Elementry and Middle School Classrooms." Effective May 1, the 12-month grant award will enable lawyers and law students to visit the classrooms of America to help young learners to understand the impor-

tance of the Bill of Rights throughtout history and in their own lives to-day. This approch will enrich and extend exiting instructional programs, provide classroom teachers with the assistance they need to transmit legally and historical accurate information the Bill of Rights to their students; promote the use of law students; and, most importantly, give young students a greater understanding and appreciation of the history, fundamental principles and present-day applications of the Bill of Rights.

A new resource guide has been written by Roger Goldman, constitutional scholar and law school professor at St. Louis University of Law, that will become the vital working tool of the project. It contains instructions for lawyers and law students on how to work with young students, how to work with classroom teachers, how to intergrate lessons into the regular classroom program, and specific lesson plans for kindergarten through eighth grade classrooms. This guide will also help the lawyers and law students adapt its lessons for educably mentally handicapped, hearing impaired, and gifted students.

In the fall of 1990, this guide and the general training model has been pilot tested with lawyers and law students from PAD law school chapters in five states: Langston Chapter in the District of Columbia, Read Chapter at Widener School of Law in Deleware, Monroe Chapter in St. Paul, Minnesota, Sutherland Chapter at the St. Louis University School of Law. The trainees are now pilot testing the lessons in classrooms in their respective communities.

The results of the pilot testing will be collected and analyzed in January of 1991, and the resource guide will be revised based on these results. Multiple copies of the guide will then be distributed to all PAD chapters shortly thereafter.

Other contributing authors of the resource guide include Linda Riekes, Director of the Law and Citizenship Unit of the St. Louis Public Schools; Armentha Russell, lead Coordinator of the same Unit; and Sharon Slane, freelance consultant to educational organizational historian, Washington University in St. Louis.

Distinguished Law School Professor Joins Staff

Beverly Bunn ha been appointed Deputy Director of the Phi Alpha Delta Public Service Center. Located in the Washington, D.C. area, the Public Service Center is an affiliate organization which administers the public service programs for the Phi Alpha Delta Law Fraternity, International.

The Fraternity, though the Public Service Center, under the leadership of Executive Vice President Robert E. Redding, conducts a program through justice system volunteers to help reduce juvenile delinquency by a community service activity called "Law-related Education" (LRE).

Past I.J. Charles Taylor Elected To Congress

Past International Justice Charles H. Taylor of Brevard, North Carolina was elected to the United States House of Representatives last November

Brother Taylor lost in his race for Congress in 1988 by 1,000 votes and in 1990, won with a 52% advantage.

Congressman Taylor is Chairman of Financial Guaranty Corporation, Chairman of North Carolina Parks and Recreation Council, a member of the Wake Forest Law School Board of Visitors, member of the Board of Directors of Cradle of Foresty, and Vice Chairman of Western North Carolina Environmental Council.

He is also a member of the North Carolina Board of Natural Resources and Community Development and of the North Carolina Legislative Study Commission on Parks.

He is a former Minority Leader of the North Carolina Senate and also of the North Carolina House. He has served PAD as district justice and in virtually every board position before becoming International Justice in 1982.

These volunteers include lawyers, judges, prosecutors, probation officers, law students and faculty. A special component in substance abuse prevention involves law students and lawyers. By going into clasarooms for interactive sessions or to present mock trial demonstrations on the subject, law students assist high school students to understand the legal and social consequences of drug and alcohol consumption and serve as effective role models.

Ms. Bunn was born in Sacramento, California and obtained her law degree from Pepperdine University. She was admitted to the California bar in 1971. A veteran attorney, Ms. Bunn has practiced law in California, as well as Alaska and Korea.

Also an experienced administrator, she spent seven years in the Middle East and North Africa as project manager for an international development agency. She has acted as Executive Director of nonprofit agencies in both Connecticut and California. No stranger to the Washington, D.C. scene, Ms. Bunn served as Special Counsel to the Legal Services Corporation from 1984 to 1986. Most recently she held a position on the faculty of Drake University school of Law in Des Moines, Iowa.

She is active in the Association of American Law Schools, the American Bar and the Federal Bar Associations.

Portraits of Excellence

The subject of the Portraits of Excellence column for this issue is the winners of the Stanley H. Kohn Outstanding Chapter Competition for 1989-90.

U of Miami Chapter Repeats

Rasco Chapter at the University of Miami School of Law has repeated as winner of the first place in the annual competition.

The chapter increased its membership from 304 to 384 from April of 1989 to April of 1990 and this out of a total law school enrollment of 1,350.

Professional programs sponsored by the chapter included publication of a chapter newsletter entitled, "The Legal Pad" and the publication of a law school directory, presentation of \$500 awards to worthy students, compilation and distribution of exam packets, pro bono legal research, a symposium on gender bias: Sex Discrimation and the Legal Profession, which was a highly publicized event which brought together a Florida Supreme Court Justice, the ACLU, and several other scholars in the field of gender bias, a parliamentary procedure workshop, a police ride along program, nursing home visits, Thanksgiving food drive and an ethics symposium. The chapter also participates heavily in law related education and in the Adopt a Pre-Law Chapter program.

Social programs carried out by Rasco Chapter included various rushing events, a tailgate club at University of Miami home football games, PAD movie night, an auction and cocktail party, a Halloween party, awards luncheon, Key Large fishing trip and PAD/Commercial Law "Happy Hours."

The chapter enjoys an outstanding rushing program which includes the following:

New projects planned by the chapter include an academic orientation workshop, a summer beach party and PAD/Commercial Law "Happy Hours."

The chapter credits a great deal of its success to the utilization of an extensive committee system. Each member is given three choices which they may prioritize. The executive committee makes the final decision by balancing the member's desires and the chapter needs.

Committees utilized by the chapter are Membership and Rush, Law Related Education, Scholarship Auction, Tailgate Club, Thanksgiving Food Drive, Police Ride Along program, Chapter Historian, Alumni and Faculty Relations, Test Packets, outlines, old folks home, Halloween party, adopt a pre-law chapter, exam preparation and scholarship.

Chapter activities are planned considerably in advance by the executive steering committee which meets extensively over the summer to discuss ideas and plans for the upcoming year

Second Place to Benton Chapter

We should not limit our concern for hte hungry to the holidays or our help to students to the school year. Professional and Public service is a year-round challenge we should meet everyday.

Widener U Chapter Receives **Best Professional Award**

At the 1990 International Convention held this past August, Read Chapter at Widener University received the award for the Best Professional Program among all PAD chapters.

Alan Horowitz, Read Chapter Justice from 1988 to 1990, and John E. Olsson, Read Chapter Justice for the current year, accepted the award presented by International Justice Larry J. Crigler.

In a message to the Convention, the Chief Justice of the United States William Rehnquist, stated, "PAD has contributed much toward educating the public about our judicial system through law related education programs, including those designed for secondary and elementary school children."

PAD Senator Edward Kennedy has stated, "Law related education is one of the few programs that has been proven effective in reducing juvenile delinquency. A good civic program involves young persons as genuine participants. The interaction between students and judges, lawyers, police officers and local government officials can produce vast changes in the attitude of young people toward their surroundings and in the opportunities, they have to make positive contributions to society.

The Read Chapter LRE program is designed to provide civic education through the in classroom work of volunteer law students. The in class instruction is intended to change the attitudes of the young people in a manner that would help reduce juvenile delinquency, especially substance abuse.

To this end, Read Chapter has completed extensive research into Delaware drug laws as a supplement to the program guide that it carried out this past fall. The guide, "A Resource Guide to Assist law Students for Participation in a High School Education Program" was developed to serve as a training manual for law students, as well as providing actual classroom materials for law student presentation.

PAD internationally, has been a leader in nationwide law related juvenile justice programs sponsored by the United States Justice Department's Office of Juvenile Justice and Delinquency Prevention, (OJJDP) SINCE 1979. PAD is one of only five agencies throughout the country approved by the justice department to conduct such a program and to



have the support of virtually all state and national law enforcement agencies and state and national legal organizations. PAd's LRE program is partially funded through a grant from the United States Justice Department's Office of Juvenile Justice and Delinquency Prevention.

Read Chapter's program got its start in 1988 when Chapter Justice Alan C. Horowitz contacted Robert E. Redding, Executive Director of PAD's Public Service Center, and asked for his approval to conduct the program in Delaware through Widener University School of Law.

The LRE manual was completed in April, 1990. It is now the official manual for LRE programs in Delaware. The committee then decided to convert the original bound manual into a looseleaf, three-ring binder of over 200 pages. The manual was then stored on a computer disk to facilitate revision of the program's manual when necessary

PAD's LRE program is organized and operated by law students who provide community service and to help law students learn the benefits and necessities of community service. Horowitz, now Justice of the Elden S. Magaw Alunni Chapter in Philadelphia said, "I can think of no finer service that a law student can provide than to help eliminate, if not reduce, the discourage of drug abuse." PAD's LRE program is aimed at exactly that goal. Moreover, an additional benefit is that it introduces law students to the rewards of performing community ser-

Convention Action

PROFESSIONAL RESPONSIBILITY AND ETHICS COMMITTEE

- Recommended the development of a professional responsibility and ethics manual to include such programs as videotape presentations, speakers, and the like.
- Recommended that each chapter recommend the faculty at its school to include ethical considerations in the curriculum of various substantive courses.
- Recommends that the professional responsibility and ethics committee continue to publish and seek funding for *The Good Law*yer family of publications.
- Recommends that the professional responsibility and ethics committee explore the existence of a national client counselling competition and further recommends participation by each chapter in such a program.
- Recommended that the PR&E committee develop an award for the best professional responsibility and ethics program and develop a chapter competition form to apply for said award with a report back to the next international convention.
- Recommended that the PR&E committee develop criteria for an award for outstanding contributions in the area of professional responsibility and ethics, with such award to be made to a professor, to a student and to an alumnus.
- Recommended that the PR&E committee undertake duplication of videotapes on law school orientation, exam taking, and the 1988 convention chapter workshop tape as necessity dictates.
- Recommends that the PR&E committee consider development of a professional responsibility and ethics program for the benefit of pre-law chapters and members.

PUBLIC RELATIONS COMMITTEE

- Recommended that the International Executive Board explore and develop a public relations kit for distribution to each chapter.
- Recommended that the International Executive Board develop a program calculated to cause the distribution to all chapters of a regularly published press release which is copy ready and suitable for application in any media by individual chapters.
- 3. Recommended that in public relation matters, the fraternity be referred to as "Phi Alpha Delta" or "P.A.D.," rather than "pad."
- Recommended that any student or alumni chapter recommending candidates for the Tom C. Clark award be given credit or, in some way, acknowledged for their efforts in nominating such candidates.
- Recommended that vice justices be reminded that public relations is a part of the vice justice's official duties.
- 6. Recommended that the foregoing resolutions be implemented within one year of this date, unless good reason exists why such cannot be accomplished, but in no case, should said time period be extended past the convening of the 1992 convention.

PUBLICATIONS COMMITTEE

- 1. Recommended that the following be adopted with respect to the publication of *The Reporter:*
- a. The inclusion of a thematic column with helpful tips on how to run a successful chapter.
- b. A more timely publication and distribution.
- c. The inclusion of District Justices' phone numbers, so long as such is approved by
- District Justices.
